

CLARA HAS CONFESSED

Tells the Story of Frank Westwood's Murder.

WHY SHE SHOT THE LAD DOWN.
Facts As to the Girl's Romantic Career.

For Two Years Was An Heir in a Chicago Livery Stable and Her Sex Was Never Disclosed—Also Offered as a Choir Boy in an Anglican Church in Chicago—Her Sex Discovered by the Toronto Woman—Frank Westwood Suffered From Sexual Perversion—Was in Fact a Female Chastity.

Clara Ford, the mulatto tailor, married Frank Westwood. To Inspector Stark and to Sergeant Detective Reburn she made a full confession of her guilt. The extent and nature of the confession will be made public when the preliminary trial of the accused takes place on the 28th inst.

There were some interesting developments yesterday. The girl was arraigned in the Police Court and pleaded guilty, but subsequently withdrew the plea and entered one of not guilty.

The World also learned some facts which show the murder to have been premeditated, and found at least two witnesses who saw Clara in the vicinity of the Westwood place the day before that of the murder.

It was also learned that for two years the girl masqueraded as a man in Chicago, where she was employed in a livery stable, that she was a choir boy in an Anglican church there and was confirmed as a boy, her sex subsequently being revealed to the minister by a former Toronto lady.

The motive of the crime has not been established by evidence corroborated by the prisoner's story in that respect. It certainly could not have been any illness that had existed between the murdered boy and his slayer. This theory has been abandoned. Everything points to the fact that the murder was suffering from what is called sexual perversion, and simply because of some remark he had made to her respecting her appearance.

CLARA FORD.

The discovery of the perpetrator of the crime came about in this way. Gen. Clark said to his mother that he believed Clara Ford shot Frank Westwood, who Clark reported it to a neighbor, who informed the detectives, which neighbor will probably receive a \$25 reward offered by the Ontario Government.

Sexual Perversion.
The World is not yet in a position to give a definite opinion as to whether Clara Ford is a man or a woman, so far as to divulge anything of which they may be possessed. But from the facts which have come out so far, there is considerable reason for believing that this young woman is a man, and that she is suffering from what is called sexual perversion. The books which are the authorities on the subject cite any number of cases of men who thought themselves women, or wished to be thought women, and of women who desired to be affected in this way. They show an intense desire to become a man, and to be thought of as a man, and to be treated as a man, and to be considered masculine. During the reading of the indictment charging her with the murder, she fixed her gaze on the magistrate, and there was no sign of nervousness. Her plea of not guilty was given in a firm, clear, unflinching voice, and she was not at all perturbed by the retort to defend the girl.

Justice to the Westwood Family.
In the light of these developments, it is a certain amount of evidence that members of the Westwood family were wronged about the cause of the tragedy, are thoroughly justified. These developments also concern young Westwood, from any suspicion that he had in any way committed himself as to supply the girl with a motive for her crime. The sympathy which has already been shown generally about the Westwood family, will be augmented in view of the above statements, which have every appearance of being a true explanation of the murder. Frank Westwood was cut off in his youthful prime by a sexually perverted girl.

A Woman With a History.
Young Westwood's mother had never been dissatisfied to Clara Ford. Her first experience as a man is one which was impelled by force of circumstances, and possibly since then made attire has apparently had an irresistible inclination for her. Her life story is one that has been full of romance and unknown history. Adopted by Miss McKay while yet a child who did not know who her parents were. Thrown on the world, her ideas hardened by her own rough contact with the thorns of existence, she possibly struck out for herself a path. Life in prosaic measure was not for her, and like a bright errand of old she started out looking for adventure.

Her kind benefactor, Miss McKay, tried to reason with her, but Clara was determined to see the world. Chicago was her first objective point. In 1888 she reached the big city on the shore of Lake Michigan.

Work was looked for in vain. Colored girls were not especially in demand on the side of the routes of Polk-street. Driven to desperation, she donned male attire and searched for a situation at a livery stable. A livery stable had a vacancy and the good-looking mulatto boy secured a place as hostler, and her master was her usual form of address.

A Choir Boy in an Anglican Church.
Her color was not noticeable and her voice was so extraordinary that she was sought for as a choir boy. The Anglican Church, which she attended, secured the supposed young man, and, as a choir boy, she was allowed to sing the praise of the Lord. The minister asked her to be confirmed and Clara consented. She attended confirmation class regularly and was all appearances a model young man. Soon the time came for confirmation and Clara was to be confirmed.

Then a Toronto woman, Mrs. Stole, living in Chicago, recognized Clara and told the pastor that his supposed young man was a woman in disguise. The pastor was naturally astonished and called the candidate for confirmation to him. He told what he had learned and Clara frankly admitted her sex, and said that being unable to obtain employment as a woman she had donned man's apparel and had been successful in getting work. Since that time she had continued to wear male attire and had conducted herself exactly as one of the superior sex.

Why She Donned Male Attire.
She did not attempt to excuse her unexplained, thinking it was completely justified by the circumstances. Her experience of two years as a man was not flattering to the males, and she declared that she had no use for men. Her close communion with them had destroyed all illusions and she was now a woman, and she expressed it to the minister, she had no use for men.

Her experience in Chicago was no doubt a precedent for the donning of the trousers in this city. Her masculine manner could not be hidden by petticoats, and she was frequently seen on the streets wearing a standing collar and white shirt and disporting herself much as a woman.

Otto Guelich's Sensational Testimony

AT THE BOODLE INVESTIGATION.
Implicates A. E. Hewitt and Ex-Ald. J. E. Verral.

The Detroit Contractor Claims That He Was Approached and the Information Conveyed to Him That Unless He Paid \$15,000 He Would Not Secure the Paving Contract, But the Detroit Man Did Not Stand Over the Cash.

The intense interest which is being taken in the boodle investigation was evidenced yesterday by the large attendance of visitors. The court was crowded from first to last. Nor were the visitors weary of the proceedings. The evidence was of a thoroughly sensational character, and the excitement maintained to the finish. The most important witnesses were Otto E. Guelich, the asphalt maw of Detroit, who stated that at a meeting with Ex-Ald. J. E. Verral and Ald. Hewitt in the Headquarters Saloon, the former had intimated to him that unless he put up \$15,000 he would not get the contract, and Ald. Hewitt, with whom he was closeted privately, immediately afterwards, repeated the assertion. Mr. Guelich, who speaks with a Danish accent, gave his evidence in a straightforward manner, and related details in the minutest particular. He also made a statement that Ex-Ald. Maloney visited him at the Rossin House and asked that if the contract for asphalt was awarded to Guelich, he (Maloney) should be allowed to supply the stone. A sensation was caused at the afternoon session when Guelich agreed to furnish the stone and swore that, after giving his evidence in the morning, Ald. Hewitt had called him a liar and threatened that he should be "slunked" before leaving the town. Contractor John Shields and George Maitland, a partner of Guelich, testified that on July 17, directly after the occurrence, the letter informed them of the proposition alleged to have been made to them, and that they had never given a dollar to influence his tender. Ex-Mayor Fleming was also in the box, but the greater portion of his evidence was postponed to a later date. The evidence of Guelich, which was not shown, or anything of the kind, was pressed to bear upon Mr. Fleming to get him to champion the cause of the contractor interested in the matter of the asphalt tenders.

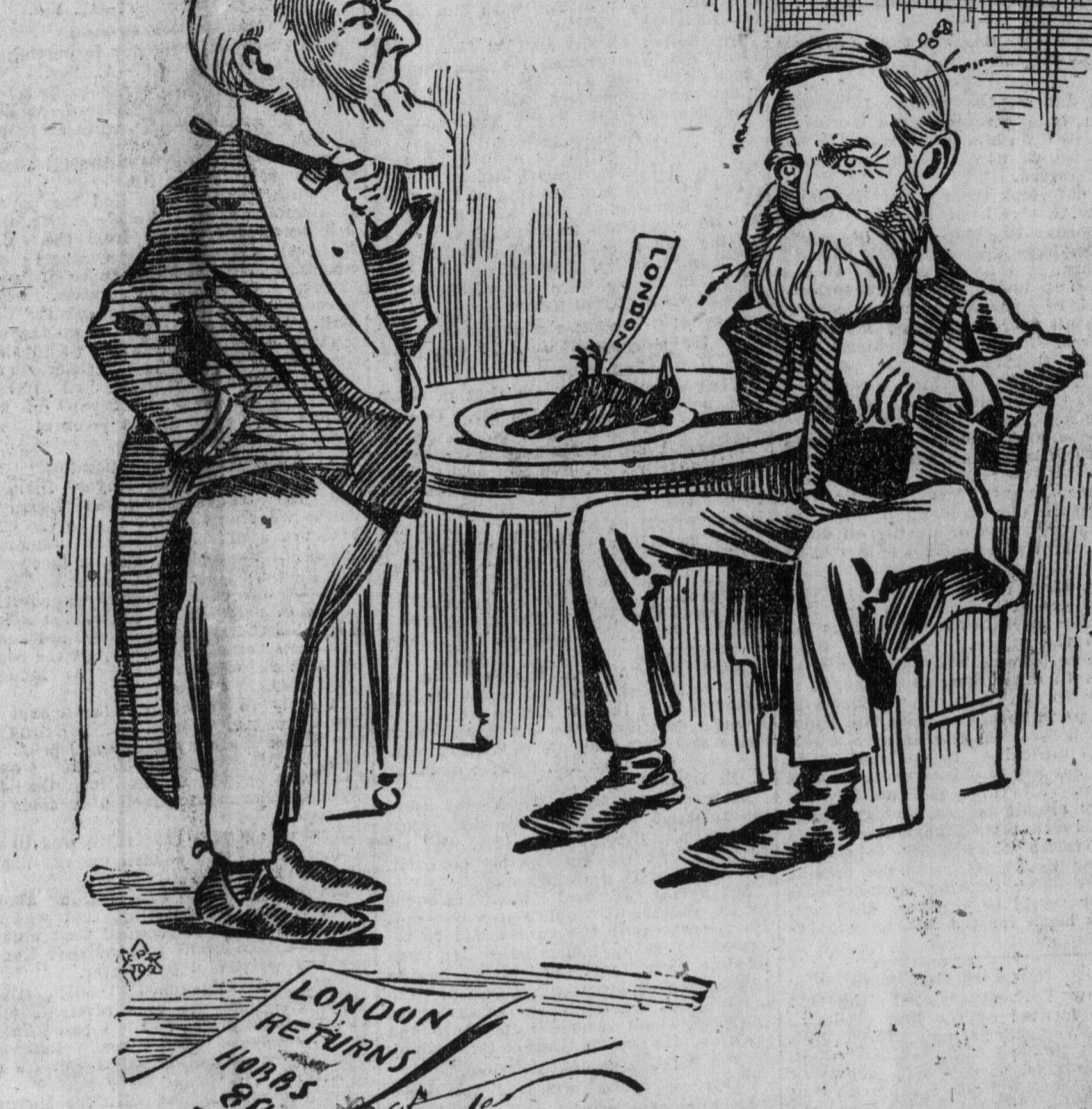

MR. MOODY ON THE SABBATH

PREFERS TORONTO'S QUIETUDE TO TURBULENT CHICAGO.

He Talks of the Heavenly Balance and says He is Fond of the West—He Keeps a Sunday House, But Lets Him Rest on Mondays—Objects to Big Saturday and Sunday Papers.

Mr. Moody's address yesterday afternoon was on "Fellowship," or "Walking with God." He said that objection was made that his theology was of the last century. "If it were not 1000 years old I would discard it altogether," said the speaker. "I have got no new gospel or doctrine or theology. Those who have regard as a curse to the community. The road that John, Paul, Martin Luther and John Wesley took is good enough for me." (A voice: "Yes, indeed it is.")

The Israelites in Jeremiah's day said they would not walk in the old ways, the good old paths; so they had to walk to Babylon. So it is with the Christian.

Mr. Moody on the Sabbath.
Last evening the evangelist spoke on Sabbatarianism to a crowded audience, composed principally of churchgoers. He read the Commandments, and, having commented on the three first, said when he came to the fourth: "Now, I am in for you. If you want to give up your Sabbath and have a day of recreation slip over to Chicago and stay there 30 days before voting. A man who says the Sabbath is for recreation has not read his Bible aright. The workmen will make their mistake if they give up their Sabbath for recreation."

Churchgoers Asked for the Cars.
"Home cars were started in Chicago to accommodate the church-going people. It looked as if Satan had taken charge now. Trains and steam cars take people out for recreation. A prominent minister advocated this, and crowds went to hear him. When the theatres were opened for recreation, the people did not now close the Chicago theatres on Sunday."

When the newboys ceased shouting their papers at midnight on Saturday and there was quiet till Monday morning, I said: "The people would not be a city as Toronto. Would that we had it in the United States."

Saturday and Sunday Papers.
"I believe the greatest curse in American cities is the Sunday newspaper, and I also believe that the great dailies in the United States are the Sunday papers. On Saturdays have done as much harm as causing people to break the Fourth Commandment, as Sunday papers."

His Conduct Troubled Him.
Mr. Moody explained his conduct on a Sunday car with a ministerial friend. He said it was all right, but his conduct troubled him and he got off.

He candidly admitted that he has a Sunday horse for long distances. He let the horse rest on Mondays, as well as on Tuesdays. "I have not any influence over the Toronto people, but I would hold on to your Sabbath." Then the evangelist predicted open seasons and theatres in the week of the Sunday electric cars. It was so in Chicago; it was so in New York. In those cities the Sabbath has gone. Thank God you still have it in Canada!

A. Mr. Small said he was very intimate with Mr. McKenney, and in a conversation that gentleman had told him that if witness would come over to his proposition there would be no objection on his part.

Did anything of a special nature occur before July 17? A. I think it was about July 15 or 16 when this conversation took place with Small in a meeting, says, state to the court that I was brought here then upon a telegram from Mr. Shields, that message he said that he thought the council would review their former action, and that Mr. Leitch, who had been an advocate of the so-called Guelich contract, he thought, had gone over to the enemy. He asked me to come at once.

I came to Toronto upon that telegram and went up to Mr. Leitch's residence and had a conversation with him in reference to his attitude with regard to the Guelich contract. I saw him on the morning of July 17.

Did he make any statement at that time about a previous occasion when I was at his house he told me that he had spoken to me with the object of obtaining money from me.

What happened? A. Upon entering we were conducted into two small rooms on the second floor, which were entered from King-street. We sat down at a table and had a couple of drinks, when Mr. Leitch, who was sitting at the head of the table, said to me: "I think you are a drinking man."

After a little while Mr. Verral asked me to go into the other side room with him. I went with him, and we talked about the vote on my contract. We discussed it for some time, and Mr. Verral expressed himself in doubt as to whether it would carry or not.

When the adjournment John Shields was the first witness called. He was a contractor and at the present time had some contracts with the city.

Did you take any part in the Guelich tendering? A. Yes, I invited Mr. Guelich to come here and when he arrived told him I would put up half the security.

Home-Raised Beef—Farm Accounts—Notes in Variety. Western dressed beef could not compete with home-raised beef if the Western beef was not of good quality.

At the end of the year each farmer should survey his work and compare his expenses with his receipts. Credit that was purchased for the family, and also the proportion of product of the farm that was consumed.

Radishes for winter may be stored in sand in the cellar. Root crops may also be kept in this manner.

Working the garden with the spade and hoe on heavy soil is hard work in the spring, and is not much relished by farmers, who prefer the horse hoe.

All small fruits in the garden will be benefited by a heavy mulching of manure, which will keep the roots from frequent thawing and freezing of the soil.

Farmers who believe that farming does not pay should ask themselves if they are using the best kind of stock, and if their investments are of the most improved labor-saving makes.

Rich food is essential to secure the maximum product from an animal, but such food should be fed to stock that can utilize it to the best advantage.
