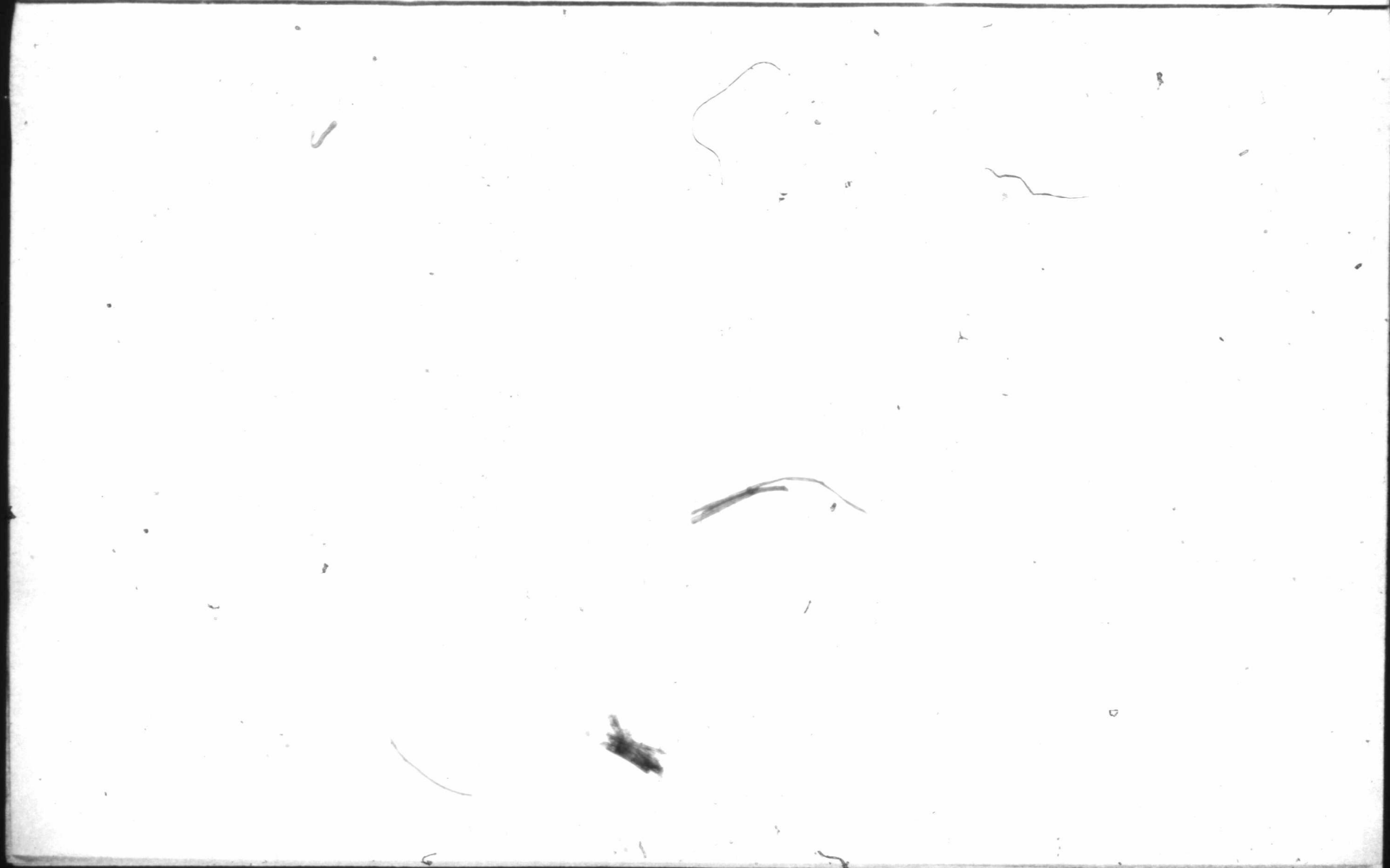

## I.—OF THE CORPORATION GENERALLY.

1. The Bishop hath the power of appointing persons from time to time, as he shall see fit, to be Members of the Board of Trustees, and of the College Council; and any *five* of the members of the Corporation shall form a *quorum*.

2. The Bishop shall have the power of dismissing any Trustee, on a representation and request to that effect from a majority of the members of the Corporation, appointed at any meeting specially called for that purpose.

3. The Bishop of Quebec, or the Superior Ecclesiastical Functionary of the United Church of England and Ireland in the Diocese for the time being, is the President of the Corporation, and shall preside at all meetings thereof, when present; and he shall have power to depute and delegate such member of the Corporation as he shall see fit, to preside at such meetings, in his absence. If no such person be deputed, the members present shall choose a chairman to preside.

4. The Corporation shall meet at Bishop's College annually, on such day, immediately before or after the commencement of the long vacation, as the President shall fix.

Special meetings shall be held at other times as the President shall judge necessary; or upon the requisition of any three members of the Corporation;—such meetings to be held at such time and place as the President shall appoint. And notice shall be given in writing to each member, at least one week before the time appointed for holding such meeting, of the specific object or objects thereof; but no alteration or amendment of the original and fundamental regulations of the Corporation shall be made at any meeting of the Corporation, unless notice of such alteration or amendment shall be given in writing to each member of the Corporation at least one month previously to such meeting.

5. All questions at such meetings shall be determined by a majority of votes of those present, including the President.

6. The Corporation Seal shall be kept by the Principal of the College, until such time as a Registrar shall be appointed.

## II.—OF THE TRUSTEES.

1. The Trustees shall have the immediate disposal and management of the funds of the College, of the buildings, and of all other property belonging to it, whether fixed or moveable; and shall have power to execute, by affixing the College Seal to, any instrument whatever, by which any property shall be alienated, demised, or acquired; provided that such act, if the same shall comprehend any alienation or lease for more than seven years, shall be confirmed by the Bishop, under his hand and Seal. The Trustees shall be responsible to the Corporation for acts done by them in the exercise of the powers herein granted to them, and the Corporation may annul such acts, if they deem it necessary.

2. The Trustees, or a majority of them, in the event of their having reason to believe that there is any matter relating to doctrine, morals, good order or discipline, which requires correction within the College, shall represent the same to the Visitor, who shall at his earliest convenience make, or cause to be made, a sufficient investigation as to the truth of any charge thus brought under his notice, and shall at the next meeting of the Corporation communicate, for their information, his decision on the subject thus investigated.

3. The Trustees shall hold meetings at the call of the Chairman, or at the requisition of any two Trustees, as shall be found necessary; with power to adjourn as they please. Notice of all such meetings shall be given in writing to each member, at least three days before-hand, by the Chairman, or, in his absence, by any two Trustees. At all meetings hereby authorized or required, three Trustees shall form a quorum.

## III.—THE COLLEGE COUNCIL.

1. The College Council consists of the persons now appointed, or who shall be hereafter appointed thereto, by the Bishop.

2. The Bishop, when he thinks proper to be present, shall preside in the Council, and, in his absence, the principal officer of the College shall preside according to seniority of appointment; in the absence of such officer the senior member of the Council present shall preside. The presiding officer may always vote, and

shall give a casting vote when a question would otherwise be undecided.

3. The Bishop, or such Principal officer or Senior Member of the Council, may call Meetings of the Council as occasion may require, by written notice; any three to form a quorum. The said Meeting shall have power to adjourn as they please.

4. The immediate internal government of the College shall be vested in the College Council who shall have power, at any such Meeting as aforesaid, to make and establish temporary Rules, Orders, and Regulations not contrary to the By-Laws or Regulations of the Corporation, whenever it shall be necessary or expedient for the better carrying the said By-Laws into effect, or in cases where no provision is made.

5. At those Meetings all other affairs of the College shall be transacted, whether relating to morals, learning, the good government and economy of the house, or the election or removing of officers and servants, in so far as such matters are entrusted by the said By-Laws to the management of the College Council.

6. All Rules, Orders, Regulations, and appointments made by the College Council, and all regular proceedings at College Meetings shall be communicated and submitted to the Corporation at their Meetings; who may amend alter or confirm the same.

7. The Council shall have the power of reprimanding publicly, and if need be, of rustivating or expelling any student guilty of misconduct, provided that such sentence of rustication or expulsion be not carried into effect, except in cases of urgent necessity, for the preservation of order and discipline, until confirmed by the Visitor.

#### IV.—OF THE VISITOR.

1. The Bishop of Quebec, or other the Superior Ecclesiastical Functionary of the United Church of England and Ireland in the said Diocese of Quebec for the time being, is Visitor of the College, with power—to inspect, from time to time, the state of the College, its concerns, management and proceedings;—to adjust disputes; to direct and enforce the reformation of any irregularity, neglect, or abuse,—and for this purpose to call before him any Officer, Member, or Servant of the College,—if need be, to remove

or suspend any such Officer, Member or Servant for misconduct—to interpret the Statutes in doubtful cases—and to make such further provisions or regulations as may seem to him expedient;— Provided always that such Regulations be not contrary to the principles on which the College is founded, and that they be laid before the Corporation at their next ensuing Meeting and be subject to their approval; but such Regulations shall have force and effect until altered or annulled by the Corporation.

#### V.—OF THE PRINCIPAL, VICE PRINCIPAL, AND OFFICERS OF THE COLLEGE.

1. The Principal, Vice Principal, Professors, and Bursar, shall be members of the Church of England, and shall, before entering upon the duties of their respective appointments, take the oath of allegiance, and make a declaration before a Judge of any Superior Court of original jurisdiction in civil matters, or any Circuit or District Judge, or any other person duly authorized to administer oaths of office, faithfully to execute their several offices; and shall subscribe the thirty-nine articles of Religion and the three articles of the thirty-sixth Canon.

2. The salaries, fees, and emoluments of the Principal Professors and officers of the College shall be paid by the Corporation.

3. The Principal of the College shall be a clergyman in full orders of the Church of England, and a graduate of some university of repute in the British dominions, and shall be appointed by the Bishop from time to time, and shall be subject to removal by him, if cause for such removal shall arise.

There shall be a Vice Principal who shall be appointed by the Bishop.

4. The Principal shall reside in or near the College, and it shall be his duty to enter Students of the College, to take care that the Statutes, Rules and Regulations of the College be faithfully observed, to enforce discipline, to order and preside over College Exercises, to have an active inspection over all the internal affairs of the College and to regulate the inferior officers and servants.

5. In the absence of the Principal and Vice Principal, or during the vacancy of the offices, the next presiding officer of the College shall have the powers, and perform the duties, of Principal.



6. The Vice Principal shall assist the Principal when called upon in the performance of the duties prescribed in the fourth paragraph.

7. The Professor of Divinity shall be appointed by the Bishop and shall be a Clergyman in full Orders of the Church of England, and a graduate of some University of repute in the British dominions.

8. All Professors, except the Professor of Divinity, shall be nominated by the Trustees, at a meeting called for the purpose; such appointment to be subject in all cases, to the confirmation of the Bishop. When any such appointment shall be confirmed, a certified copy of the resolution or vote of Trustees whereby such appointment was made, and of the Bishop's act of confirmation shall be delivered to the person so appointed—under the College seal, and signed by the Chairman or any two of the Trustees present at the meeting, at which such resolution or vote was passed; in which document the nature of the office so filled up, shall be set forth, and such certified copy shall be a sufficient authority to the person appointed to enter upon, and perform the duties of said office.

9. It shall be the duty of the Professors respectively to carry on the course of instruction prescribed by the College Council; and, for the enforcement of discipline, they shall have power to punish Students, by imposition, by inflicting fines, not exceeding five shillings; and by confinement to chambers or College grounds—such punishments to be subject to an appeal to the Council.

10. If the Principal do not live in the College, the Vice-Principal shall.

11. The Librarian shall be appointed by the College Council and act under their direction.

12. Lecturers and teachers in particular branches of education may be appointed from time to time as opportunity may offer, by the College Council, who shall also regulate their duties. Their emolument, if paid otherwise than by fees, to be regulated by the Corporation.

13. Any officer of the College may obtain leave of absence not exceeding one month from the College Council; but for a longer period only from the Visitors.

## OF THE BURSAR.

14. The Bursar shall be appointed by the Corporation.

15. It shall be his office to act as Treasurer of the College, to superintend the College accounts, to inspect and take care of the buildings, and direct small repairs, and report larger ones to the Trustees; to have immediate charge of the moveable property; and to superintend the Steward and other inferior officers under the direction of the Principal. He shall account to the Corporation at each annual meeting, up to the commencement of the previous Easter term, and when so required by the corporation, at the commencement of each term. His accounts shall also, at all times, be open to the inspection of the College Council. He shall, under the direction of the College Council, have charge of the College grounds, and the superintendence of the improvements thereof.

## VI.—OF ADMISSION, RESIDENCE, STUDIES, AND DISCIPLINE.

## I. ADMISSION.

*a*—Candidates for admission will be expected to shew a sufficient acquaintance with the Greek and Latin Languages, to be able to read and translate each language readily, and to translate English into Latin. They will be examined in Mathematics, in the earlier books of Euclid and Algebra, and will be required to show a competent knowledge of the Bible, to translate the New Testament fluently from the original, and to answer questions from both the Old and New Testament;—The judgment as to the sufficiency of the Candidate's attainments to be left in the hands of the Professor who examines him.

*b*.—They will be required to subscribe to the following declaration of obedience to the Rules of the College:—

I, A B, do solemnly promise and declare, that I will, with the assistance of the Divine Grace, during my residence in this College, faithfully obey the laws thereof, and diligently prosecute all the studies required of me, according to the Rules of the Institution.

*c*.—In the case of a Candidate having been a member of any

other Collegiate Institution, he shall present Testimonials of good conduct from the authorities of that Institution; and in all cases whatsoever, at the discretion of the College Council, any number of terms which such candidate shall have kept at any such other Institution, may count as part of the residence required by the regulations: Provided always, that such terms kept at an Episcopal Institution exclusively Theological, shall not count unless as part of the Theological course required.

## 2. RESIDENCE AND STUDIES.

- a.*—The ordinary course of Study at Bishop's College will extend over a space of four years. The subjects taught will consist of Classical and English Literature and Composition, History, Mathematics, Natural and Experimental Philosophy, Chemistry, Logic, Rhetoric, Moral Philosophy, Hebrew, and Divinity.
- b.*—Theological Students will be required to attend upon the course of Lectures drawn up under the direction of the Bishop, which course shall occupy not less than one year.
- c.*—The period allotted to study, in each year, will be divided into three terms,—
- 1st. Michaelmas.*—From the first Saturday in September to the twentieth of December.
- 2d. Lent.*—From the third Saturday in January to the Wednesday preceding the first Saturday in April.
- 3d. Trinity.*—From the first Saturday in April to the last Wednesday in June.
- d.*—Persons desirous of attending particular courses of lectures delivered in the College without becoming regular Students, may do so with permission of the College Council: but such persons shall observe the Rules of the College during such temporary attendance in so far as these may be applicable to their cases.
- e.*—During these terms constant residence will be required of all Students, unless they be prevented by ill-health, or be detained by urgent business; in either case, notification

and proof must be given to the Principal; and in the latter, leave of absence obtained from him.

- f. Nevertheless the Visitor shall be allowed to dispense with the foregoing regulations as to terms of residence and admission in the cases of all Theological students, and it is provided that the College Council may dispense with the actual residence in College of those Students whose parents or natural guardians reside in Lennoxville, or so near the College that the Students may attend the prayers and exercises of the Institution.

The same privilege shall be granted to the Lord Bishop of Montreal, being a member of the Corporation.

- g. — Until the power of granting degrees is given to the Corporation, a certificate in form of Diploma, to be drawn out by the College Council, shall be granted to those who are leaving, or have left the College, after having completed the College course, upon which they shall be entitled hereafter to claim and receive the degree of B. A. from the College, when degrees shall be conferred, and to proceed accordingly to higher degrees; and all persons receiving such diploma shall during such time be further distinguished by the title of *Alumnus Emeritus*.

### 3. DISCIPLINE.

a. — *Dress.*

All Students will be required to provide themselves with a decent Gown and Cap, according to a prescribed fashion; which they will be expected to wear at Chapel and at Lectures; as also whenever they appear in Public, unless beyond certain limits hereafter to be defined; but persons who shall be admitted to attend a particular course of lectures, as herein before provided, shall not wear the Cap and Gown required in the case of regular students.

b. — *Attendance on Divine Service.*

There shall be morning and evening prayers every ordinary week day, in the College,—at which all Members of the College shall attend; on Sundays and all other days when Divine Service shall be held in the Church of the Mission of Lennoxville, all the Students,—unless the parents or guardians shall especially direct attendance elsewhere,—shall attend upon such service; and any Student absenting himself from prayers or Divine Service, shall give account of his absence to the Principal.





*c. Lectures.*

A list of Lectures for the term will be publicly given out by the Professors at the commencement of each term, which Lectures it will be the duty of all Students, belonging to the several classes, to attend.

*d.*—There will be an examination held annually, before the commencement of the Summer vacation, by the Visitor, or such persons as he may appoint. The examination will be conducted on the plan in use at the English Universities.

*e.*—*Moral Conduct.*

The moral conduct of the Students will be carefully attended to by all the Professors. The Students will be called upon to appear before the College Council to answer any charges of misconduct which may be preferred against them.

4.—EXPENSES.

*a.*—The charge to each Student for tuition, room rent, and the use of the College Library, shall be twelve pounds ten shillings *per annum*, to be paid, in the necessary proportions each term.

*b.*—All Students shall be required to deposit in the Bursar's hands, on the first day of each term, the sum of seven pounds ten shillings towards the payment of the expenses of the said term; and shall pay the balance of the term's expenses on whatsoever day shall be duly notified at the end of each term; and it shall be the duty of the Principal to take care that no Student be received back into the College, or receive his Diploma, when otherwise entitled to it, without having complied with this regulation. This rule shall not come into operation until the commencement of the year 1850.

*c.*—Persons admitted to attend particular courses of lectures, as hereinbefore provided, shall pay in advance each term for his attendance during the whole or any part of each course a fee to be regulated in amount, and varied according to the extent of each course, by the College Council.

## VII.—THE COLLEGIATE SCHOOL.

1. There shall be a Grammar School connected with, and subordinate to the College.

2. The Master shall, from time to time, be appointed by the Trustees, at a meeting called for the purpose, subject to the confirmation of the Bishop;—and shall be removed in like manner.

3. A body of three members of the Corporation resident on the spot, shall be appointed, with the Master, to act as a Committee of Management, with power to appoint a Chairman, and to meet and adjourn as they please; any three to form a quorum. They shall be entrusted with the entire disposal of the monies arising from the school fees, and shall have the power of appointing, and of dismissing, if necessary, other masters, and of framing rules and regulations for all matters connected with the school.— Provided that no expense shall be entailed by them upon the Corporation; and that their proceedings shall be subject to the approval of the Corporation.

4. The said Committee shall give due notice of the time and subjects of public examinations to the College Council, who shall thereupon appoint one of the Professors of the College to assist in conducting the examination, and to report thereon to the Corporation at their next meeting.

## TERMS OF ADMISSION, &c.

- EXAMINATION.—Candidates will be examined in Xenophon and Homer, Cicero's Select Orations and Virgil, or in such books as they may have read in Latin and Greek ; in the first three books of Euclid, and as far as Equations in Algebra, with Proportion and Vulgar and Decimal Fractions in Arithmetic ; and in Latin Composition.
- EXPENSES—for Board, fuel, lights, and washing, do not ordinarily exceed £27 10s.—Charge for tuition, use of the Library, and room rent, £12 10s.—per annum.
- PAYMENT.—£7 10s. at the commencement of each term : viz. the 1st Saturday in September ; the 3rd Saturday in January ; and the 1st Saturday in April ; the remainder at the end of each term.
- DRESS.—Each Student will have to provide himself with a gown and cap of a prescribed pattern.
- BEDDING.—Each Student finds his own.
- VACATIONS.—At Christmas—from December the 20th to the 3rd Saturday in January. (Easter—a recess of 3 days.)  
Midsummer—from the last Thursday in June to the 1st Saturday in September.
- EXHIBITIONS.—Competed for in the week which precedes Michaelmas term. Notice of vacancies will be given from time to time.
