

WITH the object of promoting and perpetuating, on a firm basis, an interest in scientific figure skating, single and combined, a Skating Club has been formed under the Patronage of "Their Excellencies the Earl and Countess of Minto," of which the following is the Constitution :—

CONSTITUTION.

1. The Club shall be called "The Minto Skating Club." Its headquarters shall be at Ottawa.

2. The Club shall consist of the Patrons, Elected Members, and Lady Associate Members, and Honorary Members.

3. The Officers of the Club shall consist of an Hon. President, a President, and a Secretary-Treasurer, who, with a Committee of four other members, shall form the Executive of the Club. They shall be elected annually at each Annual General Meeting. Three shall form a quorum of the Executive.

4. The Committee shall have power to amend or add to the existing Rules of the Club. Notice of any change thus made shall be forthwith sent to every member of the Club, and unless rescinded

by a Special General Meeting, the Rule thus amended or added shall have full force until the next Annual General Meeting, to which it shall be submitted for confirmation.

5. At least three clear days' notice shall be given to every member of the Committee of the time and place of meeting, and of the business to be transacted thereat; and no business, other than ordinary routine business, shall be transacted at any meeting unless such notice thereof shall have been given.

6. All members and lady associate members shall be elected by the Committee, subject to passing the required test.

7. Any gentlemen who shall desire to become a member of the Club shall be proposed in writing to the Secretary by a member to whom he is personally known.

Lady associate members shall consist of the wives and daughters of members, and such other ladies as may be proposed by any of the above, and elected by the Committee.

RULES.

1. The annual subscription shall be \$1.00 for members, and 50c. for lady associate members.

2. Every candidate, before election, shall be required to pass a skating test to the satisfaction of judges appointed by the Committee.

The test for gentlemen shall be the outside edge forward and backward on both feet, and a forward three on each foot, the length of each curve being 10 feet at least.

For ladies—outside edge forward on both feet, and forward eight to a centre.

3. Every member or associate member shall, when skating at any meeting of the Club, wear the Club badge.

The badge is to be procured from the Secretary of the Club.

4. In addition to the examination for entrance to the Club, there will be, for the present, two grades of proficiency in skating, members passing which, will be entitled to receive a special certificate, and a badge supplied by the Club.

NOTE—By the kind permission of Their Excellencies. the Government House Rink will, for the present, be the headquarters of the Club, and meetings for practice, &c., will be held there every Wednesday afternoon, weather permitting.

THIRD-CLASS TEST.

The judges will be appointed by the Committee.

In every case two judges must be present at the examination of a candidate, and the candidate must satisfy both judges.

The judges will require the test to be skated in good form, the essentials of which are—

- (1) Sideways attitude of body.
- (2) Face turned in the direction of progress.
- (3) Uprightness of carriage.
- (4) Straightness of employed leg.
- (5) Approximation of heels.

TEST.

- (a) A forward outside 3 on each foot, the length of each curve being 15 feet at least. The 3 need not be skated to a centre.
- (b) The ordinary and cross outside roll forward and backward, the length of each curve being 10 feet at least.
- (c) A forward outside 8, the diameter of each circle being 5 feet at least.

SECOND-CLASS TEST.

No candidate can be judged for this test unless he has passed the Third Class Test.

No candidate who has failed to pass a Second Class Test is allowed to compete again within a week, except with the written permission of the judges on the occasion of the former failure.

The whole of the above test must be skated on the same occasion and before two of the appointed judges, and the candidate must satisfy both judges.

The judges will require all turns to be clean.

When a stroke is taken in a combined figure from outside back to outside back, the feet must be crossed.

In the following list of figures, the word 'three' means a 3 turn.

TEST.

- (a) The following edges on each foot alternately for as long as the judges shall require, each curve being twelve feet at least, namely—
1. Cross outside forward edges.
 2. Inside back edges.

(b) The following figures skated on each foot, namely—

1. Forward inside three, the length of each curve being 20 ft. at least (R. L.)
2. Forward outside three, the length of each curve being 25 ft. at least (R. L.)

(c) The following figures skated to a centre on alternate feet without pause, three times on each foot, namely—

1. Forward inside three, the length of each curve being 12 feet at least.
2. Forward outside three, do 12 ft. at least
3. Forward inside two threes do 8 “
4. Forward outside two threes do 8 “
5. Forward inside three threes do 8 “
6. Forward outside “ do 8 “

(d) Back outside two threes on alternate feet on the cross roll, three times on each foot, the length of each curve being 6 feet at least.

(e) The following figures skated on each foot, namely—

1. Forward inside ‘Q,’ the length of each curve being 30 ft. at least (R.L.)

2. Forward outside 'Q,' the length of each curve being 30 ft. at least (R.L.)
 3. Back inside 'Q,' the length of each curve being 15 ft. at least (R.L.)
 4. Back outside 'Q,' the length of each curve being 10 ft. at least (R.L.)
- (f) A set of combined figures skated with another skater, who will be selected by the judges, introducing the following calls in such order and with such repetitions as the judges may direct :—
1. Forward three entire.
 2. Once back—and forward.
 3. Once back—and forward three.
 4. Once back off meet—and forward three entire.
 5. Once back meet—and back—and forward three.
- (g) The judges shall call three 'unseen' figures of quite simple character, in order to test the candidate's knowledge of calls and power of placing figures upon the ice.
