At London, and within the First Presbyterian Church there, Tuesday, the 13th day of November, 1900, and at the hour of half-past 10 o'clock in the forenoon, which time and place the Presbytery of London met according to appointment.

Dunwich, and S. Ekfrid. and that Chalmers Church, Dunwich, and McBride's Church, Southold, be No. 37 at the foot of the roll. The

of consolidating the work of these charges and ultimately saving the funds of the church; but in view of the special application made in behalf of Fingal referred the application to the Synodical Committee. application and sympathized with Mr. McNeil, also appointed Mr. R. Stewart and Mr. I. Rathburn, elders, to be associated with the Clerk as a committee to confer with Mr. McNeil and prosecute the application in behalf of the Presbytery, with the view of obtaining immediate relief from the fund if possible, and securing that Mr. McNeil's standing, as an annuitant should date from the 25th March last, when his resignation took effect. Stewart and agreed that the petition be not received on account of irregularities, but inasmuch as these are confessedly due to ignorance of church law, a committee be appointed to confer with the petitioners concerning the difficulties complained of in their petition and report at after-

The call was very unanimous and signed by 89 members and 138 adherents of Duff's Church and by 50 members and 70 adherents of South Ekfrid. McBride's Church, and about the same number — seven — adherents, the balance being still connected with the Fingal congregation. (2) That while the petition is irregular there are difficulties existing in the parish of McBride's Church calling for the immediate consideration of the Presbytery, and recommended (1) that the irregularities be waived and the petition received and considered. (2) That the services at Lawrence be continued as at present until the settlement of a minister; (3) that thereafter services at Lawrence be once a month, and all other services there or elsewhere within the bounds of the two congregations be left to the decision of the joint sessions of Chalmers Church, Dunwich, and McBride's Church, Southwold. On motion of Mr. Currie, seconded by Mr. Drummond the report with the recommendations was

adopted and the Presbytery decerned accordingly. The committees appointed to examine the session records of Dorchester and Kintyre respectively, reported the same as carefully and correctly kept. The moderator was authorized to attest them accordingly. The Presbytery adjourned to meet in Knox Church, St. Thomas, on Tuesday the 8th of January 1901, at 11 o'clock in the forenoon the Moderator pronouncing the benediction.

No objection having been offered, Dr. McRae preached an appropriate sermon from 1st Corinthians 2nd chapter and 4 and 5th verses—Mr. Steven Moderator of Session narrated the steps that had been taken to fill the vacancy—The Moderator then put to Mr. Ellison the prescribed questions and received satisfactory answers—He was then by solemn prayer and the laying on of the hands of the Presbytery, set apart to the holy ministry

the Presbytery of London I invite you to take part in this ministry with us, induct you to the pastoral charge of this congregation and admit you to all the rights and privileges thereto pertaining—The other members of Presbytery also gave him the right hand of fellowship. Mr. J. Steven then addressed the minister and Mr. Barnett the people on their respective duties—After the benediction was pronounced Messrs Steven and Kelso accompanied Mr. Ellison to the door and introduced him to the congregation as they retired.—Mr. Ellison on signifying his willingness to sign the Formula had his name added to the roll of Presbytery. After introducing the newly inducted minister to the Session and Managers the Presbytery was closed with the benediction.
