MINISTER FOR INTERNATIONAL TRADE  
ANNOUNCES COMPOSITION OF  
SECTORAL ADVISORY GROUPS ON INTERNATIONAL TRADE

The Honourable Pat Carney, Minister for International Trade, today announced the composition of 15 Sectoral Advisory Groups on International Trade (SAGIT).

The selection process was concluded in close cooperation and consultation with various national trade groups and associations, provincial governments, and labour.

The 15 SAGIT are part of an advisory committee structure which will provide a two-way flow of advice and information between the government and the private sector on international trade matters. Their role will be to ensure that sectoral views are fully taken into account on all trade matters.

Miss Carney noted that four SAGIT groups were announced last spring by the Honourable James Kelleher, former Minister for International Trade. They were the advisory groups on Arts and Cultural Industries, Financial Services, Automotive and Aerospace, and Apparel and Fur.

The other component, the International Trade Advisory Committee (ITAC), chaired by Walter Light, deals with broad national issues relating to international trade access and marketing matters. ITAC has held three meetings. Ten of the 15 SAGIT have already met; the remainder are scheduled to meet shortly.

Both the ITAC and SAGIT report to the Minister for International Trade.

With respect to the Canada/United States trade talks and the Multilateral Trade Negotiations (MTN), the ITAC and SAGIT will work closely with the Trade Negotiations Office.

A Secretariat within the Department of External Affairs has been established to assist the advisory groups in their work.
