

THE TWENTY - FOURTH ANNUAL REPORT

OF THE

Irish Protestant Benevolent Society

To the Members of the Irish Protestant Benevolent Society:

Another year of the Society has passed and our Officers and Council feel very great pleasure in presenting their Annual Report, which may be considered satisfactory notwithstanding the continued depression which, to a certain extent, effected the usual contributions and the prompt payment of membership fees, as well as creating a greater demand for assistance to our fellow-countrymen who were unemployed, and who, with their families, were compelled to seek assistance from the Society, which was generously furnished to all deserving cases by the Charitable Committee, who have endeavored to reduce the number of the old pensioners and prevent imposition on the Society.

CONSTITUTIONAL CHANGES.

Article 6th of the Constitution was amended and will now read as follows:

"Officers to be elected shall be nominated and seconded by members in good standing at the monthly meeting previous to the annual meeting."

Article 8th was also amended and will now read as follows:

"All voting at any meeting shall be by open vote, except as hereinafter provided, or when five members desire the vote to be taken by ballot. The election of Officers and Council shall be by ballot and shall take place at the Annua! General Meeting of the Society to be held in the City of Toronto on the first Friday in April in each year. Ballots must be deposited by voters in person. Candidates who receive a majority of votes cast shall be declared elected."

MONTHLY MEETINGS.

The attendance at the monthly meetings was fairly good, but not as large as your officers would like to see.

At the meeting held on September 29th, Past President Jas. L. Hughes, who had then just recently returned from a trip to the Old Land, delivered a most interesting lecture, his subject being: "Ireland as it is." It is needless to say that Mr. Hughes' address was greatly appreciated by those who had the pleasure of being present.

At the meeting held on December 3rd, Mr. Thomas Kerr lectured on the subject: "St. Patrick, the Apostle of Ireland, and His Times." The lecture was very interesting and instructive.

ANNUAL SERVICES.

The Annual Thanksgiving Sermon was preached in Elm Street Methodist Church, on Sunday, October 21st, 1894, at 4 o'clock p.m.; the service was conducted by the Rev. Dr. Galbraith, Pastor of the Church. The sermon was preached by the Right Rev. Bishop Campbell, and was eloquent, patriotic and instructive.

The musical part of the service was under the direction of Mr. and Mrs. H. M. Blight, assisted by the excellent choir of the Church.

The Sons of Ireland attended by invitation on this occasion.

Annual Services were held on Sunday, 17th of March, at 3.30 p.m. The sermon was preached by the Rev. Arthur H. Baldwin, M.A., Rector of All Saints' Church; a very earnest practical discourse on "Freedom," I. Peter ii. 16. The Rev. Septimus Jones, M.A., Rector, kindly gave the use of the Church of the Redeemer, corner Avenue Road and Bloor Street West.

The music was of a high-class order, conducted by Mr. W. H. Robinson, assisted by the choir.

The Sons of Ireland were present by invitation. There was a large a attendance of members.

MEMBERSHIP.

There have been sixteen members elected during the year, and it is to be hoped that the brethren will exert themselves the coming year and secure a large number of new members.

Those who have died, and those who, by removals and other causes, have left the Society, were thirty-one; six having died, are recorded upon our death roll, and twenty five by removal from the city and other causes; thus leaving our membership at the present time four hundred and twenty-one.

THE ANNUAL DINNER.

The Eleventh Annual Dinner of the Society was held on March 15th, 1895, at the Queen's Hotel. It was unanimously pronounced one of the best the Society has ever held, the only regrettable feature being that more of our members did not interest themselves in making it a more decided success by their presence and co-operation.

The Society was honored by the attendance of representatives from the various National and Benevolent Societies of the city; also by a representative from the Irish Protestant Benevolent Society of Montreal, in the person of Mr. J. Hamilton Fern.

SUGGESTIONS.

The Council would earnestly recommend all Irish Protestants and their descendants to unite in the good work of increasing our membership, and so increase the usefulness of the Society in assisting the less fortunate of our people in their struggle to provide the necessities of life.

Report of the Charitable Committee.

We beg to submit the Twenty-Fourth Annual Report of the Charitable Committee, being that for the year just ended.

In reviewing the work of the Committee we find a gradual increase of applications for relief, due no doubt to sickness, scarcity of work and the severity of the winter. We have, however, been enabled to meet the pressing wants of those deemed worthy of assistance. The very great number of undeserving applicants that continually besiege the office has made the distribution to the deserving more difficult.

Single men were assisted by railway tickets and cash to take them to other parts of the Province. Several of them have since returned letters of "thanks" for help received and report improvement in their worldly prospects.

Many aged widows without children to support them are receiving aid from the Society. In one of these cases the beneficiary is 105 years old.

Very distressing cases are frequently met with where immediate relief is requisite. In one instance the father and mother were destitute and had their five children laid up with scarlet fever. Timely help was rendered and the children, with one exception, recovered.

Six families that were helped in the first part of the winter were marked "no more help this winter." 19 families have been cut off the books as unworthy of any assistance.

117 heads of families and 302 children; 30 widows and 73 children; 30 widows without children; 13 single men and women, residents of the city, and 34 single men not residents of the city were assisted by the Society during the year. Twenty of the non-residents were sent out of the city, the others were assisted by cash, board and lodgings. The total number of persons assisted was 716. The distribution was as solution follows: 93 half-tons of coal, 40 half-cords of wood, \$197 worth of groceries, 238 meals, 70 nights' lodgings, \$102.25 in cash.

Through the liberality of the Society and its friends your Committee have been enabled to meet all deserving cases that have come before them, none having been refused if deemed worthy of assistance.

REPORT OF THE CHRISTMAS DISTRIBUTION, 1894.

Many of our deserving countrymen and women look forward to our generous distribution of provisions for their Christmas dinner, it being to them one of the events of the season.

The Christmas Dinner Distribution took place on December 24th, 1894. As usual we made preparation for a very much larger number of families, and on a more generous scale than on previous occasions.

We were ably assisted during the morning by our Past President, Mr. R. C. Hamilton, and in the afternoon by our honored President, Mr. Jas. Hunter. Messrs. Samuel Crane and Frank Somers also assisted the Secretary in putting up well-filled baskets for all applicants who presented tickets from the Committee.

197 families, including 469 children, were assisted. Out of this number 87 were widows. The total number of persons made happy by this generous Christmas Dinner was 776.
