Cable News.

Special to THE Evening Telegram.
 WASHINGTON, Oct. 27. On the face of meagre returns and indications that the President has not been chosen, officials have justification for the States policy in refusing to recognize the elections in Mexico as legal and fair. It is thought the new Congress will proclaim the election null and void. Huerta's announcement of the results is not looked for here for several days.

LONDON, Oct. 27. The arson squad have burned to the ground a fine residence at Bramshot, twelve miles from Aldershot, belonging to T. McKenna, brother of the Home Secretary. Usual placards.

LONDON, Oct. 27. The Dutch tank steamer Charlois reports having examined the Volturino on Oct. 17. The fires were burned out, and several dead bodies found aboard. The stopcocks were opened and she was left sinking.

LONDON, Oct. 27. A railway accident occurred at Waterloo to-day. Three were killed and 24 injured. This is the sixth serious accident recently, and is causing grave disquiet, as all have been similar, a standing train run into.

MILWAUKEE, Oct. 27. The store of the Goodyear Rubber Company and adjoining buildings were destroyed by fire last night. Loss \$300,000. There are in a critical condition, and 17 injured. The block where the accident took place is known as the Milwaukee death block, as less than 25 lives having been lost there in the city's history.

CHICAGO, Oct. 27. Fire which destroyed two warehouses of the Swift Co. Union stock yards last night, caused a loss of half a million. Twenty firemen were overcome by ammonia fumes, but will recover.

HALIFAX, Oct. 27. The fire in the cotton cargo of the S.S. Seawall, in under control. Spontaneous combustion was the cause. The value of the cargo was \$850,000.

DUBLIN, Oct. 27. Larkin has been found guilty of sedition and inciting to riot, and sentenced to seven months' imprisonment.

LONDON, Oct. 27. Asquith's speech at Lady Bank on Saturday has demonstrated that no compromise on Home Rule is possible. Ulster papers denounce the speech as closing the doors to settlement by consent. Nationalist papers refuse to consider the exclusion of Ulster.

Leaves With Celestial.

We have it on good authority, that a young girl, formerly of Carbonara, but for some months past residing in the city, left by Saturday's express, accompanied by a Chinaman. Another Celestial was at the station to see them off. The girl was very well dressed and is about 18 years old. The affair has caused considerable comment in the city, and on this account our suspicions are naturally aroused, and we wonder if this is another victim of the White Slave traffic which has of late become alarmingly prevalent.

Nickel Theatre.



Another Bombshell Exploded! Tory Party Totally Wrecked!

Last Night's Liberal Meeting in T. A. Hall a Phenomenal Success—2,500 Voters Present—Enthusiasm Unsurpassed—Brilliant and Striking Speeches made—St. John's Announces its Verdict and Decides to Wipe Out Toryism and Misrule—Will Elect Liberal Candidates by Sweeping Majority.

As a finale to their political campaign, Messrs. Kent, Dwyer and Ryan, the Liberal candidates who are contesting St. John's East, held a public meeting in the T. A. Hall last night. It proved the success of success. The opinion expressed was that St. John's electors, having carefully, intelligently and conscientiously considered the question of who are properly fit to guide the destinies of Newfoundland, are in line with other districts and by their determined efforts to oust the Tory party from power, and by a sweeping majority return the grand old loyal and patriotic Liberal Party led by that distinguished, honest and Honourable Statesman, Sir Robert Bond.

Notwithstanding the fact that the meeting was not extensively advertised, long before the appointed hour of opening the hall was thronged with a representative and attentive audience. Eventually standing room became limited and many had to remain outside the doors. The magnitude of the meeting can scarcely be realized but cannot be disputed by the most sceptical person who was present. In every respect it outdone any campaign conference ever held in this country. Throughout not the slightest dissension prevailed and the different speakers were warmly received and heartily applauded. The meeting was called to order by Mr. M. W. Myrick, who acted as Chairman. On the platform were the

made a touching appeal to the electors, elucidating the squander of our public monies by the Tory party and justifying the policies of both parties before going into the booth to cast their vote on Thursday next. In dealing with the agricultural policy he reiterated what the previous speaker had said. Next he reviewed the Old Age Pension Scheme of the present day, showing how a worn out toiler has to be 75 years of age before he receives the paltry sum of \$59 annually whereas it is one of the principal policies outlined in Sir Robert Bond's Manifesto to give \$100 a Year to Men and Also to Give an Amount to Women in Their Old Age as Well.

He said throughout the whole country the people were awake to the wrongdoing of the Morris party and that Thursday next was going to be called "BOND'S CLEAN-UP DAY." Mr. Kent, K.C., then arose to speak and was given a great ovation. His masterly and effective criticism of the Government that has been in power the past four years was punctuated with spontaneous outbursts of applause. He lucidly pointed out the misrule and mismanagement of our public affairs under the guidance of Sir Edward Morris, and in a learned logical and convincing manner demonstrated how the Liberal Party, led by Sir Robert Bond, was best in the interests of the people. In 1894, under Tory administration, when our banks were broken, our whole commercial fabric came tumbling down around us, and this Colony's finances were wrecked. Sir Robert Bond was instrumental in raising a loan and succeeded in putting the

Historic Harbor Main.

WILL RETURN TWO LIBERALS.

On Saturday night last the Liberal candidates for the District of Harbor Main, Messrs. Lewis and Carter, held a mammoth meeting at Toppail. Nearly 200 people were present. The meeting was called to order at eight o'clock, and on motion carried Mr. Butler took the chair. ON CONFEDERATION.

T. A. HALL, Oct. 1913. "Something awful must happen before we go into Confederation." E. P. Morris. Newfoundlanders will you allow this "something awful" to happen. At his meeting in the T. A. Hall, Sir E. P. Morris declared that he was an anti-Confederate, and that before we go into Confederation something awful must happen. We certainly agree with Sir Edward in the latter part of this expression, and most people are fearing that if the spendthrift policy is to be continued, whilst the burdens of the Colony are becoming greater and greater, that the "something awful" will soon begin to appear above the horizon, and when it blazes forth in its stern reality, we take it that Sir E. P. Morris will seek refuge in Confederation with Canada. If this be so, had we not carefully consider the situation? Where are we to arrive? At the meeting referred to, one of Morris's colleagues in referring to the \$6,000,000 loan, said to this effect: "That the loan was a wonderful thing for \$3,000,000 went to the people, and taking this as a basis why not some of your business men sit down in your office and dispassionately discuss the situation? Just think of the revenue the spending of \$3,000,000 will turn into the Treasury. Now anyone who knows anything about business investigation, must know that when making an investigation to determine the earning power of a concern, that all profits of an exceptional or unusual nature must be eliminated to arrive at the true earning power—that is take out profits that don't accrue in the regular course of business—profits of a speculative nature. Therefore will not reasonable when analyzing our revenue of to-day to deduct therefrom that amount which we calculate has come to the Treasury through the spending of this \$3,000,000 in order to get at a normal revenue. Why? For the simple reason that this part of the revenue is borrowed money, and cannot always be counted on unless Morris continues to borrow. Borrow, borrow, which must of necessity lead to the

"Something Awful" Which Sir Edward Refers to. Now, then, when all the branch railways are completed, what will take the place of the millions of borrowed money, the circulation of which has led some people to recognize as a sign of permanent prosperity. Where shall we get our millions to scatter amongst the people? Will the railway produce them? No sane man thinks so, for our population is not increasing fast enough to have people settling along the line of railway and become producers, therefore, we ask, where will the millions come from to take the place of the borrowed money which we are using to-day? Morris can't tell us. If we are to have continued prosperity, if the census are to be kept up, the people must have the millions to spend. The Grabballs don't know, nor do they care where this money will come from when Morris must cease to borrow. As a Colony we cannot exist long on borrowed money. What permanent prosperity has the policy Sir Edward Morris brought to this country? None whatever. The prosperity of any permanent nature which the country enjoys to-day is due to a great extent to Coaker, who was instrumental in raising the price of the product of the fisheries to the benefit of those who keep the money in circulation. What could it have been that began the thought in the mind of Sir E. P. M. that "something awful" must happen before we go into Confederation? Was it that he has the Colonies headed in that direction already? In this connection we are led to wonder if the Reids also have a slight presentment of this "something awful" going to happen, and will not attempt any development that is calculated to bring permanent prosperity to the country, fearing the "something awful" will be delayed. Reid with his minerals, coal seams and timber—the pick of the Islands—does not attempt any development. To develop them would mean too much solid prosperity for Newfoundland and turn her a point or two away from the cherished goal "something awful." Oh, yes, Sir Edward, something awful must happen before we go into Confederation.

It is even happening now Under the guidance of E. P. Morris and F. H. Prosperity, Built up on Borrowed Money. Although we are reaping revenues from borrowed money those in office are tumbling over each other to scoop in all they can, instead of building up a substantial reserve to serve the country in the future—she'll need it, sure. Newfoundlanders, those who have large interests at stake in this country will you risk your chances with the present Government? Remember our revenues are being swollen by borrowed money. Doesn't it look like Confederation?

The voter is to vote only for three candidates.

After receiving his Ballot Paper the voter shall go into one of the compartments, and with a pencil there provided, place a cross in the division containing the name or names of the Candidate or Candidates for whom he intends to vote, thus X.

The voter will then fold the Ballot Paper, so as to show a portion of the back only, with the initials of the Deputy Returning Officer, and shall hand it so folded up to the Deputy Returning Officer, and the Deputy Returning Officer shall, without unfolding it, ascertain that it is the Ballot Paper which he furnished to the elector, and then immediately place it in the Ballot Box. The voter shall forthwith leave the Polling Station.

If a voter inadvertently spoils a Ballot Paper he may return it to the Deputy Returning Officer, who will give him another.

Premier Morris's "Figures of Speech" on Railway Contracts.

MORRIS WILL TREMBLE ON POLLING DAY.

The letters which Premier Morris and Minister of Justice Morison wrote to Governor Williams were written for the purpose of shielding Morison from dismissal. If they were not written with that purpose in view then, why did those two public officers deceive Governor Williams?

Let us take a look at his garrulous "figures of speech," when introducing the Railway Contract in the Assembly in 1910.

It will be necessary to quote his own words:—"We repeat that we have made a saving to the Colony of One Million Dollars by this contract in this way. In 1893 the rails cost \$200 a ton. The rails to go on these branches will cost \$28.00 a ton, and on the total of 250 miles, according to the figures given me by the Government Engineer the other day, the Contractor will sustain a loss of \$157,000 (poor Contractor! Reid can't lose!)"

That is to say he will have to pay for the rails he purchases \$157,000 more than in 1893. In the same way, in 1893, he paid \$1.00 a day wages, and now he has to pay fifty per cent. more. The Government Engineer informed me that with a line like ours, costing \$15,000 per mile, the labour may be said to fairly represent half that amount. Therefore where the Contractor spent \$7,500 per mile for labour in 1893, he has to spend about \$12 additional to-day. And if you multiply this sum by 250 miles, it makes \$941,000 additional the Contractor has to pay out to-day. In other words, owing to cost of labour and rails he will pay \$1,098,000 more out than he would have done in 1893. (Poor Contractor, again! Makes you wonder why he took the contract at all. Morris spent \$1,098,000 in London getting legal opinions to prove that Reid was not bound to take on the job!)

Now what does it cost the Reids per mile to build that Railway according to Premier Morris's figures? Perhaps the Government Engineer will kindly check the calculations. About 80 tons of steel rails per mile, at \$28.00 .. \$2,240 Labour per mile .. \$3,750 .. 11,250

For only Labour and Rails Morris makes it (per mile) \$13,390 Add say 3,500 sleepers per mile, freight, working change and carting .. \$400.00 on incidental expenses, per mile .. 2,000 .. \$15,890

Morris says every mile costs the Reids \$13,490 in labour and rails only. Add the cost of sleepers and incidentals on such a job at \$2,000 per mile (fair amount) and it produces a most interesting result. These figures would show that the Reids will be \$15,490 per mile to build those Railways.

But the Reids are only getting \$15,000 per mile for building it. Therefore the Reids would be losing \$490.00 on every mile they build! Interesting, isn't it?

Will it cost the Reids \$11,250 for labour alone? We do not think so. Old Morris correctly states what the Government Engineer told him. We don't think so, meaning that we don't think the Reids had any notion in their own heads of losing \$490.00 on each mile. Do you think so, Sir Edward? "I have tried to put the matter before you free from any party taint," says Morris. "If that is so, and having such mathematical ability, how was it that your name, Sir Edward, was not put down on that Bay de Verde Iron Ore prospectus? It might have lent more weight and 'party taint' to the prospect, but not to the credit."

When some one undertakes to show that Premier Morris's figures as to what it costs Reids per mile, are fairly tales, let him also explain what is Morris doing with the Loans he raised. Six Millions it is to date on 250 miles; and 250 miles at \$15,000 each does not make four millions.

Some differ from me," says Morris in the same speech "and think my mileage too high. I do not think so. But to be perfectly safe I will put the estimate at 350 miles." "One more argument," Mr. Chairman," says Morris. "This 250 miles at \$15,000 a mile will cost in round figures four millions, creating an annual interest charge of \$140,000 a year. The Committee is entitled to know how that cost, and the interest upon it, is going to be met without increased taxation. That is the vital question we have to answer to the people of this country." Then he talked about prosperity and big revenues in the future and said "then this interest of \$140,000 will be more than made up by what we shall receive in INCREASED TAXATION." (The black type, this time, are Morris's own. See his speech!)

Are the people beginning to see what still Morris talks when he opens his mouth? This speech was made in 1910. And we all know now that the Bay de Verde Iron Ore Prospectus, of infamous fame, saw the light in 1911, the next year, having the names of Morison, Cashin, Emerson and F. J. Morris on it. Now listen to these words in the same speech, "In my opinion," says Morris, "the prosperity we have witnessed in the past will be exceeded by the prosperity we shall witness in the future for I see [but visions, but] new projects taking form and substance every year; an entirely new spirit of enterprise and exploitation amongst our own people and amongst outside investors, who are embarking their capital here."

What new spirit of enterprise did Morris mean? Was it Morison's, or Cashin's, or Emerson's, or brother Frank's? We know that Morison embarked on a hazardous enterprise

with E. P. Morris when they set out to deceive a Governor with lies. We know that Cashin's enterprise was not for working on the Railway because of the Cullage. We know that Emerson helped to enterprise some lumber deals with W. H. Taylor, Esq., D. C. L. S. And we know that brother Frank was well aware that T. J. Freeman was in London when that infamous Prospectus saw the light. It was Freeman who said that Prospectus was a masterpiece in every way."

It is hardly likely that Sir Edward Morris will enlighten us on the enterprises he saw. But when we come to consider new projects, taking form and substance, and new spirits of exploitation, we see that infamous Bay de Verde Iron Ore Prospectus rising up to condemn them. That took form but not substance, thanks to one of the old shareholders, Sir J. Randless, who "crippled" it.

Has Sir Edward Morris asked Morison and the gang to explain why it was crippled? Has he asked them to explain why they opened their mouths? Why is it Premier Morris? The time is getting short. And your time will be up on Thursday. The people from the audience of your silence! You will tremble on Polling day.

Will you, Sir Edward Morris, Premier, and leader of those men, explain why you do not show that your Ministers are dead? Is it because you and Morison deceived a Governor and you fear that your word and his word will not be taken? Or is it because you fear that somebody may find them if they open their mouths? Why is it Premier Morris? The time is getting short. And your time will be up on Thursday. The people from the audience of your silence! You will tremble on Polling day.

A Grave Charge.

Editor Evening Telegram. Dear Sir—I noticed in yesterday's issue of your inestimable paper a letter from Harbor Main signed "Justice." In it the writer made some very severe references to Magistrate O'Toole, and, as I recently had an experience with that man I respectfully ask of you sufficient space to give it to the public.

On the sixteenth of July of the present year, Dr. Jones pronounced a case of typhoid fever in my house, and in accordance with the law relative to contagious diseases, he notified Magistrate O'Toole who called, ex-officio, in the capacity of Health Officer.

The customary procedure for that official and his predecessors had been to despatch the policeman or some other person to attach a red flag to the premises to serve as a placard and warning to the public to come near; thereafter they took no further cognizance of such a case. But Magistrate O'Toole made a big exception of mine. He detailed Constable Greene, of Conception Harbour, to attend to my case, and made a special visit to my house by night. To emphasize my case still further three other cases of the same disease followed within a month the one at my house and no such precautionary measures were adopted at all.

Now, I had not been hostile with Magistrate O'Toole, in fact, we had been friendly; and why he differed with me to such an extreme I have often thought but only recently discovered the solution, which is as follows:—

My name for Avondale was among those number received by the Magistrate from the Colonial Secretary's Office for the enumeration of the voters of Harbour Main District, but how to devise sufficient reason to transfer the job to his brother-in-law, John Moore, was a puzzling question for some days.

Eventually he received the Doctor's notification of the fever at my house; and whereas it was possible for the patient had been sick from the fourth of July, Magistrate O'Toole enforced the quarantine as he did that my confinement may continue 21 days from the date of being placarded, and that he may be in a position to say we could not wait for me to take the Voters' List, that I had been appointed at St. John's to do, and that he was necessarily forced to substitute his brother-in-law, John Moore, instead.

O'Dwyer, Relieving Officer at St. John's, draw on his funds for Public Charities to the amount of \$67.75, as follows:—\$21.00 to Constable Greene, \$21.00 more for Mr. Peter Moore, brother of the Magistrate's brother-in-law, about \$10.00 to a nurse, and all that he may deprive me of \$26.80 in favour of his brother-in-law, Mr. John Moore.

You will notice, Mr. Editor, a purse, my sister-in-law, was paid to attend upon my wife the patient in question. Yes, that part of the drama with frequent and unusual queries and other sympathetic outpourings at the time from the fair faces of members of the club is the smooth water concealing the great depths of mud in the bottom.
