

The M. W. the Grand Master instructed the V. W. Grand Pursuivant, to provide the necessary convenience for visiting Brethren to the Grand Lodge, and a large number of Master Masons entered and took their seats.

M. W. Bro. Laurie, Grand Master of the Grand Lodge of Nova Scotia, and R. W. Bro. Robert Ramsay, Hon. Grand Junior Warden of this Grand Lodge having been announced, were received with Grand Honors and having been heartily welcomed by the M. W. the Grand Master took their seats on the Dais.

The Order of Business prepared by the Grand Secretary was approved of by the M. W. the Grand Master, and distributed through Grand Lodge.

The Grand Secretary read the Rules and Regulations for the government of the Grand Lodge during the time of business, and was proceeding to read the minutes of the last Annual Communication, held in the City of Montreal, on the 25th and 26th of September, 1879-5879, when the same was dispensed with on the following motion, made by R. W. Bro. C. Judge, D. G. M., sec-

That, inasmuch as the minutes of the proceedings of this Grand Lodge, at its last Anntal Communication, have been printed and distributed amongst the Lodges under this jurisdiction, the same be held as read, and are hereby confirmed.

W. Bro. Knowles rose and stated that he had been requested by R. W. Bro. Wm. Miller, P.D.D.G.M. for Quebec and Three Rivers, to inform Grand Lodge that the requirements of his business had prevented him from attending his duties in Grand Lodge, and

Bro. Miller in consequence begged that his absence, the first for many years, would be overlooked.

The M. W. the Grand Master was pleased to accede to this request.

The M. W. the G. M. then delivered the following address :----

To the Most Worshipful the Grand Lodge of Quebec :

I once more heartily and fraternally welcome you to our Annual-Communication, where an opportunity is again afforded you of working together, to advance the interest and usefulness of our beloved institution.

You will no doubt recall to mind that we have now reached the close of the first decade of our Grand Lodge existence, and will gratefully remember, that notwithstanding the unusal and severe trials through which we have passed, we have been greatly prospered by the G. A. of the Universe.

Nothing has occured during the past year to call for very special attention at my hands, and I shall therefore but briefly refer to a few matters which may interest you, and throw out a few suggestions which may perhaps be deemed worthy of your consideration.

The following Grand Representatives have been appointed to represent our Grand Lodge :-Bro James N Castle, near the G L of Minnesota, in the place of R W Bro Porter; R W Bro W H Howes, near the G L of Arkansas; R W Bro A J Turpin, near the G L of Kentucky; R W Bro Alpheus Gay, near the G L of New Hampshire, in the place of M W Bro Barrett deceased, and R W Bro Edward Bourreault, near the G L of Portugal.

We shall have much pleasure, I am sure, in most cordially receiving the Representatives who have been appointed to represent, other Grand Lodges near our Grand Body, and who are the following: —V Wor Bro T P Butler, from the G L of New Brunswick; R W Bro J T McMinn, from the G L of -Kentucky; R W Bro Boisseau, from the G L of Portugal. W Bro Thomas Simpson, from the G L of Minnesota, and W Bro David Newton, from the G L of Arkansas.

I have not been called upon to grant any dispensations of importance except one for the installation, as W M of Montarville Lodge, of a Brother who had not filled the office of Warden. This was done on the urgent and unanimous petition of the Lodge, setting forth strong and, in my opinion, sufficient reasons to justify the dispensation. I have granted two or three dispensations permitting degrees to be conferred within the time prescribed by the Constitution, but before doing so I was careful, in each case, to ascertain that the circumstances warranted my granting the application. I am always disinclined to grant dispensations of that character, and only do so for urgent reasons, and I am glad to say that in this respect I but share the general feeling of the Rulers of the Craft.

St. George's Lodge, No. 11 Q.R., having, in accordance with the resolution passed at our last annual communication (p. 56,) surrendered the old warrant issued by the Grand Lodge of England, I appointed a committee to investigate the matter, and determine what should be done with the original warrant. This committee—consisting of M. W. Bro. J. H. Graham (chairman,) R. W. Bros. J. H. Isaacson and McMinn, V. W. Bros. S. N. Sansum and T. P. Butler, and W. Bros Holton and Fyfe—met in this city in December last, and after a very careful consideration of the whole matter, concluded by recommending, that in consideration of the information obtained by them, and in view of all the circumstances involved, the warrant should betrafies

mitted to the Grand Lodge of England through R. W. Bro. the Hon. Wm. Badgley, its highest representative in this Province, at an early date.

I subsequently brought the matter before the Board of General Purposes, at its semi-annual meeting, when the resolution of the Committee was fully confirmed. The conclusion arrived at by the Committee and by the Board was one in which I most heartily concurred, and I therefore surrendered the warrant to the Grand Lodge of England, through R. W. Bro. Badgley, and I feel no doubt this Grand Lodge will approve of my action.

Considerable discussion has taken place during the past year—more particularly in this city—relative to the authority of District Deputy Grand Masters, and amongst others, a question arose as to the right of a D, D. G. M. present in a lodge in his district—in fact, in his own Lodge—to exercise authority as such, his visit not having been announced as an official one, and he not being clothed in the regalia of his office.

I was called upon for an opinion involving that point, amongst others, and I stated that I did not see anything in the Constitution to prevent the D. D. G. M. from demanding the Master's chair at any time he might be present in a Lodge in his district, even though his visit was not announced as an official one, and though he was not clothed in the regalia of his office.

I have since read the articles on the powers and duties of D. D. G. Masters, written by R. W. Bro. Robinson, P. D. D. G. M., of Collingwood, Ontario, which appeared in *The Crafisman*, and which are now published in pamphlet form, and I find he states that "in Grand Lodge, and on all occasions where the Grand Officers appear in their official character, it's necessary that they should wear their proper regalia. Their rank and powers need not be recognized by the brethren unless this formality is observed."

He further on gives it as his opinion that a D. D. G. M., "has the power to assume and drop at will, as may suit his convenience or pleasure, the rights conferred on him by the Constitution."

I would understand by this that Bro Robinson holds that if a D. D. G. M. was present in a Lodge in his District, say, for instance, his own Lodge, but not clothed in the regalia of his office, and desired to assume his rights as such D. D. G. M., neither the W. M. nor the Lodge need recognize his authority in any way whatever, under any circumstances whatever, notwithstanding they know him to be the duly appointed D. D. G. M. for the District. I entertain the greatest respect for the opinion of Bro. Robinson, who has undoubtedly carefully studied the subject, as his able and exhaustive treatment of it shows, but on this point I still feel inclined to adhere to the opinion I gave; but as that opinion has been appealed from to this Grand Lodge, I will not say anything further respecting it at present.

It gives me much pleasure to state that Zetland Lodge No. 12 and Zetland No. 13 having entered into arrangements for amalgamation to work under the warrant held by Zetland No. 13, the amalgamation was consummated on the 11th September instant. As a result of this amalgamation the No. "12" on the Registry of our Grand Lodge becomes vacant, and I heartily recommend that the present Zetland Lodge be given that number, and that this Grand Lodge do at the present session authorise the Grand Secretary to change the number "13" on its warrant to that of "12." This seems to me but fair and right, and as the amalgamation was formed in the expectancy that the number would be so changed, I trust there will be no difficulty about it. The warrant held by No. 12 was of course surrendered, and is now among the archives of this Grand Lodge.

In April last, Freligsburg Lodge, No 33, was destroyed by fire, and a loss o songle \$200 was suffered by the lodge. I regret to say there was no insurance. This undoubtedly was a great oversight; every lodge should be most careful to see that its properfy is fully covered by insurance, and indeed it seems to me that this Grand Lodge should hesitate in future to grant aid to lodges which have suffered a loss that might have been so covered.

R. W. Brother McMinn having resigned the office of D. D. G. M. of the Montreal District, I had much pleasure in appointing R. W. Bro. Frank Edgar, the senior P. D. D. G. M. in the District, to fill the vacancy for the remainder of the year.

My experience of the Constitution of the Grand Lodge leads me to say that I think it could be, with very much profit, carefully revised. I think that more definite provisions should be made for the trial and punishment of masonic offences; that the authority of District Deputy Grand Masters should be more carefully set forth; that provision should be made as to the procedure to be followed by Lodges desiring to amalgamate; that the Board of General Purposes should be reduced in number, and the meetings held annually instead of semi-annually. I make this last suggestion because I am convinced, from experience I have had in connection with the Board, that the work done is altogether disproportionate to the expense incurred, and that the questions which usually come up at the semi-annual meetings could quite as well be decided by a small Committee, without any expense being incurred.

The Grand Lodges of Cuba, Colon, New South Wales and Indian Territory have applied for recognition. I cannot recommend that any action be taken at the present time as regards the two first named. About twenty Grand Lodges have recognized Cuba, about seven have refused recognition, and about twenty-three have postponed action. The question involved in the contest between these two bodies have been a fruitful source of controversy between leading Masonic Jurists. I advise that the matter be referred to our Committee on Jurisprudence for careful examination and report. I make the same suggestion as regards New South Wales, but I see no reason why the Grand Lodge of Indian Territory should not be recognized.

I am glad to be able to inform you that the difficulties which existed between our brethren both in the Provinces of Ontario and Manitoba have been adjusted; would that I could report a similar result as regard our own difficulties, but unhappily I cannot do so. In accordance with the resolution passed by this Grand Lodge at its last communication, requesting and authorizing me, either by personal interview, or by the appointment of a delegate to the Grand Lodge of England, to endeavor to secure a speedy and amicable solution of all pending difficulties between us, I appointed as such delegate M. W. Bro. J. H. Graham, P. G. M., of this Grand Lodge, whose perfect familiarity with our history and with the jurisprudence of masonry on the subject pointed him out as the fittest person I could appoint, and I am sure you will agree with me that no more able representative could have been chosen. M. W. Bro. Graham kindly accepted the position, and requested that if possible R. W. Brother Isaacson should be associated with him, intimating that they would be willing between them to save any extra expense which might be incurred by having two delegates sent instead of one. I consulted the Board at its semi-annual meeting and with their approval I nominated both Brothers Graham and Isaacson as our delegation under that resolution, and the Board were kind enough to vote a sum of money towards the expenses of the delegates should they proceed to carry out the object of their appointment, but circumstances have occurred which have made it impossible for the brethren named to proceed together to England, and con-

sequently nothing has as yet been done. The invasion of our territory by the Grand Lodge of Sootland has been condemned by almost every Grand Lodge on this Continent which has considered our question, and some have gone so far as to ent off all communication with her, but as yet ahe has made no sign of abandoning her position.

Only two courses seem open to us: one is to wait another year to see if she

T the S will pay attention to the remonstrances addressed to her by her Sister Grand Lodges or to the representations which may be made to her through a delegation or otherwise, and the other is to invite her to arbitrate. In the case of England, we can also either wait till our delegation report the result of their efforts, or offer to arbitrate. Upon you rests the responsibility of deciding which course should be pursued.

I would also suggest, particularly as we have no Committee on Foreign \mathscr{P} Correspondence this year, that a committee be appointed to draw up a statement for publication giving the history of our difficulties with foreign Grand Bodies, the opinions expressed and action taken by Sister Grand Lodges on the subject, and the reasons which we believe to justify our position.

And now, brethren, I invite you to engage more earnestly than ever in the extension and practice of brotherly love, relief and truth, and may the Most High prosper your united efforts.

It was moved by R. W. Bro. Judge, D.G.M., seconded by R. W. Bro. A. F. Simpson, G.S.W.:-

That the address of the M. W. the Grand Master, just delivered, be referred to the Board of General Purposes, to report thereon as early during the present session as practicable.

The motion was carried.

The Grand Secretary presented the following Report, which was referred to the Board of General Purposes :---

To the M. W. the Grand Master, Grand Officers and Members of The Grand Lodge of Quebec, A. F. & A. M.

The Grand Secretary begs respectfully to report, that during the past year nothing with the affairs of his office has transpired worthy of the especial notice of Grand Lodge, in consequence, this report will of necessity be brief, and merely confined to subjects of routine which are required to be reported on.

The returns and dues from Lodges have been sent to this office with greater promptness than heretofore—the amount of money received during the last past twelve months up to the 22nd day of the month of September instant is the sum of \$2048.50, which has been paid over to the Grand Treasurer on his receipt.

This amount, notwithstanding "hard times," is an increase of \$259.00 on the receipts of the preceeding year.

Since closing the books of account for the year, several Lodges have made returns and paid dues which will now have to be carried into next year's statement of accounts.

All Lodges received timely notice to make their returns and to pay their dues on or before 31st August last, so that the books could be closed in accordance with the provision of the Constitution, vide page 33 of book of Constitution, section 16—some, however failed to respond within that time, and it was deemed better for the present year, with the consent of the M. W. the Grand Master to delay balancing the books until the 22nd instant—this, however, to be no precedent for the future.

I would strongly advise the amalgamation of two or more of the City Lodges, as the scarcity of material suitable for the erection of masonic edifices and doubtless the financial depression which has been so very generally felt has materially affected them. Altho' it may probably be unpalatable to some to hear me say so, yet, I am firmly convinced that there are too many Masonic Lodges in the City of Quebec. I would also wish the Most Worshipful Grand Lodge to advise all Lodges

I would also wish the Most Worshipful Grand Lodge to advise all Lodges within its jurisdiction in framing their By-Laws to do so in such way as not to conflict with the Constitution of Grand Lodge. I am induced to make this remark as I notice the By-Laws of one Lodge in my district require three black balls to reject, this should not be the case, as in small Lodges when there are not more than seven members present, and not always that number at work, in my opinion, three black balls are too many as necessary to reject. I would therefore, strongly invite an expression of opinion in this matter from the members of Grand Lodge.

I have much pleasure in being able to report that peace and harmony prevail among the Lodges in this District; and that the work of the Craft is carried on in accordance with the custom and landmarks of the Order and the Constitution and Laws of the Grand Lodge.

I have granted no Dispensations, nor rendered any decision on disputed questions or complaints, as in my opinion, these matters do not come within the powers and privileges of a District Deputy Grand Master in this Grand Lodge. I have sent all communications having reference to these subjects, that were received by me, to the Most Worshipful the Grand Master.

I regret to have to report the continued existence in this District, of three Lodges working under Warants from the Grand Lodge of England, and three Lodges working under Warants from the Grand Lodge of Scotland, the latter organized as a Provincial Grand Lodge. Intercourse with the G. L. of Scotland has been prohibited by edict of this G. Lodge, and there is not any intercourse of a fraternal character between the Lodges under England and our Brethren. I hope that at this communication of the Grand Lodge, such steps will be taken as will secure the withdrawal of the claims of the Grand Lodges of Scotland and England to any urisdiction over Freemsconry in this District.

Scotland and England to any jurisdiction over Freemasonry in this District. I beg to call the attention of Grand Lodge to the position of Montarville Lodge, in its relation to the Lodges having (concurrent jurisdiction in the City of Montreal. Montarville Lodge is located at Longueuil, in the County of Chambly, on the south side of the St. Lawrence. Its members consist principally of Brethren whose business or occupation is in the City of Montreal, and most of them reside only during the summer season in Longueuil and its material for work must, of necessity, be drawn from the same source. It has been the custom with the Lodge to initiate citizens of Montreal having temporary residence in Longueil, and in such cases to suppose it has concurrent jurisdiction with the City Lodges. This view is disputed; and the Grand Lodge is respectfully requested to define the jurisdiction of Lodges in the City of Montreal and of Montarville Lodge and similar suburban Lodges, which, must of necessity, be established at an early date to meet the wants of Brethren in the Metropolitan City, where residence, temporary or permanent, are so far removed from the places of meeting of the City Lodges proper. In this connection it might perhaps be advisable to amend, and more clearly define the limits of the several Masonic Districts, which seem at present open to dispute.

Presby, and his two Wardens, are entitled to great credit for the able manner in which they conducted the work and lectures. And yet I trust the time is near when the Ancient York Rite will be the work of the whole Province of Quebec.

In regard to the jurisdiction between Mount Orford Lodge, and Graham Lodge, Bolton Centre, I trust the Grand Lodge will abide by the Constitution, as it would be most unjust to Mount Orford Lodge to make the Lake the boundary.

R. W. Bro. S. S. Cushman, District Deputy Grand Master for Ottawa District, presented the following report :---

To the M. W. Grand Master and Grand Lodge of A.F. & A.M., of Quebec.

In conformity to the requirements of the Constitution, I beg to submit my report on the condition of Masonry in the Ottawa District.

I have much pleasure in reporting that peace and harmony prevail in a portion of this District, viz., in the Pontiac and Eddy Lodges, each of which is enjoying a fair share of prosperity, and working with credit to the Craft in general. Whereas, on the other hand, a most unsatisfactory state of affairs applies to the Onslow and Aylmer Lodges. The former not having had a Regular Meeting since last September, owing to non-attendance of its members, a majority of whom are engaged in the lumber regions throughout both winter and summer, consequently are too far distant to attend, and seem to forget that they are in arrears for dues, thus leaving no funds in the hands of the Secretary to pay Grand Lodge dues or other outstanding amounts. This sad state of affairs has not been brought about by lack of interest manifested by the W. Master, Bro. McKay, who has done his best to collect a sufficient number of members to hold meetings, but without avail. He should, therefore, in my opinion, be exonerated from any blame in the matter, under circumstances over which he had no control. I beg to request that Grand Lodge may be pleased to take this view of the case. I would further suggest that the Dispensation to Onslow Lodge, now in his charge, be returned to this M. W. Grand Lodge and that said Onslow Lodge be erased until such times as more encouraging prospects may warrant a resuscitation of the same in this section.

The same unsatisfactory report will apply to Aylmer Lodge this year, as was given to the Grand Lodge last year by R. W. Bro. Millen, as D.D.G.M. of this District. There does not seem to be any more interest displayed by either Officers or members, who appear to be insufficiently skilled to enable them to carry on the work with much, if any credit, to themselves or the Craft. I regret that such is the case, as it is not for lack of intelligence. I have endeavoured to render the necessary assistance in this case, as instructed by Grand Ledge last year, and visited as frequently as lay in my power. I have performed the greater number of Initiations, Passings and Raisings myself, being accompanied by R. W. Bro. Millen, P.D.D.G.M., to whom my many thanks are due for his kind assistances and conveyances, on nearly every occasion.

I would therefore recommend that Aylmer Lodge Charter be recalled by this M. W. G. L., and a Dispensation be granted in due time, providing a sufficient number of members, as required by the Constitution, should, during the ensuing year deem it advisable to apply for the same. I believe the time has fully arrived when some such course should be adopted in this case, as being for the best interest of the Craft in this portion of the District.

I have to report having granted the following Dispensations: to the W.M. and Brethren of Eddy Lodge, No. 41, Hull, viz., permitting them to wear Masonic Regalia on two occasions; 1 st, to attend a concert, held at Birchton, under the auspices of Chaudiere Lodge, No. 264, G.R.C., on December 27th, 5878. 2nd, to attend a Moonlight Excursion, held under the auspices of the Masonic Burial Plot Committee of Ottawa and Hull, on the 24th June, 5879.

The following have been suspended for non-payment of dues in Pontiac Lodge, viz.: Bros. S. Wilson and Wyman Moore. And several Brethren in the Eddy Lodge, all of whom have been duly reported to the Grand Secretary.

I cannot close this report without returning thanks to R. W. Bro. Simpson, for his kindness in connection with the Aylmer Lodge, on one or more occasions. I beg further to state that it is not my desire to again accept this office, as time will not permit me to give the necessary attention to the duties in connection therewith.

That the several reports of the District Deputy Grand Masters be referred to the Board of General Purposes, to report thereon during the present session of Grand Lodge.

The motion was carried, and the reports were so referred.

1st. The Board of General Purposes beg to report that, having carefully examined into the merits of the undernoted applications for aid, they recommend—

2nd. The Board of General Purposes beg to report :--

That as to the minutes of the meeting of the Committee, named by the M. W. the Grand Master, to investigate matters in connection with the warrant of St. George's Lodge, held on the 10th and 11th of January last, 1879, and annexed hereto, marked A., the Board recommend the approval of the course adopted by that Committee and the suggestions made by them.

As to the letter submitted, addressed by the Secretary of Victoria Lodge, No. 26, G. R., to the R. W. the D. D. G. M. for Montreal Dictrict, submitting certain questions relating to the prerogatives, powers, and duties of D. D. G. Masters, and W. Masters of private Lodges, the Board beg to report that as the letter in question does not state any specific case upon which a judgment could be based, or which could form a precedent for future guidance, but only abstract and general questions, which might be seriously affected by the circumstances connected with any specific case, it does not consider that it is within its jurisdiction to give an opinion on the questions put, but suggest that they should be submitted in proper form to the M. W. the Grand Master, or to the Grand Lodge by the Lodge in question.

3rd. The Board of General Purposes beg to report :--

That they have examined the books of the Grand Treasurer, and find that he has received \$1457.65 and that his disbursements amount to \$1162.38, leaving a balance on hand of \$295.27.

The Board find that the late Grand Treasurer still owes \$573.34, which he proposes to refund to Grand Lodge by monthly instalments of twenty dollars, payable to the present Grand Treasurer, said payments to begin after the first of May next, and the Board recommend the acceptance of those conditions.

The Board have been furnished with vortchers proving the correctness of the entries.

At the same time, the Board beg to notice the lavish manner in which the funds of Grand Lodge have been expended for printing, &c., &c., and trust that some means may be adopted to prevent a recurrence of such expenditure, and would recommend that the printing in future should be let out to tender, and that no sum be paid by the Grand Secretary or Grand Treasurer without a specific order for the same.

The Board recommend that the sum of twenty dollars be offered to R. W. Bro. Murray, for his stock of Book of Constitutition, numbering 200 copies, provided that they are all of the latest issue printed.

The Board are pleased to notice the system inaugurated by the present Grand Treasurer in securing Grand Lodge from possible loss, by a policy in the Citizens Insurance and Investment Association, and highly recommend the payment of the premium by Grand Lodge.

the payment of the premium by Grand Lodge. The Board find a balance on hand belonging to Benevolent Fund of \$142.09, and that this fund has now invested forty shares of City of Montreal Corporation six per cent. bonds, equal to \$4,000.00.

4th. The Board of General Purposes beg to report with reference to the . complaint of Zetland Lodge, No. 13,-

That the questions submitted for the decision of the Board in the said complaint, were finally settled by the joint conference of the Committees of the Grand Lodge of Canada and the Grand Lodge of Quebec, held in this City, on the 17th day of February, 1874, and subsequently confirmed by those Grand Lodges, as will appear upon reference being had to the proceedings of this Grand Lodge for the year 1875, pages 71, 72, 73, 74 and 75.

and the said reports were severally received and adopted.

The Grand Chaplain then delivered the following address :----

M. W. Sir and Brethren :

I take it that I shall best fulfil the object of this address, which is imposed upon me by the kindness of the Grand Lodge in electing me to this honorable position, by calling attention to and commending the great practical object for which our order exists in the world.

It is a matter of the last importance to us that this object should be clearly understood. Beyond all gainsaying, Freemasonry is now a great power in society, and that power is rapidly increasing. It is to be found more or less widely diffused in almost every portion of the eivilized world ; and it numbers among its members a considerable proportion of the leading and influential men in every community, where its branches have been established. So widespread an organization cannot exist without having on its hands a large measure of power, which it may exercise either for good or for evil. Whether it is to be exercised for good or for evil, will depend to a large extent upon the character of the men who are at its head. According as they are true and upright men or the reverse, so will they give direction to the activity of the Order. Hence it is not at all surprising that in some countries Freemasonry should occupy a much higher place in public esteem than it does in Hence too the necessity for the utmost care and watchfulness as to the character of those who are placed in responsible offices. They should ever be men who can be depended on to stand on the right side and set a right example. Yet even in the hands of the best men, the Institution is apt to be abused, or its power for good frittered away unless there is an intelligent comprehension of the true object for which it exists.

What then, it may be asked, is that object ? How shall we define it ?

The answer to this is variously given by different authorities; and even when we interrogate the ritual of Freemasonry itself, we get very different replies. Few of these, however, are very satisfactory, as they usually em-brace far too much, and make the most preposterous claims as to the beneficent objects which it has accomplished or may accomplish Take for example the statement that is so frequently made that the three great principles of the order are *brotherly love*, relief and *truth*, or in other words that it aims at promoting these. Now, every mason knows that, so far as *truth* is concerned, practically nothing is done by Freemasonry in any direct way for its promotion. It is, indeed, in no way hostile to any truth, either religious, moral or scientific, but is simply content to leave all these matters alone. If there ever was a time when the craft was in exclusive possession of any truth, either ethical or scientific, that time has long since gone by; and probably the best service which it could now render to the cause of truth would be to still further purge its ritual from fables and historic misrepresentations, confining itself to the pure symbolism which is its only legitimate material, and which it knows so well how to use. It certainly has no right to claim that it seeks either the discovery or promulgation of truth. And therefore unless we interpret the word in the qualified sense of truthfulness or honourable dealing as between man and man we ought to drop it from our list of principles. If however, we should accept of it in that sense, then both it and relief may properly be regarded as the practical outcome of brotherly love; for where there is true brotherly love, there must be at the same time as the necessary effects of it, both a readiness to render assistance to brethren in need, and a desire to deal truthfully and honorably by all.

We may take the promotion of brotherly love then, as being the one great end of the masonic organization, all other objects are only subordinate to that; and anything that may be in any way inconsistent with it is altogether foreign to the genius of Freemasonry.

And certainly there could be no grander object proposed for any earthly institution than that of drawing the members of the human race into closer fellowship with each other; of seeking to make every man feel that every other man is his brother; of kindling in men's hearts everywhere that spark which bursting into a flame shall burn away the barriers of prejudice and suspicion, of envy and jealousy, and fuse mankind into an harmonious family; of awakening and quickening that feeling of interdependence which leads the strong ever to help the weak, and the great to stoop to the lowly; of encouraging that feeling of regard for the interests of others which banishes all double-dealing and dishonesty, inclining men ever to give others their just due. With such an aim, we have no need to be ashamed of our existence or ashamed to ask for the sympathy and the countenance of all good men.

Of course, it is not for a single moment claimed that this is the only organization or institution working towards this great and glorious end. Happily for society there are now many influences tending in the same direction, and aiming at the same consummation. And none can rejoice more than we do at any success resulting from them. We would bid God speed to all outside as well as inside our own body, who are striving in any honorable way to unite men in the bonds of universal brotherhood.

Not only, however, is this our real aim, but we believe that Freemasonry is reasonably well adapted to carry out this aim. It admits to its membership men from every rank in society, of every religious creed, of all political views, and of every nationality. It gives them the opportunity of making each other's acquaintance, and of enjoying some degree of social intercourse with each other. It urges upon them in its instructions the duty and the necessity of regarding every member of the society both at home and abroad, both in the Lodge and outside of its portals, as his brother whom he is bound to recognize and to whom he is bound to render assistance if he stands in need of it. It puts each in possession of certain tokens which he holds in common with all other members of the Craft, whereby he may make himself known to them, and discover them when they desire to make themselves known to him. And however strange it may seem, it is found practically that the community of feeling and awaken sympathy when it might otherwise be wanting. Finally, it invites the co-operation of all its members in carrying out schemes of benevolence—schemes, which in some countries, have attained to respectable proportions, though unfortunately among ourselves it is in this respect still the day of small things. It might reasonably be expected that these influences would have some

It might reasonably be expected that these influences would have some good effect in the way of enlarging men's sympathies, and breaking down their selfishness. He must be a hard man, indeed, who would be proof against them all. But, nevertheless, Freemasonry has shown its wisdom in not trusting too much even to these; and the better to guarantee their success it requires that all those who enter its membership should already believe in God, and be men of good moral characters. Recent events in the history of the Craft have shown that, by the great majority, it is not considered either sound Masonry or good policy to abolish either one or the other of these prerequisites to membership

It must be admitted, however, that even with these precautions there are many who find entrance who show little sign of profiting by the wholessome instructions of the art, who never catch the genius or spirit of the Craft. They look upon the order, not as a means whereby they may be drawn towards others, but only as a means whereby others may be drawn towards them. Not as a means of doing good, but only as a means of getting benefits for themselves. It is sally true that in many cases those who seemed at first likely to reflect credit on the Order, have shown that they were unworthy of its fellowship, and have disgraced its name, while it is also true that in some cases it has been basely prostituted to the most selfsh ends, and the confidence it inspires made but the instrument of gain.

It is not altogether surprising that it should be so; for in truth the growth of the order has been too rapid to be altogether wholesome. When we remember that one hundred and sixty-two years ago there were only four comparatively small lodges in the world, and that now it counts well nigh a million members, we need not wonder that many of those added to its membership should have been unworthy. When we remember further that an unduly large proportion of those offering themselves for admission are prompted by no higher motive than simple curiosity, (which unfortunately for itself and from a mistaken idea of its true interests has been stimulated both by the whole order and by individual members) it is easy to understand why so many should prove useless or worse, when we consider that lodges have been unduly multiplied, and that each lodge considers it a matter of honour to introduce as many new members as possible without being always very scrupulous as to their character or their motives, and that when they have received them, the officers are more anxious to display before them the beauties of ritual than to inspire them with the spirit of brotherhood, the

But great as they undoubtedly are, the case is by no means a hopeless one; and our duty in the matter is plain. It is to seek to prevent these abuses as far as may be in the future by the exclusion of unworthy men, and to cure th

them as far as may be by a more rigid attention to the legitimate purpose of the institution. Let us all seek to cultivate the spirit of brotherly love in our hearts, by the due remembrance of the instruction we have received, and by the daily practice of them in our lives, not only towards Masons, but towards all men whatsoever. Let us ever make the case of a suffering brother our own, and relieve him to the utmost of our ability. Let us seek to kindle the like spirit in all our Logges, and create a sentiment there in its favor that will give the right tone to all their proceedings. Let us be more anxious to prove by our deeds than by our words, that we are faithful to our principles, and thus we may be able to rear a temple of charity and manly virtue in the land that will command the respect of every right-minded man, and the admiration of every beholder. So mote it be.

The Board of General Purposes made the following report :---

The Board of General Purposes beg to report :--

That they have examined the books and vouchers of the Grand Treasurer, and find that there is a balance at the credit of the General Fund amounting to \$753.07, and at the credit of the Benevolent Fund of \$154.70. The accounts and books are neatly and well kept, vouchers appearing for all expenditures which are duly authorized by the President of the Board, as recommended at the last meeting of the Board.

The balances, as shown by the Grand Treasurer, are cash in his possession, and the Board recommend that he be authorized to deposit said balances in the Quebe Bank.

The balance due this Grand Lodge by the late Grand Treasurer, amounts to \$573.34, which sum that Brother at the meeting of the Board in March last, promised to liquidate by monthly payments of \$20.00, which promise the Board have every reason to expect will be faithfully carried out.

The only outstanding account of any importance is that of the Burland-Desbarats Company of \$553.75, which the Board regret has been allowed to remain so long unsettled, they recommend that the Grand Secretary and Grand Treasurer be authorized to settle the same without further delay, at the same time as the price appears excessive, they hope that a liberal reduction may be obtained.

"A complaint as to the neglect of his duties or deviation from the standard work, may be laid before the M. W. the G. M. by the Master or one of the Wardens of any Lodge, or by any Past Master.

ON STATE OF MASONRY.

In connection with this subject, the Board of General Purposes have deemed it advisable to take a cursory view of the progress of Masonry within the jurisdiction of this Grand Lodge, during the first decade of its existence now about completed.

As will be seen by the tabular statement accompanying this report, the number of Lodges under our jurisdiction has increased from 21, the number represented at the organization of Grand Lodge, to 59, the number now upon our roll.

The number of initiations during this period has been 2390, and of joining members 539; to these must be added 654 members of Lodges, which at first adhered to the Grand Lodge of Canada, thus showing a total increase of 3583 on the other hand we have lost by the hand of death 196 brethren, 1221 have withdrawn; and 666 have been suspended, a total loss, after deducting 86 restorations, of 1997. The total increase has therefore been 1586.

The Board regret to note that of the initiated 309, or about 13 per cent. have failed to prosecute their search into the hidden mysteries of our Order with sufficient zeal to entitle them to pass within the portals of the inner chamber; while even of those who obtained the second degree about 10 per cent. failed to obtain the secrets of a Master Mason. This should, we consider, cause our brethren to see to it, that more discrimination be observed in the acceptance of material, so that none but those really desirous of knowledge and likely to prove master-workmen, be associated with them in the great work of Masonry.

A still g eater cause of regret is to be found in the fact that so few of those who have been suspended have sought to be re-instated in their Masonio standing; this is by no means creditable to the Craft, inasmuch as most of these susp-usions have been the penalty of the failure of brethren to pay their accustomed dues, and especially when we consider that these dues are lighter than in most other jurisdictions, although from the weakness of our numbers it might reasonably be expected that a more liberal support from each individual would be necessary.

Within these ten years, all differences with the G. L. of Canada (to whom our organization at the time appeared an act of rebellion) have been happily set at rest; and nearly the whole Masonic world has sustained as in our independent position. There has arisen, it is true, a serious difficulty with the G. L. of Scotland, and we have not yet fully established our relations to the

G. L. of England. Time, however, must remove all differences with both these grand bodies, and we trust that a continuance in the dignified but unobtrusive conduct which has characterized this G. L. from its inception, will, at no distant day, bring about perfect peace within our borders.

The Reports of the different D. D. G. M's, which have been submitted for our consideration, exhibit on the whole a healthy condition of the Craft.

The D. D. G. M., Montreal District, refers to the continued existence of 3 lodges working under the G. L. of England, and 3 under Warrants from the G. L. of Scotland.

We recommend that the efforts already commenced to effect an arrangement with the G. L. of England, be continued, in order that, if possible, an amicable understanding, honorable alike to her dignity and our own, may be arrived at with this Grand Lodge, the originator of Masonry in this Province.

With reference to the Grand Lodge of Scotland, we would recommend that all steps consistent with our own dignity be taken, to induce her to withdraw from the unfortunate position in which she has placed herself, by the unmasonic act of granting Warrants within the jurisdiction of another Grand Lodge. It is true that moral force alone can be employed to oblige the observance of the laws of comity by one G. L. towards another; but if none but Masonic means be employed, in the end Masonic just must prevail.

A rather perplexing question is brought forward by R. W. Bro. Edgar in his report : Montarville Lodge is located at Longueuil, on the south side of the St. Lawrence, opposite Montreal, a favorite place of residence for many who have their business and interest in the City. It appears that this Lodge has, by the common acquiescence of nearly all the Montreal Lodges, been considered as having concurrent jurisdiction with the Lodges located within the city limits, and material has been accepted in this spirit, no question having been raised until recently, when the complaint was made, but withdrawn without a decision having been rendered. It appears that the Lodge was ohartered with the view that it was at liberty to accept of material residing in the City, and some at least of the D.D.G.M. shave sanctioned this view. We recommend that G. J., decide how far Lodges in the suburbs of the City of Montreal have concurrent jurisdiction with those meeting actually within the municipal limits.

The Report of the D. D. G. M. for Quebec and Three Rivers District states that there are more Lodges in the City of Quebec than the number of brethren would warrant, and strongly urges the amalgamation of two or more. We would recommend that care be taken in the granting of new Warrants, that it be fully established that more material exists than can be conveniently used in the Lodges already established. Every additional Lodge requires additional funds for its support; and one strong, well-conducted Lodge is of more benefit to the Craft than two, even though the two be not really weak. Unity is strength; and in the applying for and granting of new Warrants as in other matters, work should not be taken from a good Craftsman, if he be both able and willing to perform it.

The Board regret to observe, from the same Report, that one of the Lodges in the district requires by its By-laws three black balls to exclude a candidate. As it appears that this By-laws existed before the formation of this Grand Lodge, and that in submitting to our jurisdiction the Lodge was specially permitted to retain its By-laws as then in force, we cannot complain ; but it may well be questioned whether an alteration of this By-law would not be advisable in their own interest.

We are sorry to observe from the Report of D.D.G.M. for Ottawa District, that the unsatisfactory condition of the Onslow and Aylmer Lodges complained of last year still continues, and we recommend that his suggestion as to the withdrawal of the Warrants of these Lodges be carried out.

The D. D. G. M. for St. Francis District reports that the establishment by Grand Lodge, last year, of Lake Memphremagog as the boundary line between Mount Orford and Graham Lodges, is unsatisfactory and unjust, and we recommend that according to his suggestion this decision be reconsidered, and the terms of the Constitution adhered to, obliging Candidates to seek admission at the Lodges nearest to which they may reside.

With reference to the Report of the D. D. G. M. for Bedford District, we recommend that in future no Dispensation be granted for the public installation of officers.

The Grand Secretary's Report contains the gratifying information that Lodges generally have been more than usually prompt in the remittance of their Grand Lodge dues. We trust they will continue to improve in this respect.

À petition has been received from certain brethren of Cookshire, in the County of Compton, praying that a warrant be granted to them to establish a new Lodge in that village. The petition is recommended by Ascot Lodge, being the nearest to the place where these brethren propose to hold their meeting. We recommend that this petition be acceded to, and that a Warrant be issued in accordance therewith, upon their complying with the usual formalities.

The whole, nevertheless, respectfully submitted.

The Board further beg to report that they agree with the Grand Master as to the a visability of postponing action by the Grand Lodge anent Masonic matters in Cuba and New South Wales, and would recommend the recognition by Grand Lodge of the Grand Lodge of Indian Territory, and also of New Mexico.

The Board are rejoiced to know that the difficulties which have existed in Ontario and in Manitoba, have been happily adjusted.

The Board beg further to express the hope that the present unhappy misunderstanding between this Grand Lodge and the Grand Lodge of Socoland will be speedidly removed, and that all our relations to the mother Grand Lodges of England and Socoland will shortly be so adjusted that unity and harmony will be secured among the Craft in Quebec, and that our jurisdictional and all other Masonic relations to these Grand Lodges, will soon be settled on an enduring fraternal basis by one or all of the ways pointed out by the Grand Master, and we therefore recommend that the whole matter pertaining to our relations to these and other Grand bodies be left in the hands of the M. W. the Grand Master.

The Board would also express the hope that the committee suggested by the Grand Master to prepare a statement concerning the matter of difficulties with foreign Grand Lodges, embodying the principles adhered to by us, the reasons in justification of our position, &c., &c., will be appointed and the duty devolved upon it performed as soon as practicable.

The Board beg further heartily to join in the prayer of the Grand Master, for the faithful practice, and wide-spread extension of the great principles of our beneficent Order, and for the blessing of the Most High to prosper us in our united efforts.
