## BILL.

An Act to authorise the Quebec Turnpike Trustees to effect a new Loan and to extend the provisions of the Quebec Turnpike Road ordinance to certain other roads.

WHEREAS it is expedient to extend the provisions Preamble. of the ordinance hereinafter mentioned to certain other roads than those to which it at present extends; Be it therefore enacted. &c...

5 That from and after the passing of this Act the provisions Provisions of of the Ordinance of the Governor and Special Council 4 Vict. c. 17, extended to of the late Province of Lower Canada, passed in the certain roads. fourth year of the reign of Her Majesty, and intituled, "An Ordinance to provide for the improvement of certain 10 "roads in the neighbourhood of, and leading to, the City " of Quebec, and to raise a fund for that purpose," and the powers of the Trustees appointed under the authority thereof, shall apply, to all intents and purposes, to the roads or parts of roads hereinafter mentioned, as if the 15 said roads and parts of roads had been mentioned and described in the ninth section of the said ordinance, as forming part of those to which the said provisions and powers were intended to apply, that is to say: the road from The roads Charlesbourg, commencing from the place which forms 20 the termination of the mile and a half which is to be

macadamised under the Act passed in the twelfth year of the Reign of Her Majesty, intituled, "An Act to autho- 12 Viet. c. "rise and enable the Trustees of the Quebec Turnpike 115. "Roads to acquire and assume the possession and property 25 " of the Bridge called Dorchester Bridge, and for other

"purposes," and mentioned in the fifth section of the said last mentioned Act, as far as the land of Francois Lafrance, and thence in two different directions, that is to say, two miles in northeasterly direction towards Lake 30 Beauport, and four miles and a half in a northwesterly direction towards the Township of Stoneham.

II. And be it enacted, That in order to give effect to Trustees may the provisions herein above mentioned, and to those of borrow the Act last above mentioned, it shall be lawful for the without any

35 Quebec Turnpike Road Trustees to raise, by way of guarantee on the part of the loan, a sum not exceeding fifteen thousand pounds cur-Province. rency, and such loan and the debentures which shall be issued in conformity with the provisions of this Act, and all other matters relating to the said loan, shall be subject

Proviso: rate of interest limited, &c.

By what priority of lieu, &c., be secured.

to the provisions of the ordinance hereinbefore mentioned relative to the loan authorised under the said ordinance; Provided nevertheless, that the rate of interest to be allowed under the authority of this Act shall in no case exceed the rate of six per centum per annum; and that no money shall be advanced out of the Provincial funds for the purpose of paying the said interest; and all debentures issued under the authority of this Act, so such loan shall far as regards the interest payable thereon, shall take precedence and have priority of lien on the tolls and other 10 moneys which may come into the possession, and be at the disposal of the said Trustees, over the interest payable on all debentures which shall have been issued upon the guarantee of the Province, or which shall hereafter be issued by the said Trustees upon the guarantee 20 of the Province, as well as to all claims for re-payment of any sums of money advanced, or to be advanced to the said Trustees by the Receiver-General of this Province: and the said debentures issued under this Act shall have the same privileges, and shall be of the same effect 25 as if they had been issued under the last above mentioned Act passed in the twelfth year of Her Majesty's Reign.
