HER Majesty &c., enacts as follows:

Preamble.

I. The first, second and third sections of the 89th Chapter of the consolidated Statutes of Canada, intituled, "An Act respecting the Treaty between Her Majesty and the United States of America, for the ap-5 prehension and surrender of certain offenders," are hereby repealed.

Sections 1, 2, 3, repealed:

Governor may order the delivery of the offender on requisition from U.S.

"It shall be lawful for the Governor, upon a requisition made as aforesaid, by the United States, by Warrant under his hand and seal to order the person so committed, to be delivered to the person or persons authorized to receive such person, in the name and on behalf of the said United States, to be tried for the crime of which such person 15 stands accused, and such person shall be delivered up accordingly; and the person or persons, authorized as aforesaid, may hold such person in custody, and take him to the territories of the said United States, pursuant to the said Treaty; and if the person so accused escapes out of any custody to which he stands committed, or to which he has been 20 delivered as aforesaid, such person may be retaken in the same manner as any person accused of any crime against the laws of this Province may be retaken upon an escape."
