The Department of External Affairs announced today that it has been informed that the Austrian Government is now accepting applications for compensation to individuals who were persecuted on political, racial, or religious grounds in Austria between March 31, 1938 and May 8, 1945. Claims made by the immediate families of individuals who were persecuted will also be considered.

Applications must be filled not later than
August 31, 1962 with the "Fonds zur Abgeltung von
Vermoegensverlusten Politisch Verfolgter, Taborstrasse
2-6, Vienna II". Official application forms are

THE DEPARTMENT OF EXTERNAL ANNOUNCED TODAY
THAT IT HAS RECEIVED INFORMATION CONCERNING RECENT
AND PENDING AUSTRIAN LEGISLATION DESIGNED TO ASSIST
INDIVIDUALS WHO WERE PERSECUTED ON POLITICAL, RACIAL
OR RELIGIOUS GROUNDS IN AUSTRIA BETWEEN MARCH 13, 1938,
AND MAY 8, 1945.

PARTICULARS OF THIS LEGISLATION ARE AS FOLLOWS:

(I) THE AUSTRIAN GOVERNMENT WILL ESTABLISH A FUND FOR THE SETTLEMENT OF CERTAIN PROPERTY LOSSES OF PERSONS EXPOSED TO PERSECUTION ON POLITICAL, RACIAL OR RELIGIOUS GROUNDS (FONDS ZUR ABGELTUNG GEWISSER VERMOEGENSVERLUSTE POLITISCH VERFOLGTER). THE FUND WILL HAVE A CAPITAL IN THE EQUIVALENT AMOUNT OF SIX MILLION DOLLARS FOR THE SETTLEMENT OF THE CLAIMS OF PHYSICAL PERSONS WHO WERE SUBJECT TO POLITICAL, RACIAL OR RELIGIOUS PERSECUTION IN AUSTRIA FROM MARCH 13, 1938, TO MAY 8, 1945, AND WHOSE BANK ACCOUNTS, SECURITIES, MORIGAGES OR MONEY WERE THE SUBJECT OF FORCLD TRANSFERS OR WERE CONFISCATED BY THE NATIONAL SOCIALIST AUTHORITIES. THE FUND WILL ALSO SETTLE CLAIMS OF PERSONS EXPOSED TO PERSECUTION ON POLITICAL, RACIAL OR RELIGIOUS GROUNDS AS DIFINED ABOVE FOR THEIR PAYMENTS OF THE DISCRIMINATORY TAXES KNOWN AS "REICHSFLUCHTSTEUER" AND " SUEHNELEISTUNG

DER JUDEN (JUVA)". THE AUSTRIAN GOVERNMENT WILL APPROPRIATE AN ADDITIONAL AMOUNT OF THE EQUIVALENT OF APPROXIMATELY DOLLARS 600,000 TO PAY THE ADMINISTRATIVE EXPENSES OF THE FUND. THE FUND WILL BE EXEMPT FROM AUSTRIAN TAXES AND PAYMENTS FROM THE FUND WILL NOT CONSTITUTE INCOME ON WHICH THE RECIPIENTS ARE LIABLE FOR AUSTRIAN TAXES. ALL PERSONS EXPOSED TO PERSECUTION ON POLITICAL, RACIAL OR RELIGIOUS GROUNDS WHO SUSTAINED LOSSES IN THE ABOVE ENUMERATED CATEGORIES ARE ENTITLED TO FILE CLAIMS REGARDLESS OF THEIR PRESENT RESIDENCE. CLAIMS FORMS WILL BE AVAILABLE AT THE AUSTRIAN EMBASSY, SUITE 707, 140 WELLINGTON STREET, OTTAWA, AND AT THE AUSTRIAN CONSULATES AT 31 HOLLINSWORTH BUILDING, CALGARY, 1121 SHERBROOKL STREET WEST, MONTREAL AND 525 SEYMOUR STREET, VANCOUVER, AND ENQUIRIES FOR FURTHER INFORMATION SHOULD BE DIRECTED TO AUSTRIAN REPRESENTATIVES.

AN AMENDMENT (AUSTRIAN GOVERNMENT HAS ENACTED AN AMENDMENT (AUSTRIAN FEDERAL LAW 99 OF MARCH 18, 1939) TO THE WAR AND PERSECUTION PROPERTY DAMAGE LAW (AUSTRIAN FEDERAL LAW 127 OF 1958) INCREASING THE AMOUNTS TO BE AWARDED TO CERTAIN CLAIMANTS RESIDING ABROAD FOR CONFISCATED FURNITURE AND CERTAIN OTHER PERSONAL PROPERTY. THE DEADLINE FOR THE FILING OF CLAIMS IS DECEMBER 31, 1959. COPIES OF THE OFFICIAL FORMS, WHICH MUST ACCOMPANY CLAIMS, ARE NOW AVAILABLE AT THE AUSTRIAN EMBASSY IN OTTAWA AND AT THE AUSTRIAN CONSULATES IN CALGARY, MONTREAL AND VANCOUVER. THE FORMS CONTAIN DETAILED INFORMATION

AND INSTRUCTIONS CONCERNING THE FILING OF CLAIMS

UNDER THE PROVISIONS OF THE WAR AND PERSECUTION

PROPERTY DAMAGE LAW AND ENQUIRIES FOR FURTHER

INFORMATION SHOULD BE DIRECTED TO AUSTRIAN REPRESENTATIVES.

LEGISLATION INTENDED TO ENABLE PLRSONS WHO WERE EXPOSED TO PERSECUTION ON POLITICAL, RACIAL OR RELIGIOUS GROUNDS IN AUSTRIA BETWEEN MARCH 13, 1938, AND MAY 8, 1945, AND WHO FAILED TO FILE A RESTITUTION CLAIM WITHIN THE TIME LIMITS PROVIDED IN AUSTRIAN RESTITUTION LAWS FOR THE RESTITUTION OF PROPERTY, LEGAL RIGHTS AND INTERESTS, TO OBTAIN SATISFACTION OF THEIR CLAIMS. THE PREPARATION OR FILING OF INDIVIDUAL CLAIMS MUST BE THE RESPONSIBILITY OF THE CLAIMANT. ENQUIRIES REGARDING SPECIFIC CASES SHOULD BE ADDRESSED TO THE APPROPRIATE AUSTRIAN OFFICES REFERRED TO ABOVE.
