The Tight Money. Everybody is hard up for money. Merchants send out their bills, but their creditors to step in when the collectors return, and look cheerful in the result of the day's doings amounting to \$5. The financial conditions are full of gloom. Those who are not able to pay the bills on time. Credit is at a premium. No money is coming in, and bills are becoming due every day. The banks, with the exception of the one characterizing their policy, have decided that this particular time is just the one for reducing their discounts, and are refusing to renew maturing paper or cash any more. It makes no matter by whom a note is drawn, by whom it is cashed, or by whom it is endorsed, the banks will not look at it. "Not that they distrust the paper," oh, no, but they really have no money. The private bankers have been leading all rates all the way from one to three per cent a month, and their accounts are about empty. As high as twenty percent has been asked, and the bank granted only as a favor at that, recently on paper endorsed by the "heavy man" of St. John. If the banks do not lower the rate they will be forced to refuse to issue any more paper. Their plan of no money is not possible when the question is one simply of renewal, as they can renew paper without paying out any money. And yet their short-sighted institutions, that have been so generous in the business community in prosperous times, and finally loaned the money they now peremptorily demand, drive their customers to the wall. They have no other recourse but to refuse to renew their bills, or to discount them at such a rate as to make it impossible for the merchant to get on. In accordance with the understanding on which the account was opened! Banks seem to be excellent institutions in good times, but in times of stress they are the enemy of the merchant. They are not to be trusted when they have money, and refuse to lend when everybody is hard up. A merchant who has been doing business for years on the basis of a certain amount of indulgence in his favor, and who has built up a business on that basis, is at a loss what to do when the bank, as a season of particular business stagnation, suddenly demands payment. He has bought goods, and made all his arrangements, on the basis of the bank's continuing to carry that amount of his paper, and he can not sell the goods, or carry his business in any way in accordance with the reduced condition of the capital on which his affairs are based. He is forced to close his doors, or to sell his business at a loss, or to see his credit ruined, and his name blackened for the rest of his life.

The Lost Letter. The Halifax detectives, having arrived here, repeat their assertions that Lally passed through St. John. The Detective, in giving their theory, says that after leaving Toronto Lally appeared under the influence of liquor, talked freely, gave it to be understood that he was a book agent, and displayed with a vantage of literature on the cases as to the price of his wares. Amherst was reached, and here he got another bottle of brandy, filled a flask from it, and waited the conductors of the train to leave. The hotel, on the way again, he made enquiries as to who would be the best parties in St. John to hire a good team from, as he wanted to travel further. St. John was reached and about ten minutes before the train was to start, he was standing on the platform, and his coat, pulled his hat over his eyes, and the instant the cars stopped jumped out and disappeared. A few seconds later Sergeant Ryper, who had received a tele gram from Halifax, searched the train, but could find nobody he wanted; he then "interviewed" the conductors, and they gave the account of the above suspicious character, who assumed the description of Lally. The hotel was gone to; in the billiard room of one there was a man that "looked like the description; but he was proved not to be the party wanted by the Sergeant. Ryper went to the "heavy man" to notify him; and here Lally came in again. He had proceeded to the station of the N. S. Railway, where it is now held by St. Stephen's on a train which runs two hours before the morning train. He had some arrangements to make for hunting parties who would come to do the day's business. He was offered \$25, which Lally said was cheap enough. While he was in the office arranging this trip, Ryper came on the outside stairs to give the warning of the party wanted by the Sergeant. Ryper quickly overheard him, as he stepped out by another entrance and did not come back. The detective is under the impression that he was driven to the street by the "heavy man" and went to the latter place, and obtained slight traces, but not enough to follow his movements. The St. John Chief of Police had got the idea firmly fixed in his mind that Lally did not come this way; but when the detective took him over the trail as narrated, he was satisfied they were right. And this ended the pursuit of the criminal, who has made his escape by the loss of less than 100 cents.

St. Stephen has a spelling match to-morrow. Gray Police Court. When Justice McEwen took his seat this morning he saw three prisoners in the dock, all charged with drunkenness. Last week he broke through his resolution, and on Sunday night a Portland policeman found him drunk on Main street and leaning against a lamp post. "Take me to the station," said Danny, and to the station he was taken, and on Monday morning found \$4. Last evening he came to the city and soon fell into the hands of the police. This morning he asked to be discharged, but the Magistrate thought the wiser course was to fine him \$4 in default of which he could go to Jail and get sober. A girl was that of Mary Ann Dick, a grey haired woman of 60, charged with simple drunkenness. She had been in the Alms House all winter, but had never before been before the Police Court. She was let go, on promising to go back to the institution to-day.
