## RULES FOR REGULATION OF THE LIBRARY.

---

1. No conversation shall be allowed in the Library.
2. No book shall, under any circumstances, be taken away from the Court House, nor shall any book be taken from the Library except for use in the Court Room or Judge's Chambers, or in the public offices in the Court House.
3. No one shall take a book from the Library without first entering the title thereof in the Register kept for that purpose, and signing his name to such entry, and it shall be his duty to return without delay the book or books taken by him.
4. The Library shall be kept open daily, from half-past nine o'clock a.m., until 5 o'clock p.m., except Saturdays and during the long vacation, and the Christmas vacation, when it shall be opened at half-past nine a.m., and closed at one p.m. When Courts are sitting the Library must be kept open till the rising of Court.
5. The Caretakers of the Court House are authorized to permit members of the Association only to have access to the Library in the evening, and members availing themselves of this privilege are required to enter their names in the Register.
