MUSSEY AN ARTISTRESS A Pitiful Appeal to the Island of C. WE ARE GOD'S CREATURES.

Ambassadors and the Sultan Asked to Send Them Succor.

Christians Have Destroyed Their Olives and They Are Naked and Starving—British South Africa Company Want Heavy Indemnity From Kruger for Interference in Matabeleland—German Protectionists Taking Action—Plot to Kill the Cas-Cable News.

Canea, Island of Crete, Sept. 28.—The Mussulman notables have sent the following telegram to the ambassadors of the powers at Constantinople and to the Sultan:

Our position is becoming unbearable. Winter is approaching and we are without shelter, and living on a hectograin of flour per day, given us by Mussulman charity.

Our Christian compatriots have burned our olives, and the island will soon be denuded of timber. Showing berries in October. If we do not return to our homes, how can we live next season?

Public charity has already expended 5,000,000 piastros, and it is doubtful if that source of relief can support us another month. We, too, are Christians, and we have the same humanity put an end to our desperate position.

A Whole Street of Warsaw Was Undermined. But the Schemers Looked On.

Warsaw, Sept. 28.—Through an official denials will be forthcoming, it has leaked out from official circles in such a manner as leaves no room for doubt that there was a deliberate and determined plot against Emperor Nicholas at the time of his recent visit to this city. Its success was only frustrated by accident.

Several weeks before the arrival of the Imperial party a number of persons, supposed to belong to the German Socialist party, undermined Novy Sviat, a number of houses and mansions between the Governor-General's palace and the Royal castle. As the tunnel work had been detected by the police and a herd of men approached completion, the conspirators became apprehensive of a collapse of the roadway and called in several Polish masons to build supports. The masons, whose suspicious words were overheard by the police and 130 arrests followed. Among those in custody are four disguised German officers, eleven on leave of absence belonging to the Landwehr, who had been active in the actual work of tunnelling. Several of the conspirators were manufacturers from the town of Lodz, Poland, and also implicated.

Propose to Have an Autonomous Tariff and New Commercial Treaties.

London, Sept. 28.—A despatch to the Standard from Berlin says: At Saturday's conference of members of the German League of Nations, which are the main advocates of agrarian, industrial and commercial protection, held under the presidency of Count von Drosowitsh-Welcher, Secretary of State for the Interior, it was resolved to prepare a new autonomous tariff and new commercial treaties, on the basis that iron lords consent to the raising of the corn duty, while the agrarians consent to the reduction of the tariff on raw materials.

The commission proposed by the conference will be so constituted as to be directly dependent on the Government. This has caused much excitement among German commercial men who are not thoroughgoing protectionists. They have resolved to establish an independent impartial committee to obtain the material they deem necessary for the preparation of the treaties, on the basis of new commercial treaties. A bitter conflict between the two committees is inevitable.

GETTING EVEN WITH KRUGER. British South Africa Company Demand Three Million Pounds Indemnity.

London, Sept. 28.—A despatch to The Daily Mail from Capetown says it is rumored in Johannesburg that the British South Africa Company has demanded £3,000,000 indemnity from the Government of the Transvaal for inciting the natives of Matabeleland to revolt against the company and for supplying them with rifles.

Called in Scotch Bacon. Dealers in London Fined for Selling Canadian Pork Under a Wrong Name.

London, Sept. 28.—(Telegraph Cable.)—Considerable talk has arisen among pork establishments here because of a prosecution upon certain bacon dealers. The dealers sold as Scotch bacon pork imported from Canada, and for this offence they were subjected to fines.

There have been many rumors of purchase of cannon by the Canadian Government for the defence of the Dominion. Enquiries made at the Woolwich Arsenal resulted in a denial by officials that any armaments for coast defence had been ordered by Canada.

Spain Shows Her Teeth. Berlin, Sept. 28.—A despatch to the Frankfurter Zeitung from Madrid asserts that a powerful Spanish squadron will immediately proceed to Cuba on the pretext of attending the installation of the new floating dock at Havana. THAS LUETGERT'S DAY

Important Statement Came From Nebraska.

A LAWYER FROM TEKEMAH

Who is Quite Positive That Mrs. Luetgert Called Upon Him.

The Woman Was Poorly Clad and Wanted to Enter Suit for Divorce in That State, Where Divorce is Easy—She Said Her Husband Lived in Chicago and Was Wealthy—Kummers Are Frying About That Perjury Has Been Committed by Witnesses for the Defense.

Chicago, Sept. 28.—The court proceedings opened to-day with the appearance upon the witness stand of Dr. Clarence Lutherford, the Luetgert family physician. He testified as to Mrs. Luetgert's physical condition, stating that she was in fairly good health.

Armada Opdyke, a fruit vendor from near Janesville, Wis., said that in May he was in the vicinity of Lake Zurich, near Janesville, with a horse and wagon. On the night of May 9 he camped out, sleeping out in his wagon. In a small grove near him he saw two women. They were lying on the ground and said they were going to remain there during the night. Opdyke said he carried an amount of hay from his wagon to the women and they made a bed of it. The witness positively and unconditionally identified the photograph of Luetgert as one of the women he saw in the woods near Lake Zurich the night of May 9.

Maegle Shaugnessy of No. 1348 North Roby-street was put on the witness stand to strengthen the impeached evidence against Emma Schimpke. The witness was with Emma Schimpke and Rosa Gleich at the dance in West Hall, opposite Luetgert's sausage factory, the night of May 9. She said she saw Luetgert in the bar room of the place, and that she and Emma Schimpke left the hall about 9 o'clock, and went home. Consequently Emma Schimpke could not have seen Luetgert and his wife in the bar room.

Marens Heinemann added the weight of his testimony to that of others who have told how Mrs. Luetgert had frequently said she was going away from her home because Luetgert had failed. On April 28, the witness said, Mrs. Luetgert told him she was leaving away. Dr. B. L. Riese, one of the medical experts of the defense, testified as to experiments he made at the sausage factory and elsewhere with bones and other material found in and about the vat.

INTIMATIONS OF PERJURY

Remors Around the Court Buildings in Chicago Which May Mean Trouble.

Chicago, Sept. 28.—Intimations that perjury had been committed by witnesses for the defense in the Luetgert murder trial were heard around the Criminal Court building to-day, coupled with a suggestion of grand jury investigation. It was said that the prosecution had only exhibited seeking the indictment of Mrs. Luetgert. Smirring before the grand jury now in session. During the time Mrs. Luetgert was on the witness stand she was questioned sharply by Assistant State-Attorney McEwen relative to her testimony. Mr. Trimmer, grand juror in charge, asked the grand jury which indicted Luetgert, she admitted that her story before that body, as well as the evidence she gave before Justice Keenan, who held Luetgert for trial, was different in material points from the evidence she gave at the present trial. The explanation of the discrepancy was that Inspector Schaack had threatened her when she appeared before the grand jury, telling her that if she did not testify against Luetgert she would be punished.

Inspector Schaack denounced this statement as utterly false. The daily crowd at the entrance to the Criminal Court building to-day was even larger than usual. It was about equally divided as to sex.

SAYS HE SAW MRS. LUETGERT.

An Attorney From Tekemah, Neb., Believes the Woman Called on Him.

Tekemah, Neb., Sept. 28.—H. Wade Gillis, an attorney of this place, claims to have seen the defendant, Mrs. Luetgert, who is now on trial in Chicago for her murder, long after the woman's body is supposed to have been boiled to pieces in the sausage factory. He says the woman came to him in the latter part of May and consulted him about getting a divorce. His story is as follows: "I think I saw this woman who is said to have been murdered. Perhaps I can do the accused husband no good, for I may not be able to convince the jury that I saw Mrs. Luetgert, but if I did not see the woman I saw a person who resembles her in every particular. Why did I not speak of it before? For the very good reason that I never occurred to me that the woman I saw was Mrs. Luetgert until I central the court in Chicago Wednesday and heard the woman described by one of the witnesses. Then I hunted up a photograph of Mrs. Luetgert, and was certain that I knew some important facts about the case. "His thing was precious. "I said nothing about it at the time. Why? Because I was in charge of other business, and our court opens here to-day, and I could not afford to be detained in Chicago. I wanted to tell all those lawyers what I knew. I might not have got home for a month. "About noon on May 27 or 28, I met certain which, a woman, poorly clad in a black dress, entered my law office here. She said she wanted to consult me about a divorce suit. She was very nervous, laboring apparently under great mental excitement. "She said she lived in Chicago, where her husband was wealthy. She had left her husband because of his cruelty, and was anxious to know if her deserting him would give her chances for securing a divorce and the custody of her two children. She said she had two boys, whom she wanted. "She said she had come to this State because she understood it was easy to

get a divorce here. She said she had no money, but could get some, and desired to know the chances of success. I told her, and she inquired the way to an hotel, saying she would return in the afternoon and close the case. I intended to see her more about herself when she returned. She did not tell me her name, and all the time seemed to want to see before me. That was the last I saw of her. "When I was in the court room in Chicago Wednesday last, I viewed the description of Mrs. Luetgert by one of the witnesses. I was satisfied that my strange visitor was the wife of the assassin. "When I got to Omaha last night I wired to the attorneys for the defense, telling them what I had just heard. They wired me to come to Chicago at once."

Vincenz is Elated. Chicago, Sept. 28.—Attorney Vincenz of the defense is elated over the news from Tekemah, Neb. He has not decided whether to have Attorney Gillis make a deposition in Burt County, Neb., or have him come to Chicago as a witness to testify regarding the woman he believes was Mrs. Luetgert.

The Highlanders' band rendered choice music at intervals during the day. The children were much appreciated. OF INTEREST TO BICYCLISTS.

Judge Morson Says There is No Law as to Which Side of the Street a Vehicle May Take.

Judge Morson yesterday rendered a judgment in the Division Court of Interest to cyclists. James Miller, cyclist, was riding east on College-street near Beverley-street behind a street car. The latter stopped at Beverley-street, and Miller took the devil strip, passed the car and ran into Hackman McNeerney's horse. His wheel was injured and one of the most prominent planters in this state, was fatally shot by a negro yesterday near Monroe, Onaschita parish. He was killed while leading the pursuit of a negro named Ferren, who on Sunday assaulted the pulpit and preached a doctrine of a former near Cadville. The negro, who was a farm hand, threatened to kill the girl if the facts were made known, and it was later learned that two weeks ago he had assaulted the little girl's sister. Many leading citizens of the country turned out as a posse to run the negro down and bloodhounds were placed on the trail. Mr. Rutland McEmery was one of the leaders in the pursuit of the negro, and he learned of James Turner. He went there and demanded admission. Turner was denied access to the school. When he opened fire on him with the rifle. The bullet entered his right arm and he fell. McEmery is steadily injured and the entire male population of Onaschita parish, reinforced from surrounding parishes, is on the hunt for Ferren.

TORONTO'S PUBLIC SCHOOLS.

Committee Decides Against the Teaching of Religion—More Maps Required. The Public School Board's Committee on Inspection, with Dr. Noble in the chair, met yesterday afternoon and was interested chiefly in the question of religious instruction in schools, shall or shall not be allowed. The committee was that it would not be in the interests of the public schools should be devoted to the giving of denominational or sectarian instruction to the pupils. Dr. Noble visited one of the schools a day or so ago, and was horrified to find some of the pupils without any practical knowledge of geography. "Stand up and face the south," said the pro tem inspector to a bright-looking enough boy, but the boy looked agnost and knew not which way to turn. Repeated failures in receiving answers to similar questions convinced Dr. Noble that more maps are required, so a recommendation for such was registered.
