## BILL.

### An Act to limit the time for redeeming Land Scrip.

**W**HEREAS it is desirable to call in all Land Scrip Preamble. heretofore issued, or that may hereafter be issued, at as early a day as may be consistent with justice to the parties holding the same: Be it therefore enacted, &c.

- 5 And it is hereby enacted by the authority of the same, No Land Scrip  
that no Land Scrip heretofore issued, or that may here- to be redeem-  
after be issued, under the authority of any Act, Ordinance able or receiv-  
or Law in force in this Province, shall be redeemable by able in pay-

other dues of or upon Public Lands, or otherwise, unless ing of this Act.
- the same be presented and offered in payment at the office of the Commissioner of Crown Lands, or at the office of one of his Agents, within from
- 15 the passing of this Act; and all such Scrip which shall not be presented and offered in payment within the period aforesaid, shall be null and void: any Act, Ordinance or Law to the contrary notwithstanding.
