

## BILL.

An Act to incorporate The St. Lawrence School of of Medicine of Montreal.

M7 HEREAS Francis C. T. Arnoldi, Robert L. Mac- Preamble. donnell, Horace Nelson, Aaron H. David, George D. Gibb, and George E. Fenwick, Licensed Practitioners of Medicine and Surgery for the Province, have united 5 for the purpose of giving Public Lectures and instruction on the various branches of Science connected with the exercise of their profession, and have, for that purpose, established a Public Medical School, with suitable apparatus and convenience; and have by their petition repre-

10 sented that if they and their successors were incorporated and invested with the powers hereinafter mentioned, they would be able still further to increase their means of affording adequate instruction to their pupils:

And whereas it is expedient to grant the prayer of the 15 said Petitioners: Be it therefore enacted, &c.,

That the said Francis C. T. Arnoldi, Robert L. Macdon-Certain per-nell, Horace Nelson, Aaron H. David, George D. Gibb sons and their successors and George E. Fenwick, and their successors, and those incorporated. who may hereafter become associated with them or their

- 20 successors, in the manner hereinafter mentioned, shall be and are hereby constituted a Body politic and Corporate by the name of "The St. Lawrence School of Medicine Corporate of Montreal," and by that name shall have perpetual suc- name and cession and a Common Seal, with power to break, alter,
- 25 or make anew the same, and may by that name sue and be sued, plead and be impleaded, in all Courts of Law or Equity in this Province; and may purchase, take and hold real and personal property, provided the real pro-perty so held by the said Corporation, does not at any
- 30 time exceed the value of five thousand pounds, currency; and may alconate the same, and acquire other property instead thereof.

H. And be it enacted, That whenever any of the Mem- Election of bers of the said Corporation shall die, or shall become new members.

35 permanently resident out of the City of Montreal, or shall resign, (and any Member shall be at liberty so to resign,) or it shall be deemed advisable to increase the number of Members thereof, (which the said Corporation may always do,) then the said Corporation shall elect the 40 candidate or candidates by ballot.

III. And be it enacted, That the said Corporation shall. vearly cause to be delivered at least one hundred and as per sec. 12, twenty Lectures each of at least one hour's duration, in of 10 and 11 accordance mith accordance with, and on the subjects provided by, the twelfth section of the Act passed in the Session held in 5 the tenth and eleventh years of Her Majesty's Reign, and intituled An Act to incorporate the Members of the Medical Profession in Lower Canada, and to regulate the Study and Practice of Physic and Surgery therein, to be given by competent Lecturers between the first day of November 10 and the last day of April.

Fee on matriculation.

IV. And be it enacted. That the Fee to be demanded of any Pupil on his entry or matriculation in the said School, shall not exceed ten shillings currency, to be applied by the Corporation in such manner as it may 15 deem proper.

Pewer to make By-laws.

V. And be it enacted, That the said Corporation shall have power to make such by-laws as may be necessary for the conduct of its affairs and business, the Government of its Pupils, and for carrying into effect the pro-20 visions of this Act, as to the Members thereof shall, from time to time, appear expedient, and as shall not be in any wise repugnant to or inconsistent with this Act or to law

How powers of the Corpo-ration may be exercised.

Service of process, etc.

VI. And be it enacted, That all the powers of the said Corporation may be validly exercised by any majority of 25 the Members thereof for the time then being, and that any deed or instrument under the seal of the Corporation, and signed by any such majority of the Members for the time being, or by such person as shall be appointed as their Attorney for that purpose, shall be held to be a 30 deed of the Corporation; and any service of process or otherwise, made at the place at which the said Medical School shall be kept, (and if in such case personal service be required, but not otherwise, on one of the Members of the Corporation), shall be deemed a valid service 35 upon the said Corporation.

Public Act.

VII. And be it enacted, That this Act shall be a public Act, and taken and received as such in all Courts of Justice, and by all persons in this Province.
