DIPLOMATIC APPOINTMENTS

The Secretary of State for External Affairs, the Right Honourable Joe Clark, announces the following diplomatic appointments:

Mr. Earl G. Drake (59), born in Saskatoon, Saskatchewan, as Ambassador to China.

Mr. Drake [B.A., University of Saskatchewan, 1950; M.A., University of Saskatchewan, 1951; Ph.D. Studies, University of Toronto, 1952] joined the Department of External Affairs in 1955. He has served abroad in Karachi; Kuala Lumpur; as Deputy Permanent Representative of Canada to the Organization for Economic Co-operation and Development in Paris from 1968 to 1972; as Executive Director for Canada to the World Bank in Washington from 1975 to 1982; and as Ambassador to Indonesia from 1982 to 1983. In Ottawa he was Director of Planning at the Canadian International Development Agency (CIDA) from 1964 to 1968; Vice-President at CIDA from 1972 to 1975; and Director General for South and Southeast Asia from 1983 to 1985. He has been Assistant Deputy Minister for Asia and Pacific since 1985. Mr. Drake replaces Mr. R. Gorham who returns to Ottawa.

Mr. David Rose (51), born in England, as High Commissioner to Tanzania, with concurrent accreditation as High Commissioner to the Seychelles, and as Ambassador to Madagascar.

Mr. Rose [B.A., University of Western Ontario] joined the Department of External Affairs in 1960. He has served abroad in Lagos; Dar-es-Salaam; as Counsellor, Rome from 1971 to 1975; as Counsellor, Washington from 1978 to 1982; and as Counsellor, Peking from 1982 to 1984. He has been Director, Security Division since 1985. Mr. Rose replaces Mr. D.C. Arnould who returns to Ottawa.

Mr. André S. Simard (46), born in Montreal, Quebec, as Ambassador to Cameroon, with concurrent accreditation to Chad.

Mr. Simard [B.Ed., Collège Ste-Thérèse de Blainville/Collège Ste-Croix; LL.B., Montreal University; Certificate in International Law, International Law Academy, The Hague] joined the Department of External Affairs in 1967. He has served abroad in Tokyo; Saigon; Vientiane; Tunis; and as Counsellor and Consul, Bangkok from 1981 to 1984. In Ottawa he was Director, Pacific Relations from 1984 to 1986. He has been Director, Japan Relations since 1986. Mr. Simard replaces Mr. M. Faguy who returns to Ottawa.
