CONSTITUTION.

NAME.

I. The name of this Club is THE HALIFAX CLUB.

NUMBER OF MEMBERS.

II. The club shall consist of not more than three hundred active members and as many honorary, supernumerary, privileged and non-resident members as may from time to time be elected.

DISCUSSION OF POLITICS AND RELIGION.

III. The open discussion of political and religious questions of every kind within the club is prohibited.

GOVERNMENT.

IV. (a) The management of the club shall be entrusted to a committee

consisting of fifteen active members and the treasurer.

- (b) Five members of the said committee shall annually retire by rotation and the vacancies so created shall be filled at the first annual general meeting of the club; and the said retiring members may be re-elected.
- (c) If a vacancy occurs in said committee by death, resignation or otherwise, the committee may fill such vacancy temporarily until the next annual general meeting, when such vacancy shall be filled by the election of a member to serve out the unexpired term of the retired member.
- (d) The members of the committee shall be elected by ballot in all cases.
- (e) A treasurer, who must be an active member, shall be annually elected at the first annual general meeting and

the person so elected shall be ex officio a member of the committee.

- (f) The treasurer-elect shall, before entering upon the duties of his office, give security satisfactory to the committee in the sum of four thousand dollars.
- (g) The committee shall elect one of themselves as chairman, and he shall during his term of office be known as the president of the club.

COMMITTEE MAY MAKE RULES, ETC.

- V. (a) The committee shall at its first meeting after each annual election, or so soon thereafter as may be convenient, appoint from its own body as many sub-committees as may be required to superintend the several departments of the club.
- (b) The committee shall from time to time make such rules, consistent with

this Constitution, as it shall think necessary for the well-being of the club.

(c) The committee shall, after each annual meeting, appoint a secretary who shall be subject to the directions of the committee.

MEETINGS OF COMMITTEE.

- VI. (a) The committee shall meet weekly on a stated day for the transaction of current business.
- (b) Four members of the committee shall constitute a quorum.
- (c) The president shall preside at all meetings of the committee at which he is present, and in his absence the senior member of the committee present shall preside.

MEMBERSHIP.

VII. The membership of the club shall consist of five classes:

- (a) Honorary,
- (b) Supernumerary
- (c) Privileged,
- (d) Non-Resident,
- (e) Active.

HONORARY MEMBERS.

- VIII. (a) The committee shall have power to admit as honorary members, His Excellency the Governor-General of Canada; His Honour the Lieutenant-Governor of Nova Scotia; the General commanding the Imperial or Canadian Troops in the Halifax Garrison; and the Admiral commanding the Fleet on the Halifax Station, and the General commanding the Militia of Canada.
- (b) The committee may admit also to the privileges of the club as honorary

members, for such periods as it may from time to time think fit, any persons of distinguished rank and position, or any body of persons visiting the city to whom it may seem proper to offer such a compliment.

- (c) The resolution to admit such person or persons must be agreed to by a majority of the whole committee.
- (d) The person or persons so admitted to honorary membership shall not be required to pay any entrance fee or subscription.

SUPERNUMERARY MEMBERS.

IX. (a) If a member leaves the Province of Nova Scotia, he may make a written application to the committee before the first day of January, and, with its approval, and by payment of an annual subscription of five dollars, become a supernumerary member, and during his absence he shall be

exempt from the payment of the ordinary annual subscription. He shall be liable, however, to the payment of the ordinary annual subscription for the year in which he departs from the Province and also for the year in which he returns to it, less the five dollars so paid as above, provided he remains within the Province for more than one month from the date of his return, and if he remains that length of time only, he shall be entitled to the privileges of the club for that period.

(b) No member's name shall be placed or retained on the supernumerary list unless he makes payment of the current year's subscription of five dollars before the second day of February.

PRIVILEGED MEMBERS.

X. (a) The committee may elect the following persons as privileged members:

- Officers in His Majesty's Imperial or Canadian Army who are stationed in Nova Scotia for an indefinite period.
- Persons having no usual place of residence or business within the County of Halifax.
- 3. Members of the Executive Council of Nova Scotia, whose ordinary residence, otherwise than official, is outside of the County of Halifax.
- 4. Other eligible persons who satisfy the committee that their residence in the County of Halifax is temporary or uncertain or liable to be terminated by the occurrence of circumstances beyond their control.
- (b) The privileged members mentioned in the foregoing sub-sections shall be exempt from the payment of the entrance fee, but they shall be required to pay the same subscription as

is required in the case of active members.

- (c) The committee may also elect as privileged members:
- 1. Visiting strangers who satisfy the committee that their residence in Halifax is not likely to exceed three months. Such members shall pay a subscription of ten dollars for that period, but shall not be required to pay any entrance fee. Should such stranger before the expiration of the said period desire to have his membership extended, he may obtain from the committee such extension from month to month, but not to exceed three months in all, upon payment of five dollars per month.
- 2. Officers in His Majesty's Navy may be elected by the committee for such periods and on such terms as the committee may decide and such persons, after having been balloted for, may renew their subscriptions each

successive season while on the station without further ballot.

- (d) Privileged members shall be subject to the constitution and rules of the club, and shall, after having paid their subscriptions, be entitled to enjoy all the rights of active members, except that of being elected members of the committee or of attending or voting at meetings.
- (e) Each candidate for privileged membership must be so designated in the Candidate's Book and on the list of candidates for election posted in the reading room, and he shall be balloted for and elected in the same manner as an active member. No candidate for privileged membership shall be placed on said list unless his name shall have been approved by the committee six days before the date of election.

- (f) All candidates for privileged membership, referred to in sub-sections (a) I, (c) I, and (c) 2, may, after they have been proposed and seconded, use the club until their election; but any such candidate before taking advantage of this privilege will be required to pay to the secretary or treasurer his subscription in advance, which subscription shall be returned to him in the event of his not being elected a member of the club.
- (g) If a privileged member, who has been elected as such on the ground that his residence in Halifax is temporary or uncertain or liable to be terminated by the occurence of circumstances beyond his control, has continuously resided within the County of Halifax for upwards of two years, the committee may require him to pay for a period of five years the sum of ten dollars a year in addition to the ordinary annual subscription, and if

he shall have paid such additional sum for five years, his name shall be transferred from the list of privileged members to that of active members.

TEMPORARY ADMISSION OF STRANGERS.

- XI. (a) If a member wishes to introduce a friend who is visiting Halifax temporarily and does not reside in the Province of Nova Scotia, (the Island of Cape Breton excepted) as a visitor of the club, he may procure a card for that purpose, signed by the secretary, by writing and signing in a book provided for that purpose, an application stating the name and residence of the visitor and the number of days, not to exceed fourteen at one time, or thirty in all in any one year, for which the privilege is desired.
- (b) This privilege may be extended with the consent of the committee, for the period of one month on payment of five dollars.

- (c) No member shall have the privilege of introducing more than two visitors at one time.
- (d) Every member who introduces a visitor shall be responsible for the conduct of such visitor, and his observance of the constitution and rules of the club, and for all liabilities incurred to the club by such visitor.
- (e) No person is eligible for proposal as a visitor after he has been in Halifax fourteen days.
- (f) All ordinary members of the St. James Club, and Mount Royal Club, Montreal; Garrison Club, Quebec; Toronto Club, Toronto; and Union Club, St. John, who are duly certified as such, and whose usual place of residence is without the Province of Nova Scotia, shall be entitled to the privileges of the club for fourteen days upon presenting such certificate.

NON-RESIDENT MEMBERS.

- XII. (a) Persons having no usual place of residence, business or study within the Province of Nova Scotia may be elected as non-resident members of the club upon being proposed and balloted for in the manner provided in the case of active members, and shall upon election, pay the sum of ten dollars subscription for the then current year, and a like sum each year thereafter.
- (b) The annual subscription of nonresident members shall become due on the first day of January and shall be paid on or before the second day of February in each year.
- (c) A non-resident member shall not be required to pay any entrance fee.
- (d) Non-resident members shall enjoy the same rights as privileged members, and shall be subject to the provisions for non-compliance with any of

the sections of this constitution or of the rules made in pursuance of it.

(f) If such non-resident member becomes a resident of the Province of Nova Scotia, or has a place of business or study within the Province, he is no longer entitled to remain a non-resident member.

ACTIVE MEMBERS.

XIII. Active members may be elected by the committee or by the club.

PROPOSAL FOR MEMBERSHIP.

XIV. (a) Every candidate for admission shall be proposed by one active member and seconded by another. The name of the candidate, and his usual place of residence, rank, profession or other description shall be written at the time of his proposal in the Candidates' Book, and shall be signed by the droposer and seconder.

- (b) All elections of active, privileged or non-resident members shall be by ballot.
- (c) A list, dated and signed by the Secretary, containing the name of each candidate to be balloted for, and the name of the proposer and seconder, shall be posted in a conspicuous place in the reading room for six days before the date of ballot, and such list shall contain a notice stating that the ballot will be by the committee or the club as the case may be.

ELECTION BY THE COMMITTEE.

- XV. (a) Whenever the committee shall deem it expedient, they shall have power to elect active, privileged or non-resident members.
- (b) The ballot for such members shall take place in the club house on the first Wednesday of each month at such hour as may be fixed by the com-

mittee; and if a sufficient number of members are not present at the appointed time, the ballot may, by direction of the president or acting president, be postponed to the following Wednesday.

- (c) At least ten members shall vote at all elections by the committee.
 - (d) One black-ball in five shall reject,
- (e) Should the ballot prove adverse. the proposer and seconder of the rejected candidate may bring the name of the candidate before the club for a new ballot, and the committee shall fix the time for the ballot, and send notice of the same by post to each active member of the club.
- (f) A candidate who has been twice black-balled cannot be again proposed until after two years from the date of the last ballot.

ELECTION BY THE CLUB.

- XVI. (a) The ballot for members shall take place in the club house on the first Wednesday in each month, to commence at one o'clock, p. m., and close at four o'clock, p. m.
- (b) During the time of balloting a notice stating that a ballot is going on shall be posted in a conspicuous place in the club with a request that members will attend.
- (c) There must be at least thirty votes to constitute an election, and one black-ball in five shall reject.

RULES OF BALLOT.

XVII. The ballot boxes or box shall, previous to use, be examined and secured by the secretary and one member of the committee, and after the ballot is over, the boxes shall not be removed until they have been open-

ed and examined by the secretary in the presence of at least one member of the committee, and the result of the ballot as regards each candidate shall be immediately entered opposite his name on the list and shall be signed by the secretary.

NEW MEMBERS.

XVIII. The secretary shall forthwith notify every new member of his election and furnish him with a printed copy of the constitution and rules.

ENTRANCE AND SUBSCRIPTION.

XIX. (a) The entrance fee payable on admission to the club, shall be fifty dollars, and the annual subscription forty dollars, which may be paid in two half yearly instalments of twenty dollars, in January and July of each year.

- (b) Members elected after the month of January, in any year, are required to pay only *pro rata* for the remainder of the half year in which they have been elected.
- (c) All subscriptions shall be due on the first day of January in each year, and the half yearly instalments shall be payable on the first days of January and July in each year.
- (d) After the first day of January in each year, no resignation or withdrawal shall relieve the retiring member from the payment of the current year's subscription, except in the case of death during the first half year, which shall relieve from payment of the instalment for the second half year.

NEW MEMBERS TO PAY BEFORE VOTING.

XX. No active member shall be permitted to enjoy any of the privileges of the club until he shall have paid his entrance fee and subscription.

FAILURE TO PAY ON ENTRANCE.

XXI. Should a new member fail to pay his entrance fee and his subscription within three months from his election, the committee may erase his name from the list of members, unless he shall have justified the delay to its satisfaction.

FAILURE TO PAY SUBSCRIPTION.

- XXII. (a) The name of every member who shall not have paid his half yearly subscription before the second days of February or August, as the case may be, shall be posted in the reading room, and notice of such posting shall be sent to him or his agent.
- (b) If the subscription be not paid within thirty days after such posting, such person shall cease to be a member of the club, and his name shall be erased from the list of members; but

he may be re-instated by the committee on giving a satisfactory explanation of his default.

WHEN MEMBERS NOT ALLOWED TO VOTE.

XXIII. From and after the first day of February or August in each year, no member of the club shall be allowed any of the privileges of the club, unless he shall have paid his subscription for the current half year.

EXPLUSION OF MEMBERS.

- XXIV. (a) The committee shall take immediate cognizance of any infraction of the provisions of the constitution or of the rules of the club.
- (b) If the conduct of any member, in the opinion of the committee, tends to endanger the good order, character or welfare of the club, the committee may, by a majority vote, at least ten being present, expel such member, and

he shall be immediately notified by post of his expulsion.

- (c) A member so notified of his expulsion shall have the right to appeal to the club from the decision of the committee, and in order to prosecute his appeal he shall within fifteen days of the posting of the notice of his expulsion give notice to the secretary of his desire to appeal. The committee shall then call a special meeting of the club to consider the matter, which said meeting shall be held not more than thirty days after the service of the notice to appeal. The appellant shall have the right to be present and to be heard at such special meeting of the club.
- (d) There shall be at least thirty members present at such meeting, and they shall vote by ballot.

- (e) If two-thirds of those present vote to sustain the appeal, the appeal shall be allowed, and the name of the appellant shall be restored on the list of members; otherwise the appeal shall be deemed to be dismissed.
- (f) The decision of the club on such appeal, or where there has been no appeal, the decision of the committee, shall be final.

PAYMENT OF CLUB BILLS.

- XXV. (a) Members shall pay their bills for every expense incurred by them in the club on the monthly credit system in accordance with such rules as may be adopted by the committee from time to time.
- (b) The committee may make regulations to restrict the amount of credit which any member shall receive; and any member who refuses or ne-

glects to pay his bills, after demand, may be dealt with as provided in Section XXIV.

RETIREMENT OF MEMBERS.

XXVI. Any member whose dues are all paid may resign by giving notice in writing to that effect to the committee. The committee may re-elect on such terms as it may consider right any active member who has resigned and wishes to re-join the club.

MEMBERS RETIRING TO FORFEIT ALL RIGHTS.

XXVII. Any member who resigns or is expelled or ceases to be a member of the club shall thereby forfeit all right or claim thereon, or in or to its property or funds; and any member who has been expelled or has left the club in bad standing shall be ineligible to be re-admitted as a member.

GENERAL MEETINGS.

- XXVIII. (a) There shall be two general meetings of the club held in the club house every year, the first on the second Thursday of February, for the purpose of filling vacancies on the committee, and receiving from the committee a report and abstract of the accounts and general concerns of the club for the past year, together with an estimate of the receipts and disbursements of the current year; which report and estimate shall be printed for the use of the members, and one copy thereof put in each of the public rooms of the club at least seven days before the first annual general meeting.
- (b) At this meeting a member may submit any proposition having reference to the management and concerns of the club.
- (c) The second annual general meeting shall be held on the fourteenth day

after the first for the purpose of deciding on such propositions as may have been submitted at the first meeting, with such amendments, if any, modifying the same as may be offered.

- (d) The chair shall be taken by the president, or in his absence by the senior member of the committee present, at said meetings at five o'clock, P. M.
- (e) The accounts of the club, above mentioned, shall be properly audited by a competent person who is not a member of the committee.

SPECIAL MEETINGS OF THE CLUB.

XXIX. (a) The committee shall have power at all times to convene a special meeting of the club by giving fourteen day's notice, which notice shall be posted during that period in the public rooms of the club, and shall specify the object of such special meeting in the form of a resolution to be

signed by not less than six members of the committee.

- (b) The committee shall call a special meeting of the club at any time on a like notice and under similar restrictions on the requisition of twenty active members who are not members of the committee, provided they shall state distinctly the object of such special meeting.
- (c) At all such special meetings, called under the provisions of subsections (a) and (b) hereto, no subject shall be considered except what is specified in the notice of such meeting.

STRANGERS.

XXX. (a) The committee may regulate the admission of strangers, whether resident within the County of Halifax or not, in company with members, and designate the rooms to which such strangers may be admitted.

(b) No person who has been expelled or rejected or has left the club in bad standing shall be admitted to the club as a guest.

HOUSE HOURS.

- XXXI. (a) The club house shall be open every day for the reception of members at seven o'clock in the forenoon in the summer, and at eight o'clock in the forenoon in the winter, and shall be closed and the lights extinguished at twelve o'clock midnight, except on Sundays, when it shall be closed at eleven o'clock, F. M.
- (b) On special occasions the active committee for the month may extend the hour for closing mentioned in the foregoing sub-section.
- (c) No member shall be admitted into or permitted to remain in the club house after the hour of closing unless specially authorized by the committee.

ADDRESS OF MEMBERS.

XXXII. Each member of the club shall from time to time give to the secretary, his address or that of his banker or agent in Halifax and all notices sent to such address shall be deemed to be delivered to such member.

COMPLAINTS.

XXXIII. All complaints respecting meals shall be stated on the back of the bill and signed by the member complaining, and such complaint must be specially noticed by the committee at its next meeting; and all complaints respecting the servants or domestic arrangements of the club must be stated by letter signed by the member complaining, which letter addressed to the secretary must be laid by him before the committee at the next meeting.

NOT TO TAKE AWAY PAPERS, ETC.

XXXIV. No member shall take or permit to be taken from the club, or shall injure or destroy any newspaper pamphlet or other article which is the property of the club.

NO PROVISIONS TO BE SENT OUT.

XXXV. No provisions cooked in the club house, wines or liquors, shall be sent out of the house.

NO GRATUITIES.

XXXVI. No member shall give any money or other gratuity to any servant of the club, or permit a stranger to do so.

DOGS.

XXXVII. No member shall be permitted to bring a dog into the club house.


AMENDMENT OF CONSTITUTION.

XXXVIII. (a) If any new section or alteration of an old one is duly proposed at the first annual general meeting, and is approved of at the second annual general meeting by two-thirds of the members then present, whatever the number may be, the same shall thereupon come into effect.

(b) If it is proposed to adopt a new section or alter an old one at a special general meeting of the club, fourteen day's notice of such meeting shall be given, and the proposed new section or alteration of an old one shall be posted up in the reading room of the club fourteen days previous to the day of meeting. If the said new section or alteration of an old one is approved by two-thirds of the members present at such special meeting, of whom forty at least must vote, the same shall thereupon come into effect.

CONSTITUTION AND RULES TO BE PRINTED.

XXXVIX. This constitution and the rules made thereunder shall be printed, and a copy, together with a list of the committee, shall be delivered to every member of the club or sent to his address.

HOUSE RULES.

MONTHLY ACCOUNTS.

On the first day of each month, or as soon thereafter as may be practicable, a notice shall be sent to each member of the amount of his indebtedness to the Club.

If any member so notified fails to pay his indebtedness on or before the fifteenth day of the month, a second notice shall be mailed to him informing him that, on a day to be specified, being the sixth day after the mailing of such second notice, his name will be posted in the Club house, together with the amount of his indebtedness and that further credit will be refused to him until his indebtedness is paid. Upon the day specified his name shall be so posted, and his credit if his indebted-

ness still remains unpaid, and failure to pay his indebtedness before the first day of the next ensuing month shall be deemed to be a circumstance likely to endanger the good order and welfare of the club under Rule XXIII. The limit of a member's credit shall be \$50.00, but the committee may permit a member upon application to exceed said limit, either upon or without payment of the existing indebtedness before the end of the month and either to a specified amount or generally.

Each member's account shall be made up from the checks signed by the member during the month. Checks must be signed for all expenditures in the club, but in the case of visitors and of members about to leave the City, accounts may be procured and paid before the end of the month.

Members are to be requested to pay their accounts by cheques drawn to the order of "The Secretary, Halifax Club," but accounts may be paid to the Hall Porter, who will enter the name and amount so paid in a book kept for that purpose, which book the member paying must initial.

COFFEE ROOM.

Breakfasts may be served from eight until eleven o'clock, A. M.

Hot lunches and dinner from one to three o'clock, P. M., and from six to eight o'clock, P. M.

Hot suppers up to ten o'clock, P. M., on giving notice before eight o'clock.

Cold meats and tea and coffee and toast at any hour up to eleven o'clock, P. M.

No wine or liquor shall be served to any members in the coffee room, except with breakfast, lunch, dinner or supper. Members will fill up their dinner orders themselves and must on no account employ the waiters to do so.

Articles of glass, earthenware, etc., which are broken by the members either in the coffee room or elsewhere in the house must be paid for by them at prices to be fixed by the committee.

DRESSING ROOM.

Any portmanteau, bag or baggage of any kind must be taken away immediately after use, and not allowed to remain in the club. No servant of the club is to be employed by any member to clean clothes, boots or shoes or to assist him in dressing.

No member, except on special duty, nor servant of a member, will be allowed to go down into the basement story of the house, apportioned for the use of the servants of the club, nor will any such servant be allowed to go into any

other room than the dressing room, and then only to assist his master in dressing.

HALL PORTER.

He shall enter in his book once a day the name of every member coming into the house, and will see that members introducing strangers write their names and address, with that of the introducer, in the book kept for that purpose.

Strangers calling to see members of the club will be shown by him into the reception room or other room set apart by the committee for that purpose, and intimation of their arrival must be immediately sent by him to the member inquired for, if in the house. If a letter for an absent member be called for by any other member who may wish to forward it, the latter will be required to pay the postage if any, and to sign an acknowledgement in the Porter's book of his having received the letter, in case of future question.

He shall report to the Secretary all letters arriving at the club addressed to strangers.

GENERAL SERVANTS' REGULATIONS.

No officer or servant shall receive, under penalty of dismissal, any present whatever from the members, guests or tradesmen of the club.

Servants while on duty must not talk to each other, except on matters connected with their duties and no servant is permitted to address an individual member in the house on matters, either personal or relative to the concerns of the club; all communications of the latter kind to be made to the Secretary for the information of the committee.

If any money or articles supposed to be the property of members should be found by the servants in the club house, they must be delivered to the manager.

No application for re-instatement of a servant, who may have been dismissed on the representation of a member will be read or taken into consideration unless it come through and be recommended by the member by whose representation he or she was dismissed.

Servants will be held responsible for breakage and loss of, and damage to the property of the club.

No servant of the club shall be sent out of the house on any errand or pretense whatever, unless upon club business by the manager, Secretary or member of the committee, or to post letters at stated periods, or to call a cab from the nearest stand.

MISCELLANEOUS.

No pamphlet, advertisement or notice of any kind shall be laid on the tables or put up in the club without the consent of the Active Committee. Any pamphlet which it may be wished to make known to the club, shall be sent to the committee for approval.

Two morning papers may be used in the coffee room.

Sandwiches, biscuits or other light refreshments may be served to members in the billiard, smoking and card rooms.

The foregoing regulations may be altered by a majority of the general committee at any meeting, notice of such alteration having been given at the previous meeting and communicated to each member of the committee, together with the date of the meeting for final disposal of the same.

VISITORS-LUNCHING OR DINING.

T

Gentlemen resident within the County of Halifax, may be admitted to lunch or dine as guests of members and any such guest shall have the privilege of the club house as long as his host remains. Provided, always, that the same person shall not be admitted to the club house more than twice in any one year. Members must enter the names of their guests in a book provided for that purpose. A member shall not invite more than two such guests (residents) on any one occasion. In all cases members will be held responsible for the conduct of their guests. In no case shall visitors make any gratuity to servants.

In order to avoid inconvenience in the coffee room, members giving a luncheon or dinner of over six persons, at which there are visitors, may be required to occupy the private Dining room.

Members shall not invite visitors as guests to dinners given in the name of the club, unless the consent of the subcommittee in charge of the dinner has first been obtained.

Members are expected to ascertain if their proposed guests are eligible, under these regulations, to lunch or dine at the club.

These privileges may be suspended by the committee at any time it may be considered advisable to do so.

PRIVATE DINING ROOM.

The Private Dining Room may be engaged by a party of not less than five, for their exclusive use, by giving notice to the manager on the morning of the day on which they may wish to lunch or dine; and on such terms as the committee may direct. The card room adjoining may also be secured, provided the party censist of not less than ten persons.

BILLIARD ROOM.

The following regulations will be in force in this room:—

- r. The game of Pool shall have choice of tables, (with the exception of the centre table, which shall be reserved for billiards) and take precedence over billiards and Pyramids, and may be played in consecutive games.
- 2. For billiards the tables can only be engaged for one game of fifty or one hundred points as intimated to the marker. Precedence in playing and choice of tables given according to entry of names on the marker's slate.

The charges will be as follows:-

LIFE POOL —Five cents per ball; stars to pay extra.

BLACK POOL—Fifty cents per hour for five players or less; over that number ten cents per ball. For every succeeding half-hour, five cents per ball.

BILLIARDS—Fifteen cents for a game of fifty; twenty-five cents for a game of one hundred points, or two consecutive games of fifty.

Pyramids—One cent per ball. Two consecutive games fifty cents

SNOOKER POOL—Twenty-five cents a game. Volunteer snooker fifty cents per hour.

OTHER GAMES-By the hour, fifty cents.

No games shall be commenced after 11.45, p. m.

CARDS.

No cards shall be sold for use in the house, but each player shall pay fifteen cents per day. Second-hand cards for use out of the house can be purchased from the Hall Porter for 10 cents per pack.

No rubber shall be commenced after 11.30 o'clock, p. m.

SMOKING.

Smoking is permitted in all the rooms, except that in the coffee room it shall be permitted only after Table d'Hote or other special dinners.

ENTRANCE HALL.

No large articles of baggage belonging to a member will be admitted into the hall. Bags or portmanteaus sent by members wishing to dress, will be conveyed to the dressing room.
