### MEETINGS.

The Meetings of the Committee of Management are held on the second Monday in every month.

The meetings of the Sub-Committee of Charity are held weekly.

# REPORT

OF THE

## COMMITTEE OF MANAGEMENT

TO THE MEMBERS OF THE SOCIETY

FOR THE YEAR 1876.

---

The Committee of Management have the honor to lay before the members the forty-first Annual Report.

Although the dulness in commercial and industrial affairs has, throughout the year, had its natural effect in sending before our Society a large number of cases of distress—some of them very sad—yet the number has not been so great as during the previous year, nor has the amount expended been as large.

We have relieved 89 cases comprising about 120 persons in all.

The total amount expended in charity is \$766.55 details of which will be found in the Report of the Sub-Committee of Charity.

The Treasurer's Report shows the financial condition of the Society.

Your committee desire to bring under the notice of the members the great advantage which would result to the Society if donations of cast-off clothing were made from time to time.

The sub committee of charity report that a sum of about \$50 has been disbursed in the purchase of clothing alone. If members, or others desirous of aiding us, having cast-off clothing to give away would notify any of the officers of the Society arrangements would be made to send for it.

Your committee regret to state that our membership Roll has not been increased during the year, and they would urge upon the members the desirability of endeavouring to

augment their numbers, thereby increasing the usefulness of the Society. One ordinary member has elected to become a Life member.

Our anniversary service was held in the Cathedral on the Eve of St. George's day (St. George's day falling on Sunday) when an excellent sermon was preached by the Revd. M. M. Fothergill; the Revd. G. V. Housman; M. A. and Revd. C. W. Rawson, M. A., assisting in the service. The musical portion of the service was conducted by Mr. Ed. A. Bishop, to whom the Society is much indebted: we have also to thank the Ladies and Gentlemen of the Cathedral Choir and others who kindly lent their aid on the occasion.

The offertory in aid of the society's charitable fund amounted to \$74.25.

Our arrangements with the Finlay Asylum and Ladies' Protestant Home continue to give satisfaction, and our thanks are due to the officers of both these institutions for their ever ready and willing help to forward our interests.

Our acknowledgments are also due to the Quebec and Gulf Ports Steamship Company and Richelieu and Ontario Navigation Company for kindly reducing the fares for those passengers we have had occasion to send them.

To R. H. Russell, Esq., we owe many thanks for his cheerful and kind assistance in various ways, especially in obtaining opportunities for men who were anxious to return home and willing to work their passage. We are also indebted to the Deputy Shipping Master for similar favours.

Our thanks are due to our Physician for gratuitous services and also to our Clergy for their valuable aid.

There have been no interments in our lot at Mount Hermon this year.

The Society deplores the death of James G. Colston, Esq., Q. C., L. L. D. He was a member of the Committee of Management for some years and always took a lively and active interest in the affairs of the Society.

In conclusion your Committee would bring under your notice the number of undeserving *tramps* who are continually



travelling from place to place and appealing to the various Charitable Societies with plausible stories which it is impossible to disprove—and they would suggest for the consideration of their successors in office whether some means cannot be devised to lessen this evil.

SUB-COMMITTEE OF CHARITY  
TO THE COMMITTEE OF MANAGEMENT  
FOR THE YEAR 1876.

The Sub-Committee of Charity have the honor to report  
as follows :—

Relief has been extended to eighty-nine cases of distress,  
comprising one hundred and twenty persons ; 73 men 27  
women and incidentally 20 children.

The amount expended by the Sub-Committee in charity  
is \$666.55, distributed as follows :

Of those partially assisted to return Home two were single men, and the others were families of 3, 5, 7, and 3, respectively; all were deserving cases.

It is worthy of note that the above expenditure includes some \$50 or over for clothing which had to be purchased for individuals completely destitute, about to cross the Atlantic, &c.

R. H. Russell, Esq., shipping master, kindly found opportunities for six of the above to work their passages home, the Society providing them with clothing and other necessities. These were *able-bodied* individuals temporarily without employment, whom we make it a rule never to send Home at the Society's expense. The Deputy Shipping Master, Mr. Miller, has also been very obliging in rendering assistance in the same direction.

A mother and her two children were accommodated for a time in the Ladies' Protestant Home, where every care and attention possible were shown them.

The Richelieu and Ontario Navigation Company, and the Quebec and Gulf Ports S. S. Company have kindly favoured us in the usual way.

Our physician has cheerfully rendered professional aid, and our chaplains have earnestly assisted this Committee in its efforts to alleviate distress. The Rev. J. S. Sykes, Port Chaplain, has also done good service in this way.



As in past years your Sub-Committee have found their chief difficulty in distinguishing between deserving and undeserving cases, and in guarding against the class of vagrants, or *tramps*, who travel over the Country preying upon our charitable organizations.

Crystal Palace, which made him favorably known to the American people. He visited Quebec also at that time, and was the guest of the Earl of Elgin. He expired at Bridgewater house, St James, on Wednesday, the 18th March, 1857. The deceased was born on the first January, 1800.

Georg Germain Ardouin, born at Quebec. 16th January, 1824. Died in Quebec, 23rd February, 1857, at the age of 27 years.

William Dupont, native of London, England. Died at Three-Rivers, 5th November, 1857, at the age of 58 years.

Robert Roberts, born in 1797, at Halh'n, North Wales, came to Canada, 1819. Died at Quebec 2nd July, 1858, at the age of 61 years.

Zaccheus Williams, born at Bangor, North Wales, 12th July, 1797. Died at Quebec, 19th November, 1858, at the age of 61 years.

John Robert Nathaniel Symes, Justice of the Peace, (senior Life Member of the Society), born at Camberwell, Surrey, 6th Jan'y, 1794. Came to Quebec, 22nd May, 1816. Died suddenly at the residence of his son, Dr. T. Fargues Symes, coroner, Meaford, C. W., 10th December, 1858 at the age of 64 years. Was treasurer from the formation of the Society for sixteen years consecutively. The Society has erected a monument to his memory in the Cathedral.

John Shaw, born at Davenport, England. 27 October, 1811, came to Canada, July 6, 1833. Died at Quebec, 8th July, 1859.

I. R. Eckart, born at Quebec, 16th March 1805. Died by accidental drowning at Lake St. Charles, near Quebec, July, 1859.

Wm Dawson, born in Sunderland, England, 1786, elected a member of the Society in 1837. Died at Quebec, May, 1859.

Francis B. Noad, born at Quebec. Died at Montreal, 18th February, 1860, aged 39 years.

W. W. Wheeler, native of England. Died at Quebec, 20th November, 1860, aged 45 years.

Henry Lemesurier, Justice of the Peace, born at Guernsey. Died at Quebec, 25th May, 1861, aged 69 years.

James Taylor, born in Northumberland. Died at Quebec, 15th November 1861, aged 46 years.

The Right Revd. George Jehosaphat Mountain, D.D., D.C.L., Lord Bishop of Quebec, was the second son of Bishop Jacob Mountain, the first Anglican bishop of Quebec. He was born 27th July, 1789, at Norwich, England, came to Canada with his father, 1703, and died after a brief illness at Bardfield, his country seat, on 5th Jan'y, 1863. He was nineteen years Rector of Quebec, and was consecrated Bishop 14th February, 1836. He was a diligent visitor among his flock, and in the dreadful visitations of cholera in 1832 and 1834, he literally lived night and day among the dying and the dead, while in 1847, when the province was visited with the plague of typhus fever, and the poor emigrants were dying by thousands at the Quarantine station, the Bishop took his turn at Grosse Isle regularly with the rest of the clergy; and again when the cholera visited Quebec, in 1849 and 1854, he was diligent in visiting the hospitals. During many years and up to the time of his death, Bishop Mountain, besides his Life membership, contributed regularly to the Society a donation equal to four annual subscriptions, and at all times took a great interest in its proceedings.

John Jameson, born at South Shields, Durham, 1785. Died at Quebec, May, 1863.

G. B. Symes, born in Quebec. Died at Montreal, 12th June, 1863.

Bernard Thompson, born at Peckham, Surrey, England, Died at Quebec, 18th January, 1863.

Henry Jessop, born in England, many years Collector of Imperial Customs at Quebec, Died in England, 1863.



Horatio Nelson Patton, born at Málthamstone, Essex, 9th January, 1806, came to Canada, 2nd May, 1823. Died at South Quebec, 1864.

Henry Atkinson, born at Stokwell, Surrey, came to Canada in May, 1809. Died in England, 1866.

Samuel Newton, native of England, a most zealous member of the Society. Died at Quebec, 1866.

J. Taylor, native of England, died at Quebec, 1865.

William Smith Sewell, Sheriff of Quebec, son of the late Chief Justice Sewell, died at Quebec, 1866.

William Hunt, a native of England, died at his residence in Quebec, 1866.

James Bankier, a native of Newcastle, died at Quebec, 5th May, 1866, aged 65 years.

Edward Poston, a native of Shropshire, died at Quebec, September, 1866, aged 56 years.

Horatio S. Anderson, a native of Quebec, died at Quebec, 28th May 1867, aged 53 years. He was Vice-President of the Society for two years.

The Hon. William Sheppard, a native of Cornwall. Died at Three Rivers, 1st July, 1867, aged 64 years.

George Fitch, a native of Essex. Died at Quebec, 11th August, 1867, aged 70 years; for three years Vice-President, and for many years Secretary of the Charitable Committee.

Noah Freer, born in London, 1783. Died at Montreal, 2nd January, 1869, aged 86 years.

Wm. B. Vallean, born in New Jersey, U. S. Died at Quebec, on 22nd August, 1868, aged 46 years.

Henry Knight, born at Exmouth Devon, 19th October, 1814, came to Canada, 1842. Died at Quebec, 21st August, 1869.

William Hadly Anderson, a native of Quebec. Died at Cheltenham, England, on the 9th December, 1869, aged 70 years. He was one of the original members of the Society and President for two years.

Henry John Noad, born in England. Died at Montreal, 18th August, 1870, aged 58 years. One of the original members and twice Vice-President.

Joseph White, a native of London. Died in London, 10th November, 1870, aged 43 years. He was President of the Society for two years.

Henry Le Mesurier, a native of Quebec. Died at Quebec on the 8th January, 1871, aged 52 years.

William Poston, born in Withchurch, Shropshire, England. Died at Quebec on the 1st June, 1871, aged 59 years.

John Broster, born in Liverpool. Died at Three Rivers 26th July, 1871.

The Hon. Thomas Cushing Aylwin, one of the judges of the Queen's Bench for Lower Canada, a native of Quebec. Died at Montreal, 14th October, 1871, aged 66 years.

Edward Burstall, a native of Hull. Died at London, England, 24th November, 1871, aged 58 years.

Charles Sharples, born at Liverpool, 1818, came to Canada, 1843. Died at his residence, "Broadgreen," Quebec, on 31st January, 1872, at the 54th year of his age.

Joseph Auld, born at Chesterfield, Derbyshire, 1812, came to Canada 1833. Died at Quebec, 1st August, 1872, aged 60 years.

Rev. George Mackie, D. D., eldest son of the late Major General Mackie, C. B., became a member of this Society in 1842, was elected Chaplain in 1843, and held this office until his departure from Quebec. 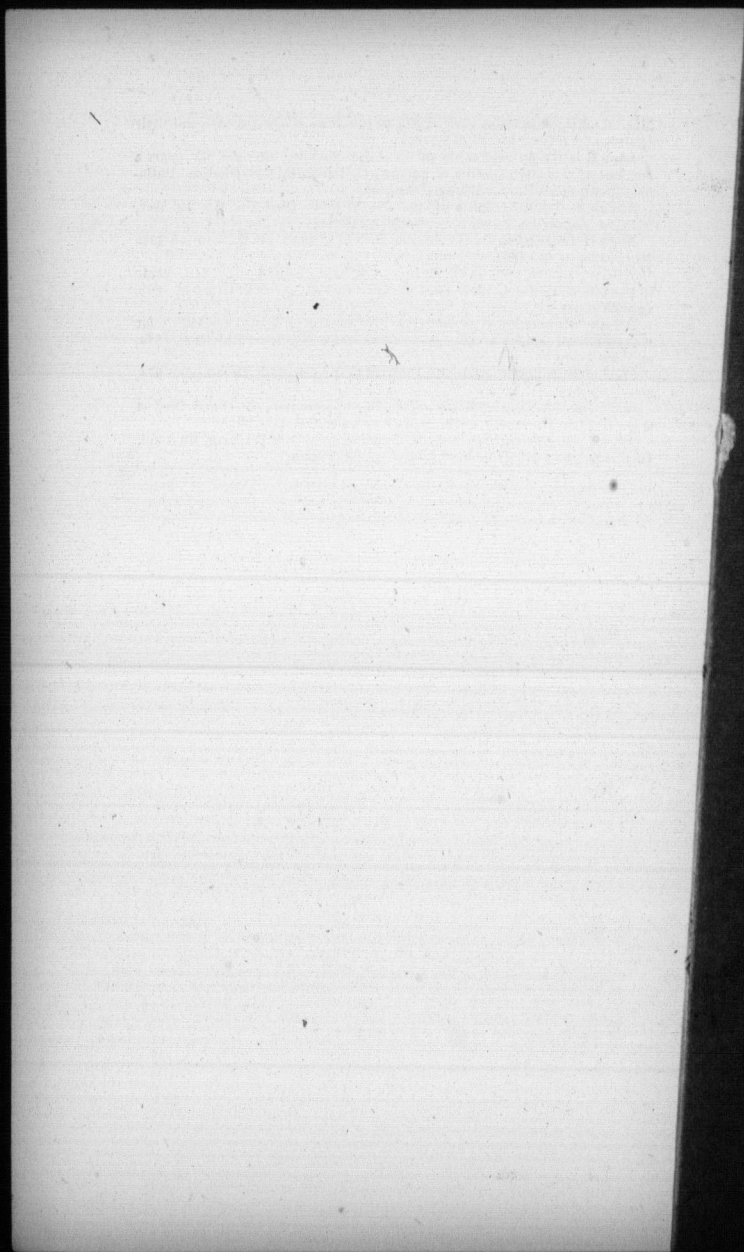
