An Act to amend the Assessment Law of Upper Canada, so as to enable County Councils to sell unimproved Lands of non-residents two years in arrears for Taxes.

TO diminish the evils arising from the holding of tracts of unimproved Lands in Upper Canada, by non-residents.

Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:—

5 The 123rd section of the Act respecting the Assessment of property in Upper Canada, shall not after the passing of this Act, apply to un-^{Certain sec-}tions of the improved or unoccupied lands of non-residents, with respect to which a U. C. Assess-^{ment Act not} By-law shall be passed under this Act; and, notwithstanding any thing to apply to in the said section or in the 124th or 127th sections, or in any other ^{the unimprov'd} part of the said Act, the Council of the County may by By-law direct ^{lands of non-}residents. that a warrant shall issue from the Treasurer of the County to the Sheriff, commanding him to levy upon any unimproved or unoccupied lands of non-residents, whenever a portion of the tax on any such lands ^{Provision for} has been due for two years, or for such longer period or for such amount ^{levying taxes} 15 as such By-law shall prescribe. ^{on unimprov'd lands of non-residents.}
