Canadian-West
Land Regulations

The sole head of a family over 18 years old, who was at the commencement of the present war, and who has since continued to be a British subject or a subject of an allied or neutral country, may homestead a quarter section of available Dominion Land in Manitoba, Saskatchewan or Alberta applicant must appear in person at the Dominion Lands Agency Office in the District. Entry by proxy may be made on certain conditions. Duties—Six months residence upon and cultivation of land in each of three years. In certain districts a homesteaded may secure an adjoining quarter section as a pre-emption. Price \$3.00 per acre. Duties—Reside six months in each of three years after earning homesteaded and cultivate 10 extra acres. May obtain pre-emption patent as soon as homesteaded patent on certain conditions.

A settler after obtaining homesteaded patent, if he cannot secure a pre-emption, may take a purchased homesteaded in certain districts. Price \$3.00 per acre. Must reside six months in each of three years, cultivate 50 acres and a horse worth \$300.00.

When Dominion Lands are very tired or posted for entry, return of settlers who have earned pre-emption and have been honorably discharged, receive one day priority in applying for entry at local Agency's Office (not Sub-Agency). Discharge papers must be presented to Agent.

Holders of entries may count time of employment as farm laborers in Canada during 1917, as residence duties under certain conditions.

AT THE FEDERAL CAPITAL

Hon. Prime Minister paid a fitting tribute of respect to the memory of each of the deceased members. The Leader of the Opposition, Hon. W. L. MacKenzie King, followed, and joined the Prime Minister in the tribute of respect and regret to the memory of the departed members of the House. The debate on the Address in reply to the speech from the throne was then taken up. The address was moved by Mr. James McIsaac (Kings, P. E. I.), and seconded by Mr. John A. McKelvie (Yale, B. C.) It is a curious fact that both the mover and seconder are newspaper men, and that they come from the extreme east and west side of the Dominion, respectively. The debate was continued by the Leader of the Opposition and then by the Prime Minister in the usual way. Both mover and seconder were highly complimented on the manner in which they had acquitted themselves in the discharge of the important duty entrusted to them.

In complimenting the mover of the address (Mr. McIsaac) the Right Hon. Prime Minister said: "That he had not only done credit to himself and his Province, but had contributed to the debate a literary charm, that constitutes to the present point, at least, one of its main excellences."

The Leader of the Opposition, in reference to the mover, said: "That his speech was very creditable to himself and to the Island, was, I think, the highest compliment that could be paid him."

In accordance with the usual procedure, the Leader of the Opposition followed, in the debate on the address in reply to the speech from the throne, after the mover and seconder. After a few preliminary remarks, congratulating the mover and seconder, etc., the Leader of the Opposition immediately started in to berate the Government and to endeavor to show that they had no mandate to carry on, and that they should ask for a resolution, in order that a new Parliament might be elected. In the course of two hours of talk, he advanced no argument to buoy up the position he took. The greater part of what he said was but a repetition of what he has been saying in about every speech he has made since he came to the present Parliament. No doubt it might be very desirable on the part of Mr. King to have a new Parliament, provided there would be sufficient members to support himself and his party to carry on the public business; but a great many things have to be considered before such an eventuality as that, and the Leader of the Opposition, during his tirade, absolutely failed to impress upon the House any conviction at all that he was standing on tenable ground. The whole idea was to bring about non-confidence in the Government. No doubt, that is a legitimate course for the Leader of any Opposition to pursue, but in order to advance such a proposition as that, it would be expected that a leader of a party would present some, at least apparent, reasonable and substantial argument to back up such a demand; but throughout his two hours speech, Mr. King absolutely failed to do this, and at the end of his long tirade, moved a simple bald amendment to the address in reply to the speech, and in a blunt and unsophisticated manner, placed on record his desire for the defeat of the Government. His proposition was that to the end of the address be added these words: "We respectfully submit to Your Excellency that Your Excellency's present advisors do not

possess the confidence of this House or of this country, and that their retention of office constitutes a usurpation of the powers of popular government." It was within a few minutes of six o'clock when the Leader of the Opposition concluded his remarks. The Prime Minister then rose and in the few moments that intervened before six o'clock simply complimented the mover and seconder of the address on the excellent manner in which they had discharged the duty devolving upon them. When the House reconvened at eight o'clock, the Right Hon. Mr. Meighen resumed his speech. It did not take him very long to expose the hollow and unimpressiveness of the address of the Leader of the Opposition. As a matter of fact, the task of the Prime Minister, in his first parliamentary address since his accession to the leadership, was not beset with any difficulties. There was nothing in the singularly unimpressive speech of the Leader of the Opposition that required any serious answer. The Leader of the Opposition had not accused the Government of any serious misdemeanour, or sins of commission or omission, or made any charge against their capacity or integrity. He had simply made an assertion that the Government had no right to office, and without backing up his assertion by any substantial evidence, simply asked Parliament to vote it out of power. His analysis of the speech of the Leader of the Opposition, his merciless logic and his great powers of debate were most devastating in their effects upon the remarks of Mr. King. He characterized the amendment of the Leader of the Opposition as an attempt, not so much to throw an issue into Parliament as to see that Parliament did not get an issue at all. He went on to show that Mr. King's overdrawn picture of the ministry usurping the powers of the popular government as an "unparalleled exaggeration."

Referring further to the charges of the Leader of the Opposition as to why the Government continued to carry on the public business the Prime Minister said they did so by the right of the confidence of the majority of Parliament, elected by the majority of the people. Mr. King had endeavored to show that the Government had no constitutional mandate to continue in office, but the Premier quoted numerous precedents, from both British and Canadian parliamentary history, to show that a change of premiership and ministry did not by any means necessitate an appeal to the people. He adroitly turned the Opposition Leader's contention against himself by pointing out that while he was now protesting that the ministry had no right to deal with the tariff, Mr. King had last year moved an amendment condemning the ministry for not dealing with the tariff. "As a matter of fact," said the Prime Minister, "the Government, notwithstanding the unsupported assertions from Mr. King had been carrying on all phases of public business, including the tariff, at every session since the war had come to a close." It was a remarkable fact, that notwithstanding the attempt of Mr. King at the very first stage of the session to bring before the House something for which both Liberals and Agrarians could vote; so little effect did the ingenious attempt have upon the members that the Leader of the Government was not even called upon to defend the ministry's record. After all the criticism and complaints that the Leader of the Opposition, and some of his friends would endeavor to conjure up, this certainly was a spectacle that challenged reflection. The Prime Minister was enthusiastically applauded during his admirable speech, and at its close received an ovation.

Died of Pneumonia

Deep sympathy will go out to Mr. James P. Duffy, the well-known Queen Street grocer, in the sad bereavement which has suddenly come to him by the death of his son Elmer, a bright youth of eighteen years who died last Sunday after only a short illness. The deceased who had been attending St. Dunstan's University was brought home from that Institution on Thursday last ill with what proved to be the dread malady, pneumonia. Notwithstanding all that was done in the way of medical treatment and tender care his condition grew worse until death brought this bright young life to a close. The deceased, it is needless to say will be sorely missed at home and in the college as well, for he was quite a favorite and took an active part in all those games such as baseball and hockey in which every normal boy delights. Besides his father there are left to mourn one brother and sister to whom the sincere sympathy of all will be extended.

Rules Relating to Private Bills. 36 All petitions for Private Bills must be presented within fourteen days after the commencement of the session exclusive of adjournment.

37 No Private Bill shall be brought into the House, but upon a petition first presented, truly stating the case at the peril of the suitors for such Bill, and such petition must be signed by the said parties.

38 A committee shall be appointed at the commencement of every Session consisting of five members of whom three shall be a quorum, to be designated upon any person or persons whom shall be referred every Private Bill, and no proceedings after the first reading shall be had upon such Bill until such Committee has reported thereon to the House.

39 So soon as the Committee has reported any Bill, such Bill together with any amendments that may be suggested by the Committee, shall be printed at the expense of the parties who are suitors for such Bill and printed copies thereof delivered to the members before the second reading if deemed necessary by the Committee.

40 No Bill for the particular interest of any person or persons, Corporation or Corporations or body or bodies of people shall be read a second time until all fees be paid for the same into the hands of the Clerk of the House

41 No Bill having for its object the vesting in or conferring upon any person or persons, Municipality or Body corporate the title to any tract of land shall be received or read in the House unless at least four weeks notice containing a full description of the land in question has been published in the Royal Gazette and one other newspaper in this Province of the intention of such person or persons Municipality or Body Corporate to apply for such Bill. The sole head of a family of 12 years over 18 years old, who was at the commencement of the present war and who has since continued to be a British subject or a subject of an allied or neutral country, may homestead a quarter section of available Dominion Land in Manitoba, Saskatchewan or Alberta.

applicant must appear in person at Dominion Lands Agency or Sub-Agency in District. Entry by proxy may be made on certain conditions. District—six months residence upon and cultivation of land in each of three years. In certain districts a homesteader may secure an adjoining quarter-section on a pre-emption. Price \$3.00 per acre. District—Reside six months in each of three years after earning homestead on rent and cultivate 50 extra acres. May obtain pre-emption patent as soon as homestead patent on certain conditions.

A settler after obtaining homestead patent, if he cannot secure a pre-emption, may take a purchased homestead in certain districts. Price \$3.00 per acre. Must reside six months in each of three years, cultivate 50 acres and a house worth \$200.00.
