

Soon after my return to DEA as DMT, I was pleased to review this, the third trade tracking reporting system report which was produced from your quarterly submissions for the first quarter of this FY. The information in these reports provides me and my colleagues in senior management an important insight into your activities and workload on a worldwide basis. As well as being an internal management tool, the trade tracking system will give the department far greater facility to keep other government departments, the provinces and the private sector abreast of our activities on a more current basis than has previously been the case. I would like to stress the importance of maintaining and improving the quality and accuracy of the trade tracking system reports towards which end the majority of missions have made considerable progress.

In response to previous departmental requests for views on the trade tracking system, a number of missions and headquarter's bureaux have made suggestions for changes and these suggestions have led to modifications to the format of the trade tracking system which will be integrated with the new Export and Investment Promotion Planning and Tracking System. This will replace the trade and industrial development component of the post operational plan to be prepared by all posts this fall. For the rest of this fiscal year we will continue to use the current trade tracking system format because the new format has been designed to be linked directly with the planning system.

I would remind you that the department's ability to monitor progress and measure results and workload is of critical importance now and for the foreseeable future. I consider the trade tracking system to be an important source of continuing operational information and the attention you pay to its preparation will have a direct bearing on the accuracy of the information it is ultimately able to provide me.



Peu après mon retour au MAE en qualité de DMT, j'ai été heureux de prendre connaissance du troisième rapport du Système de suivi des résultats commerciaux, qui a été produit à partir des rapports que vous avez présentés pour le premier trimestre du présent exercice. Ces rapports nous fournissent, à moi-même et à mes collègues de la haute direction, des données importantes sur vos activités et votre charge de travail à l'échelle mondiale. Tout en étant un outil de gestion interne, le Système de suivi des résultats commerciaux permettra au Ministère de fournir plus facilement aux autres ministères, aux provinces et au secteur privé des renseignements plus récents sur nos activités. Permettez-moi de souligner l'importance de tenir à jour et d'améliorer la qualité et l'exactitude des rapports établis dans le cadre du Système. D'ailleurs, la majorité des missions ont déjà fait des progrès considérables en vue de la réalisation de cet objectif.

A la demande du Ministère, des missions et de directions générales ont proposé des changements qui nous ont amenés à apporter à la présentation du Système de suivi des résultats commerciaux des modifications qui se reflèteront dans le nouveau Système de planification et de suivi pour la promotion des exportations et des investissements. Ce nouveau Système remplacera la composante "expansion commerciale et industrielle" du plan opérationnel que toutes les missions doivent établir cet automne. Jusqu'à la fin du présent exercice, nous continuerons d'utiliser l'actuel Système de suivi des résultats commerciaux, car la nouvelle présentation a été conçue de façon à se rapporter directement au système de planification.

Je voudrais vous rappeler que la capacité du Ministère de surveiller les progrès accomplis et de mesurer les résultats et la charge de travail est d'une importance critique à l'heure actuelle et le restera dans le proche avenir. J'estime que le Système de suivi est une source importante de données opérationnelles à jour et que l'attention que vous prêterez à l'établissement des rapports aura une portée directe sur l'exactitude des informations qu'il me permettra finalement d'obtenir.

Trade Tracking System Format

In seeking clarifications related to the completion of the trade tracking system, missions are reminded to review the original instruction book as well as the forecast Personnel Utilization Plan of the FY 86/87 post operations plan. One point of concern raised by some missions relates to the accounting of time spent on economic reporting. In those missions where economic reporting is part of the assigned "package" of the Trade and Industrial Development program manager, those activities would normally be allocated to "other trade development activities". Where economic reporting is normally performed by other programs at the mission but where there is significant contribution from the TID program, this contribution could be allocated to service to External Affairs or other government departments depending upon the client of such reports. The "new" trade tracking system format will eliminate this lack of precision. Time accounted for "other programs" should be restricted to direct participation in other post programs e.g. consular, general relations, etc.

Trade Program managers should ensure that multiple counting of any one event does not occur (3 post officers may attend a particular trade fair; however, that should be recorded as 1 event).

Dollar values shown for "new business connections" are considered potential and hence not included in any totals unless the "export sale agreement" box is also marked.

Business visitors need not necessarily be physically on a mission's premises to be tallied. You could count those who have made contact with the mission from its territory (e.g. telephone calls, registration at post exhibits, etc.). The governing factor on deciding whether to count such a contact or not is to decide if the caller requested and received a level of service normally given in an office visit.

Présentation du Système de suivi des résultats commerciaux

Nous rappelons aux missions qui ont besoin d'éclaircissements pour remplir les formulaires du Système de suivi des résultats commerciaux de revoir le premier guide ainsi que le plan d'utilisation de l'effectif pour les opérations de la mission au cours de l'exercice 1986-1987. L'un des points soulevés par certaines missions concerne la comptabilisation du temps consacré à la préparation de rapports économiques. Dans les missions où cette fonction est assumée par le gestionnaire du Programme commercial, elle serait normalement rapportée sous la rubrique "Autres activités d'expansion commerciale". Lorsque les rapports économiques sont habituellement établis par les responsables d'autres programmes de la mission, mais que le gestionnaire du Programme commercial y contribue de façon importante, sa contribution pourrait figurer sous la rubrique des services offerts aux Affaires extérieures ou à d'autres ministères, en fonction du client pour le compte duquel ils sont établis. Le nouveau Système de suivi permettra d'éliminer cette imprécision. Le temps comptabilisé pour les "autres programmes" devrait se limiter à la participation directe à d'autres programmes de la mission concernant les affaires consulaires, les relations générales, etc.

Les gestionnaires du Programme commercial doivent veiller à ce qu'un événement ne soit pas comptabilisé plusieurs fois; par exemple, une foire commerciale à laquelle participent trois agents doit être comptée comme un seul événement.

Les montants en dollars qui correspondent aux "nouveaux contacts" sont considérés comme "potentiels" et ne doivent être inclus dans aucun total, à moins que la case "Accord d'exportation" n'ait été cochée.

Les visites de gens d'affaires comptabilisées ne sont pas forcément des visites à la mission même. Il peut s'agir de contacts pris avec la mission dans le territoire de cette dernière (p. ex. appels téléphoniques ou inscriptions à des foires organisées par la mission). Il faut surtout considérer si la personne qui a appelé a demandé et reçu un service qui lui aurait été normalement fourni si elle s'était présentée au bureau de la mission.

INTRODUCTION

This is the third quarterly report of Trade and Industrial Development Program results and activity. It covers the period April through June 1986 and contains information drawn from the TID Program Tracking System. The report is based on the returns that were available up to August 15, 1986, from a total of eighty-seven missions in all five major regions abroad.

There are two main sections to this report:

Section I, immediately following, consists of six program results summaries; one for each major region and one for "All Regions", i.e. a global summary. Each page summarizes for its respective region: the business activity reported and highlights of that activity; key statistics on trade and investment enquiries; and the number of business visitors. Data in this section referring to the previous quarter has been updated to include reports received after publication of the January-March 1986 Quarterly Results and Activity Report.

Section II contains an "Activity Report" for each region, its respective sub-regions and posts. The format of these reports is identical throughout this section, regardless of the level of geographic aggregation. "Activity" on these reports is broken into TID program activity (items A-G) and activity relating to other mission programs (item H). For each activity there is an indication of the average time spent by Canada-based and locally-engaged trade program and non-trade program officers. There is also a "total time allocation" for each activity which should be read as an indicator of program officer person-years. Finally, each report indicates workload by activity.

INTRODUCTION

Le présent document constitue le troisième rapport trimestriel des résultats et activités du Programme commercial. Il couvre la période d'avril à juin 1986 et contient des renseignements tirés du Système de suivi des résultats commerciaux. Il a été établi d'après les rapports présentés, au 15 août 1986, par quatre-vingt-sept missions réparties dans les cinq grandes régions du monde.

Le rapport se divise en deux grandes sections:

La section I, qui suit, comprend les résumés des résultats de six programmes; soit un résumé pour chaque grande région et un pour "toutes les régions", c'est-à-dire un résumé mondial. Pour chaque région, le résumé présente les activités commerciales et leurs points saillants, des statistiques clés sur les demandes de renseignements relatives au commerce et aux investissements et le nombre de visites de gens d'affaires. Les données de cette section qui se rapportent au trimestre précédant ont été mises à jour de façon à tenir compte des rapports reçus après la publication du rapport trimestriel des activités et des résultats de janvier à mars 1986.

La section II renferme un "Rapport d'activités" pour chaque région et ses sous-régions et missions respectives. Dans toute cette section, tous les rapports sont présentés de la même façon, quel que soit le regroupement géographique effectué. Les "activités" sont subdivisées en activités du Programme commercial (article A à G) et activités se rapportant à d'autres programmes de la mission (article H). Pour chaque activité, on a indiqué le temps moyen consacré par les agents canadiens et les agents recrutés sur place chargés du programme commercial et d'autres programmes. Il y a également pour chaque activité une rubrique "Total du temps consacré", qui doit être considéré comme un indice du nombre d'années-personnes relatif aux agents de programme. Enfin, chaque rapport indique la charge de travail par activité.
