ANNUAL REPORT
OF THE
COMMITTEE OF MANAGEMENT
OF THE
ST. GEORGE'S SOCIETY.

The Committee of Management at the close of their term of office, beg to report :—

That the permanent fund at the credit of the Society has this year reached the sum of £1500, affording a gratifying guarantee for the continuance of the useful labors of the Society, and increasing the means at the disposal of its officers for relieving their distressed countrymen.

On the Anniversary, divine service was held in the Cathedral, for the second time in the Evening, when a numerous congregation attended. The Lord Bishop of the Diocese preached on the occasion, prayers having been offered by the Rev. G. V. Housman, and the lessons read by the Rev. A. W. Mauptain. The voluntary choir conducted by Henry Carter, Esq., executed the musical portion of the service (though at a great disadvantage, the organ being under repair,) in their usual superior manner. The charitable fund was augmented by the amount of \$86.05, collected after the Sermon.

The much desired visit of the Prince of Wales, afforded the Society an opportunity of renewing the expression of the attachment of its Members to Her Majesty's person and government: and the presence of our future sovereign was hailed by none with greater delight or more cordial affection, than by the countrymen of His Royal Highness. The occasion having led to the revival of the vexed question of the order of precedence which should be adopted on public occasions by the National Societies, steps were subsequently taken which we trust will very shortly lead to results satisfactory to all parties.

The Sub-Committee of Charity have this year expended the sum of \$375.39, towards the relief of 170 applicants, and could have extended their good work towards the close of the season, had the funds (only recently augmented by the receipt of a Bank dividend) enabled them to do so. By the increased amount hereafter to accrue in the shape of interest from the Permanent Fund, your Charitable Committee will for the future be in a better position to carry out their work and labor of love. The amount now in the hands of the treasurer and available for charitable purposes, after payment of the expenses of the year, (which, in consequence of the Royal visit above alluded to, have necessarily been much larger than usual) is \$265.71.

The roll of the Society has had added to it during the year, the names of four Ordinary Members, while three Ordinary Members have become Life Members. The Committee would desire here to impress upon all Ordinary Members now on the roll, or to be hereafter elected, the great advantage which would result not only to themselves, but to the Society, by their at once becoming "Life Members," the premium for which is now reduced to the lowest possible figure—£5.

The Committee regret to state that death has deprived the Society of two Life Members during the year, namely: Mr. Francis Noad, who died at Montreal, and Mr. W. W. Wheeler, who died at Quebec. Mr. W. Ginger, also of Quebec, recently deceased, was one of the Original Members of the Society.

The Right Honorable John George, Earl of Durham, G. C. B., Patron. Died at Cowes, Isle of Wight, 28th July, 1840, at the age of 48 years.

The Right Honorable Lord Sydenham, G. C. B. Died at Kingston, C. W., September 1841, at the age of 42 years.

The Right Honorable Sir Charles Bagot, G. C. B. Died at Kingston, C. W., 18th May 1843, at the age of 62 years.

William Kemble, past President. Died at Quebec, 5th March 1845, at the age of 64 years.

Charles Gibb Gortley. Died at Dartmouth, 24th March 1846, at the age of 35 years.

Froste Ralph Grey. Died at Quebec, 11th April 1846, at the age of 38 years.

James John Lowndes. Died at St. Foy near Quebec, 23rd July 1846, at the age of 45 years.

The Right Honorable Lord Metcalfe, G. C. B., Patron. Died at his seat near Basingstoke, Hants, 5th September 1846, at the age of 62 years.

John Jeffrey. Died at Quebec, 13th December 1846, at the age of 62 years.

Anthony Anderson, born at Eldwyn, Northumberland, 1768. Died at Hedley Lodge, Quebec, 3rd of April 1847, at the age of 80 years.

John Racey M. D. E., one of the Physicians to the Society. Died at Quebec, 25th October 1847, at the age of 39 years.

William Phillips. Died at Quebec, 4th April 1849, at the age of 59 years.

John Charlton Fisher, LL.D., past President. Died on Steamer "Sarah Sands" on her passage from Liverpool to New York, on the 10th August, 1849, at the age 55 years.

Abraham Lenfesty, born at Guernsey, 1810. Died at Quebec, 13th July, 1849, at the age of 40 years.

Thomas Yates. Died at Quebec, 13th July, 1849, at the age of 62 years.

William Benjamin Poston. Died at San Francisco, 13th October, 1850, at the age of 25 years.

William John Chapman Benson, native of Stepney, London. Died at Whitehall, U. S., 3rd December, 1850, at the age of 33 years.

Peter Paterson, native of Whitby, Yorkshire. Died at his residence, Montmorency Falls, 12th June 1851, at the age of 83 years.

Stephen Codman, native of the City of Norwich, England, came to Canada, in 1816, as organist to the Cathedral. Died at Quebec, 6th October, 1852, at the age of 56 years. The congregation have erected a tablet to his memory in the Cathedral Church.

William Patton, born at Low Leyton, Essex, London, 26th July, 1798 came to Canada, 16th June, 1819; seven years President of St. George's Society. Died at Quebec, 14th August, 1853, at the age of 55 years.

Charles Poston, born at Whitechurch, Shropshire, 3rd October, 1788; came to Canada, 23rd May, 1815; past President. Died in England, 5th April, 1853.

Peter Sheppard, native of Guernsey, came to Canada, in 1809. Died at Quebec, 23rd August, 1856, at the age of 63 years.

John Racey, Senior, native of Bath, came to Quebec in 1801. Died in England, in 1856, at the age of 73 years.

The Earl of Ellesmere, K. G., visited the United States in 1854, as one of the Queen's Commissioners to attend the opening of the New York Crystal Palace, which made him favorably known to the American people. He visited Quebec also at that time, and was the guest of the Earl of Elgin. He expired at Bridgewater House, St. James, on Wednesday, the 18th March 1857. The deceased was born on the 1st Jan., 1800.

George Germain Ardouin, born at Quebec, 16th January, 1824. Died in Quebec, 23rd February, 1857, at the age of 37.
