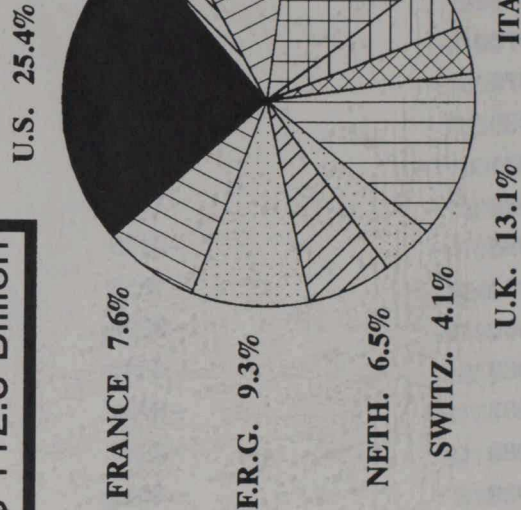

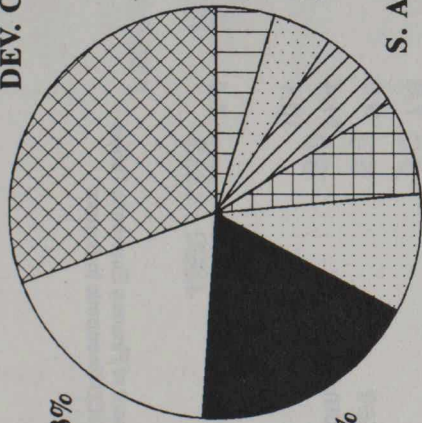

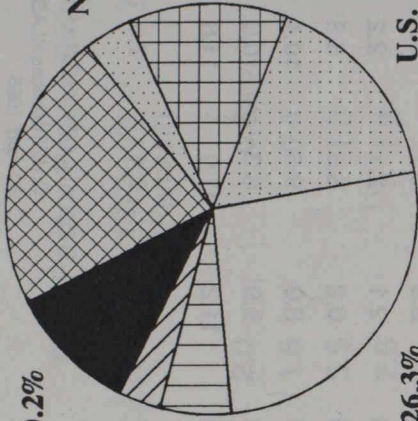

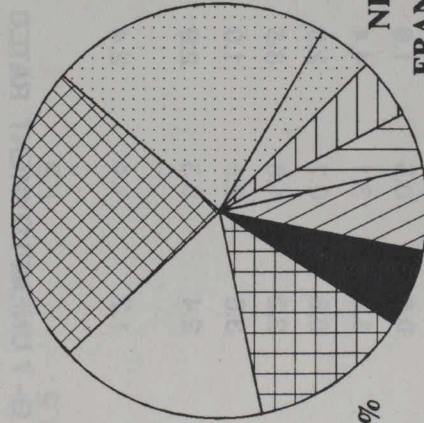

Stock mondial des Investissements directs à l'étranger

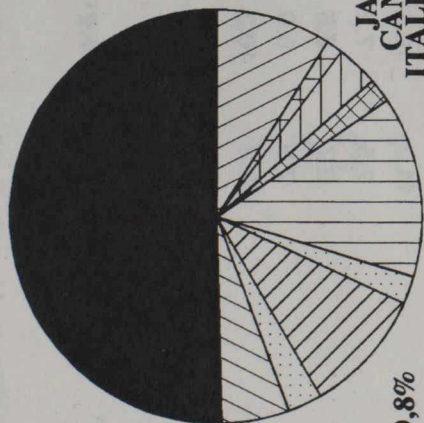
Ventilation par grands pays de destination

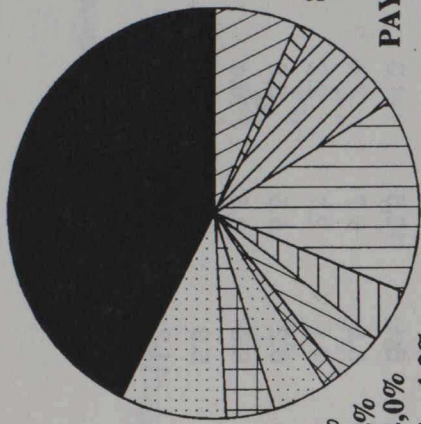
Ventilation par grands pays d'origine

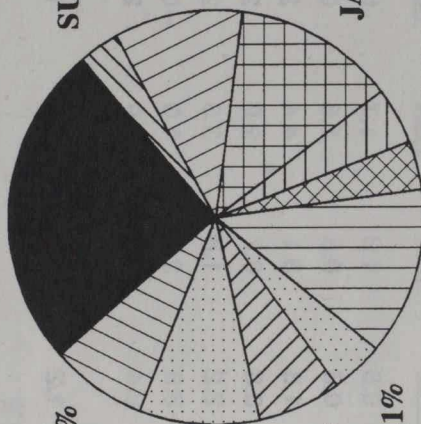
