TORONTO, 27th, 28th and 29th March, 1883.

AT TORONTO, and within the Vestry of St. Andrew's Church there, on Tuesday, the 27th day of March, 1883, at 2 o'clock in the afternoon, the Home Mission Committee (Western Section) of the Presbyterian Church in Canada, met and was constituted with prayer. Rev. W. Cochrane, D.D., Convener. The Committee continued in session till one o'clock p.m. on Thursday, 29th March.

Special grant,—It was agreed to place at the disposal of the Presbytery of Kingston a sum not exceeding \$150 for the ensuing year, to meet necessary expenses in exploring and in dispensing ordinances in the Mission fields of the Presbytery.

PRESBYTERY OF PETERBOROUGH:-

Haliburton and Minden,-Granted \$250 per annum for ordained Missionary, or \$4 per Sabbath for Student.

PRESBYTERY OF TORONTO :-

Omagh,-Granted \$2.50 per Sabbath.

PRESBYTERY OF BARRIE :-

Parry Sound,—Rev. A. Hudson was appointed for a term of two years, and the grant increased to \$400 for first year, conditional on the people contributing at least \$400. The sum of \$25 granted for Mr. Hudson's travelling expenses to the field.

Penetanguishene,—Granted \$50 per annum.

St. Peters, Franklin,-Granted \$3 per Sabbath.

It was agreed to postpone action in regard to the future supply of Prince Arthur's Landing and Fort William till the June meeting of the Committee and to request Mr. Herald to continue his services meanwhile.

Manitoulin Island.—It was agreed in the event of no ordained Missionary being got for Manitoulin Island to place at the disposal of the Presbytery of Bruce a sum not exceeding per Sabbath the rate of the present grant to the field, for the services of such ministers as the Presbytery may be able to secure to visit the Island and dispense ordinances during the ensuing summer.

BRITISH COLUMBIA.

There was laid on the table and read a letter from Rev. R. Jamieson, with the report of the New Westminster Congregation for the past year, showing an increase of 21 in the membership and of \$200 in the contributions towards the salary. It was resolved to record the satisfaction with which the Committee has learned from Mr. Jamieson's report that the congregation has made progress during the past year both in numbers and finances and also that there is a prospect that after this year there will not be needed much, if any, assistance from this Committee; and further, that in view of certain statements which have been published regarding the report of the General Assembly's Deputy to British Columbia, the Committee record their entire confidence in the impartiality and accuracy of that report.

There was submitted a letter from Rev. Dr. Gray, convener of the Colonial Committee of the Church of Scotland, as to the work in British Columbia; also an extract minute of the Presbytery of British Columbia, and an extract minute of a meeting of the congregation of Nanaimo. It was agreed in the event of the congregation of Pandora street, Victoria, asking the appointment of a minister from the Presbyterian Church in Canada before the next regular meeting of the Committee, that the Sub-Committee be empowered to make an appointment. REV. J. ROBERTSON presented a written report of his work for the past six months, which was received and considered. His expenses for the half year were ordered to be paid.

SPECIAL CLAIMS.

REV. F. McRae.—The Presbytery made application for \$150 for services rendered by Rev. Farquhar McRae during the past half year. It was agreed to grant \$75.

Mr. B. Jones.—A similar application on behalf of Mr. B. Jones was made and \$75 granted.

REV. G. RODDICK.—An application from the Presbytery for \$300, being expenses incurred by Rev. G. Roddick while laboring within the bounds, was granted.

Mr. J. Todd.—An application for a grant to meet the expenses of Mr. J. Todd, catechist, in moving his family to Manitoba, was not entertained.

REV. J. A. TOWNSEND.—Mr. Townsend applied for \$150, being deficit in his salary for the past year. There being some misapprehension as to the amount of salary promised by the people in Mr. Townsend's field, the Convener was authorized to pay the sum claimed, in the event of the Superintendent not being able at an early date to obtain the amount from the people in the field.

ITINERANT MISSIONARIES.

The Presbytery asked the sanction of the Committee to the appointment of two of the ordained Missionaries now laboring in the bounds, as itinerant Missionaries in the Presbytery for four months during the ensuing summer,—the salary to be at the rate of \$800 per annum. It was agreed to sanction such appointments.

WEST LYNNE.

A letter was read from Rev. J. Scott of West Lynne, asking an increase of the grant from \$200 to \$400 for the current year. The application was referred to the Presbytery of Manitoba for its opinion.

ARCHIBALD.

The Rev. J. A. Townsend being under call to this congregation, it was agreed that his salary be \$850 per annum from the date of his induction,—the congregation contributing at least \$600 for the first year.

APPLICATION FOR INCREASE IN SALARIES.

An extract minute of the Presbytery of Manitoba was read asking the Committee to increase the salaries of ordained Missionaries in the bounds to \$1,000 per annum, or \$900 with a Manse. The Committee, while expressing cordial sympathy with the resolution of the Presbytery, did not feel itself warranted in recommending the General Assembly to carry it into effect, except in connection with an effort to secure a more adequate maintenance for ministers throughout the Church generally.

DONATION OF \$600.

The Convener reported that he had received, and suitably acknowledged the sum of \$600 from a gentleman in Ottawa to aid in supporting a Missionary in Manitoba. The report was received and the cordial thanks of the Committee tendered the generous donor.

Letters were read from Revs. Jas. Sieveright and R. J. Sinclair, as to the condition of the work at Prince Albert, Carrot River and adjacent stations. The Prince Albert field is now contributing \$800 per annum towards the Missionary's salary, and is about to be erected by the Presbytery into a regular congregation. Mr. Sieveright intimated his intention to withdrawn from the field on 1st October, and the Sub-Committee were empowered to appoint a suitable Missionary to Prince Albert in his stead.

The Convener reported that he had received and duly acknow ledged a grant of £250 from the Presbyterian Church in Ireland on behalf of Home Mission Work.

GIFT OF CATECHISMS.

The thanks of the Committee were voted to Mr. J. Browning of St. Johns, Newfoundland, for a grant of a large number of copies of the Shorter Catechism and of the Mother's Catechism for distribution in the more destitute Mission fields of the Church.

NEWSPAPER ATTACK.

The attention of the Committee having been called to a comunication in a recent issue of the Toronto *Mail* affecting the Home Mission work of the Church, the following Sub-Committee was appointed to consider the matter: Dr. King, (Convener), Dr. Cochrane, Messrs. Macdonnell, Farries and McKenzie. At a subsequent stage of the proceedings the Sub-Committee presented the following report which was unanimously adopted by the Committee:

The Home Mission Committee having had its attention called to an anonymous communication which, as admitted by the editor, was allowed without due consideration, to appear in the Toronto Mail of Friday, 23rd March, reflecting injuriously on the Committee's administration, and throwing very grave and slanderous aspersions on the character of the Superintendent of Missions in the North-West, resolves as follows:

1. That the statements contained in the letter respecting the working of the Home Mission field both in the North-West and in Ontario, are in many particulars misleading and untruthful.

2. That Mr. Robertson, the Superintendent of Missions, has proved himself to be an intelligent, indefatigable and self-sacrificing agent of the Church; that during the short period in which he has filled the position, he has been singularly successful, in developing the liberality of the people in Manitoba and the North-West, both in the support of ordinances and in the creation of a Church and Manse Building Fund; in securing the accession to the field of valuable laborers, both Ministers and Students, and, generally, in promoting the rapid extension of the work therein.
