The above Representatives being in waiting, were introduced by the Grand Conductor, duly initiated, and took their seats as members of the Grand Division.

Representative David White being P.G.W.P. elect, took his seat accordingly.

Representative Thos. White, jr., was appointed by the G. W. P. to act as assistant Grand Scribe, and took his seat accordingly.

The Minutes of last Session were read and approved, with the exception of two omissions in the printed proceedings, embraced in the following resolution:

On motion of Grand Scribe Rose, it was

Resolved,—That one hundred copies of a resolution, omitted to be inserted in the last printed proceedings, anent borrowing fifteen pounds each from Gough and Howard Divisions, be printed on slips, and inserted into the printed Report of the Proceedings of last Session, and copies be sent to the Divisions who received the said proceedings, for insertion into the same; and also to notice on said slip the misprint in the Financial Report of £20, as printed, instead of £27.

The G. W. P. appointed the following Committees:

On the State of the Order—Brothers Kneeshaw, T. White, and Watson, and, on motion, the G. W. P. was added to the same.

On Finance—Brothers LeSueur, Lighthall, and D. White.
On Appeals and Communications—Brothers Barnard,
Shaw, and McEachern.

The G. W. P. read the following Report, which was referred to the Committee on the State of the Order:

G. W. P.'s REPORT.

QUEBEC, September 7, 1852.

Representatives and Brothers,

Before proceeding to the business of the Session, it becomes us to acknowledge the hand of Him through whose protecting and preserving care, we are indebted for the privilege of meeting each other once more, to deliberate on matters that are inseparably connected with the best interests of our fellow-men.

It is gratifying and satisfactory to know that we have assembled for such a purpose, that it is not only the object and design of the Order of the Sons of Temperance to promote the happiness and prosperity of our race, but because it is so well adapted to effect this, whenever and wherever it is honestly and fairly tried. It is this conviction, brothers, that adds so much to the pleasure that I experience on the present occasion; and let me remind you it is this fact which I am persuaded you all fully comprehend and appreciate, that invests every meeting of this Grand Division with an importance, and the action of its members with a responsibility, which we may not, which we cannot, which we dare not overlook, if we seek to fulfil the obligations we have all voluntarily taken upon ourselves.

The date of our present meeting approaches so near to that of our annual meeting that we do not attempt any retro-

spect of the past, except what may appear in the Report of our Grand Scribe. I may add, however, that so far as known to me, the interval that has elapsed since our last meeting has not been marked by anything of special interest. The Divisions have been making progress, though slow it may be in some instances, yet, nevertheless, still advancing.

*You are aware that I have called you together somewhat later than was agreed upon at our last meeting, but this has been done with the advice of several of the Divisions, and for reasons which I have no doubt you will all approve.

During our last session several resolutions were come to, which were to be carried out during the recess, as will appear from the Grand Scribe's Report, all of which have been attended to so far as it was in our power so to do.

1st. In the matter of petitions in favor of a law similar to that now in force in the State of Maine, our attention was early directed to the attainment of this desirable object, and we have reason to know that the different Divisions under our jurisdiction have carefully responded to our advice. was thought desirable, however, to depart from the advice of this Grand Division in one particular, viz., instead of desiring that the different petitions should be sent in to the Grand Scribe for presentation to Parliament, we have advised that the Sub-Divisions should endeavor to interest the members of Parliament for their respective localities, and forward the petitions through them, under the impression that by this means, a greater number of our legislators would become interested in obtaining the law, we all desire should forthwith grace the Statute Book of Canada—the Canadian Maine Law.

2d. With respect to the matter of transferring from fifteen to eighteen of the Divisions located in Canada West, but laying on our borders, from under the jurisdiction of the Grand Division of Canada West, we have to inform this Grand Division that our efforts in this behalf were unsuccessful;

but this will be more fully adverted to by the Grand Scribe, with some other matters which come more fully under his duties, and which will embrace all that can be fairly expected from your G. W. P.

During the recess we have had the honor of answering several questions by Sub-Divisions, respecting the working of their different Divisions, upon which difference of opinion had arisen, and we are not aware that such Divisions have in one instance refused to accept the advice given.

From some unaccountable mistake as to the precise date at which the National Division was to hold its Annual Session, we were prevented from fulfilling our appointment at last Session, to represent your interests on that occasion, and consequently had not the privilege of bringing before that body the different topics suggested at our last Session. However, on a recent visit to New York, the same object was accomplished, by a conference with the P. M. W. P. Oliver, and which information will be communicated during our present Session.

Let me express the hope, that the same unanimity and good feeling will prevail throughout our present Session as have distinguished those that have preceded it, and that the same forbearance and candid regard will be extended to your G. W. P. as have hitherto been accorded.

On the call of the G. W. P., the Grand Scribe submitted bis Quarterly Report as follows, which was referred to the Committee on the State of the Order and the Finance Committee.

GRAND SCRIBE'S REPORT.

MONTREAL, September 8, 1852.

In presenting this Quarterly Report, although I cannot say that we have added any new Divisions to our Order

since last Meeting, yet I have to report the addition of seven Divisions to those already under the jurisdiction of this Grand Division, transferred from under the jurisdiction of the Grand Division of Canada West.

The subject of Divisions lying in Canada East, but under the jurisdiction of the Grand Division of Canada West, which occupied your attention at last quarterly meeting of this Grand Division, I am happy to inform you has since been fully consummated, by the action taken in the matter by the Grand Division of Canada West, embodied in the following copy of a Circular which was sent to the Sub-Divisions lying in Canada East under their jurisdiction:

> OFFICE OF G. D. Sons of Temperance, C.W., Hamilton, May 28, 1852.

To H. Rose, G. Scribe, G. D. of C. E.

I beg to forward you the annexed extract from the Committee's Report, on the G. W. P.'s Report, for your guidance in respect to Divisions in Canada East, at present under the jurisdiction of this G. D., intending to join the G. D. of Canada East, it having been fully sanctioned at the May Session of this G. D.; the permission, however, is not extended to those Divisions located in Canada West.

"We recommend that all Subordinate Divisions, located in Canada East, and under the jurisdiction of this Grand Division, that may wish to withdraw from this G. D., for the purpose of becoming united with the G. D. of Canada East, be allowed to do so, at any time within four months from the date hereof, upon the following terms and conditions:—First, upon their paying to this G. D. all legal demands that this body may have against them, at the time the Resolution hereinafter named may be passed by a two-third vote, at a regular meeting of the Division, after one week's notice has been given, in writing, by some member thereof, that he intends at the next regular meeting to introduce the said Resolution referred to.

Resolved—That —— Division, No. —, is desirous of separating from the Grand Division of the Sons of Temperance of C. W., for the purpose 28

of joining and being placed under the jurisdiction of the Grand Division of the Sons of Temperance of Canada East.

Carried by a two-third vote of the Members present at a regular meeting of this Division, after one week's notice having been given in writing of the same.

Second, That when and so soon as any of the said Divisions shall pay all demands as aforesaid, and pass the above Resolution, that they, or any of the said Divisions shall have full power and authority to withdraw from this G. D., for the purpose of connecting themselves with the G. D. of C. E., and that the said Grand Division of C. E. have the full consent and permission of this G. D. to receive them under their jurisdiction: provided always, that the said Divisions withdrawing from this G. D. as aforesaid, shall file in this office a copy of the above Resolution and a certificate from the Grand Scribe of the G. D. of C. E., under the seal of the G. D. last aforesaid, to the effect that the said Division so withdrawing, as before mentioned, has become a Subordinate Division under the jurisdiction of the G. D. of C. E. That then their connection with this G. D. shall cease and determine, and not befere."

In answer to this Circular the following Sub-Divisions laying in Canada East, having complied with the terms of the Resolutions there laid down, made application for the necessary certificate, which was immediately granted them on receipt of the resolutions passed by them, and they are now working under the jurisdiction of this Grand Division:

- 1. Aylmer Division, Aylmer, Ottawa.
- 2. Perseverance Division, Huntingdon.
- 3. Chelsea do. Chelsea.
- 4. Wakefield do. Wakefield.
- 5. Litchfield do. Portage du Fort.
- 6. Bethel do. Ormstown.
- 7. St. Michael's Union Division, St. Michaels, Huntingdon.

These embrace all the Divisions in Canada East which received their Charters from Canada West, so far as I am aware.

Although this Grand Division has received applications for admission into our jurisdiction from Sub-Divisions laying beyond the geographical boundaries of Canada East, as will be seen by the Grand Scribe's Report of last quarterly meeting; and although it might be desirable to us and more convenient and favorable to them that such should be accomplished, yet the Grand Division of Canada West have resolved not to grant this permission, in answer to an application from this Grand Division, that a certain number should be set off, now laying upon our borders, and willing to join us. This of course closes all correspondence in the meantime on this subject.

Owing to the accession of the Divisions above alluded to into our jurisdiction, and the most of them having been organized before some of those already under our jurisdiction, the whole Sub-Divisions now in Canada East will have to be renumbered, and the best way of doing this—whether by the date of their Charters or organizations—will be brought under your consideration.

In accordance with your instructions at last meeting, the following form of Petition was prepared and printed, and copies sent in triplicate to all the Sub-Divisions under our jurisdiction, with instructions to each Division to send them, when filled up, to their representatives in Parliament:

disease, lunacy, and crime; entailing heavy burdens on society, and erecting a fatal barrier in the path of individual and national progress.

That your Petitioners regard Total Abstinence from the use of intoxicating liquors as the only effectual means of prevention or cure of this great evil; but while rejoicing that many thousands of their fellow-countrymen in this Province are persuaded of the truth of these statements, and act on such persuasion, your petitioners regret that many, from interested motives, consequent on their peculiar avocations, or from the blinding influence of vitiated appetities, are, in this matter, still unmoved, and apparently unmoveable by the remonstrances of moral suasion.

That your petitioners deem it the duty of a wise and patriotic Government, in such circumstances, to protect the community from the immense pecuniary sacrifices, the mental and physical maladies, the outrages on life and property, and the moral contamination, consequent on the use of alcoholic beverages.

Your Petitioners, therefore, pray your Excellency to pass a Legislative enactment, prohibiting the manufacture and sale of intoxicating liquous, except for medicinal or mechanical purposes.

And your Petitioners, as in duty bound, will ever pray.

I have also to lay before you two cases of appeal—one from St. Andrew's Division, and the other from Gough Division, Quebec, and also the resignation of the Grand Treasurer.

A communication was read from St. Andrews Division, stating their inability to send a representative,—Bro. M'Arthur having withdrawn from the order; and also stating

that the said brother had gone to Montreal to attend the meeting of the Grand Division, at the time appointed at the last meeting of the Grand Division, thereby incurring certain expenses.

Both communications were referred to the Committee on Communications.

The resignation of Bro. M Arthur, as Grand Treasurer, was read, and, on motion, accepted.

The G. W. P. read a letter which he had received from the M. W. Scribe, making exception to certain action had by this Grand Division, and also a copy of the answer to it, both of which were referred to the Committee on the State of the Order.

The Committee on the By Laws of the Grand Division presented their Report, which was considered section by section, some amendments made, and adopted as follows:—

To the Officers and Brothers of the Grand Division of C. E.

Your Committee, appointed to prepare a Code of By-Laws for the government of the Grand Division, beg leave to

REPORT:

That we have carefully examined the By-Laws of the Grand Division of Canada West, and would recommend their adoption, with the following alterations:

Article 1, Section 1, strike out the sentence commencing "The Annual Sessions," and ending "Division," and insert, "The Annual Session of this Division shall be held in the City of Montreal, on the fourth Wednesday of October, and the other two sessions in the months of May and August, the time of such meeting to be fixed by the G. W. P., who shall require the G. S. to give all Sub-Divisions at least three weeks' notice of the time, date, and place of meeting."

Strike out "Brockville," and insert "Montreal," also the word "West," and insert "East," wherever the same may occur.

Article 4, Section 7, that the word "nine" be struck out, and the word "five" inserted.

Article 5, Section 5, strike out clause, "Nor shall any Division under this jurisdiction be named after any living person."

Article 5, Section 20, in place of "12s. bd." say "5s." Also instead of "five," insert "three." Abolish Dispensation Fee.

Also we recommend the adoption of the Exposition of Art. VII. of Constitution of Subordinates, as laid down in Code of Canada West, and Viclation of Article II.

Resolved—That the Divisions whose names stand on the application for the Charter of this Grand Division be requested to pay their proportion of the amount of Charter Fee paid, and that the Divisions who signed the first application, and whose names are not now on the Charter, be refunded the sums they advanced for the said Charter.

Moved by Bro. C. P. Watson, and adopted-

Resolved—That Bros. G. Matheson, P. Le Sueur, and T. White, jr., be a Committee to prepare a Memorial to the Legislature, requesting that the Act of the Incorporation of the Order of the Sons of Temperance of Canada West, be amended so as to extend to and include the Grand Division and Sub Divisions of the same Order in Canada East.

Bro. C. P. Watson was, by ballot, declared duly elected Treasurer of this Grand Division, instead of Bro. M'Arthur, resigned.

A communication was read from the R. S. of Litchfield Division, asking certain questions in regard to action taken by that Division in election of a representative to the Grand Division.

To the Officers and Brothers of the Grand Division of C. E. The Committee on the State of the Order beg to

REPORT:

That they have had under consideration the G. W. P.'s Report, and have given it such consideration as the limited time allotted to committees to report allowed them.

Your Committee believe that the change made in the time of meeting was a movement tending to the benefit of the Order, as by the change the opportunity is given to present to the Legislature the petitions for the

Maine Law.

Your Committee also believe that the suggestion made by the G. W. P. to subordinate Divisions to present their petitions to the members representing the locality in which the Division was located, instead of sending them to the Grand Scribe to present, within a certain date, is calculated to enlist the action of members of Parliament, who might be doubtful on the subject of a prohibitory law, into its advocacy, and is therefore highly com-

Your Committee also approve of the action had in reference to the transfer of subordinate Divisions from the jurisdiction of the Grand Division of Canada West, and while they regret that the constitutional principles of the Order prevented those Divisions situated immediately on the opposite of the Ottowa from connecting themselves with us, they feel that there is

abundant cause for rejoicing in what has actually been effected.

Your Committee regret exceedingly the inability of the G.W.P. to attend the meeting of the National Division, but regard his explanation in reference to his non-attendance as perfectly satisfactory, and such as exhonorates him from all blame. They are glad, however, to learn that the G. W. P. was enabled to see P. M. W. P. Oliver, and from him receive such information as this Division required. Your Committee would recommend that no further action be taken by this Grand Division for the increase of the number of black balls necessary to exclude a member from t was referred to the Committee on Communical, rebooled

Your Committee cannot conclude this report without bearing testimony to the uniformly affable and courteous demeanor of the G. W. P., and also his promptness in performing the ardous duties which attach to his office.
