C. H., S. 4, SS. 2.

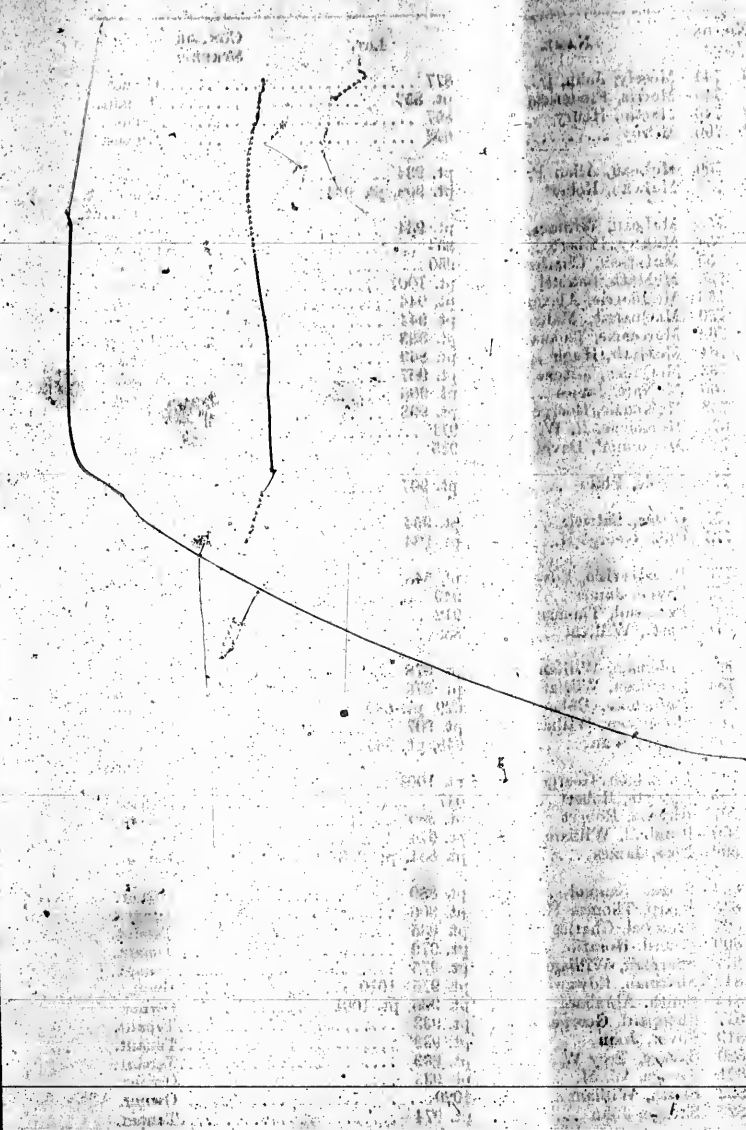
