FREDERICTON, Monday, June 15th, 1835.

THE General Assembly having been by Proclamations prorogued until this day, then to meet for the Dispatch of Business,

The House being met—

A Message from His Excellency the Lieutenant Governor, by the Gentleman Usher of the Black Rod, requiring the attendance of the House in the Council Chamber.

The House attended, and being returned—

Mr. Partelow, by leave, presented a Petition from Thomas Nisbet, John Haws, George Waterbery, C. D. Everitt, John Hooper, and 156 others, Mechanics and Tradesmen of the City of Saint John, praying for an Act of Incorporation under the name of *The Saint John Mechanics' Whale Fishing Company*; which he read.

Ordered, That the said Petition be received and lie on the Table.

Mr. Partelow moved for leave to bring in a Bill, to Incorporate *The Saint John Mechanics' Whale Fishing Company*.

Leave granted.

The said Bill being brought in, was read a first time.

Mr. Speaker then reported that His Excellency the Lieutenant Governor had been pleased to make a Speech to both Houses, of which Mr. Speaker said he had, to prevent mistakes, obtained a Copy; which he read to the House, and is as followeth:—

“Mr.

“ *Mr. President, and Honorable Gentlemen of the Legislative Council,*
 “ *Mr. Speaker, and Gentlemen of the House of Assembly,*

“ **A**T the close of the last Session of the General Assembly I had to express to you the regret which I felt at the loss of the Appropriations. This feeling has since been very much increased by the Petitions I have received from many of the Counties, representing the inconvenience and distress likely to arise from this unhappy circumstance, which, if not remedied, will create difficulty and embarrassment in every branch of the public service, and cannot fail to prove particularly discouraging to the poor classes who derive benefit from the expenditure of the public Monies, which the bounty of the Legislature is accustomed annually to distribute throughout the Country.

“ The earnest solicitations contained in those Petitions that I should reassemble the Legislature at an early period, for the purpose of relieving the Country from the anticipated evils, have alone induced me to call you together at this unusual and inconvenient season. If, however, you should deem it expedient to confine your proceedings to this single object, your absence from your homes need not be of any long duration.

“ *Mr. Speaker, and Gentlemen of the House of Assembly,*

“ I rely upon your liberality and zeal for the public good, to make such Appropriations as the public service requires.

“ *Mr. President, and Honorable Gentlemen of the Legislative Council,*
 “ *Mr. Speaker, and Gentlemen of the House of Assembly,*

“ I earnestly trust that a spirit of wisdom and moderation will guide your deliberations to such a result as will promote the welfare of the People, advance the interests of the Province, and thereby afford the most solid and lasting satisfaction to your own minds.”

On motion of Mr. Partelow,

Resolved, That an humble Address be presented to His Excellency the Lieutenant Governor, in answer to His Excellency's Speech at the opening of the Session.

Ordered, That Mr. Partelow, Mr. L. A. Wilmot, and Mr. Chandler, be a Committee to prepare the Address.

On motion of Mr. End,

Ordered, That *One hundred and fifty Copies* of His Excellency's Speech be forthwith printed for the use of the Legislature.

Mr. Street moved for leave to bring in a Bill, to provide for the payment of the expences of the Speaker and Members of the House of Assembly.

Leave granted.

On motion of Mr. Robinson,

Ordered, That the Journals of this House be daily printed, or as soon as a Copy thereof can be prepared by the Clerk, and that the Printer do furnish *Two hundred Copies* for the use of the Legislature.

On motion of Mr. Partelow,

Resolved, That a Committee be appointed to whom may be referred all matters which may arise, that may in any way be supposed to affect the privileges of this House.

Ordered, That Mr. Chandler, Mr. L. A. Wilmot, Mr. Brown, Mr. Street, and Mr. Woodward, be a Committee for that purpose.

On motion of Mr. Chandler,

Ordered, That the House do to-morrow go into Committee of the whole, in consideration of Supplies to be granted for the Public Service.

On motion of Mr. End,

Resolved, That a Committee be appointed to examine what Laws are near expiring, and report thereon to the House.

Ordered,

Ordered, That Mr. End, Mr. Street, and Mr. Robinson, be a Committee therefor.

Mr. Partelow, by leave, presented a Petition from Justus S. Wetmore and James Whitney, praying for an Act of Incorporation, for a Bridge across the Kennebecasis above Hampton Ferry, by the name of *The Norton Bridge Company*; which he read.

Ordered, That the said Petition be received and lie on the Table.

Mr. Wyer, by leave, presented a Petition from the Rector, Church Wardens and Vestry of All Saints' Church, in the Parish of Saint Andrews, praying an Act may pass authorizing the sale of certain Lands; which he read.

Ordered, That the said Petition be received and lie on the Table.

Mr. Wyer moved for leave to bring in a Bill, to authorize the Rector, Church Wardens and Vestry of All Saints' Church, in the Parish of Saint Andrews, in the County of Charlotte, to sell and dispose of certain Lands in the said Parish.

Leave granted.

The said Bill being brought in, was read a first time.

The House adjourned until to-morrow morning at 10 o'clock.

TUESDAY, 16th June, 1835.

Prayers:

Read a second time the following Bills:—

A Bill to Incorporate *The Saint John Mechanics' Whale Fishing Company*: and

A Bill to authorize the Rector, Churchwardens and Vestry of All Saints' Church, in the Parish of Saint Andrews, in the County of Charlotte, to sell and dispose of certain Land in the said Parish.

Mr. Freeze, by leave, presented a Petition from Sylvester Z. Earl, Azor Hoyt, Edwin Fairweather, and 127 others, Inhabitants of King's County, praying an Act may pass to authorize the erection of a Bridge over the Kennebecasis River, near Hampton Ferry, and also for pecuniary aid towards the erection of said Bridge; which he read.

Ordered, That the said Petition be received and lie on the Table.

Mr. M'Leod, by leave, presented a Petition from Michael S. Harris, Abraham Baxter, James Irving, and 230 others, Inhabitants of the Parishes of Norton and Sussex, in King's County, praying an Act may pass authorizing the erection of a Bridge over the Kennebecasis, above Hampton Ferry, as prayed for in the Petition of Justus S. Wetmore and James Whitney, presented to the House; which he read.

Ordered, That the said Petition be received and lie on the Table.

Mr. M'Leod, also, by leave, presented a Petition from Joshua Upham, Samuel Foster, Ebenezer Smith, and 275 others, Inhabitants of the Parishes of Hampton and Kingston, in King's County, praying an Act of Incorporation may pass to Justus S. Wetmore and James Whitney, for the erection of a Bridge above Hampton Ferry; which he read.

Ordered, That the said Petition be received and lie on the Table.

Mr. Street informed the House that Mr. Rankin, a Member returned for the County of Northumberland, was in attendance, and prayed to be admitted to his Seat.

Ordered, Thereupon, That Mr. Street and Mr. Robinson, be a Committee to attend the Commissioner and see Mr. Rankin qualified.

Mr. M'Leod, by leave, presented a Petition from William Burnett, and 19 others, Inhabitants of the Parish of Springfield in King's County, praying an Act may pass authorizing the erection of a Bridge above Hampton Ferry, as prayed for in the Petition of Justus S. Wetmore and James Whitney; which he read.

Ordered, That the said Petition be received and lie on the Table.

Mr. Woodward, by leave, presented a Petition from Barnes Travis and others, Merchants and Shipowners, interested in the navigation of the River Saint John, praying a grant may pass in aid of individual subscription towards the improving the navigation of the Falls at the entrance of the River, by erecting a Wharf at Blind Island; which he read.

Ordered, That the said Petition be received and referred to the Committee of Supply.

Mr. End gave notice that in the course of the next Session he should bring the state of the Poor Laws of this Province under the consideration of the House, with a view to their alteration, or total abolition.

Mr. Partelow from the Committee appointed to prepare an Address to His Excellency the Lieutenant Governor in answer to His Speech at the opening of this Session, reported a Draft thereof which he read, and submitted the same.

It being again read at the Clerk's Table was ordered to be accepted.

Mr. Street from the Committee appointed to attend the Commissioner with Mr. Rankin and see him qualified, Reported, that they had attended thereto, and that Mr. Rankin had taken the Oaths prescribed by Law; whereupon

Mr. Rankin took his seat.

On motion of Mr. Partelow,

The House went into Committee of the whole, on the Draft Address to His Excellency in answer to His Speech at the opening of the Session, reported by the Select Committee.

Mr. Palmer in the Chair of the Committee.

Mr. Speaker resumed the Chair.

The Chairman reported, that they had gone into consideration of the Draft Address referred to them and agreed to the same, without making any amendment thereto; and

On motion of Mr. Partelow,

Resolved, Unanimously, that the Address be engrossed, signed by the Speaker and presented to His Excellency by the whole House; and further

Resolved, That a Committee be appointed to wait upon His Excellency to know when he will be pleased to receive the House with their Address.

Ordered, That Mr. Partelow, Mr. Slason and Mr. Burns, be a Committee for that purpose.

Mr. Street, pursuant to leave, brought in a Bill to provide for the payment of the expences of the Speaker and Members of the House of Assembly, which was read a first time.

Mr. End submitted certain Resolutions on the subject of Quit Rents in the Province, and gave notice, that he should bring the subject under consideration of the House to-morrow.

The Resolutions as submitted by Mr. End were then laid on the Table for the information of the House.

On motion of Mr. End,

The House proceeded to the Order of the Day.

The Order of the Day being read,

The House accordingly resolved itself into Committee of the whole, in consideration of Supplies to be granted for the Public Service.

Mr. Hayward in the Chair of the Committee.

Mr. Speaker resumed the Chair.

The Chairman reported, that the Committee having the business referred to them under consideration, in the Committee the following Resolution was moved:—

Resolved, In the opinion of this Committee, that the Resolutions of Appropriation which passed the House by Bill at the last Session of the Legislature; should be adopted without alteration; and that no further matter be considered by this Committee, except making the usual Provision for the expences and travelling charges of the

the Speaker and Members of this House serving in General Assembly, and also the annual allowance of the Clerks of the Legislative Council and this House."

To which the following amendment was moved, to insert after the words *the Legislature* "with the exception of the grant to the Trustees of the Savings' Bank of Saint John."

And upon the question for adopting the amendment, the Committee divided as follows:—

And it was carried in the affirmative.

The question was then taken upon the Resolution as amended—when it was likewise carried in the affirmative.

That the Committee then passed a number of Resolutions, which he read, and they being handed in at the Clerk's Table were then again read, and are as follows:—

Resolved, That there be granted to the Chaplain of the Council in General Assembly, the sum of twenty-five pounds for the last Session.

To the Chaplain of the House of Assembly, the sum of twenty-five pounds, for the last Session.

To the Sergeant at Arms attending the Council in General Assembly, the sum of twenty shillings per diem, during the last Session.

To the Sergeant at Arms attending the House of Assembly, the sum of twenty shillings per diem, during the last Session.

To the Doorkeepers attending the Legislative Council and Assembly, the sum of twelve shillings and six pence per diem each, during the last Session.

To the Messengers attending the Legislative Council and Assembly, the sum of ten shillings per diem each, during the last Session.

To His Majesty's Attorney General, for his services for the year 1834, the sum of one hundred pounds.

To His Majesty's late Solicitor General, for his services for the year 1834, the sum of fifty pounds.

To the Clerk of the Crown in the Supreme Court, for his services for the year 1834, the sum of one hundred pounds.

To the Hon. R. Simonds, Province Treasurer, the sum of six hundred pounds for his services from the 31st day of December, 1833, to the 31st December, 1834: Also, the further sum of one hundred and fifty pounds to enable him to pay a Clerk in the Treasury for the same period.

To His Excellency the Lieutenant Governor, a sum not exceeding six thousand pounds, for the encouragement of Parish Schools, agreeably to a Law of the Province.

To His Excellency the Lieutenant Governor, the following sums for Grammar Schools in this Province, for the year 1835:—

For the Grammar School in Westmorland, one hundred pounds.

For the City of Saint John, one hundred and fifty pounds.

For King's County, one hundred pounds.

For the County of Kent, one hundred pounds.

For Queen's County, one hundred pounds.

For the County of Charlotte, one hundred pounds.

For the County of Northumberland, one hundred pounds.

To His Excellency the Lieutenant Governor or Commander in Chief, a sum not exceeding three hundred pounds, to encourage the destruction of Bears, agreeably to a Law of this Province.

To the Commissioners of Light Houses in the Bay of Fundy, the following sums to pay for services in the year 1835 :—

To the Keeper of the Light House on Campobello, the sum of one hundred and twenty pounds, for the year 1835.

To the Keeper of the Light House on the Gannet Rock and his Assistant, the sum of one hundred and sixty-five pounds, for the year 1835.

To the Keeper of the Light House on Point Le Proc, the sum of one hundred pounds, for the year 1835.

To the Keeper of the Light House on Machias Seal Island, the sum of one hundred and thirty pounds, for the year 1835.

The sum of four hundred pounds, to defray the expenses of the Gannet Rock and Point Le Proc Light Houses, for the year 1835.

The sum of five hundred and fifty pounds, to defray the contingent expenses of the Light Houses at Campobello, Machias Seal Island, and the Harbour at Saint Andrews, for the year 1835.

To the Commissioners of Light Houses at the entrance of the harbour of Saint John, the sum of two hundred pounds, for contingent expenses for the year 1835.

To the Commissioners of Light Houses in the Bay of Fundy, the sum of two hundred pounds, to be applied by them towards the support of Cape Sable Seal Island Light House; and also the sum of one hundred pounds towards the support of the Light House on Brier Island in the Province of Nova Scotia, for the year 1835.

To the Keeper of the Light House on Partridge Island, the sum of one hundred pounds, for the year 1835.

To the Keeper of the Beacon Light in the Harbour of Saint John, the sum of one hundred pounds, for the year 1835.

To the Adjutant General of the Militia Forces, the sum of seventy-five pounds, for his services for the year 1835.

To the Quarter Master General of the Militia Forces, the sum of twenty-five pounds, for taking care of the Arms for the present year.

To His Excellency the Lieutenant Governor, a sum not exceeding four hundred and thirty five pounds; to pay the Adjutants of Militia of the different Counties of this Province for the last year; and a further sum not exceeding two hundred and seventeen pounds ten shillings, to pay the Sergeant Majors of Militia of this Province, for the time being, who were actually employed for the same period; provided that each Sergeant Major who shall appear by a Certificate from his Commanding Officer to have faithfully performed his duty, shall receive a sum not exceeding seven pounds ten shillings.

To His Excellency the Lieutenant Governor or Commander in Chief, a sum not exceeding one hundred pounds, to be applied in rewarding persons for the apprehension of Deserters from His Majesty's Land Forces within the Province; provided always, that no greater sum than five pounds be paid for the apprehension of any one Deserter.

To the Master in Chancery, appointed to carry Messages between the Legislative Council and House of Assembly, the sum of forty pounds.

To D. W. Jack, Tide Surveyor for Saint Andrews, the sum of one hundred and fifty pounds, being for his services from the 1st of April, 1834, to the 1st April, 1835.

To His Excellency the Lieutenant Governor or Commander in Chief, the sum of ninety-one pounds five shillings, to enable the Treasurer to pay John Abrams for his services as Tide Waiter at Saint John, for the year 1835.

To His Excellency the Lieutenant Governor or Commander in Chief, the sum of seventy-five pounds, for the service of a Tide Surveyor at Miramichi, for 1835.

To

To B. C. Chaloner, Tide Surveyor at Saint John, the sum of fifty pounds, being for his services from the 1st May, 1834, to the 1st May, 1835.

To the Hon. R. Simonds, Province Treasurer, the sum of one hundred pounds, being for the services of a Tide Waiter or Messenger to the Treasury, in the year 1835.

To the Governor and Trustees of the Madras School, the sum of five hundred pounds, for the year 1835, towards the support of that institution.

To His Excellency the Lieutenant Governor or Commander in Chief, a sum not exceeding five hundred pounds, to defray any expenses that may be incurred in the protection of the Revenue of the Province, for the year 1835.

To the President and Directors of the Fire Insurance Company, the sum of six hundred pounds, being one year's Interest on the Provincial Loan, ending the first day of March, 1835.

To the Hon. R. Simonds, Province Treasurer, the sum of one hundred and eleven pounds eighteen shillings and eight pence half penny, being for contingencies of Office for the year 1834.

To David W. Jack, Guager at Saint Andrews, the sum of seventeen pounds thirteen shillings, being for Guaging, &c. in the year 1834.

To Robert Watson, Guager at Saint Stephen's, the sum of four pounds five shillings and six pence, being amount of his Account for 1834.

To C. H. Jouett, Guager at West Isles, the sum of eleven pounds twelve shillings and six pence, being amount of his account for the year 1834.

To George Henderson, Guager at Miramichi, the sum of five pounds four shillings, being amount of his account for the year 1834.

To His Excellency the Lieutenant Governor or Commander in Chief, the sum of fifty pounds, to defray the expense of a Courier from Newcastle to Fredericton.

To the Commissioners of Buoys and Beacons for the Inner Bay of Passamaquoddy, the sum of one hundred and eleven pounds and three pence, being the amount advanced by them in building a House for the Keeper of the Light House at the entrance of Saint Andrew's Harbour, to be taken out of the Light House fund.

To the Commissioners appointed for affording relief to Shipwrecked Mariners on Saint Paul's Island, three hundred and nineteen pounds fourteen shillings and seven pence, being amount of their account for expenditures for the year 1834.

To His Excellency the Lieutenant Governor, the sum of thirty pounds, in aid of individual subscription, to pay a Courier passing between Hopewell and the Bend of Petticodiac River in the County of Westmorland.

That the sum of not exceeding four hundred pounds granted at the last Session to the Commissioners of Light Houses in the Bay of Fundy for the purpose of erecting a Buoy or Beacon on Quaco Ledges, the same to be taken from the Light House fund, be reappropriated, and that the whole of that sum or so much of it as may be necessary be applied for the erection of a Light House at or near Quaco Head.

To His Excellency the Lieutenant Governor, the sum of fifty pounds, to defray the expenses of a Missionary to the Milicite Tribe of Indians, for the year 1835.

To His Excellency the Lieutenant Governor or Commander in Chief, the sum of thirty pounds, in aid of individual subscription, to pay a Courier passing between Bathurst and Shippegan, in the County of Gloucester.

To John Pendlebury, Keeper of the Light House on Machias Seal Island, the sum of fifteen pounds, for expenses incurred by him in consequence of the wreck of a vessel on that Island in the year 1834.

To James Whitehead, a meritorious old Soldier who served in the Revolutionary War, the sum of ten pounds, to aid him in his present distressed situation.

To John Simpson, King's Printer, the sum of two hundred pounds, for printing the daily Journals of the Legislative Council and Assembly during the last Session.

To John Simpson, the sum of one hundred and fifty pounds, towards the printing the Journals of the Legislative Council and Assembly the last Session.

To Flora M. Rae, widow of the late Captain Alexander M. Rae, the sum of twenty pounds, to assist her in her present distressed situation.

To Matthew Brannen of the Secretary's Office, the sum of fifteen pounds, as a mark of approbation of his attentive and courteous demeanour in the said Office.

To William Watts, the sum of ten pounds for airing and taking care of the Province Hall.

To the Chairman of the Committee on Public and Private Accounts, the sum of one hundred pounds for his services during the recess, in conformity with the directions of the House, and also for extra services during the Session in auditing, allowing and reporting the same.

To Harris Hatch, Clerk of the Peace in and for the County of Charlotte, the sum of twenty two pounds one shilling, being amount of certain Grain Bounty claims omitted to be returned in the Schedule for 1832.

On motion of Mr. Taylor,

The Resolution submitted yesterday on the subject of the sale of Crown Lands, and which was put off upon a division on the previous question, was again brought under consideration.

The Resolution was then read, and is as follows:—

A Message from His Excellency the Lieutenant Governor.

The Honorable Mr. Secretary Odell, by command of His Excellency, communicated a Copy of a Dispatch received from the Government of Nova Scotia, as follows:—

(COPY.)

President, Halifax, 19th June, 1835.

"SIR,

"I HAVE to acknowledge the receipt of your letter of the 10th instant, inclosing the copy of an Address of the House of Assembly of New Brunswick, on the subject of the Fisheries, and having laid the same before the Commander in Chief, I am directed by him to acquaint you in reply, that he is hourly in expectation of the arrival here of His Majesty's Sloop Despatch, and that as soon as she joins him he will order her to proceed to the Bay of Fundy, to attend to the Service requested by your said inclosure; and her Commander will be directed to communicate with the Authorities at the Grandmanan and at Saint Andrews; for more minute information as to the particular acts of violation of the Treaty, which have been committed by the Americans, and the best course to be pursued by His Majesty's Sloop to detect those who commit such depredations, and to prevent any recurrence thereof; and the Commander in Chief requests, therefore, that His Excellency Sir Archibald Campbell will be good enough to give the necessary directions for some proper person to be prepared at those places, respectively, to communicate with the Commander of the Despatch, and to give him the necessary Information on the aforesaid points accordingly.

The House attended, and being returned,

Mr. Speaker reported, that he had addressed His Excellency to the following effect :—

“ May it please Your Excellency,

“ The Assembly, with an anxious desire to quiet the agitation and discontent which the determination of His Majesty to collect the Quit Rents has occasioned throughout the Province, have passed a Bill for commuting and extinguishing these Rents. This is a measure which cannot fail of producing the happiest results, and will be hailed with joy by the people of this Province.

“ I now present to Your Excellency, on behalf of His Majesty’s faithful and loyal subjects, the Assembly. “ A Bill for commuting His Majesty’s Quit Rents in the Province of New Brunswick,” to which I pray Your Excellency’s assent; and I earnestly hope that it will prove acceptable to our Most Gracious Sovereign, and become a law of our land.

“ These Bills I also present to Your Excellency on the same behalf, and pray Your Excellency’s assent to them.”

That His Excellency was then pleased to give his assent to

The Bill for the Commutation of His Majesty’s Quit Rents in the Province of New Brunswick—*with a suspending clause;*

And to the several Bills of Appropriation presented by the House; and also to the following :—

A Bill to authorize the Rector, Church Wardens and Vestry of All Saints’ Church in the Parish of Saint Andrews, in the County of Charlotte, to sell and dispose of certain land in the said Parish :

A Bill for altering the times of holding the Terms of the General Sessions of the Peace and Inferior Courts of Common Pleas of the County of Carleton :

A Bill to amend an Act to repeal all the Laws now in force relating to Saint Andrew’s Church in the City of Saint John, and for incorporating certain persons Pew-holders of the said Church, and of the several Churches erected or to be erected in the Province in connexion with the Church of Scotland :

A Bill in addition to the Laws now in force for establishing a legal Tender in all payments to be made in this Province :

A Bill to authorize the erection of a Toll Bridge over the River Kennebeckacis in King’s County :

A Bill for the punishment of persons who shall be guilty of the trespasses therein mentioned in the City of Saint John : and

A Bill to incorporate *The Saint John Mechanics' Whale Fishing Company.*

And His Excellency was then further pleased to make the following Speech to both Houses :—

“ *Mr. President, and Honorable Gentlemen of the Legislative Council,*

“ *Mr. Speaker, and Gentlemen of the House of Assembly,*

“ **I**N releasing you from your further attendance at the present Session, I must express to you my great satisfaction at your having so promptly responded to the wants and wishes of the Country. The result of your deliberations on the subject of the Quit Rents will be hailed with congratulations by every well-wisher to the prosperity of the Province, and I have the most confident expectation that it will prove entirely acceptable to His Majesty's Government.

“ I am persuaded that, on your return to your respective homes, you will continue to cultivate those sentiments of loyalty to our Most Gracious Sovereign, of attachment to the Parent State, and of respect and affection for our Provincial Institutions, for which this Colony has always been distinguished, and which alone, under the blessing of Providence, can insure its future peace and welfare.”

That His Honor the President of the Legislative Council then said

“ *Honorable Gentlemen of the Legislative Council,*

“ *Mr. Speaker, and Gentlemen of the House of Assembly,*

“ It is His Excellency the Lieutenant Governor's will and pleasure that this General Assembly be prorogued until the Third Tuesday in September next, and this General Assembly is accordingly prorogued until the Third Tuesday in September next then here to be holden.”
