

ed by me to proceed to England to confer with Her Majesty's Government on various questions of importance, and to conduct other negotiations on behalf of this Province. The report of the delegates will immediately be laid before you, and you will learn with satisfaction that a contract has been entered into by them which, in conjunction with measures adopted by the Government of Nova Scotia, will ensure the completion of railway communication between St. John and Halifax at no distant date.

A contract has also been completed for the construction of a Railway from St. John to the frontier of the United States, the works on which have already commenced and are now in progress.

Since I last met you in parliament, the Crown has been deprived of two of its most distinguished functionaries in this Province, and I now desire to express to you my keen sense of the loss which New Brunswick has sustained in the retirement of Chief Justice Sir James Carter, and the death of Chief Justice Parker.

Mr. Speaker and Gentlemen of the House of Assembly:

An account of the income and expenditure of the past year will be laid before you. Although the revenue was considerably less than that received in 1864, it yet exceeded the estimate; and I am happy to inform you that since the close of the financial year it has steadily improved.

The estimates which will be immediately submitted to you have been framed with as close an attention to economy as a due regard for the exigencies of the public service and the security of the Province would permit.

Mr. President and Hon. Gentlemen of the Legislative Council:

Mr. Speaker and Gentlemen of the House of Assembly:

I have received Her Majesty's command to communicate to you a correspondence on the affairs of British North America, which has taken place between Her Majesty's principal Secretary of State for the Colonies and the Governor General of Canada; and I am further directed to express to you the strong and deliberate opinion of Her Majesty's Government that it is an object much to be desired that all the British North American Colonies should agree to unite in one Government.

These papers will immediately be laid before you.

I trust that your deliberations may tend to advance the welfare of the Province and of its people; and a pledge that this will be the case may be found in their being undertaken, as I am sure they will be, under a full sense of your grave responsibilities and in a spirit of once of confident self-reliance and of loyal attachment to that great Empire of which New Brunswick forms a part, and her connection with which is at once her security and her pride.

FREDERICTON, March 9.

Sharp contest in the House between Wetmore, Anglin, Smith and Cadlip.

Des Brisay, of Kent, asked Hatheway, about a Bridge. The question was partly answered.

Gilbert asked who composed the Government? Declined.

Anglin got up; said such questions were disrespectful and out of order till after Address. He made a considerable speech. Wetmore rejoined that Anglin seemed to have charge of the Government indoors and out. Their members were on the floor, yet Anglin must answer and say what information they would give and what not. A pretty state of things!

Smith indignantly replied that no one had the Government in charge. They would answer for themselves, and if voted recalcitrant to their trust, as Wetmore insinuated, would give place to others.

Cadlip assailed Wetmore as changing base in attacking Government.

The Speaker closed the discussion.

Anglin asked if the Opposition would propose an amendment to the Address.

Connell replied, if Anglin would vote for it he might consider it on the table!

Notice of such amendment will be given to-morrow.

Wilmot's resignation accepted this week. Troop sworn in; was in the House during discussion.

Two paragraphs of Address passed in the Legislative Council.

These elicited discussion on Fenianism.

Mitchell charged that defence of Fredericton consisted of four guns, two of which were wooden.

A good deal of feeling exists here about Fenian movements on the borders.

The Opposition are strong and defiant.

The Speech and Address do not fully please either party.

The position of the Government is considerably critical.

Hill, Young and Thompson not arrived.

March 10.

Mr. Fisher gave the following notice of motion.

In amendment of answer to the speech, strike out all that part of the 4th paragraph from "and your Excellency" and substitute the following:

"And your Excellency may rely with confidence upon our cordial co-operation and support in the adoption of such measures as may be deemed necessary for the protection of the country. And while we respectfully state to your Excellency that your constitutional advisers by their general conduct are not entitled to our confidence, we regret that no sufficient assurances have been given that the people will not be found unprepared to defend their homes and their families against lawless conspirators from the neighboring republic."

In answer to inquiry of Wetmore, the Attorney General stated, the correspondence in

reference to the appointment of Chief Justice Ritchie would be laid before the House in due time.

Lindsay introduced a Bill relating to settlement and support of poor; Fisher a Bill to establish an additional polling place in York with petition, a Bill to incorporate the Fredericton Railway Company to Fredericton; Des Brisay a Bill to change name of Parish of Palmerton, Kent; Lindsay a Bill to enable the town of Woodstock to take stock in Woodstock Branch Railway; Connell a Bill to facilitate construction of Woodstock Railway, also a Bill relating to marriage; Oty a Bill relating to weights; Scott a Bill to increase representation of King's County.

Wetmore gave notice of motion for correspondence on appointment of Chief Justice. In reply to Wilmot, the Attorney General said the defence Government is taking active measures for the defence of the country but it would not be prudent to state details.

March 12.

Boyd introduced Bill and Petition for Incorporation St. Andrew's Friendly Society.

De-Brisay, Bill to place part of road from Colesburg to Shediac on great Road.

Address in answer to Speech under consideration during the afternoon.

Boyd endorsed language of Speech and Address, and believed Government would not be opposed to a scheme of Union that was fair.

Fisher spoke two hours to his amendment. He said, the Government, although they had a majority of fifteen members last Session, did not initiate a single measure except the Militia Law. They had not filled a vacant office because of fear to open the constituencies, knowing the country was against them.

March 13.

The Gloucester Scrutiny Committee reported in favor of Messrs. Young and Melan, sitting members.

Mr. Wetmore introduced a Bill relating to debtors confined in jail or on limits; a Bill to amend law of evidence; a Bill to authorize Judges of the Supreme Court to preside at trials when the City of St. John is interested.

Mr. Fisher, a Bill in amendment of Parish School law, and a Bill in amendment of the Law.

Mr. Fraser, a Bill to give Fredericton representation in the Assembly.

Mr. Caie, a Bill to increase representation of Kent.

Mr. Melan, a Bill to increase that of Gloucester.

Mr. Lindsay, a Bill to increase the representation of Carleton.

Mr. Oty, a Bill to provide increased representation for several Counties.

Mr. Costigan, a Bill to abolish property qualifications of members of Assembly.

Mr. Fraser, a Bill to incorporate Provincial Oil Company.

Mr. Williston, a Bill to provide more effectually for the repairing of Roads and Bridges in Newcastle; also a Bill relating to partition of lands.

FROM THE STATES.

NEW YORK, March 8.

The World's Albany special despatch says that it is understood that Governor Fenton has been urged to call out three regiments to prevent Fenian raids from Ogdensburg on Canada.

NEW YORK, March 10.

A despatch from Ottawa, Canada, says Parliament has been called to meet April 10th. Nova Scotia and New Brunswick are immediately accede to the Confederation with Canada.

A large reinforcement will be sent out from England as soon as navigation opens, to meet the threatened Fenian raid.

TORONTO, C. W., 10th.—Volunteers continue to respond to the call with great enthusiasm.

Bishop Lynch has issued a circular denouncing the Fenians.

The Customs Department have issued a circular specially instructing the officers to thoroughly search all baggage and passengers coming into the Provinces, and detain all arms munitions of war.

All weapons will be taken from passengers whose names will be taken with a list of such as they may have in their possession. Express goods shall be closely compared with the manifests and suspected packages will be opened. Freight trains will be carefully examined, and no package not mentioned in the manifests will be allowed to pass. Cars will be sealed before passing the frontier.

Confederation in Newfoundland.

The following extract from Hon. Mr. McCully's Speech in the Nova Scotia Legislature, shows that Newfoundland has expressed herself in an unmistakable manner in favour of Confederation.

He was glad, for many reasons, that the Government had undertaken to complete this road. It appeared by papers just received, that both branches of the Legislature in Newfoundland had endorsed the Confederation policy. In the debate on the Address, in the Assembly there, the main topic discussed was Confederation, and the following clause was passed by a majority of 18 to 6:

"On the important question of Confederation, in recognizing the solicitude of Her Majesty's Government for the welfare of this colony, we concur in the view of Your Excellency, that the abstract advantages of Union are so obvious as to be almost necessarily acknowledged, whilst, with regard to this colony, and on the details of so grave a measure, it is natural that much diversity of opinion should prevail. This is a matter which shall engage our serious attention."

In the paper from which he had just read, (the Newfoundland of the 19th February,) he also found the following paragraph:

"The Legislative Council, in their Address

have adopted definitely, and by a unanimous vote, the principles of Confederation, reserving the question of details.

ST. JOHN, March 13.

Montreal despatch reports Fenian meeting in that city on Friday night, and states that 25000 Fenians will take up arms in Canada, as soon as Gen. Sweeney reaches there. The number of volunteers responded to call of the Government exceeds the demand. Bishop Lynch's letter read in all the Catholic churches in Toronto; the Priests called on the people to take no part in the processions.

We notice that the increase on the European and North American Railway for February, is \$1,689 65, being a difference in favor of the E. and N. A. Railway of only \$382 73, which tells favorably for the traffic on the N. B. & C. Railway, and its management.

Every American journal we receive, contains notices of large and enthusiastic meetings of those misguided people called the Fenian Brotherhood, with their head centres, generals, it is *ditto* *omne*; and the telegrams from various parts of the Union, announce that they are only waiting the signal to attack some point in either Canada or New Brunswick.

One grand idea with the leaders is, to send the large amounts collected from their willing dupes, to Mr. Mitchell in Paris, for the avowed purpose of purchasing munitions of war, but more likely to have a snug competency for themselves, when their wicked enterprise fails, as fail it will.

The Fenian organization has undoubtedly increased to huge proportions, if the accounts in the American papers can be credited, and Head Centre Stephens letter to his New York confederates, in which he says—"That he was ready to move the armies of Ireland when the signal should be given. Ireland had 325,000 men ready for the conflict, and had a signal corps as efficient as any in the world."

He could not have had the fear of the suspension of the Habeas Corpus act before his eyes—not the large military force daily arriving in that part of the Empire, or he would never have written such nonsense.

The latest telegrams point to New Brunswick, as the scene of attack, and even Campbell has been named as possessing the most advantages for a maritime port, where they can fit out piratical cruisers, and form a mimic republic. Fenian agents are said to be posted throughout the Provinces, who inform the H. C. of the exact situation of each town, its defenses if any, and the value of all movable property, in fact the leaders are as well informed upon these questions, as the inhabitants. It has been reported for some months that the Fenian circle in Eastport has been drilled, and it is also said that in Calais a Circle has recently been formed. Now all this stir and bustle on the frontier bodes no good, but if they will only "wait a little longer," they will have the satisfaction of meeting their "hated foes," either on land or sea. In the meantime preparations are being made to warn the people and applications have been forwarded to the Commander in Chief for arms, ammunition and men, and also armed vessels for the protection of Her Majesty's loyal subjects on the frontier. Up to the present we confess very little has been accomplished. Men are ready to volunteer, provided they have rifles and ammunition, and upon these being received His Excellency can call out the Militia, and the call will be promptly responded to,—but, Field pieces are required—and also some heavy ordnance for the Fort. In some quarters there is we confess great excitement, and some families are preparing to leave. Capt. Osburn has his Artillery Company under arms, and keeps nightly watch, a supply of ball cartridge and two field pieces are, we are informed, in readiness. The men we are happy to notice, are rapidly acquiring a knowledge of the drill, and a fine soldierly body they are. Capt. Pheasant's Company, are punctual at their drill, under their efficient instructor, Serjt. Quinn, of H. M. 10th Regt.

THE LEGISLATURE met on Thursday last, and His Excellency's Speech, with a synopsis of the proceedings of each day, will be found in our columns. The Hon. Charles Fisher has moved an amendment to the Address; which will test the strength of the Government, as it is virtually a want of confidence motion; what its fate will be, it is impossible to say, but that the discussion will bring out the true state of feeling on the question of Confederation or Union, there can be no question. That there has been a change cannot be successfully contradicted, but to what extent is yet to be determined,—that a Union of the Colonies will take place, is as certain as that the sun shines. No amount of political intrigue can prevent the much to be desired consummation—the current has set strongly in that direction, and no party by its influence ever so powerful can stop it. Upon what basis a Union will take place, we cannot positively state—but we feel that there is sufficient loyalty and patriotism,—without mentioning self-interest—to carry triumphantly a measure desired by the Queen, the British Ministry, Parliament, and the people of England and these Provinces. These are our deliberate convictions, and we state candidly, that we know respectable and influential men who supported the "Anti" ticket, at the last election—who entertain and will support these views by their votes when they have the privilege of doing so at the Polls. The letter of a leading "Anti," elsewhere noticed, proves the correctness of our position.

The St. Andrews Friendly Society, held its Annual Meeting on Thursday last, when several new members were elected, and the exhibit showed that there was a large and rapidly increasing fund on hand. At 6 o'clock the Society and guests, numbering upwards of fifty, dined at Bradford's Hotel. The President Mr. John Lochary Jr. in the chair, after supported by the Vice president and Treasurer. After the cloths were removed, the usual standing toasts were given, and also several volunteer toasts, which were responded to in neat and pertinent speeches. Several songs were sung, and the utmost harmony prevailed. The Company broke up at 10 o'clock P. M. much pleased with the evening's entertainment.

We learn that our respected friend, Lt. Col. Anderson, will visit this County for the purpose of placing the Militia in an effective state—may be on a war footing. The Colonel is so well adapted for the duty, not only from his professional knowledge and experience, but also from his great popularity, that we augur much good from his visit. He will be well received by the officers and men of the Volunteers and Militia.

EXPLORATION.—Mr. Buck, C. E. and his exploring party returned on Saturday, bringing very satisfactory accounts of the country lying between the St. Andrews line and Harris's Mills. They found it remarkably level, with no engineering difficulties except in the neighborhood of the Magogundavic river, and these not of a serious character.—[Courier.]
