SELF-INFLICTED WOUNDS.

There is much to admire in England's present condition, even although it is one of "splendid isolation." Her world-wide Empire and stupendous sea-power, her enormous floating commerce, reserves of capital and capacity for manufacturing would amply justify any quantity of self-gratulation on the part of a boastful Briton if he were inclined that way. As a matter of fact, however, he does not usually indulge in anything like "spread-english," and his patriotic orations are frequently tempered by admissions recommending caution and even conveying reproof to his fellow-countrymen. There is a quotation of this nature from Shakespeare which is frequently used by Imperialists and which might with infinite advantage be pondered over by the English people at the present time. In King John, the Bastard, Falconbridge, taught by his slanders which disunion and treachery had brought upon England, uses the well-known words which form the conclusion of the drama: "This England never did (nor never shall) I set at the proud foot of a conqueror. But when it first did help to wound itself. Come the three corners of the world in arms. And we shall shock them: Nought shall make us rue. If England to herself do rest but true." In these lines the poet makes use of two powerful ifs. England is to have power and inviolability, but only in the event of her never injuring and always being true to herself. History teaches us that, many a time and oft since Shakespeare wrote, England has neglected his warnings, and that disaster has always been the consequence of such neglect. When England restored the "Merry Monarch," and he accepted of Louis XIV., the punishment soon came when the roar of Bayter's cannon was heard in the Thames and when the Dutch fleet sailed proudly along the southern coast, valiantly challenging a contest. More recently England was untrue to herself when, previous to the peace of Tilisi, she refused to go to the aid of the Continental powers against Napoleon. The cowardly of her statesmen averred nothing for she was forced afterwards to wince through seas of blood and spend millions of money to accomplish, almost single-handed, the liberation of Europe. Even at the present day there are indications that the Mother Country has not yet unlearned the fault of helping to wound herself. In reading Colonel Denison's article in the December number of the Nineteenth Century it is difficult to avoid coming to the conclusion that the unpatriotic legislation of sixty years ago is beginning to bear fruit. During that time commercial civilization has been waged in England by the general public against some particular nations, and one after the other navigation, agriculture, manufactures and trade with the Crown colonies have all suffered. And this has taken place in spite of warning, for, in 1843, Lord Beaconsfield protested against the notion that England should fight hostile tariffs by means of free imports. He declared it to be "a policy of the most dangerous kind; at any rate there was sufficient evidence to prove that its immediate consequences would be tariffs more hostile to England."

Colonel Denison also calls attention to the fact that England's commercial policy does not merely wound herself, and we quite agree with him when he writes: "The British Empire is not the Empire of England only. It is partly ours. We have the right to ask that the English people shall take steps to make her condition safe. We have a right to ask the English people to provide against possible disaster from insufficient food supply—either by granaries, bounties or preferential tariffs."
