FIRST EDITION. THE MISSING BELLE.

MANY THINK HANDSOME MARIE TAYLOR IS IN BOSTON.

Clandestine Meetings Between Young Penitentiary and the Royal Keeper's Beautiful Daughter Before the Disappearance.—The Young Man Maintains a Careless Air.

COCONA, Nov. 13.—Probably never will the attention of society in this town be directed to a more absorbing topic than that which now agitates the public mind, and which concerns the handsome daughter of Mr. J. H. Taylor, proprietor of the Thorsen House, and the young man, Ira Penitentiary, who, it is said, holds the young woman a prisoner in some unknown place.

The exact complexion of this case cannot be determined until development commences.

Rumors are as thick as snowflakes in winter. The atmosphere of mystery which surrounds the whole affair, and the assumption of omniscience which all the principals take on, arouses the gravest suspicion.

There was a perfect rush for Herald's exclusive narrative of the social occasion which is shaking the ancient town to its very center.

To-night the interest in the case has increased. The missing girl still remains an unexplained mystery.

The Thorsen House, which is the center of the scene, is one of the oldest buildings in New England. Its origin speaks truly, was established in 1770.

The present proprietor, who is from Newburyport, has been in charge of the Thorsen since the early part of 1898.

His family consists of his wife and two daughters—Belle, aged 17, and Marie, aged 15.

Marie is the subject of the existing sensation, which is 25 years old.

Some years ago Marie was sick for a long time, and a brain trouble, but of late years she appeared to have completely recovered, and gave into a beautiful young woman.

She was considered the belle of the place. A brunette, with piercing black eyes, and a form like Diana, Marie Taylor soon had around her a host of admirers, but none were ever desired to approach closely.

FIRST EDITION. A BATTLE FOUGHT.

THE HONDURAS REBELLION IS NOW PRACTICALLY ENDED.

President Bogoras Forces Completely Victorious—General Sanchez Surrenders—A Barracks—The City Slightly Wrecked.

NEW YORK, Nov. 15.—A special to the Herald from Tegucigalpa, Honduras, says: President Bogoras forces completely routed, the revolutionaries under General Sanchez at the capital yesterday.

The rebellion is thus practically ended, and the inhabitants in a state of jubilation. The loss on both sides has been heavy. Sanchez and his men are surrounded in one of the barracks, which is being bombarded with solid shot.

His only chance of escape is to make a sortie. He does not believe he will become a prisoner to the president, which means not only his death, but that of all his henchmen, and many prisoners. Guerrillas remained loyal throughout the struggle.
