The R. W. Grand Master then delivered the following Annual Address and Report :

OFFICERS AND BRETHREN :

Once more we have the privilege of assembling together as Representatives of the Lodges of the Order, in Canada West; banded together by links which hold us by none other than a moral force; associated in a common cause of philanthropy; armed with no other weapons but such as should be in the hands of every good subject and every Christian man. 'Our little community consisted a twelvementh age of 12 Lodges and 603 members; our labours have been blessed with a good increase; while we have been under the necessity of lopping off many useless and decayed members, the parent stock has been strengthened by the addition of timber of a better growth.' We now number 15 Lodges and 738 members in good standing. In recording the removal of several from our ranks for their own oarelessness; and a few who proved themselves recreant to their duty and unworthy of a seat within our councils, we have, with thankfulness to the Great Giver of every good and perfect gift, to report that of those who met with to th Cath we a obey in o berea attac relati his e

with us in solemn deliberation this time last year, but one has been called to the dread bar of judgement. P. G. Osborne, of Union Lodge, St. Catherines, whose zeal for the advancement of the great work in which we are engaged was unfaltering, whose great pleasure it was at all times to obey the commands of our order, has heen called from our midst. "Within our jurisdiction," says the worthy brother who reports to me this bereavement, "we have lost a bright example of unswerving fidelity and attachment to our noble Institution and its heaven-born principles." His relations and friends have our sincere sympathy; we trust that their loss is his eternal gain; that he has his reward in the mansions of eternal bliss.

It is also my painful duty to announce to you the decease of another highly respected brother, who though not living within our jurisdiction was always considered one of our very selves. He was one of the little band who united with and counselled me cordially in the movement to which we owe our present existence as a Grand Lodgé. P. G. T. McClaren of Quebec, perished in the late heartrending steamboat disaster-one of the victims of. the sad mismanagement of the ill-fated Montreal. Brother McClaren struggled manfully to keep alive the small remaining flame of Odd Fellowship flickering in Canada East; but I am sorry to add, without the success which his exertions merited. A few days before his sad end he wrote me, " although envy is a sin, I feel almost inclined to commit it, when I see the position you occupy in respect to our beloved Order: your circular calling the meeting of the Grand Lcdge at London, has caused me some pain as it arrived at a time when we were about committing suicide, and by the time your meeting is held we shall be no more. The skill of one physician has kept the Order alive in Canada West, but I fear it would require half a dozen such to resuscitate it in Canada East." We hope he was spared the pain of seeing the last Lodge in his jurisdiction broker, up and the funds divided as was contemplated---a measure which he had for a long time, contended against almost single-handed. I cannot refrain from transcribing the words of the Quebec paper which brought me the notice of his melancholy death: "He was a man who proved by his example that intellect can elevate and Christianity soften the rigor of any office, who brought to the management of a jail an amount of judgement, sagacity, resolute intrepidity, and the power of methodical management, which might have sufficed for the command of a fleet or the generalship of an army." 1 may only add that his remains were followed to their last resting place by the principal citizens of Quebec, and by what would more than anything else have been a gratification to him, the children of St. Peter's School of which he was the superintendent. It is recorded "inasmuch as ye did it unto the least of these little ones, ye did it unto me." His fidelity to his trust has verily not been without its reward.

I regret exceedingly that I was unable to appear at Baltimore as your representatives to the Grand Lodge, U. S., that I was unable to thank our brethren for their many acts of kind consideration towards us. The proceedings of this communication are in your hands and you will observe that our interests were not left unprotected. You are I dare say aware that although I could not from pressure of professional engagements leave home, as strong a representation as possible was made for the remission of the claim against us by the G. L., U. S. The application at first was unsuccessful, but upon reconsideration by the committee ; through the kind offices of the R. W. G. Secretary, B. Ridgely. whose name is dear to as all, and especially to those who have the high privilege of his acquaintance, all that we asked was granted, our representation of the case was sufficient to satisfy those who were adverse to our petition. The question in which some of you expressed a strong interest at our last meeting, the mergement of the Encampment order has not yet been settled. It is too long a subject to enter upon, but I am happy to tell you that the growing desire to satisfy the requirements of the Order in this respect is likely to meet with a generous response from all parties. . I must not now omit to acknowledge with many thanks the receipt from the various Grand Lodges of the Union, of copies of their proceedings in the past year, and at the same time to apologise to them for not returning the compliment to all who so favored us. Most of these documents are replete with matter of the deepest interest and instruction, and I trust the several Grand bodies will excuse us for exercising a rigid economy in our management, putting up with the inconvenience of not having appropriate regalia and jewels for our Grand Lodge, in preference to incurring a debt upon the head of our successors. We hope that this explanation will be accepted, and that we may be found to have engraven in our hearts the stern realities of which these emblems and symbols speak so plainly to the external senses.

Much exertion has been made for the advancement of the Order in the western section of the Province by our worthy D. D. G. Masters. I have looked in vain for some sign for good in the East, but the cloud is yet " no bigger than a man's hand." Three new Lodges have been opened whose names will be found in our Report—the one at Mt. Vernon, instituted by the D. G. Master and Grand Secretary, the Lodge at St. Mary's, and the very promising Lodge, taking the name " Forest City," by our highly respected and energetic Brother Bissell, who I am proud to say yields to no one in zeal for the cavies in which we are laboring. I am happy to lay before you Reports from our Deputies Van Brocklin, Bissell, Henry and Claris, with the hope that others will be stimulated by their good example —will be prompted to go and do likewise. While upon this subject allow me to suggest to you the propriety of sending an officer of this Grand Lodge to the several Towns where Lodges formerly existed or where new ones

are likely to be formed, imparting necessary information, stirring up our Brethren to renewed exertion, collecting the scattered properties of the order, and inducing the Lodges in good standing to work uniformly. endeavored but in vain to produre the services of an efficient visitor for the Lodges since last session. A system of proselytizing is at all times to be deprecated, but at the same time it must be admitted that by judicious visitation of the kind I refer to, much good would undoubtedly accrue to the order. There was an appeal case of some importance from one of the Lodges, which I intended to submit for your adjudication, but as the party has since been expelled from the order and is consequently beyond our control, it will be unnecessary to lay the matter before you or take up your time. I have had a good many decisions to make since last session, and have endeavored as far as possible to be guided by the laws of the Grand Lodge, U.S. Among others I decided that when the fact of a candidate's predisposition to ill health or his liability in any way to become a burden to the Lodge, is discovered between the time of his election and the time of initiation, the Lodge, is at liberty and will be justified in refusing him admission. I also rule that a P. G. depositing his card in a Lodge is entitled to his rank in that Lodge, but is otherwise governed by the local By-laws. The name under which the dispensation for a Lodge at Mt. Vernon was granted was Kirby Lodge, but upon a petition of the members and with the advice of the D. G. M. Van Brocklin, it has been changed to Imperial Lodge No. 37. I am very happy to notice that through the exertions of our worthy Bro. D. D. G. M. Claris, the ladies of St. Thomas have shown an intrest in our order, and a goodly number have received the degree of Rebecca. It is pleasing to notice the advancement of this branch of the order. Wherever the influence of woman is exerted in a labor of love good must result.

Ours is a cause to which the energies we are possessed of, should most unreservedly be devoted. It gives us free scope for the exercise of principles founded upon justice to ourselves and our fellow men. We claim no prominent place-we say not " stand off, we are holier than thou ;" but we do say that if we have attained to "light and liberty" we are the more responsible for it. We ask others to examine our fellowship, and if they see aught of good in it to follow our example. To our own members we say be not weary in well-doing -- be not satisfied in having filled the chairs of your Lodge ; the command of your order is still binding upon you-the purpose for which the Order was Instituted never dies-persevere then in the good cause while this earthly tenement incases the brighter spirit within !

The Grand Secretary then submitted the following report :

To the R. W. Grand Lodge of Canada West, I. O. O. F.

It has been the commendable custom and practice of those who have been appointed to fill a similar office to the one which you at your last Annual Communication did me the honor (much against my wish, for reasons which I then expressed,) to confer upon me, to lay before the Grand body in which they may have held the office, a detailed report or statement of the manner in which they may have discharged the duties thereof during their respective incumbencies, and I have observed that many of these Reports are the result of much, and oftentimes great labour and consideration.

It has, however, been my good fortune to have been so honored under and during the administration of one, I mean the honored originator and founder of your noble institution in this section of the Province, who has watched over its every interest, and been unto it a nursing father from its birth up to the present cheering, gratifying, and (as I hope from the bottom of my heart it may prove) auspicious moment, that I have had little or nothing to do, indeed, he feels such a paternal regard and solicitude for all its interests, both physical and mental, as to be unwilling to trust even the least of them in the hands of any of his subordinates without his supervision; and while those interests have been thus better promoted and protected, the labour of his subordinates has been rendered comparatively light and easy, and, therefore, I, as one of them, have very little to say on this occasion, indeed nothing, unless it is by way of apology.

When I accepted the post assigned me, I did it most reluctantly, fearing, as I did at the time, and as I then stated to you, that my official and professional duties were likely to be such as to render it out of my power to discharge those which would necessarily devolve upon me by its acceptance in a manner worthy of their importance, and my fears have been more than realized, as I feel that I have come far short of my duty in many if not in every respect.

1 am consoled, however, in the reflection, that the great interests of our beloved and heaven-born institution, under a good and all-wise Providence, in the hands of our noble, most excellent, and highly esteemed Grand Master, have not suffered in any manner, but contrariwise have been promoted beyond anything we could have anticipated under all circumstances, and such being the case, I can and do with some degree of confidence throw myself upon your kind and fraternal indulgence for all my short comings, and sins of commission and omission, since I was honored with the office which I now surrender up to your hands.

A statement of any financial matters that may have passed through my hands will be duly laid before you, and all books, papers, documents, and other things appertaining to, or belonging to the office will be handed over to my successor.

At the close of the year ending June 30th, 1856, we numbered within the juridiction of this Grand Lodge 605 members in good standing, with a Widows and Orphans' Fund of £1033, and a General Fund of £1223. At the close of the present year, we have the gratification of saying that we have 738 members in good standing, showing an increase of 133; with a Widows and Orphans' fund of £1330 13s. 6d., and a General Fund of £1592 6s. 10d. This, compared with the report of last year, cannot but be gratifying to every Odd Fellow, and is an earnest of what may be expected in the future, when the energies of the Order are fully developed, and we all engage as one man to spread the knowledge of its principles.

Your Committee deem it unnecessary to take up each lodge in order to report on its standing and progress, and the usual matters contained in the Reports of the different District Deputies, as these have all been discussed in the very lucid and interesting report of the Right Worthy Grand Master.
