ADDRESS TO THE SYNOD.

The Clerical Secretary read the following Address to the Synod from a Committee of the Vestry of St. George's Cathedral: To the Lord Bishop, the Clergy and Laity of the Diocese of Ontario, in Synod

In accordance with a resolution passed by the Vestry of St. George's Church, Kingston, on Easter Monday , April 6, 1863, the undersigned, being appointed a Committee to "memorialize the Synod of the Diocese of Ontario, in relation to the unfortunate position of St. George's Church, in respect of the Rector," beg to state, that in calling your attention to the occurrences which have lately convulsed the Congregation whom we represent, it is not our wish to disturb the harmony of the Synod, or to

ask for an investigation into the painful personalities which have unfortunately complicated and added bitterness to the contest. On the contrary, we desire studiously to avoid all reference to the peculiar circumstances of our case, not only because we perceive the extreme difficulty the Synod would experience in dealing with them, but also because the whole matter has already been placed before the public, which must form its own judgment upon the facts. Our object in addressing you is rather to induce you to reconsider your recent action on the important question of patronage, and respectfully but strongly to impress upon you the inexpediency of wholly ignoring the claims of the laity to any, even the smallest, voice in a matter which concerns them and theirs so deeply as the selection of their Pastor for life.

It is to be regretted that longer notice of so important a change as that made by the last Synod, was not given, and especially that it was not deferred until the election of new delegates had afforded the various Congregations an opportunity of distinctly expressing their opinions on the subject. We cannot but feel that a measure like this ought not to have been hurried through at a few weeks' notice, at a second meeting of the Synod ; and we fear that much evil is certain to arise from the attempt to apply to us a system so peculiarly unsuited to the temper of the people of Canada, and sought to be put in force without the slightest precaution in avoiding dangerous collisions between Congregations and their Ministers. As we understand, the custom of vesting the right of presentation to particular parishes in single individuals is of considerable antiquity in our church, but, as we also believe, the practice of concentrating all the patronage of a diocese in any one man's hands is not only not sanctioned but is actually discouraged by English usage; and that the system of presentation arose, in a great measure, from the marked disincliration which the people of England have always evinced against centralizing power in the hands of the Bishop or Government of the day. In former times, doubtless, the majority of Congregations in England may have been illiterate, and perhaps incapable of forming a correct opinion of the qualifications of their Clergyman. But we cannot suppose that this Synod would insult the laity of the Diocese by maintaining that the same ignorance and incapacity which prevailed in the middle ages exist now, or that a Clergyman is so far exalted above the laity that they are necessarily wholly disqualified from forming an opinion of his piety or his talents. Moreover, we hold that all presentations are a sacred trust, to be exercised by Patrons with a single eye to the benefit of the people, and for no other purpose whatsoever. If, indeed, the power which gave could recall, and if a Patron who presented could remove the presentee, there might be a remedy, when inappropriate presentations were made. But we must remember that, by law, every benefice is a freehold, and consequently

that a Minister, once installed, becomes practically a fixture for life, irresponsible alike to the people for whose benefit he is supposed to have been placed there, and, in a measure, to the ecclesiastical superior to whom he may owe his advancement. When we consider this, the great danger of placing a man in the closest and most sacred life-long relations with a Congregation, without taking the smallest precaution to ascertain whether he is or is not likely to prove acceptable to them, would seem to require no comment. We would most respectfully ask whether the Synod are prepared to assert that no regard should be paid to the wishes and feelings of the Congregation in selecting a Minister, or whether they can possibly maintain that the most decided aversion on the part of the people is no serious objection to a Pastor's entering upon one of the closest of all possible human relations, and that nothing short of legal proof of misconduct, serious enough to deprive him of his gown, can justify a Congregation in objecting to an appointment. It is true, and we are far from denying it; that Congregations, when left to themselves, do not unfrequently make a mistaken selection, but independently of the fact that they are not more likely to commit an error in this respect than those to whom the appointment would otherwise be entrusted (while they might reasonably be expected to bear the results of their own mistakes with more patience than those of another,) it must be remembered that what we are contending for is, that Congregations shall have a voice in the appointment of their Min-

And although, for the reasons given above, we have deemed it right to request our representati es to abstain, [unless specially called upon,] from occupying the time of the Synod with our congregational difficulties, we cannot refrain from pointing out to you the great evils which have arisen, in our own case, from neglecting to ascertain the feelings of the Congregation towards the Clergyman appointed to minister among them, and which may; and no doubt will; follow every similar error in whatever part of Canada it may be committed. What do the circumstances show? Our Congregation as it were dispersed-our oldest and most estimable Church members abandoning their wonted place of worship after a continuous attendance of a life time-our Church revenues diminizhed-the unseemly spectacle of one of the largest Congregations of the Diocese, inhabitants of the Cathedral town, at open war with their Bishopthe injury to his position-the additional difficulties likely to rise in the working of the Diocese during the continuance of this state of things-the appeal to the Courts of Law, and the possible intervention of Parliament itself. All these things speak trumpet-tongued, and all read but one lesson-the exceeding impolicy of refusing to consult Congregations on this subject, or of attempting to introduce a system so unsuited to a country like Canada. We have no desire to create a prejudice. We

only wish earnestly to press this one fact upon your attention, that all this injury to the Church and to us might have been prevented by the simple expedient of giving notice of the intended appointment, and giving heed to the feelings and wishes of the Congregation. Surely, on the mere ground of courtesy, not to speak of Christian feeling, it would be advisable to notify a Congregation some little time in advance of the actual presentation and induction. We understand it is customary to do so in other Dioceses. Nay, in Montreal it is the practice for the Congregation to nominate three Clergymen, of whom the Bishop selects one; and were this plan followed in our own Diocese, it could not be said it was without precedent, or that it detracted from the rightful authority of the Episcopal office. In Nova Scotia, presentations come from the parishes; and in the United States, the Congregations present.

Moreover, as regards the right of Congregations to be consulted, we hold that it was virtually conceded, once for all, when the laity took part in the election of the Bishops themselves, since it is impossible to see on what grounds it can be maintained that laymen, though well able to decide on the merits of a Bishop, are necessarily incapable of judging of the fitness of a Clergyman to be their Pastor.

It is not our wish to enlarge on the possible danger which may accrue to the whole Rectorial grant throughout Canada, if it should unfortunately come to be guerally believed that these endowments are administered without due reference to the special trusts for which they were created; but we cannot in justice to the Church abstain from expressing our conviction that a repetition of the occurrences which followed the late appointment to the Rectory of Kingston will have a most injurious effect upon the interests of the Church in this particular. And we must say in all frankness, that however much we may be disposed to admit the excellence of the motives which actuated the late Synod, we cannot but feel, that in delegating a trust like the power of presentation to other hands, without taking any precaution whatever to secure the power's being exercised with due regard to the feelings and interests of those intended to be benefitted thereby,] they did, unwittingly, a very serious injury to us, and to the inhabitants of the remaining Rectories. And we think that such action on their part was the more to be deplored, inasmuch as, being in part an elective body, it was hardly right to deprive their successors, as well as themselves, of one of their most valuable privileges.

In conclusion, we desire to state to the Synod, that although our object in addressing them is mainly to advocate reconsideration of the former action on the subject of patronage, and although we have carefully abstained from entering upon details of our own particular grievances, yet we should be completely deceiving the Synod if we hesitated to express our conviction, that the breach in our Congregation and neighborhood cannot l pointme

No action was taken by the Synod on the foregoing memorial. THE BISHOP'S ADDRESS.

His LORDSHIP then gave the following statement of the facts relating to the appointment of the Very Rev. W. B. Lauder to the Rectory of Kingston :

My Rev. Brethren and Brethren—Since we last met the Diocese has been disturbed, and the minds of Churchmen perplexed, by circumstances arising from my having appointed the Rev. Dr. Lauder to the Rectory of St. George's Church, Kingston. I have been branded with the foulest names, and the Church has been injured, to the utmost possible extent, by a portion of the Vestry of the Cathedral of the Diocese. A truthful statement of the whole difficulty cannot easily be obtained by individual members of the Church, owing to the multitude of letters and pamphlets which have been published by violent partizans, who seemed to care little how far the Church was injured provided they could give vent to their angry invectives. I determined to await this meeting of the Synod as the proper time to defend myself from the attacks of my assailants, whose conduct has proved that they aimed quite as much at overwhelming me with personal insults as at redressing a supposed ecclesiastical grievance.

I now ask your attention to a plain statement, which is easily authenticated by any one who will impartially consider the subject.

The Synod met in Ottawa Nov. 5th, 1862, and on the following day the question of the Patronage of the twelve Rectories in the Diocese came up for consideration. A resolution whereby the right of presentation to those Rectories was vested in myself during my life or incumbency, was proposed, and gave rise to much discussion. Two amendments were moved ; the first of which was to the following effect : "That during the life or incumbency of the Right Rev. J. T. Lewis, Lord Bishop of Ontario, the appointment to all Rectories within this Diocese be vested in the aforesaid Right Rev. J. T. Lewis as such Lord Bishop, his Lordship consulting the Churchwardens and Lay Delegates of the vacant Rectory ; and that such appointments to Rectories as have been made in this Diocese since the Synod in April last be hereby confirmed." After this amendment had been spoken to, I rose to put the question, and before doing so told the Synod in the plainest terms that I would not accept the Patronage if I were bound to

I reminded the Synod that as they legally possessed the Patronage of the twelve Rectories, they could retain it in their own hands, but if they thought that the interests of the Church required that it should be exercised by the Bishop, they must give it to him untrammelled by any conditions whatsoever.

In consequence of my remarks, the amendment was withdrawn and another substituted, namely: "That all Rectories becoming vacant, the appointment shall be made in the following way: A Vestry Meeting being called, three Clergymen of the Diocese being named by a two-thirds vote at said meeting, that the Bishop shall then choose one from the three recommended." This amendment gave occasion to a debate, at the close of which I again informed the Synod that I must decline acc. pting such a trust as that involved in the amendment; that I could not in justice to myself share in a divided responsibility, and that I had a decided aversion to the invidious task of selecting one out of three names submitted to me by a vestry. The second amendment was then withdrawn.

This seems to me to be the place to call your attention to the first charge made against me in a speech uttered in the Vestry Meeting of the Cathedral by one who was not present at the Synod, and who should therefore have been cautious how he represented my conduct. The Vestry was told that "after a very peculiar use of my power of veto," I obtained the right of presentation to all the Rectories. This Synod knows that there was no opportunity afforded me of exercising a veto at all, Both amendments were withdrawn, the Synod seeing the unfairness of thrusting on me a duty which I disliked and refused to perform. The right of regulating the Patronage still remained with the Synod who might have conferred it on any body politic or corporate, or have themselves presented by open vote on each occasion of a vacancy. It is certainly a very peculiar use of language to describe my determination not to accept a conditional trust to which I had a great repugnance as an excrcise of veto power, but this misrepresentation did the work for which it was intended, and inflamed the Vestry.

The original motion was then put and carried by a vote of 43 Clergymen to 4, and 20 Parishes to 10.

After the motion was carried, I rose and thanked the Synod for the confidence they had reposed in me, and expressed myself to the effect that I would endeavor to fulfil the trust unconditionally reposed in me to the best of my judgment, and that it was not to be supposed that a Bisbop, whose only aim would be the good of the Church, would appoint a Rector to whom the Congregation had a decided dislike. I cannot now remember whether these be the exact words I used, but I do say that they express my meaning, and furthermore, positively affirm in the presence of this Synod, most of whom were ear-witnesses, that it was after the vote vesting

the Patronage in the Bishop had possed, that I volunteered the observations I made, and that not a word of mine, spoken on that occasion, can be honestly represented as uttered with a view to induce the Synod to present me with the Patronage. I must be explicit on this point, because the most serious charge made against me is that of having broken faith with the Synod. The same individual who falsely accused me of having made a "peculiar use of my veto," asserted that I obtained the right of presentation to the Rectories "on the honorable understanding" that I would not use that power to make any appointment distasteful to the wishes of a congregation, and informed the Vestry of the Cathedral that all the witnesses whom he consulted were agreed on two points-" that his Lordship pledged himself in substance not to make any appointment distasteful to a congregation, and that he gave this pledge before he got the power into his hands at all." Now, were I guilty of such baseness as this Vestryman laid to my charge, I should indeed be unworthy of your confidence; but when it is remembered that when the first amendment was before the Synod, one which merely stipulated that I should consult the Churchwardens and Lay Delegates, I positively refused to pledge myself to consult anyone, and also, that the observations I made which are tortured into a pledge, were spoken when I was returning thanks for a vote already passed, I think it impossible to conceive a more wicked slander than that perpetrated in the Cathedral Vestry, and spread through the Province by a

I must now proceed with my statement of the facts in the order in which they occurred. At the time the Sec.

At the time the Synod conferred on me the patronage of the twelve Rectories, the Rectory of Kingston had been vacant for a month; and curiosity was excited as to the person who would be appointed. The name of the Rev. Dr. Lauder was spoken of at Ottawa, and more than one Clergyman was an applicant for the mission of Brockville, which it was conjectured would be vacated by Dr. Lauder's removal to Kingston. I did not, however, appoint Dr. Lauder precipitately. I delayed his appointment twelve days, and then inducted him to the Rectory, no remonstrance of any kind having been made to me regarding him. His induction took place on the 18th November, and on the 13th or five days previously, I was memorialized by the two Churchwardens and three Lay Delegates of Brockville in favor of the Rev Mr. Tane as Dr. Lauder's successor. I mention this to show the publicity of the intention of appointing Dr. Lauder to Kingston. The three Lay Delegates of the Cathedral were present at the Ottawa Synod, and whether they heard of Dr. Lauder as the probable Rector of Kingston or not, they never spoke to me on the subject. Here let me say that if the Cathedral congregation were so apprehensive that Dr. Lauder would be appointed, it was the bounden duty of the Lay

Delegates, or some members of the congregation authorized so to do, to have remonstrated with me, particularly as I had been so explicit at the Synod in expressing my determination not to bind myself to consult any one before making an appointment. But it is replied that I was already aware of Dr. Lauder's unpopularity. Now, I candidly admit that I felt convinced that Dr. Lauder would never have been elected by the Cathedral Vestry, on account of his reputed exertions to obtain my election as Bishop of this Diocese. This I knew was enough to prevent his being a favorite with a Vestry which stood almost alone in its opposition to my being elected Bishop. But I say also, in the most solemn way, that I had no conception whatever of the extent to which the Vestry carried their hatred of Dr. Lauder. I hoped that as acquaintance with myself seemed gradually to lessen the Bishop's unpopularity, so after a while the dislike of the Rector would diminish on better knowledge of his true character. I therefore now repeat what I have before stated, that I did not believe Dr. Lauder's unpopularity to be of such a nature that it would prevent his usefulness, and I appointed him because it was of great consequence that the Rector of the Cathedral should be a personal friend and of the same views on Church matters with myself; besides I knew him to be a useful Parish Clergyman of eighteen years standing, and a Doctor of Laws of the same University as rayself. On its being known that Dr. Lauder was inducted, a large majority of the Vestry was much displeased, and next day an indignation meeting was held. Three Resolutions were passed, one of them of the most offensive character-it implied that a simoniacal contract existed between Dr. Lauder and myself. I am justified by every consideration of honor and justice, and those feelings which should be entertained towards their Bishop by Churchmen at all worthy of the name, in denouncing that meeting. No amount of charity can prevent my attributing to the chief perpetrators of that outrage an eagerness to expose the Bishop, and gain their point by intimidation. Not a word of remonstrance was vouchsafed. No attempt was made to induce me to re-consider the appointment. The courtesy of sending me a copy of the Resolutions was not extended. The reason of my laying such stress upon the conduct of the Vestry, is my knowledge of the fact that there never need have been the least trouble in arranging matters to the satisfaction of the congregation. Had a memorial or a remonstrance signed, as it might have been, by a very large majority of the Vestry, been sent to me, I should have thought it my duty to lay it before Dr Lauder, who would unhesitatingly have withdrawn from his position, and all the subsequent difficulty would have been avoided. Though I felt greatly hurt by the action of the Vestry, yet I determined to exert myself to bring about an amicable arrangement, and I therefore advised Dr. Lander to send me a conditional resignation. I could not advise him to resign absolutely, under the circumstances; but I

urged him to resign conditionally, on all charges against his moral character being either investigated or publicly withdrawn. Dr. Lauder consented, and I consequently convened a meeting of the congregation, at which I informed them that I held Dr. Lauder's conditional resignation, expressed my willingness to institute a legal investigation, and plainly intimated that I could not accept the resignation till the third resolution of the indignation meeting was explained. Four days after this meeting another Vestry was held, and the obnoxious resolution was declared to imply no such charge against Dr. Lauder and myself as we supposed it to contain. A deputation waited on me with this apology, requesting me to accept Dr. Lauder's resignation. I told the deputation that I was very glad indeed to receive the announcement of the Vestry having withdrawn their most offensive resolution, and expressed myself as perfectly satisfied, but I was sorry to be obliged to say, also, that I observed in the public papers a report of their meeting, in which an individual had spoken of "disgusting rumors" regarding Dr. Lauder, and another person had spoken of the Dr. as one from whom they "shrunk instinctively;" that I could not accept Dr. Lauder's resignation without investigating these rumors, and that if I did at once accept the resignation it would appear as if I wished to screen him from enquiry. The deputation replied that it would be a hardship if the Vestry were to suffer for the rash observations of one or two of their number. I said that, nevertheless, I must not seem to act precipitately, that but a short delay would be involved, and that I would give the person or persons who repeated or invented these rumors a fortnight to decide as to what course they would adopt. I expressed 'my intense anxiety to sift these rumors by a commission of enquiry, and intimated that if at the expiration of the given time my offer of a commission of enquiry was not accepted, the resignation of Dr. Lauder would take effect. The deputation seemed to think my proposal a reasonable one, and retired, as I thought, satisfied.

I must here add that besides the mention of "disgusting rumors," three members of the Vestry had put in writing over their signatures their intention "to impugn" both Dr. Lauder and myself, and further said that they could not "make charges before a court constituted and presided over by his Lordship." Thus I was justified in determining not to accept Dr. Lauder's resignation with indecent haste, but calmly to await the action of our assailants. Indeed, so evidently were serious charges against Dr. Lauder's moral character supposed to lie in the background of this controversy that twenty-five members of the Vestry sent a requisition to the three individuals who had promised "to impugn" Dr. Lauder, and earnestly solicited them to prefer their charges within the specified time or else publicly to withdraw them. Two of the individuals so appealed to replied in an evasive, and what I must call a disingenuous letter, the only

part of which that related to the subject was a clause in which they say, "we distinctly deny that the Rev. Mr. Bartlett had the least authority to call the memorandum 'charges' preferred in any shape or way by us." What these persons meant by writing to my secretary on November $25th_j$ and expressing their intention of "impugning" both the Bishop and Dr. Lauder, and objecting to my court as a proper tribunal before which to investigate those "charges_j" and afterwards_j when brought to the point by a straightforward requisition, to reply that their "charges" should not be called charges by Mr. Bartlett, I cannot determine, unless the letter in question was written for the wicked purpose of intimidation.

At this stage of the proceedings, therefore, nothing remained to be done but to wait till the time I mentioned had expired, and all that the Vestry desired would have been accomplished. But another Vestry was held December 1st, when a resolution was moved which re-opened the whole offensive allegations, and was supported in a speech of singular vindictiveness. The Vestry did not, however, sustain the resolution, but passed one in amendment, to the effect that, at the expiration of two weeks. the Bishop be asked to give an answer to the deputation. The proceedings of this Vestry, especially the speech in which all manner of gossipping charges were made against myself and Dr. Lauder, attracted great attention, and the result was that Dr. Lauder, goaded by this constant persecution and urged on by his friends in Brockville, who were jealous for his reputation, withdrew his resignation, and so left me powerless at a time when I thought peace and harmony on the point of being re-established. I could not possibly blame Dr. Lauder for thus determining to defy his assailants, which he did without any consultation whatsoever with me, nor can I now, after many months of reflection, blame myself for feeling indignant at the conduct of the Vestry of Dec. 1st, in allowing a long speech full of venom and falsehood to be launched against their Bishop in the presence of reporters for the press, at a time when they knew that I had no legal power whatever over an inducted Rector, and that nothing could be accomplished in the way of arranging our difficulties except by forbearance.

In order to intensify feeling the original cause of the whole controversy, namely, Dr. Lauder's appointment, was gradually withdrawn from public attention, and all sorts of extraneous matter introduced. Some disputed notes of the Episcopal Fund given at Renfrew, the dismissal of Mr. Stewart, a contradiction made by myself to a statement of Archdeacon Brough, and such like topics were brought in to blacken the Bishop's character. I have no intention of occupying the time of the Synod with a refutation of these malevolent statements which only excite in me a sentiment of pity for the compiler of them. Synod whom I highly respect are indirectly made parties to it. It is said that I managed to procure from the Vestry a withdrawal of their offensive resolution at the indignation meeting, by employing the good offices of the delegates of the other Kingston Churches, and by leading them to believe that I would instantly accept Dr. Lauder's resignation if the obnoxious resolution were withdrawn. The circumstances which led to this accusation are worth attention as showing how slight a pretext will sometimes be sufficient to supply grounds of suspicion.

After the meeting convened by me on Nov. 24th, there appeared an article in a Kingston newspaper which endeavored to enlist the sympathy of the other churches in favor of the Vestry of St. George's, by an attempt to show that their interests were equally at stake and identical with the Cathedral. Wishing to remove this impression I asked the Delegates of St. James', and St. Paul's Church to meet me, and I explained to them the peculiar circumstances of a Cathedral Church. I told them that their Churches were very differently circumstanced from St. George's, inasmuch as the congregations they represented partially supported their Ministers, and I gave the history of the dispute between the Vestry and myself. This, and this alone, was the object of the meeting, and nothing was further from my thoughts than to ask the Delegates present to mediate between myself and the Cathedral Vestry. Indeed such an idea would not have occurred to the Delegates were it not for the unfortunate circumstance that one of the Delegates of St. Paul's Church was also a Vestryman of St. George's, and he with, no doubt, good intentions diverted the conversation into an attempt to get a promise from me that I would accept Dr. Lauder's resignation if the offensive resolution was withdrawn. I positively refused to make any such promise, but in answer to the very pressing appeals and urgent application of the Delegate, I did say that the way would thus be opened for amicable arrangement. On my leaving the meeting the Delegates, without my knowledge, agreed on a resolution which they intended to persuade the Cathedral Vestry to adopt. I am told that they exerted themselves most laudably to obtain the passing of that resolution, but I neither wished nor asked them to do anything of the kind, nor did I think it would have ever occurred to them to act in the matter but for the presence of the Delegate from St. Paul's, who being a member of the Cathedral Vestry also, made use of the meeting, I had called for a specific purpose, to further his own good object. Indeed I have no doubt whatever that the Cathedral Vestry would have passed the resolution in question, sooner or later, whether the Delegates of the other Churches had interfered or not ; but however that may be, I had not the remotest intention to use the Delegates as mediators in any way. They acted, however, I am convinced, from the best motives, and I affirm that strict faith was kept with them ; since, after the resolution

they wished for was carried in the Cathedral Vestry, I told the Vestry that we were now in harmony again, and that a great obstacle to my accepting Dr. Lauder's resignation was removed, but that I must wait a little to give the retailers of the "disgusting rumors" an opportunity of bringing their charges before an Ecclesiastical tribunal.

In concluding this statement I have to say that no one can possibly regret more than I do that this agitation should have been commenced, but having been set on foot, I resolved to meet it firmly. My duty towards the Clergy is as imperative as my duty towards their congregations, and I freely confess that I should prefer that a Congregation should be wholly dispersed rather than that one innocent Clergyman should be sacrificed to clamor, and his character blasted forever. Another congregation can be gathered, but a reputation blasted is gone forever. I am thankful to say that the Cathedral Congregation has not diminished, but so far as I can judge, much increased, especially at evening service. The Offertory is larger than ever it has been, and the Communicants more numerous than formerly. I am not without hope that an arrangement may yet be made, through the Christian feeling of Dr. Lauder, whereby harmony may be perfectly restored, but of this there is no certainty till the decision is given in the Chancery suit, which some men. ars of ...e. Cathedral Vestry have commenced against this Synod to set aside thair by-law respecting the patronage of the Rectories. Whatever may be the opinion of the Cathedral Congregation the Diocese at large knows that I am ever disposed to listen respectfully to the reasonable wishes of congregations on any subject, more especially on the important one of the appointment of their pastors, but the moral derivable from the agitation in Kingston is this, that it is safer and better to use in the first instance remonstrance and friendly negociation, before we appeal to the passions of indignation meetings, and the prejudices of an uninformed public opinion.

ELECTION OF CLERICAL SECRETARY.

The ARCHDEACON brought forward, as the first order of the day, the following recommendation of the Executive Committee:

That in order to the efficient management of the various Funds of the Synod a competent Book-keeper be appointed by the Bishop, at a salary of \$300 per annum: and that he be paid the sum of \$500 from the Commutation Fund, and \$100 from the Episcopal Endowment Fund; and that an Honorary Clerical Secretary be appointed at a salary of \$100 per annum, to be paid from the Assessment of Parishes.

That if among the Clergy of the Diocese there be found one capable of performing the whole duties of Secretary, be keeper of the Books and Records of this Synod, such person be selected, whose salary will be \$600 per annum, and who will give security for the honest and faithful discharge of the duties in the sum of \$4,000.

Against this unjust preference this Synod enters its solemn protest, and demands, as an act of common justice, that the privileges granted to the Roman Catholics be granted to ethers, or that those now accorded to the same be withdrawn.

REPORT OF COMMITTEE ON DIVISION OF FUNDS. The Committee appointed by the Synod of the Diocese of Ontio, at its Session in November last, to confer with a similar formittee from the Diocese of Toronto, in order to investigate

the state of the Commutation and other Funds, with a view to an equitable division of the same, beg leave to

REPORT :

That in pursuance of their Instructions from the Synod, they proceeded to Toronto the following week, and having presented their credentials to the Committee of the Church Society of the Diocese of Toronto, they requested said Society, with the sanction of its President, the Bishop, to appoint a corresponding Committee to confer and arrange with your Committee as above.

That upon attending the Quarterly Meeting of the said Church Society the following day, your Committee were informed that with the sanction of the Lord Bishop of the Diocese, the Hon. John Hilyard Cameron, and the Rev. Dr. Fuller, had been appointed to represent the interests of their Diocese in the premises, and to arrange with your Committee the terms for an equitable division of the Lands, Stocks, and other Securities held by said Diocese of Toronto in trust for both Sees.

The Gentlemen thus named met your Committee the following day, at 9 A. M., and negotiations were at once commenced in a most amicable and conciliatory spirit, which tended greatly to facilitate the settlement of the important interests at issue. The first principle settled, was to abide as closely as possible by the award of the late Chief Justice Macauley, when he acted as joint arbitrator between the respective Sees of Toronto and Huron, in the division of Funds, Lands, &c., between them.

The joint Committee then entered upon the division of the Lands owned by the Ven. "The Society for the Propagation of the Gospel in Foreign Parts;" and it was finally agreed that the Diocese of Toronto should assign to the Diocese of Outario 600 Acres of said Lands, for a description of which, and other Lands to be hereafter referred to, see the paper annexed marked Letter B.

With respect to the lands belonging to the General Purpose Fund, and the Widows' and Orphans' Fund, it was agreed that they should be divided in the proportion of one-third to the Diocese of Ontario, and twothirds to the Diocese of Toronto; the result of which division gives to this Diocese from the General Purpose Fund, 450 Acres, and from the Widows' and Orphans' Fund, 383 Acres-See Letter B.

It was further agreed that this Diocese should receive other lands belonging to the General Purpose, and Widows' and Orphans' Funds, and situated, lying, and being within the limits of this Diocese, amounting to 650 Acres—See Letter B.

Moreover, all Lands held in special Trusts for the benefit of Interests within this Diocese, were directed to be assigned to this Synod-said miscellaneous Trusts amounting to 1400 A. 2 R. 16 P.—See Letter B.

At a subsequent meeting it was discovered that 100 Acres of the Lands assigned from those pertaining to the Ven. S. P. G., being the Glebe in Ameliasburg, were already in the possession of this Diocese, and therefore the Committee of the Diocese of Toronto agreed to give 200 Acres in Mariposa, in lieu thereof, thus making, in addition to the said Glebe, 700 Acres derived from the Lands of the S. Having thus arranged for an equitable division of the Lands, the attention of the joint Committee was next directed to a settlement of the Commutation Fund : but here the Committee were stopped, almost in limine, by the inability of the Secretary to furnish them with the exact amount contributed to the Commutation Fund by the Clergy of the respective Dioceses of Toronto and Ontario. At this stage of the preceedings it became necessary for the Hon. J. H. Cameron to leave for the City of Hamilton; so after making out a list of documents for the Secretary to have in readiness prior to the next meeting, which it was arranged should be held early in January, the first conference of the joint Ccmmittee was terminated.

Owing to the sickness and lamented death of the Rev. T. S. Kennedy, the able and energetic Secretary of the Diocese of Toronto, the necessary documents could not be prepared in time to enable the joint Committee to meet until the 4th, and the two following days in February, when, in the judgment of your Committee, a satisfactory adjustment of the Commutation and other Funds pertaining to the two Sees was mutually agreed upon.

I. THE COMMUTATION FUND.

After some discussion the joint Committee agreed upon the List of the Clergy who commuted within the bounds of what now constitute the respective Dioceses of Toronto and Ontario, and it was agreed to divide the Commutation Fund on the principle of giving to each Diocese what it had originally contributed to the Fund, while the profits which had ac-crued should also be equitably divided, in proportion to the sums thus contributed by each. From the List thus agreed upon it appeared that 40 Clergymen commuted within the Diocese of Ontario, and that the amount of their commutation was £60,880 17s 11d. Cy. Their names and respective sums commuted for, are fully set forth in the paper marked A. hereunto annexed. The number who commuted in what new constitutes the Diocese of Toronto, was 68, and their commutation amounted to £115,118 5s 62d, as appears from the annexed paper marked C. According to these proportions this Diocese became entitled to one-third of the profits of the Fund, or £13,257 4s 6d. cy., which, added to the sum contributed by this Diocese, gives to it the total amount of £74,138 2s 5d, cy. This amount is to be received by taking the one-third of those Debentures, Bonds, Mortgages, and capitalized Interest in which the moneys of the Fund are invested. The details are fully set forth in the paper marked D. hereunto annexed, and from which it will appear that this Synod will receive an equitable share of the Investment. The following is a brief abstract of the paper marked D. :---

By the death of the late Venerable the Archdeacon of Kingston, the Diocese of Ontario is virtually entitled to a further sum of ± 756 from the Commutation Fund, the interest of which it is designed should form a portion of the stipend of the Archdeacon of Ontario, but this sum the Diocese of Toronto will not assign to the Diocese of Ontario, until the Synod of said Diocese shall have executed a covenant to the Church Society of the Diocese of Toronto that the said sum of £756, together with the sum of £910 13s 4d, cy., "to be provided by the said Synod of Ontario, shall stand, be and for ever remain a fund, from the proceeds of which a Salary of One Hundred Pounds per annum shall be for an Archdeacon of Ontario for the time being."-See award.

No. II .- THE WIDOWS' AND ORPHANS' FUND.

In the division of this Fund, the joint Committee took as the basis the amounts contributed within the limits of each Diocese for the past 20 years, and ascertained that the proportion contributed by the Diocese of Ontario was as 5 to 13; Ontario having contributed \$5,270 92c., and Toronto proper the sum of \$13,456 52c., as appears more fully from the details of the paper marked E. At the estimated value of the securities, as agreed upon by the joint Committee, they amount to \$15,665 (as shown more fully in the paper marked F.) five-thirteenths of which sum amount to \$6025, in satisfaction of which amount the following Securities, &c., were received, as more fully exhibited



Mission Fund.

This fund consists of \$3200, invested in Mortgage, to one-third of which the Diocese of Ontario is entitled. This proportion, however, amounting to \$1066.34c, the Ontario Committee agree to give up, in part payment of the indebtedness of that Diocese to the Mission Fund, paying the balance of \$29.55c in cash.

General Purpose Fund.

One-fourth to the Diocese of Ontario, of any balance at the credit of the fund on the 1st January, 1863.

Commutation Fund.

Such proportion of the Fund, as was contributed by those who were doing duty within the limits of the Diocese of Ontario, at the time of the Commutation.

The number of such Clergy was forty; the amount of their Commutation was $\pounds 60,880$ 17 11. The proportion of the profits, to which they were entitled, being one-third thereof, and amounting to $\pounds 13,257$ 4s 6d, and making the *total* sum, to be paid to the Diocese of Ontario, on this account, $\pounds 74,138$ 2s 5d, in the following securities, at their par value.

REPORT OF COMMITTEE ON THE SALE OF CHURCH LAND IN THE PARISH OF EDWARDSBURGH.

The Committee appointed by your Lordship to consider the request of the Incumbent and Churchwardens of St. Paul's Church, Edwardsburgh, for power to deed a certain portion of the Church Land in that parish, beg respectfully to Report,—

That on examining the Deed by which the Land was given, and the correspondence with the Department of Public Works, on the subject of compensation for the portion appropriated to canal purposes, they ascertained,

1st, That the land, consisting of three acres, was deeded by the late Col. R. D. Fraser to certain Trustees, to be used as a Church-Site, Burial-ground, and Parsonage Lot, for the benefit of the Congregation of St. Paul's Church.

2nd, That the Board of Public Works had promised to pay the sum of $\pounds 29$ 11s 3d in compensation for the portion, about an acre and a half, taken for the Canal, so soon as a proper title to that portion was made over to the Department.

3rd, That no deed had been as yet offered to the Department, owing to doubts existing as to whether the power lay in any one to give such title.

4th, That the memorial of the Incumbent and Churchwardens, presented in 1861 to the Governor in Council, praying for relief in the premises, although advised by the Engineer of the Department, had received no answer.

5th, That the application to the Synod for power to sell the land was made under the impression that the Act of Incorporation vested in the

Synod the title to Church Lands in this Diocese, deeded to individuals in trust for Church purposes.

On examining the Acts of Parliament relating to the subject, your Committee found,

1st, That by section 1 of the Church Temporalities Act the freehold of the land in question was vested in the Incumbent for the time being.

2nd, That section 6 of the Act Incorporating the Synod of this Diocese simply provides that the title may be transferred by the Incumbent to the Synod.

Since, however, no transfer of the kind has been made, your Committee concluded that the title to the land remains, as it was vested by the Church Temporalities Act, in the Incumbent of the Church, and that the Synod has no legal authority in the matter.

All which is respectfully submitted.

2nd, The addition, as a separate paragraph after section 3, of the following words :

"Each and every Olergyman, from any other Diocese, seeking a license to the cure of souls in the Diocese of Ontario, shall be required to pay into the Widows' and Orphans' Fund, as the condition of his admission, a sum equivalent to \$2 for every year by which he is older or above the Canonical age for Deacon's Orders, and, being admitted, shall thenceforward, be subject to the annual payments, as ordered by section 3 of these Canons."

To the Most Reverend the Archbishops, and the Right Reverend the Bishops of the United Church of England and Ircland. Trustees of "The Colonial Bishoprics' Fund."

The undersigned, members of "The Episcopal Fund Committee of the Diocese of Ontario," beg leave most respectfully to address your Lordships in compliance with the instructions contained in the following resolution passed at the late meeting of the Synod of said Diocese, held in the City of Ottawa on the 5th inst.,

Moved by the Ven. Archdeacon PATTON, seconded by THOMAS KIRKPATRICK, Esquire,

That "the Episcopal Trust Fund Committee" be instructed to make application, at the request of this Synod, to the "Colonial Bishopric's Fund," for such assistance to "the Ontario Episcopal Endowment Fund," as they may be kindly disposed to grant."

In furtherance of the spirit of the above Resolution, the undersigned beg leave to represent, that as a condition precedent to the erection of the Diocese of Ontario, the members of the United Church of England and Ireland resident within its bounds, were required by the Governor General, as the representative of her Majesty the Queen, to raise, as an Episcopal Endowment Fund, the sum of ten thousand pounds currency—about eight thousand pounds sterling.

After great exertions in canvassing every portion of the proposed new Diocese, and being aided by liberal grants of $\pounds 1,000$ and of $\pounds 500$ from the two benevolent Societies, the Ven. S. P. G. F. P. and the Ven. S. P. C. K. the required sum was obtained, and invested, and the Bishop elect was consecrated on the 25th of March last.

When the question of a division of the Diocese of Toronto was first mooted, we were given to understand, that the Trustees of the Colonial Bishoprics' Fund had appropriated $\pounds 2,000$ for the contemplated Diocese of Kingston, the present See of Ontario, but when afterwards the Endowment Fund was being raised, we forbore to make an application to your Lordships, from the impression having gone abroad, that the resources of the Fund were exhausted.

Having since learned that the Diocese of Huron, after the consecration of its Bishop, received a grant from the Fund of $\pounds 1000$, in aid of their Episcopal Endowment, and that there are still funds at your disposal, the Synod has instructed us to appeal to your Lordships for such aid to the Ontario Episcopal Endowment Fund as the means at your disposal will enable your Lordships kindly to grant.

maintenance of a Bishop, and very much below the average income of Colonial Bishops. With every disposition to increase the income of our Diocesan, the members of the Church within the Diocese are at present unable to do so. Having no Episcopal residence or See House, the Diocese is now endeavouring to contribute the necessary funds for the erection or purchase of one, the expense of which cannot be less than about £2000. Willing as our people are to exert themselves, it will require a great effort to procure this sum from the members of the Church within this newly organized Diocese, as they have but just completed the Episcopal Endowment, and have to contribute about £700 per annum towards the support of fourteen Missionaries; while every Parish has also to aid in supporting its own resident Clergyman.

The spiritual destitution existing in many parts of the Diocese will indeed severely tax the utmost liberality of our people, even when aided, as we trust they will continue to be, by the benevolence of the two venerable societies, whose praise is in all the Colonial Churches of the British empire. The Diocese of Ontario consists of one hundred and fifty surveyed townships, each of which comprises, on an average, one hundred square miles. In only forty-two of these are there resident Clergymen. Tracts of country, equal in extent to the largest English counties, are destitute of the stated ministrations of the Church.

The population of the Diocese, according to the last census, was 371,-541, of whom \$1,000 enrolled themselves as members of the Church of England. The harvest truly is plenteous but the labourers are few.

It may be further stated that the Diocese of Ontario is inferior in wealth and population to the Diocese of Huron, and therefore possesses, if possible, stronger claims to consideration. Lying contiguous to Lower Canada, its climate is more severe, and its soil less easily tilled than is the case at the West; hence the tide of emigration has usually flowed towards the Western Diocese, thus yearly adding to its wealth and population.

Upon the whole, the Committee venture respectfully to appeal to your Lordships' kind consideration, and to solicit such aid towards the Ontario Episcopal Endowment Fund as it may be in your Lordships' power to grant, and your memorialists,

REPORT OF THE BOARD OF MISSIONS PRESENTED TO THE SYNOD AT THE PUBLIC MISSIONARY MEETING HELD IN BROCKVILLE, ON WEDNESDAY EVENING, JULY 1st, 1863.

The Board of Missions begs leave to submit to the Synod this its first Report. Organized but nine months ago it has yet existed long enough to prove that it is destined by God's blessing to become an important agency in spreading abroad throughout this portion of the Lord's vineyard a knowledge of the Gospel of Salvation. Commencing its labours amid a period of severe agricultural distress, and consequent scarcity of money in the rural districts, its appeals for aid on behalf of the spiritually destitute have been responded to in a most generous and liberal spirit. He who has the hearts of all men in his holy keeping, and who can mould them as he will, has been graciously pleased to open the hearts of his people, and the result has exceeded our expectations, and yet we have faith to believe that the experience of the past winter is but a prelude and an earnest of far better things for the future.

The Missionary spirit is the vital spirit of Christianity, for it is the spirit of love,-of love for perishing, yet immortal souls. The religion of Christ contains within itself the germ of its own growth and extension, and that germ is love. It was love divine that called down Christ from Heaven. He was the first Christian Missionary. He went from town to town, from village to village through the length and breadth thereof, Judea, Samaria, and Galilee, proclaiming the Gospel of the grace of God. His Apostles, bearing his Divine commission, went forth the heralds of salvation to a fallen world. As missionaries of the cross they proclaimed in almost every region of the then known world the unsearchable riches of Christ, and through God's abundant blessing on their faithful and zealous ministrations the word of the Lord grew mightily and prevailed. The Primitive Church sent forth its missionaries. the spirit of truth encountered the spirit of error, and after a long and severe struggle it overthrew the altars of paganism. The worship of Jupiter and the other fabled gods of ancient Greece and Rome paled before the victorious banner of the cross. Although the preaching of the cross was to the Jews a stumbling block, and to the Greeks foolishness, yet three hundred years had not elapsed ere a Christian emperor swayed the sceptre of imperial Rome. The missionary spirit still sent forth the heralds of the cross, and the hordes of barbarians, who finally conquered the Western Empire, were themselves in turn subdued by the all-conquering power of the religion of Jesus.

The missionary spirit has again been wonderfully revived in these latter days, and the United Church of England and Ireland has engaged heartily and zealously in the pious work, and God has abundantly bless-

In every quarter of the globe, and far beyond the bounds of Britain's wide extended empire, has Britain's Church proclaimed Christ the power of God, and Christ the wisdom of God for salvation to all them that believe. As faithful members of that pure branch of Christ's one Holy Gatholic and Apostolic Church it becomes our duty to emulate the holy example of our brethren at home, and, to the extent of our means and ability, to proclaim throughout the length and breadth of this Diocese the truth as it is in Jesus. It is our duty, and we must learn to esteem it as our privilege also, to labour in this good and holy work until the glorious banner of Evangelical Truth and Apostolic Order shall wave in triumph over every township in the Diocese of Ontario. It was for this object the Board of Missions was constituted, and, God being our helper, we will not remit our labours of love until all the waste places of our Zion are cultivated by the spiritual husbandmen, and every portion of our spiritual wilderness is made, by God's blessing, to rejoice and to blossom as the rose.

Already a good beginning has been made. Early last winter his Lordship the Bishop of the Diocese appointed an Eastern and a Western Deputation to visit every Parish and Mission in this Diocese, and to solicit aid for carrying on the great and important work for which the Board of Missions was originally constituted. The Eastern Deputation was again divided—to the one portion was assigned most of the region east of Kingston, lying between the St. Lawrence and the Rideau Rivers, to the other the country between the Rideau and Ottawa. The Western Deputation visited every Parish and Mission west of Kingston.

The North-eastern Deputation reports that one or more of its members visited the following parishes, and held Missionary Meetings therein, viz: Metcalfe, North Gower, March, Fitzroy, Pakenham, Arnprior, Innisville, Carleton Place, Balderson's Corners, Perth, Franktown, Smith's Falls, Ottawa, Richmond, Almonte, Clayton, Renfrew, Cobden, Stafford, Pembroke, and Beachbury-Total 21. Collections were taken up in all these places, with the exception of Balderson's Corners, Ottawa, and Cobden. Appointments were also made for the Missions of Huntley, White Lake, and Forrester's Falls, but no meetings were held in these places. The sickness of the Incumbent prevented the meeting from being held in Huntley; at White Lake sufficient notice had not been given, and at the last place no suitable preparations had been made to receive the Deputation, as there is no resident Clergyman there. The meetings in nearly all the Missions were well attended ; Perth, Smith's Falls, and Carleton Place especially so. A large portion of the ground travelled over, viz : the County of Renfrew, has only been recently occupied by the Church. Should the pecuniary results not prove as great as from the parts visited by the other Deputations, it must be remembered that in all the Missions

visited by the North-Eastern Deputation the depressed state of the lumber trade especially affects them. The hope is confidently entertained that in future years there will be a steady increase of contributions to the fund from this quarter of the Diocese.

The proceedings of the South-Eastern Deputation have already been so fully and so graphically described, in a series of articles that appeared at the time in the Canadian Churchman, that the briefest statement of facts may suffice for the Report of the Board. The Deputation visited and preached, or held Missionary meetings, in Prescott, at Vankleck's Hill, Cornwall, Moulinette, Osnabruck, front and rear ; Williamsburg, Morrisburg, Matilda, Edwardsburg, Kemptville, Burritt's Rapids, Merrickville, Lamb's Pond, North Augusta, Maitland, Brockville, Rear of Lansdowne, New Boyne, Newboro', rear of Leeds, Gananoque, Lansdowne Front, Mountain and Finch .- Total number of stations visited, 24. In every place collections were made, and a goodly sum has since been subscribed and remitted to the Treasurer. The members of the Deputation had the good fortune to be assisted at several of their meetings, not only by the resident and neighbouring Clergy, but also by several zealous laymen, among whom it may not be deemed invidious to mention the names of His Honor Judge Jarvis, S. T. Chesley, W. H. Oliver, Robert Leslie and J. Hannah, Esquires. The Deputation has also great satisfaction in reporting that in every place visited they were received with the greatest cordiality, and treated with the most generous hospitality. The Clergy afforded them every facility, and co-operated with the greatest alacrity, while many of their Lay brethren kindly conveyed the Deputation from station to station, so that no expense was incurred for entertainment, or for conveyance, except when the railroad was occasionally resorted to.

The Western Deputation reports that they commenced their series of Parochial Missionary Meetings on the 19th of January, by holding a meeting in the City Hall at Kingston, on which occasion a crowded audience manifested great interest in the proceedings. A collection of \$50 gave proof of a desire to forward the good work, and encouraged the Deputation to proceed on the tour, which was forthwith undertaken and completed in about three weeks.

All the parishes West of Kingston were duly visited. The various meetings held, with a few exceptions, were attended by all the members of the Deputation. Parochial duties compelled one or two to be occasionally absent. The route taken was by Bath to Picton and Belleville, and no intermediate station was omitted. Thirty-five meetings were held. Those held in the morning were somewhat thinly attended, those in the evening were invariably successful,—\$380, collected at the meetings, was the substantial evidence of good will towards the promotion of the dause concerning which so much was said and heard.

All the members of the Deputation agreed in expressing their gratification at the hearty welcome which awaited them in every parish. It was evident that real interest is felt by the people in the welfare of the Church, which is making her power known and extending her influence both at home and abroad. Great attention was paid by the people to the statements which were made by the several speakers, who were supported, in a few instances, by the kind assistance of the neighbouring Clergy, and the resident Laity. A conviction rested on the mind of all, that although there exists great cause for thankfulness, it is the part of prudence to count nothing done whilst so much remains to be done. It is believed that there happily exists a strong desire on the part of many members of the Church to exert themselves to make our Jerusalem a praise and a glory in our midst, and that it only requires united and vigorous action to enable the Church to reconquer the territory which she may have lost, to cultivate those portions of the vineyard which have not yet felt the power of her implements of spiritual husbandry, and to take possession of the fields which are white already to the harvest, upon the assurance that there remaineth yet very much land to be possessed.

The Board will now proceed to give a statement of the Funds placed at its disposal for missionary objects, since the separation of the Diocese unto the middle of May, 1863, including also some of the Parochial collections since received :

making a grand total of \$5852.40 contributed in the year 1862-3 for missionary objects, a measure of success for which most fervent thanks are justly due to their Heavenly Father, for disposing the hearts of his servants to give of their substance to the advancement of his glory. The measure of his people's liberality is also heightened by a reference again to the circumstances of the country. Owing to the lightness of last year's crops, and to the stagnation of many branches of business consequent upon the unhappy war that is convulsing the neighbouring Republic, the Deputations were everywhere met with the cry of "hard times," and any one at all acquainted with the state of the country must be aware that there was too much reason for the cry. But notwithstanding the pressure of the times many were found ready even to make some sacrifice for the advancement of the good cause. And there is this further source of encouragement in the experience of the past, that if so much could be raised during a season of comparative scarcity how much more may we reasonably anticipate during the ensuing winter, as a testimony of our people's gratitude to Almighty God for the abundant crops of

which, through his great and undeserved goodness, there is so favourable a prospect.

A meeting of the Mission Board was held in the City of Kingston on Wednesday, May 13th, when sundry appropriations of the funds on hand were voted.

The Board felt itself bound, in the first place, to secure for a limited period the stipends assigned to the following places, while we were yet a portion of the Diocese of Toronto, viz: Camden, Merrickville, Matilda, Marysburg, North Gower, Roslin, Stirling, Hillier, Carleton Place, Osgoode, Lansdowne Rear, and Newboro'.

The propriety of continuing hereafter the present grants to all of these stations may perhaps be questioned, but the Board considered that it would be unjust to make any alterations without some previous notice, and therefore they have continued the grants for three years, at the end of which term they will either cease, be renewed, or be modified at the discretion of the Board. The same rule was also adopted with reference to new Missionary Stations, no chgagements are made for a longer period than three years, when they may be renewed or modified, as their several circumstances may require. Subject to these conditions, grants were also voted as follows:—\$200 per annum to Sydenham, Madoc, Lamb's Pond and Almonte, \$236 per annum to the Addington Road Mission, \$136 to the Tamworth Mission, \$113.36 to the German speaking Mission on the Ottawa, \$100 to the Travelling Mission of Marysburg, Sophiasburg, and Athol. A gratuity of \$50 was also voted to the Rev. Thos. Taylor, of Ashton.

Several of these grants were made to Missions of long standing, but which are even yet unable to provide the whole of a Clergyman's stipend. There are several such Parishes or Missions that have been accustomed to enjoy the ministrations of a Clergyman, paid in part at least from the Commutation Fund, and upon his death or removal they find it difficult, and in some cases impossible, at once to raise the whole amount of his successor's salary. In such cases the Board is authorized by its Constitution to grant aid to the extent of \$200 per annum, on receiving from the Mission a guarantee of \$400 more for the Clergyman's stipend. This is a very wise provision, inasmuch as it is equally our duty to assist our weaker brethren, where the Church is already planted, as to open new Missions. It is our duty, not only to extend the borders of our Zion, but also to secure the stability of existing stations.

The Report shews that the attention of the Board has been given in both directions, and the further extension of the good work must depend upon the increased liberality of our people, for although a good beginning has been made, still it is but a beginning, and although the liberality displayed has been commended, yet is it most apparent that the sum contributed bears after all but a very inadequate proportion to the resources and means of our people generally. May God cause us all to realize more deeply our responsibility to advance, to the utmost extent of our ability, the cause of Christ and His Church, so that the report of each succeeding year may be of a more cheering and encouraging character than its predecessor, while to God be ascribed all the glory through Jesus Christ our Lord.
