Arrival of the Steamship



Canada.

The steamship Canada arrived at Halifax on the 12th inst., at 9 o'clock, bringing Liverpool papers to the 1st of June. She had 60 passengers.

The Irish steamer Viceroy, from Galway, also arrived at Halifax at 6 o'clock in the evening.

The commercial news generally is without change. At Manchester and the other manufac-
turing districts a good demand for goods was man-
ifested, and prices for some descriptions had an ad-
vancing tendency.

The Grain market exhibits no material altera-
tion. Flour was firm at former quotations. Corn was
declining, in consequence of the favourable reports
of the weather, and the expectations every where
entertained of a bountiful harvest, and a reduction
of 6d. to 1s. per quarter had been submitted to.—
Provisions there is no change. Cotton had ad-
vanced 1-8d. per lb. The sales of the week
reached 65,000.

The Money market remained steady.
The Bill to enable Baron Rothschild to take his
seat as a member for the City of London, which
was rejected last session in the House of Lords,
has again been introduced in the lower House.

The Commons have passed an address to the
Queen, brought forward by Lord Ashley, praying
that measures may be taken to abolish all Post-offi-
ce labour on the Sabbath. The motion was op-
posed by the Ministry.

The accounts from Ireland continue to be of a
very encouraging character, so far as agricultural
operations are concerned.

European Intelligence.

FROM PAPERS BY THE CANADA.

The French Government is about to bring a bill to effect a gradual reduction in the duty on sugar.

A Paris letter states that numbers of a Englishman, young and old, have recently arrived in England to await the outbreak of the war.

The culture of flax is receiving a large measure of attention in all parts of the United Kingdom.

The *Deutsche Arbeiter* says, "The increased number of 14,000 young crows has, since the beginning of last week, down to Wednesday night, been killed in the plantations of the island."

The new harbour at Greenock is rapidly approaching completion, and the workmen have for some time been engaged in the most difficult part of their labours, the tying of the new and new quays together.

WESLEYAN REFORM.—A very crowded assembly meeting of the Wesleyan Reformers took place at the Right London and other neighbouring churches was held at Exeter hall, London, on Wednesday evening. The meeting was addressed by Mr. Dunn, one of the expelled ministers, who asserted that the people of the Wesleyan Church were fully alive to the matter—namely, the expulsion of the expelled ministers. Mr. Dunn, Griffiths, &c., and pledging the meeting to raise a sum of £20,000 to effect a reformation in the connexion were put and unanimously agreed to.

DEMAND FOR EMIGRANT SHIPS.—The Liverpool dock quays are now crowded with emigrants (chiefly Irish) awaiting vessels to carry them across the Atlantic.

The demand for ships in this trade has recently been so active that numbers of Liverpool vessels have been put on. Hitherto the business has been chiefly confined to American bottoms, but owing to the crowds of emigrants arriving at the port, the vessels of both countries at present in our docks are inadequate to meet the demand. The consequence is, that for some days back the rate of passage has been considerably raised, and will remain so until the arrival of other vessels from America.

IRELAND.

It is stated that a very valuable copper ore has been discovered on the property of a Mr. Harbord, close to the city of Limerick.

The emigration from Waterford averages 900 a week, by steam via Liverpool to America, not to speak of the large numbers that leave by vessels direct from that port and Ros.

Two more Orange lodges in the county of Armagh have resolved to follow the liberal example of their nineteen predecessors, by destroying the badges of their hostility to their fellow-countrymen who differ from them in religion.

According to the Limerick Chronicle, mortality and emigration have so thinned the ranks of the Roman Catholic priests in that diocese, that the Bishop (Dr. Ryan) has not a clergyman to fill a vacant curacy at Bruff. A Roman Catholic parish priest, connected with the county of Limerick, and who is good authority upon the subject, stated in that city, yesterday week, that at least one half the Roman Catholic population had diminished in Ireland within the last six years, whilst the Protestants have increased in number.

The Galway coach to Limerick was delayed in Ennis, on Wednesday night, for upwards of an hour, in consequence of a thunder storm by which the town was visited. The river Fergus overflowed its banks, and the vicinity of the bridge and club-house was one sheet of water. Several numbers of business were inundated, and considerable damage done to property.

We regret to state that there is a probability of the revival of the Orange disturbances in the north of Ireland. Sir Wm. Verner and other officials of the Grand Orange lodge lately visited Londonderry, and denounced such of the brethren as burned their flags, calling them "disloyal" &c. &c. The effect of this has been to induce these parties to revive their meetings. At the fair of Laphoe, in the county of Donegal, a party of Orangemen attacked their Catholic countrymen, and beat several of them unmercifully. A similar outrage has since taken place at Castlefin, in the same neighbourhood.

Outrage at Cognac.—A correspondent of the *Miramichi Gleaner* states that two individuals recently attacked the residence of Mr. Peter Keenan, an industrious settler on the Cognac river, during the night, and demanded his money. Keenan told them, that by industry, perseverance, and hard labour, he had scraped together a few pounds in order to meet the sale of his land, about to be effected the next day, and that sooner than give it up, he would risk his life. On meeting with this reply, one of the distasteful miscreants struck Keenan with a club on the face. On recovering himself he seized a bill of wood, and returned the blow, and immediately retreated into his house, in order if possible, to secure his axe for further defence. On gaining the door he received another blow on the back of the head, which completely stunned him, when the cowardly ruffians were glad to retreat, leaving poor Keenan weltering in his blood until the following day. No clue has been discovered which will lead to the detection of the guilty parties.

New Ship.—There was launched on Wednesday last from the Ship-building yard of Messrs. John & Robert Townshend, at Chamcook, a splendid ship of 762 tons named the *Cornelia*, in honor of the Lady of Capt. J. J. Robinson, R. N. This vessel is highly spoken of by competent judges, as well sustained.

The Elections.—Ten Candidates are now in the field for this County: an active canvass is going on, there being but little time for action. We trust the Electors will insist on the Candidates declaring their principles in the clearest and most candid manner; that they will require a pledge from them, that, if elected, they will, to the utmost of their ability, advocate the surrender of the initiation of Money Grants to the Government, which will make it a working government, as well as a responsible one:—the establishment of Municipal Corporations, the advantages attending which are too apparent to require further notice: Reduction of salaries of Public Officers to a standard commensurate with the importance of their offices, and the means of the Province to remunerate them. They should also pledge themselves that they will not accept any office of emolument from the Government while they continue members of the House. These are a few matters worthy of serious consideration, and we trust the Freeholders will look to their own interests, and require pledges from the Candidates to use their best exertions to obtain these objects.

As there appears to be a difference of opinion among the voters respecting the place to which they should vote: it may be of service to state, that freeholders owning property in the County, must vote in the Parish in which they reside, and no other. Any person voting without being properly qualified will forfeit the sum of £15.

HALIFAX AND QUEBEC RAILROAD.—The Halifax Recorder of the 15th inst. states, intelligence has been received by the steamer from England, that Lord John Russell has assented to a Government guarantee of 4 per cent on £3,000,000, for the purpose of building the Halifax and Quebec Railroad. This has been mainly brought about by the influence of Lords Stanley and Montagu, and the perseverance of the Canadian Land and Railway Association. This news may be correct, but we feel rather sceptical upon the subject.

GENTLEMEN,

There are few men in this world, I believe, (however they may imagine it) upon whom the approbation and praise of their fellow men, fail not to make some gratifying impressions; at least such I own were my feelings on receiving the respectful and numerous signed requisitions from the Freeholders of the County of Charlotte, inviting me to come forward as a Candidate at the present Election; and, in consenting thereto, I beg leave to return you many thanks for the honor done me; that honor in my opinion not consisting so much in the office as in the way that office may be obtained. I therefore tell you frankly, that it is not my intention to go about and beg votes, like a *Panper*, of resort to unfair practices—such as I observed taking place at the last Election in this County—neither is it my wish to say one word against any of my brother Candidates. The Electors have a right to choose for themselves; and I beg leave most explicitly to say, that I have not entered into any arrangement whatever with any other person, or engaged in any coalition, but stand solely and entirely on the requisitions you have been pleased to offer me; and therefore leave myself entirely in the hands of my friends.

I shall certainly pay my respects to as many of the Freeholders as the very limited time given admits of; and those whom it will not be possible for me to see before the Election, I pledge myself to call upon afterwards; and, in carrying out this plan, I would suggest to my friends to call a meeting of my supporters, on different days, in each Parish; and it would give me much pleasure to attend and give my views and any explanations that might be wished, as to the policy to be adopted for the good of the Province and County generally—there being a great difference between answering any questions from a Freeholder, and hearing his opinions, and supplying and cringing for support.

It has been the practice in this County, and I believe in the Province generally, to take the MAX entirely as the object in view, in the case of choosing a Member, without regard to the MEASURES that man might adopt when elected: permit me to say, with all due deference, I do not think this altogether correct; and, certainly, as yet we have not seen it work particularly well. Much as is to be dispensed all electioneering "clap traps," and promises put on paper which can never be redeemed, even in those who made them had the power—which, in nine cases out of ten, they have not; still, there is one point on which, as a Freeholder, I should refuse my vote to any man—and that is, where the Candidate would not promise me to advocate, to the best of his ability, "The surrender of the Initiation of Money Grants to the Government." I consider this to be the foundation on which must be built all our future operations in reforming any existing abuses; for, until that is obtained, no permanent good can be done. It will certainly do away with all petty jobs of corruption; but the greatest point gained will be, we shall have some one answerable for the expenditure, instead of having, as at present, the whole House of Assembly verifying the old maxim, "What is every-body's business, is nobody's."

And let me tell you, our *Chancellor of the Exchequer* (whoever he may be) will have no easy job at first in bringing forward his budget. Other changes are now being talked of, but, in my opinion of very inferior moment to this. Get this, and the rest, if they are worth having, will follow. There will be few leaves and fishes; and those that there are will have to be well earned before being received; besides, on the present state of

Colonial subjects, it is impossible to say how one would act; but there ought to be that confidence between the member and his constituents, that he does not lose his character of member and become that of a mere *delegate*, but that, on the contrary, if questions arise that will require urgent and active decision, he will be trusted to do what he thinks right in such a case; for, I consider the present state of all our Colonies in British North America is in such a position as they never were before; and, in speaking of this, there is another, and a more important point, I would beg most particularly to call your attention to at this period—return no man who has not some stake in the Country, who, in fact, has not something to lose if the Province is ruined. Would a meeting of Stockholders of a Bank, or Insurance Office, vote for a Director, a man who had not a share in the company? I think not.

I know it is the fashion to listen to, and, in some instances people are led away with some popular orator for the time. He talks of the reforms he is going to make, and the abuses he is going to correct &c., these are the most expensive animals we have in the Province; lengthening out debates in the House of Assembly until every word uttered has cost the Province a shilling, and the chances are in many instances, that that very shilling would be about the value of the whole debate. It has been said in the House of Commons:—"one good Committee man is worth a dozen popular debaters"—one gets through the business—the others; in many cases, only retard it—and it is not very often the same with us on a small scale?

In conclusion, I beg leave to state, it is my opinion every man in a Community is bound to give his time and attention for the good of that community, to the best of his abilities and power. I have done so for the County of Charlotte for these last three or four years to the best of mine, at a considerable personal inconvenience; but consider myself more than repaid by the kind manner I was received, on my return from England, by your so handsomely, giving me a public dinner, as well as your new gratifying compliment.
