Swift Raid on Irish Suspects in Cities In England and Scotland

Ninety-Eight Men and Women Taken to Dublin—Irregular Leader Caught in Irish Capital—New Organization Is Formed.

(Canadian Press.)

Dublin, March 12—Ninety-eight men and women, arrested in England and Scotland, were landed here late last night. No official statement regarding the arrests was issued.

Glasgow, March 12—An official police statement issued today says that thirty-eight rebels were arrested in Scotland over the week-end. Twenty-eight of the prisoners were taken in this city. Several are alleged to have been leading organizers in the Irish Republican army.

Sensation In London.

London, Mar. 12.—The swift and great raid upon Irish suspects in Great Britain has created something of a sensation here and developments are awaited with much curiosity.

London, Glasgow and Liverpool, all of which have large Irish communities, were the main centres of the raids, but places as far north as Aberdeen, furnished their quota of captives.

It is said that the arrests in England were made under an order signed by Home Secretary Bridgeman. This order, issued under date of March 7, cited the Defense of the Realm Act, and the Restoration of Order in Ireland Act.

The arrests in Scotland were apparently made under the authority of an order signed by the secretary for Scotland charging the suspects with "acting or being about to act in a manner prejudicial to the restoration of law and order in Ireland."

Dublin, Mar. 12.—Frank Henderson, described as a leader among the irregular forces in Dublin, was captured in the street yesterday by Free State forces. Several other arrests were made in connection with the discovery of a big arms dump in the city.

New York, March 12—Three brothers, named Tisbo, who conduct a bank and a steamship agency in Mott street in the heart of New York's "Little Italy," disappeared mysteriously on Saturday, and immediately a crowd of depositors gathered demanding their savings, which were reported to total \$200,000 to \$300,000.

It is estimated that 40,000 persons, mostly of the poorer Italian class, had entrusted the Tisbo brothers with their life savings.

When news of the disappearance reached the police, a hasty crowd of reservists was thrown about the bank. It was still there last night to keep back the hundreds who refused to leave and continued to demand their money.

Many times the crowd had rushed the officers on guard in an effort to force a way into the building.

Meanwhile, police headquarters were busy on various clues and today called the Italian authorities to arrest the Tisbo brothers should they arrive in Italy by steamer.

The authorities say that the brothers were not authorized to conduct a banking business and that the money put in their institution came from persons who trusted them to safeguard it. Vincenzo Tisbo was head of the bank. Associated with him were Vito and Francesco. A fourth brother, Riccardo, was said to have served as the bank's agent in Italy.

COMMENT ON DECISION RE THE ENGINEERS

Ottawa, March 12—(Canadian Press) A decision of Mr. Justice Galt in Winnipeg that the International Brotherhood of Locomotive Engineers, an "illegal organization," cannot sue its members in the courts has not created surprise in labor circles here.

It is said in high labor circles here that the case is the result of a dispute between the International and a Canadian association of railway engineers which recently seceded from the parent body. S. T. Starr, who was the defendant in the case, is the secretary of the Canadian association.

The decision is not regarded as likely to cause much trouble to the unions, as it is not looked upon as controlling the general situation. It is said that a Montreal court recently gave a decision pointing in the opposite direction.

Winnipeg, March 12—"It is a startling decision indeed for, as I understand the matter, it throws our labor unions open to plundering of all kinds on the part of members."

This was the comment made last night by R. C. McCutcheon, Canadian grand lodge vice-president of the International Brotherhood of Boilermakers.

FIND PLANT FOR COUNTERFEITING HALF DOLLARS

R. C. M. Police Make Seizure in Montreal—Two Men in Court.

Montreal, March 12—A counterfeit-plant for the making of fifty-cent pieces of Canadian currency was seized by the R. C. M. P. on Saturday and was followed by the appearance before Judge Perreault of G. A. Brisson of this city and A. Mariotte of New York. They were charged with counterfeiting and remanded in the sum of \$1,000 bail each.

Clashes Mark Hearing in Mayor's Repair Permit Matter

Inspector Charged With Defying Law; Mr. Thornton With Abetting Him

Mayor in Turn Accused of Attempting to Evade the Building Law by Making Repairs Without Permit—No Progress Made in the Case.

Some sharp encounters between Mayor Fisher and Commissioner Thornton, during which charges were made against the mayor, the commissioner and the building inspector, marked a discussion on the matter of the Mayor's request for a permit to repair a building in Charlotte street, damaged by fire recently, when it came up at a committee meeting of the Common Council this morning.

The Mayor's contention was that James Carleton, building inspector, was defying the law and that he was being aided and abetted by Commissioner Thornton.

Thornton, in turn, charged Mayor Fisher with attempting to evade the law in trying to repair a wooden building in No. 1 fire district, where he alleged repairs to wooden buildings were not permitted by the act. The debate waxed rather heated at times.

The matter was brought up when Commissioner Thornton presented a report on a recommendation presented to Council by the Mayor in which he characterized Mr. Carleton as not being a safe man for the position. Mr. Thornton, in his report, said that in his opinion the inspector was a safe man to carry out the duties imposed on him by law; that he had never been guilty of discrimination, and that the Mayor was receiving the same treatment at his hands as any other citizen received.

Further Evidence. The Mayor said he had further evidence of his contention and presented the following report: "As further evidence that the building inspector is not a safe man to have charge of the inspection of buildings, I beg to report that on the 8th inst., without warrant or authority, he interfered with electric wiring work in a building on Charlotte street, engaged in the said work to quit."

Regarding alleged discrimination, Mr. Thornton said that Miss Hanson for repair to a building in North Market street, a case similar to that of the Mayor. He said that he had never known of Mr. Carleton discriminating against anybody.

The Mayor in reply said that he was doing everything to uphold the law, but the Building Inspector was defying the law.

The question before the meeting, he said, was the building inspector, not the Mayor. He said that when he applied for a permit he knew that repairs had been made in No. 1 fire district. He said that if repairs were not forbidden was upheld by the city solicitor.

His worship said that in conversation with Commissioner Thornton he inferred that the Commissioner was not in favor of the action of the building inspector. The Mayor said it was true that the police inspector had told the building inspector that no court would uphold him in his view. He said the only charge laid against him in the court was "infraction of the building law," without specifying in what way. He said he was going ahead with the repairs in order to have the matter brought into court and decided finally.

Commissioner Wigmore. Commissioner Wigmore said the letter from the solicitor stated that the building inspector should issue a permit attaching conditions under which the repairs might be made.

Commissioner Thornton—"The city solicitor is entirely wrong in his interpretation of that section."

Commissioner Frink. Commissioner Frink called attention to a statement made by the building inspector before the meeting, that he would not grant a permit for repairs with wood. He thought the charge that repairs were being made without permit should be investigated. He said that the solicitor ruled that the permit could not be refused, but the building inspector could attach conditions to the material to be used.

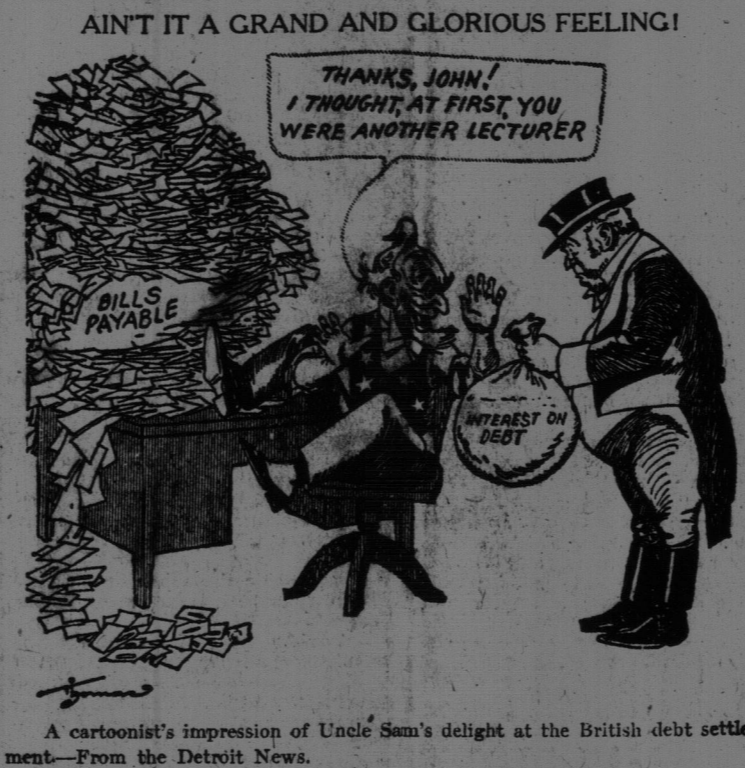
As to whether the building inspector was a safe man, Commissioner Frink thought the evidence was that he was acting within what he considered was the law. Either the law must be amended to permit a change, he said, or the courts must be appealed for a decision. On the main ground, he said he could not sustain the opinion of the Mayor that the building inspector was not a safe man.

Commissioner Bullock said that he had known of alterations and extensions in No. 1 fire district which were made in wood and he believed, without permits. Mr. Bullock said that repairs had been made to the laundry adjoining the Mayor's property, damaged at the same time. He said that the inspector told him that those repairs were allowed to protect the premises from the elements. He asked what would happen if a portion of a floor in a residence should be used.

Commissioner Thornton said that he had not contended any infraction of a law. He said it was the duty of commissioners to notify the authorities of any infractions. He added that if the Mayor proceeded with the repairs he would instruct the building inspector to proceed with an injunction.

The Magistrate Offers To Retire on \$2,800 Pension

Adds That He Will be Satisfied with Whatever Action the Council May Take in the Matter—Question to Come Up Again Tomorrow.

Man Hunt Is Ended By Death Of The Fugitive

Nashville, Tenn., March 12—Lewis Douglas, negro desperado, who shot and seriously wounded five persons at Spencer, Vanburen County on Thursday morning, was shot to death at the home of a tenant on the property of Sam Hanson, one of the victims, by armed deputies, on Saturday afternoon.

The negro's death ended a two-day chase with bloodhounds. The shooting of the fugitive was the climax of one of the most brutal tragedies in the annals of the state, two men and two women being shot down as they watched beside the bedside of a dying woman at the home of Sam Hanson, brother of Tennessee's secretary of state. The negro had been accused of robbing a corn crib.

Apologizing for not replying in writing to the council's offer, the magistrate said the council had set him a bad example, as he had written twelve letters, which had not been answered. Commissioner Thornton said that he had done his part; if anyone wanted to do anything more, he could. He felt that the Council had dealt very generously with the magistrate.

Commissioner Bullock said that he felt that the matter could not be decided upon until the magistrate's resignation was received.

The matter was allowed to go over until tomorrow.

COL. W. M. HUMPHREY DEAD.

Halifax, N. S., March 12.—Colonel W. M. Humphrey, retired army officer and former Halifax business man, is dead in Windsor, N. S. He was seventy-five years old. He was commanding officer of the sixty-sixth regiment Princess Louise Fusiliers from 1886 to 1908. Previously he was a member of the firm of Neal White & Co. here, and later Halifax manager of Bradstreet's.

KILLED IN CYCLONE.

Richmond, Ky., March 12.—Three persons were killed, two fatally injured and others seriously hurt by a cyclone which swept over a small section on the Madison-Fayette County border before midnight.

French Occupy More Stations; Serious Clash And 8 Germans Killed

(Canadian Press.)

Berlin, March 12.—The French last night occupied the railway stations of Recklinghausen, Castroop, Gammertschach and other points to the south, according to special despatches to the Berlin newspapers.

Recklinghausen, March 12.—Eight Germans are dead as the result of clashes with French troops in the various parts of the Recklinghausen district last night. One French soldier and three Germans were wounded in a riot at Dortmund. A state of siege has been declared in the entire Recklinghausen district in consequence of these overnight disturbances. Additional troops have been sent to preserve order at Buer. Of the Germans who met death, two were shot down while trying to escape from gendarmes in the Buer disturbances. Five others were killed and several wounded an hour later when a crowd attacked a French guard post. The eighth German was killed at Dortmund when a crowd attacked a French detachment.

Dusseldorf, March 12.—The Recklinghausen district today faced severe penalties for what was perhaps the most serious incident of the Franco-Belgian occupation—the killing at Buer of Lieutenant Colin de Chausseurs and M. Joly, director of the Buer railroad station. French officials indicated that Buer would be placed under what will amount to martial law, in addition to a fine of one hundred million marks.

ASTOR DINNER AROUSES RE OF SOME LABORITES

Flood of Letters to Party's Official Paper in London on "Hobnobbing With Royalty."

London, Mar. 12.—Some of the rank and file of the labor federations appear to be aroused over the idea of Laborite members of parliament "hobnobbing with royalty," at the recent Astor dinner, judging from the large number of letters addressed to the Herald, the Labor party's official paper. Extracts from several of these communications are published today.

The writers want to know what it all means, and suspect that the incident has a "political significance" and will have far-reaching results, putting the Laborites in a false position.

The fear is expressed that the dinner reported an attempt "of the rank and file of the labor federations to reconcile the leaders to the state of affairs by dividing them."

One critic says: "Continuous association with the political opponents is likely to reduce our campaign in the House of Commons to the old sham fight between Tweedledum and Tweedledee, which we have done so much to expose."

The Herald, in its comment, declines to foster the complaints and says that the Labor "M. P.'s" are the best judges of their own action, and that the members immediately concerned are entirely without any weakness of character.

The mine exploded, killing the fisherman and completely shattering the boat. Two other fishermen were in the bark. One disappeared, the other was seriously injured.

Chief among these, it is said, was O'Rourke, who set out to tease Murphy. The latter's quick replies to O'Rourke turned the tables and set the saloon hangers-on laughing at the younger man, who became angry and struck Murphy on the side.

With that, the bystanders say, the pent-up bitterness of a score of years of disappointment and wounded pride, flashed into the man's face, and there followed the glint of the descending knife and the heavy fall of Murphy's forehead to the floor.

FROM WEALTH TO FLOOR SCRUBBER

Once College Honor Man and Leading Salesman, Kills Man Who Taunts Him.

New York, March 2.—Forty years ago Joseph Murphy was graduated with honors from Nicolette College, St. John's, Newfoundland. Twenty years ago he was widely known as the leading wholesale leather salesman in Canada and the New England States. Last week police took him from a cheap hotel, where he lived while working in a former saloon at 474 East 146th Street, swabbing the floor and cleaning cuspidors for the few dollars a week that enabled him to get food and lodging. He is locked up, charged with homicide.

The climax of Murphy's life of misfortune came when, goaded beyond endurance first by taunts about his condition, and then by blows, he seized a cheese knife from the lunch counter and plunged it into the neck of Joseph O'Rourke, a laborer, of 465 East 146th Street, one of a group of loungers in the saloon, who were amusing themselves at old Murphy's expense.

PROGRESS WITH HYDRO.

An enumeration of what has been accomplished by the Civic Power Commission to date shows that despite delays it has made a great deal of progress. The sub-station is to be ready by the first of May. The plans for the street lighting system have been perfected and approved. The plans for the general distribution system are under way. Canvasers are to be sent out at once to get contracts for light and power. It is only necessary to continue as speedily as a reasonable care for the public interest will permit and the citizens will soon be reaping the benefit of the Musquash development. It is the plain duty of the City Council and Civic Commission to cooperate fully, with a complete disregard of all talk about competition.

A company tried competition in Ottawa, and an Ottawa despatch on Saturday showed how far it has got with that policy. The people of St. John can get power at cost from Musquash. It will be their own power, with no profits to anybody but themselves. They want it, and they want no delay. There is at the present time an attempt to discredit hydro in Ontario, or rather to show that it has not been well administered, but, as the Toronto Globe says—

"The triumph of civic co-operative ownership of a great natural asset is written across the face of every bill for light and power."

Mr. W. E. Saunders, a wholesale merchant in London, Ontario, in a letter to the Globe, recently expressed the views of the people who have got the benefit of hydro. He said—"When hydro was created we were abundantly satisfied—nay, we were rejoiced—to have our rates cut in half. Now, if no change had ever been made in the rates since then, and we did still pay half of what we did pay to the privately owned companies, what a vast surplus hydro would have! My own rates is about \$50 a year. At former prices it would have been around \$250. If the Commission saves to every user one-quarter of the difference shown, then two hundred thousand users are saving ten million dollars a year. If that money lay in the coffers of hydro it would have enough to pay outright for the Chippewa scheme and have a comfortable nest-egg remaining."

It would be well for every citizen and especially every member of the City Council and Civic Power Commission to take note of what Mr. Saunders has written. To show any weakness or hesitation in dealing with the situation in St. John would be to play into the hand of profit seekers and inflict loss upon the people. The progress that has been made calls for a continuous policy along the same line, without hesitation or delay.

THE LEGISLATURE.

A careful reading of the speeches of Messrs Richards and Fawcett in the debate on the reply to the Speech from the Throne suggests no cause for bitter discussion during the session, nor any reason for prolonging the debate on the address after the Premier has spoken. Both Mr. Richards and Mr. Fawcett had commendatory words for the new Premier, and neither had any charge to make against the Government. Mr. Richards, in their view, had been extravagant and that the Speech from the Throne was not sufficiently definite in regard to what may be done to make conditions better for the farmer. Mr. Richards thinks the Compensation Board costs too much, and he appears to fear that more money than the province can afford may be spent on the roads; while in regard to Grand Falls he uses the argument with which we are quite familiar, since incorporation interests always keep it to the front, that the province should proceed with extreme caution on this matter. Both he and Mr. Fawcett want more done for the farmers, but neither of them declares a policy in that regard. On the whole the Government may congratulate itself that its acts have caused so mild a degree of criticism as marks the speeches of these two members.

Mr. McKenna, in his admirable speech in moving the address, referred to the need of action to improve the schools in remote rural districts, and commended the subject to the attention of the Legislature. He also dwelt upon the advantage of cheap power, and what the development of Grand Falls by the Government would mean to the whole province. Dr. Violette, who seconded the address, was even more emphatic, and declared that justice to the northern part of the Province called for the development of Grand Falls, even as Musquash had been developed. Both Mr. McKenna and Dr. Violette paid a warm tribute to the Public Health Act and the Minister of Health. Mr. McKenna deals with the handicap of high freight rates under which the farmers labor and urged co-operation of the Governments of the Maritime

DEVELOPMENT OF GRAND FALLS

Edmundston Wants 5,000 Horse-power - Enough Business in Sight to Justify Expenditure.

C. O. Foss, chief engineer of the New Brunswick Hydro-Electric Commission, returned on Saturday from St. Leonard, Edmundston and other places in northern New Brunswick. He had a meeting with the town councilors of Edmundston on Friday at which he decided to contract for 5,000 horsepower upon the completion of the Grand Falls development if the province should decide to go on with the work. This is a decision of no little importance because of Premier Violette's determination that a decision by the province to harness Grand Falls might depend very largely upon the proof that there would be a market for the electricity produced, so that the province would be virtually assured of a return upon its money.

Y. M. C. A. DRIVE.

A meeting of those in charge of the financial campaign for the Y. M. C. A. was held on Saturday afternoon with R. S. Stephenson in the chair and assisted by Harry Bellantyne, general secretary for Canada of the National Council Y. M. C. A. The objective is \$8,800.

PROGRESS IN USE OF WATER POWER

During 1922 Installation in Canada Grew to About 3,000,000 H. P.

Development Under Way - New Projects When Completed Will Have Ultimate Capacity of 1,000,000 H. P.

(Montreal Gazette)

The water power industry may be likened to a flywheel in that it possesses a momentum which enables it to tide over periods of depression and great industrial activity without excessive fluctuations. The history of water power development in Canada has been one of steady progress, and the industry has been a stable one. Whether times have been good or bad the output has been steadily growing, when general business has been poor and interest rates high the increase has been provided for the gradual expansion of the industry.

The most significant feature of 1922 from the hydro-electric standpoint was the development of 2,200 h.p. on the Bull River in the southeastern corner of the province by the East Kootenay Power Company. This plant serves an important mining area in the Fernie, Crabrook district. The same company also commenced construction of a 24,000 h.p. plant on the Elk River near Elk. The initial installation which will consist of two 8,000 h.p. turbines is expected to be completed by the fall of 1923.

Ontario Again Led. As in recent years the construction operations of the Ontario Hydro-Electric Power Commission during 1922 ranked first in magnitude. Work continued throughout the year on the 540,000 horse power Queanston-Chippewa development and the initial stage of this project now nears completion.

At Ranney Falls on the Trent River near Campbellford, Ontario, the 10,000 horse power development of the Commission was completed and placed in operation during August last. Additional powers on the Trent are now being investigated by the Commission; also powers at Bingham Chute on the South River and at Port Severn on the Severn.

Province of Quebec. In the Province of Quebec the turbine capacity actually installed during 1922 did not reach the figure of the previous year, but a number of very important projects were commenced which will add very materially to the utilization of the large power resources of the province.

In New Brunswick the province carries on an active development policy through the New Brunswick Hydro-Electric Power Commission. The first development undertaken by the commission on the Musquash river near St. John was completed and ready for operation by July, 1922, with an installation of 11,110 horsepower. Owing however, to differences between the city of St. John and the New Brunswick Electric Power Company, the agency of its final distribution was not settled until December, 1922, when the city of St. John contracted with the New Brunswick Electric Power Commission to purchase energy up to 15,000 k.w. hours per annum at a price of 12 cent per k.w. hour. The city and the New Brunswick Power Company have not yet composed their differences with regard to the distribution of the power, the civic authorities in the meantime are making preparation to build their own distribution system. The city of Moncton had already contracted with the commission for 5,000,000 k.w. hours per annum, and the transmission line to that city was nearing completion at the close of 1922.

The Nova Scotia Power Commission formed in 1919 for the purpose of creating a complete electric power system for the province brought into operation in June, 1922, its 11,000 h.p. development at St. Margaret's Bay. This plant has since been carrying the entire load of the city of Halifax, and under the present peak conditions the city load is rapidly approaching its maximum capacity. Additional installation of 5,000 h.p. may be added to this development before its ultimate capacity is reached.

BIRDMAN APPOINTED A. D. C.

In the completion of the 168,000 h.p. development of the Manitoba Power Company was passed on December 28th, 1922, when the first unit of 28,000 h.p. was placed in operation under partial head. This event was the culmination of a year of remarkable constructional achievement in which the programme, as planned by the company, was carried out in every respect.

Construction Work in B. C. New hydro-electric construction work in British Columbia during 1922 consisted of the development of 2,200 h.p. on the Bull River in the southeastern corner of the province by the East Kootenay Power Company. This plant serves an important mining area in the Fernie, Crabrook district. The same company also commenced construction of a 24,000 h.p. plant on the Elk River near Elk. The initial installation which will consist of two 8,000 h.p. turbines is expected to be completed by the fall of 1923.

The British Columbia Electric Railway Company has under construction extensive alterations to its development at Stave Falls, at the outlet of Stave Lake involving an expenditure of \$1,250,000. The main dam is being raised 20 feet, and additional side dams are being erected which will approximately double the water storage. An additional unit of 18,000 h.p. was installed and placed in operation in November, 1922, which brings the total in this plant to 32,000 h.p.; provision is also being made for the addition of a fifth unit.

The Granby Consolidated Mining & Smelting Company in 1922 commenced construction of a large concrete storage dam on Falls Creek near Anxox as an essential part of its power development. The dam will provide additional storage of 25,000 acre feet which is intended to eliminate the necessity of steam-generated power for the company's plant and smelter. The company contemplates the installation of a new 3,600 kw. unit during 1923.

A PASTOR AND THE Y. M. C. A. To the Editor of The Times: Sir,—Will you allow me a little space in your excellent paper to state, from the standpoint of a pastor, a few reasons why we should support the Young Men's Christian Association in its present appeal for funds? There are many of our citizens, of course, who will not need any urging to contribute, because, like myself, they have, on many occasions—both at home and abroad, both as civilians and soldiers, been recipients of the physical, social and spiritual benefits largely furnished by the Y. M. C. A. What a splendid life in the army would have been but for the social ministry of this splendid organization.

But much as it met a need in the life of the nation during the period of our present association, I think that it is meeting an even greater need in the life of the community in these present days. It is one of the best things in the life of our city, and should be given the most generous support.

I am thoroughly convinced that our work among young men and boys could not be accomplished with anything like the same efficiency without the co-operation of the Y. M. C. A. In some quarters there is a tendency to regard the Association as a rival organization. This is a mistake. It is not a rival organization, but a supplementary organization which aims to help in bringing about the all-round, four-fold, symmetrical development of our young men and boys. It is co-operative and not competitive.

The Church and the Y. M. C. A. are of mutual benefit to one another. While it is true that the Association does not exist apart from the Church, it is also true that the Association has greatly enriched the life of the Church. The Y. M. C. A. had done nothing else that had two such men as D. L. Moody and John R. Mott into the Church, it would have amply repaid its debt. No man on earth has inspired more students to consecrate their lives to Christian service than John R. Mott. But the "Y" has not only given outstanding men to the work of the Church, it has been a decisive factor in enlarging the scope and mission of the church to the modern world. It was under the stimulus and inspiration of the four-fold Christian work inaugurated by the Y. M. C. A. that the institutional Church came into being, that our Christian Endeavor Societies were organized, that the Student Volunteer Movement was instituted, and that our "Trail Rangers" were organized. It was this work which was launched, which is doing such efficient work in the physical, mental, spiritual and social development of our boys at the present time.

I am confident that the appeal which is being made at the present time on behalf of our local Association will meet with a very generous response on the part of our people.

Two radio sets can receive from the same aerial providing each operator uses the antenna at different times. Electro-Magnetic Waves. 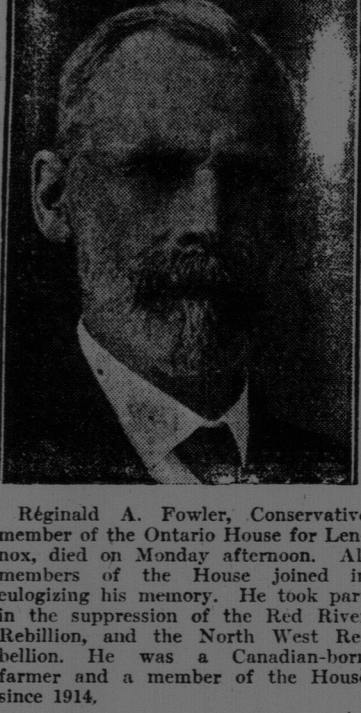

**New York Lawyer's
Advice to Wives**

New York, March 12.—(By Canadian Press.)—Leonard McGee, attorney for the Legal Aid Society, from his experience in the handling of cases of domestic infidelity, has evolved twenty suggestions for husband and wife to follow to avoid estrangement. He presented them at a recent meeting of the society. Here are Mr. McGee's suggestions for wives:—

- 1—Do not be extravagant. Upon the proper and careful expenditure of your husband's income depends his willingness to exert himself for the maintenance of your home. Nothing appeals more strongly to a man than the prospect of acquiring that independence of which a bank account is the guaranty.
- 2—Keep your home clean. Nothing is more refreshing to the eyes of the tired, nerve-racked worker than the sight of a well-looked home.
- 3—Do not permit your person to become unattractive. A slovenly wife makes a traitor husband.
- 4—Do not receive attentions from other men. Husbands often are jealous and some are suspicious without cause. Do not supply the cause. Friendly attentions from others may be received in a spirit of perfect innocence. When reported by the busybody they become distorted, even criminal, in character.
- 5—Do not resent reasonable discipline of children by their father. Many mothers assume that all chastisement of a child by its father is severe and unjustifiable. Even just men consider this an interference. It may easily engender combative hostilities.
- 6—Do not spend too much time with your mother. In such case you may easily spend too little at home for the proper administration of your domestic affairs.
- 7—Do not accept advice from the neighbors or stress too greatly even

- 9—Smile. Be attentive in little things. The smile is an antidote to the toxic effects of ill-humor. Consideration for your husband's feelings makes him respectful of yours. An indifferent wife is often supplemented by an ardent mistress.
- 10—Be tactful. Be feminine. Men in last analysis, are but overgrown children. They do not mind coaxing, but they resent coercion. Most men prefer their opposites. Femininity attracts and compels them. By the same token, masculinity in the female repels.

Tut! Tut! Not All "Ruins" Are In Egypt; Pre-Roman Relics in Panama

Salt Lake City, Mar. 12.—Why go to Luxor, Egypt, to delve into antiquity's secrets when this continent has volumes to disclose?
John Q. Critchlow, has found it interesting pastime to dip into American soil with an investigating spade.
The most valuable disclosures he has made are the product of a trip up El Volcans de Chiriqui, an ancient volcanic mountain on the Isthmus of Panama which rises 11,600 feet above sea level.

The wonders of a civilization that flourished before the days of Caesar were revealed in a pueblo on the mountain side, inhabited by the Maya people, forefathers of the Aztecs. Numerous examples of pottery and clay figures were found, similar to the work done by the Southwestern Indians.
A striking similarity between some of the carved stone "furniture" and that dug up at Luxor from Tut-ankh-Amen's tomb was noted, however, particularly in the stone benches carved to represent animal forms.
No student of hieroglyphics, however, has so far been able to read the curious design carved on stones outside the pueblo. The curious circular writing, if it is writing, was made by scratching shallow grooves on the smooth face of huge rocks.
The symbols were so worn away by the elements as to be almost indiscernible, and had to be filled with salt before they could be photographed.

15 New Cases of Sleeping Sickness Reported in N. Y.
Increase, Believed Due to Presence of Influenza, Falls to Alarm Doctors—112 Deaths This Year.
New York, March 12.—The increase in the number of cases of encephalitis lethargica, commonly known as sleeping sickness, has not alarmed the Department of Health, Dr. Louis I. Harris, director of the Bureau of Preventable Diseases, said last week. Reports showed a total of fifteen new cases, as against the five cases of the preceding day. Deaths decreased from four to two. Since January 1 there have been 360 cases and 112 deaths, slightly higher than the figures for the same period last year.
No specific cure for the disease has been found, Dr. Harris said, but general instructions for its prevention are being issued by the Health Department. The public is urged to obey the simple rules of health, breathe fresh air, sleep eight hours in a well ventilated room, eat enough, and avoid the presence of those suffering from influenza.

London, March 12.—Four attendants have been chosen for the wedding of the Duke of York and Lady Elizabeth Bowers-Lyon, at Westminster Abbey, April 26. They are: Lady Katherine Hamilton, youngest daughter of the Duke of Abercorn; the Honorable Diamond Harding, daughter of Lord Harding, former British Ambassador to France; the Honorable Cecilia Lyon, niece of the bride and daughter of Lord Elphinstone; and Lady May Cambridge, daughter of the Earl of Athlone and a bridesmaid of Princess Mary's wedding.

Many British Going to U. S.
London, March 12.—If the flood of English emigration to America continues at the present rate, Great Britain's quota under the American law will be reached long before July 1, the end of the fiscal year.
Contrary to general impression, it is learned that Britons are going to America at a rate almost never equaled and there is room for only 28,000 more in this year's quota.
Emigrants are leaving Glasgow alone at a rate of more than 800 weekly, which is greater than the number from all other English ports combined last year. The annual quota for Great Britain now is 77,243.
To show the increase in emigration since January 1, last, it is only necessary to state that only 846 persons sailed the first week of January, whereas in the last week of February the departures numbered 1,973. According to emigration statistics, more Britons are going to America than to all the British colonies combined.

SCHOOL SUICIDE
STARTS OUTCRY
AT "BULLYING"

Hundreds of British Parents
Aroused by Act of Boy
Who Ended Life When
"Mildly Kicked" by a
Pupil.

London March 12.—It is a matter of history that one of Britain's wars was fought because the subjects of a foreign power clipped off an ear belonging to a loyal subject of the King of England. That was several hundred years ago. Today a miniature version of "Jenkins' Ear" is being conducted in the London newspapers and magazines because a public school boy, after being kicked by one of his schoolmates and "ragged" by others, committed suicide.

To understand the reason why the majority of distinguished educational authorities of the kingdom have participated in the keen discussion that has followed one must know that in England practically every one who can afford it sends his children to "public" schools, which, of course, are really not public in any sense of the word. Education in England is free and compulsory, but the "board schools," which correspond to the elementary public school as it is known in the United States, are patronized, as a rule, only by the children of the poorer classes. The son of ordinary middle-class parents does not necessarily go to a school of the stamp of Rugby, Eton, but he does attend one of the innumerable privately run institutions which dot the country.

Many Parents Interested.
Instead, then, of being a matter of concern merely to the wealthy, the tragedy holds a personal interest for thousands of parents, who naturally ask themselves:

"Is this the sort of thing which goes on in all public schools, and are my children subjected to it?"

The facts of the basic incident are these:—
Vivian Merton Tanner, fourteen, was a student at Christ's Hospital (the "Bluecoat" school immortalized by Lamb). While acting as a linesman at a rugby football match he made several errors, which angered the players and other officials, and at the end of the game was sent to a senior boy, named Jeffrey, who emphasized his reprimand with what was described as a "mild kick." Later on, Tanner was "ragged" by several other boys, and, in a moment of uncontrollable temper, whipped out a heavy knife and stabbed himself in the breast. The knife blade entered his heart and he died.

Both the headmaster (W. Hamilton Fox) and the medical officer of Christ's Hospital gave it as their opinion that Tanner had been an exceptionally sensitive boy, not fond of games, and that he had not intended really to kill himself, but merely to frighten the other boys.

This general opinion was upheld by Canon, the Honorable Edward LITTLETON, formerly head master of Eton, who asserted that the truth is that the all-fashional bullying is no more, and it seems most improbable that it will ever revive. It is known only to schoolmasters. Canon LITTLETON would have us believe that bullying is one of those old unhappy far-off things that happened long ago—sixty years ago, he says, which conveniently throws it back to the time of Lord Salisbury's exposé martyrdom.

tin, and is as lively as ever. I may remind Canon LITTLETON that during his head mastership of Eton there was a matter in a certain house, in which a number of boys were implicated, and that this led to the issuance of all housemasters of a new set of regulations in restraint of eating."

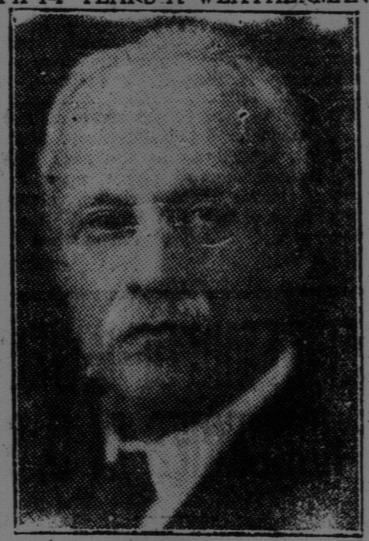
The reference to the late Lord Salisbury recalls what is probably, excepting in fiction, the strongest indictment of English public school life of the early Victorian era. Lord Salisbury (or, as he then was, Lord Robert Cecil) in 1844 wrote to his father a series of letters which found their way into print many years afterwards. They contained such extracts as:—
"Eton has become insupportable. I am bullied from morning to night. When I come into dinner they kick and shin me, and I am obliged to go without eating anything. . . I have hardly any time to do lessons because I pass so much time in being bullied."

It is not seriously contended that the majority of public school boys undergo any such systematic torture as was undoubtedly meted out in the larger schools during the last century.

Some reconciliation of the extreme views of Canon LITTLETON on the one hand, and Sir James Crichton-Browne on the other has been attempted by Guy Kendall, headmaster of University College School, London, and by Alec Waugh, a well-known writer on public school life. Both these authorities believe that the broader sense, bullying is comparatively rare.
Perhaps the most acute attempt to gauge the psychology of the school boy was that of Mr. Kendall. "A really mild kick," he wrote, "hurts no boy physically, but the very mildest of kicks may cause exquisite mental torture if there is any feeling of injustice in the deed, and especially if the victim is of a sensitive nature."
Remembering that there is seldom a now-famous school bully, Mr. Waugh tended to believe that unfairness on the part of other boys was the cause of the bullying. He would have us believe that bullying is one of those old unhappy far-off things that happened long ago—sixty years ago, he says, which conveniently throws it back to the time of Lord Salisbury's exposé martyrdom.

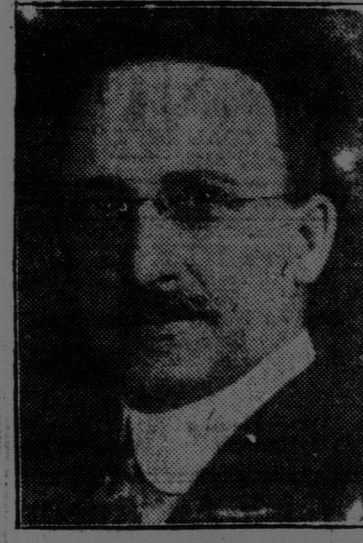

\$80,000 FIGHT ON FOR ESTATE OF LITTLE IRISH NEWSTAND WOMAN

Grandchildren Contest Right of Uncle and Aunt to Fortune That Ellen Corcoran Saved Year by Year From Pennies of Passers-by on Park Row.

New York, March 12.—For many years and up until a few years ago Mrs. Ellen Corcoran, a hardy, pleasant little Irish woman, kept a news stand in front of Perry's Pharmacy, in the Pulitzer Building. In sunshine and rain, in the heat of the summer sun and in the cold of winter evenings she stood by her stand and shouted her "latest extras." There was nothing exactly pathetic about the old news woman, but often when a patron dropped pennies into her wrinkled and sometimes nearly frozen hands there would be a glance of sympathy for her. But Ellen Corcoran never asked man or woman anything but their patronage of her newspaper business, and for that she always added to the odd penny a cheery "Thank ye, sir," or "Thank ye, ma'am."

Mrs. Catherine Malone, who, with her husband, Patrick Michael J. Malone, used to live with Mrs. Corcoran, and her son Michael J. Corcoran. The court proceeding was the trial of a contest brought by three grandchildren of the testatrix. One of these contestants, Mrs. Catherine Droge, testified that her aunt, Mrs. Malone, had told her that her grandmother intended to leave her money to her and her brother. Another witness was Madeline Droge, thirteen years old, a great-granddaughter of Mrs. Corcoran. The little girl said that she called upon her grandmother just before she was to be confirmed at St. Joseph's Church. She told Mrs. Corcoran that she was not sure of having a new dress for her confirmation, for she was not sure her mother could afford to buy her one. To this, said Madeline, Mrs. Corcoran replied: "If I could do with my money as I want to I'd buy you a new dress to be confirmed in, but I can't do anything without Katie (her daughter). Another time, said the girl, her great-grandmother said: "I'll leave you my mother enough money when I die so you and your mother can get a good education."

Mrs. Ellen Corcoran died in October, 1922. Her passing was not noted, as has been the passing of many other Park Row characters, and the men and women, some of whom began to patronize her stand when they were mere boys and girls, will learn of her death only now. The Mrs. Ellen Corcoran, over whose estate, valued at \$80,000, eminent attorneys engaged in legal battle in the Surrogate's Court, it developed, was the same Ellen Corcoran who used to stand at her news stand on Park Row. She was not a mere tenant in the tenement house at 83 Catherine street, where she died, she was a landlady. That property, valued at \$80,000, is the chief asset of her estate, all of which she left to her daughter,

However, there was no provision in the will of Mrs. Corcoran for her grandchildren, who assert in their contest that Mrs. Malone, her daughter, had control over her and her money and used to handle her business affairs. No evidence was adduced showing Mrs. Corcoran was not of sound mind and understanding when she executed her will, while two witnesses testified to the execution of the will was regular in every particular. Edmund L. Mooney and Terence Farley appeared as counsel for Mrs. Malone and her brother, Michael J. Corcoran, the executors, while Goldstein & Goldstein represented the contesting grandchildren.

Man Shot in Gang Feud Refuses to 'Squeal' on Slayers

"They Got Me, But Keep Out, It's My Busy Day," Dying Victim Tells Police With Smile on His Face.

(New York Tribune.) "They" got Dave Stone yesterday. It wasn't a particularly clean job and Stone lingered in agony for three hours after "they" got him, but true to his creed, he refused to give up to the detectives a single word of information which might help them to make an arrest.

"Keep out. No bulls admitted. This is my busy day. I'll fix it my own way," was what the dying gangster told Detectives Nemitz and Hoffman who hustled over to the Harlem Hospital from the West 123d street police station as soon as Patrolman Michael Harris had reported the killing. The name "David Stone" apparently didn't mean anything to the police. The well dressed chap who was shot down in Bernie's poolroom, but the circumstances of the shooting and the fact that Stone kept his teeth clamped tightly on his lips and resisted all inquisition with a taunting smile, stamp the affair as a gang fray. "They got me," Stone said, but when the detectives told him he was dying and begged him to tell just who "they" were, he simply shook his head. Stone entered Bernie's poolroom at 2004 Eighth Avenue, near 110 street at around four o'clock yesterday afternoon.

For three-quarters of an hour he shot pool with an acquaintance. There was no indication of an approaching murder cloud. The thirty or more customers went peacefully about their absorbing pastime. Perhaps "they" had set a quarter to five o'clock as the zero hour for Dave Stone. The hands of the clock marked that precise moment when there came the staccato bark of a single revolver shot. Stone, clutching his waistband, crumpled on the floor. The poolroom emptied as though a magic vacuum cleaner had sucked its customers into the street. In thirty seconds every one within sight or sound of the shooting had sought the open air, grabbing hats and coats from the racks on the way to the door. The proprietor, who was in a nearby restaurant, hurried back to his premises. He found the place deserted, save for Stone, who writhed on the floor, blood trickling from the corners of his mouth.

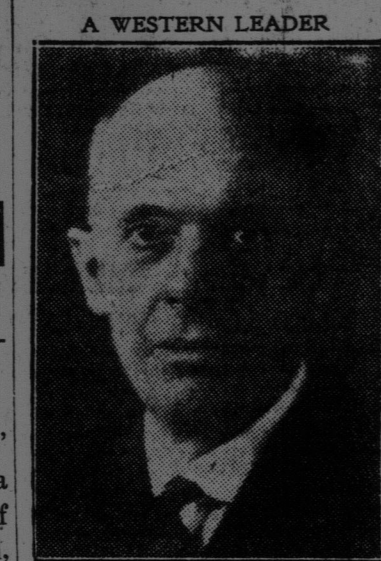

FIRST GUN FIRED IN CAPITAL WAR ON SOCIETY RUM

\$10,000 Seizure in Fashionable Apartment
Only "a Drop in Bucket," Agents Say, Beginning a Clean-up—Customers of High Rank—List Seized, With Messages from Vessels.

Washington, March 12.—Police and prohibition agents today declared they had begun a clean-up of "society bootleggers" in Washington, and meant to keep it up until the national capital takes on some semblance of order. Last Wednesday night they raided the fashionable apartment of William Edward Swanson and seized imported liquors valued at \$10,000. In the collection were more than 2500 gallons of champagne, cordials, Scotch whisky and rye whiskey. The liquor was sent to Internal Revenue Bureau warehouses today. In addition to seizing liquors, the officers took an automobile and obtained telegrams from alleged rum ships docking at Norfolk and a list of several hundred alleged customers of Swanson. The names have not been made public, but they are said to include persons of high social and official prominence. Swanson is free on bond.

Greater Raids Are Forecast.
The police and revenue men declare what they captured in Swanson's apartment is "just a drop in the bucket," however. They say this was the first skirmish in an effort to drive out of Washington and out of business the sellers of liquor in exclusive apartments and homes. Edgar N. Reed, division chief of the prohibition forces for the District of Columbia and nearby states, said Swanson had been under surveillance for several days, but his arrest had been delayed in order to find out his source of supply. Reed says it was Norfolk. Ten cases of rum which were confiscated April 19, 1922, in a raid on the place of Timothy Shine, 428 Seventh Avenue, New York, were among the liquor seized at the apartment of Swanson, according to the police. 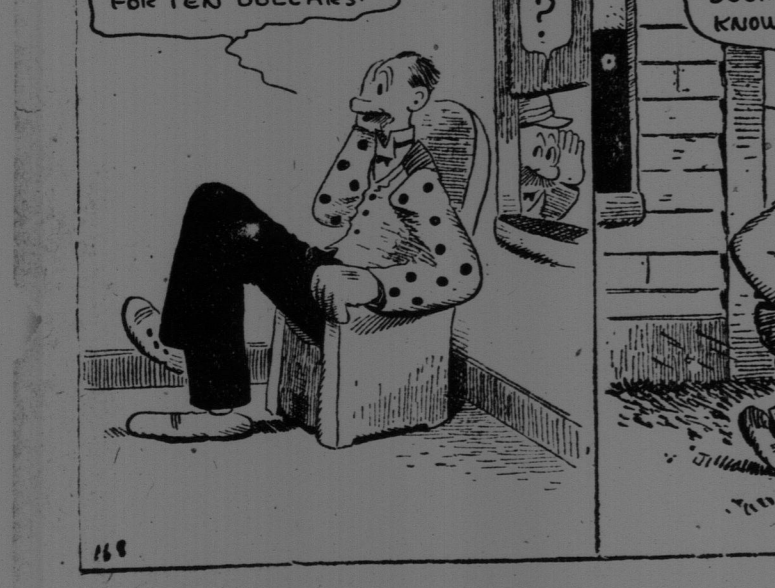

mystery is how the confiscated liquor got out of New York. It is suggested the liquor may have been stolen from a New York warehouse. Reed has found that some of the bootleggers keep apartments for their business, entirely distinct from their homes. These homes are strictly dry. It appears the drive has begun largely as a sequence of the wet parties which marked the farewell of members of Congress at the Capital March 4 and thereafter. Agents watched the Capitol and office buildings of the House and Senate to get information.

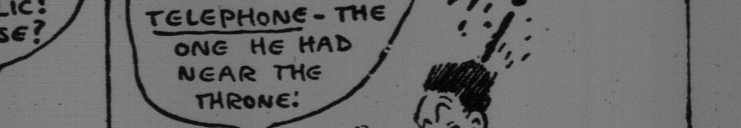

J. T. FITZGERALD MAKES REPLY TO A. W. COVEY

International Skating Association President Says Record Clear

Takes Exception to Reference to Himself as Professional and Commercializing the Skating Game Speaks of the Situation Here and in General.

A. W. Covey has received from Julian T. Fitzgerald of Chicago, head of the International Skating Union, the following letter relative to skating matters:—

A. W. Covey, President Maritime Province Branch, A. A. U., St. John, N. B. My dear Mr. Covey:

I have carefully read all of the newspaper articles regarding the resignations of the Maritime Province Skating Association, and while I am thoroughly familiar with the fact that there is a factional grievance in the Canadian skating circles and believe myself that some investigations could be looked into for an improvement of the skating sports in Canada for the future, I take exception to your remarks in reference to myself as head of the I. S. U., being an out and out professional and a promoter of professionalism and, as an officer of the Alfred Johnson Skating Co., highly commercializing the skating sports.

While I want to help you and the rest of those good officers who have given so much time, and perhaps money, to the further promotion of the skating sports in Canada, I would like to know where I have commercialized the sports in any degree. I have been connected with the skating sports for twenty-five years, served every office in the Western Skating Association from the lowest office to the presidency, in which organization I am, and while the remark of my commercializing the sport has been mentioned numerous times during my official capacity with the other skating organizations, I have never given the Alfred Johnson Skating Co. any financial aid that has been mentioned in your article.

I am also secretary and treasurer of the Central Association of the U. S. vice-president of the Amateur Bicycle League of America, and hold numerous other official positions in athletic and skating organizations, and hardly believe that I could serve any of these organizations during the past twenty-five years in such a manner as to have had my name mentioned in your article as having commercialized the sport in the different organizations in which I have held, and still hold, office.

Some of the greatest achievements ever accomplished in athletic and skating sports have been started by my untiring efforts in trying to see that athletic and skating sports were placed on a higher scale. I have assisted in making the Western Skating Association one of the greatest skating affairs of the I. S. U. I have resisted in placing the I. S. U. before the skating world as a real skating organization which in the past few years has grown from a small organization to one that is now recognized as the greatest skating union in the world.

I have assisted in making Chicago one of the greatest skating cities in the country, and still with all of these achievements I fall to see where, if I had commercialized the sport, it would be in the skating and athletic public would still wish to retain me at the head of their organizations.

As to Commercializing. There is no greater way in the world to commercialize the sports than some of the many things that happened during the big circuits this year, and, I might add, for the past few years, among officials and other members of the skating organizations affiliated with the I. S. U., who have been allowed to act as officials when they had their hearts and souls interested in their own skating who were competing in the races in which they were acting as officials. This has been allowed repeatedly when the rules of the I. S. U. specifically state that no official is allowed to officiate at any meet under the jurisdiction of the I. S. U. wherein any skaters from his club, organizations or otherwise, are competing. This is what I call commercializing from this standpoint of view—that during the past few years it has been known that certain officials acting as officials in meets where sums of money have been paid on the results of their skating, and this is no secret either. Still, these things have been allowed to go on without objection and the parties to the crime have not been censured or even referred to as commercializing the sport.

Now, I have no connection whatsoever with any skaters competing in any of the races. They all look alike to me, if they care to use our skates, we make a good enough skate for them to wish to use or they would not do so. We have never paid any skaters for using our skates, but we do know of other skaters who have made this practice and are still doing so, but they are getting away with it and not commercializing the game because they have no member of their concern who is before the skating public like myself.

Many remarks have been made about Bill Small and some of the skaters going on a "barnstorming tour" after the close of the circuit at Moncton, and if there is any truth in the statement that these skaters competed in any of the races for a split of the gate receipts, the charges should be brought to the attention of the I. S. U. and no doubt the members of the Board of Control of the I. S. U. are honest enough to mete out whatever punishment is due

the skaters if they are proven guilty of receiving money for their competition. I agree with you that matters of this kind should be very thoroughly looked into and I could show you how quick I could prefer charges against any of the skaters in our Western Skating Association if it can be proven that they were receiving money for their performance of skating.

It has been said several times of late that some of the top notches in the amateur ranks have been receiving money, but so far there has been no proof furnished and therefore no action can be taken.

The fact also that the circuit this year was of too long a duration and that is the reason some of the skaters from our section were not able to make the circuit this year go to school, while others are holding down good salaries and their earnings are being used to keep them away from their positions for so long a time. We had a hard time to get Harry Kasey released from his position as skater in the circuit, and with Father Moore of his parish to allow him to get away for the length of time he did.

The fact also that various skaters held up associations for money may have some truth in it, as we know the expenses connected with the underwriting of putting on our National Championships in Chicago were greatly exceeded by the skaters, but this is a matter for the I. S. U. to take up and to guard against any repetition of this in future circuits.

Amateurs and "Pros." One thing in which I do not agree with you is your remark that professionals should not be permitted to perform on the same ice as the amateurs. This has been practiced in the United States ever since I can remember anything about skating sports. The reason for this is to allow a rest for the skaters between the heats, semi-finals and finals. I fall to see where the professional skaters appearing on the ice between races can in any way mar the amateur standing of the ice skaters. He does not skate with them but merely entertains the spectators while the amateurs are getting the desired rest. My only objection would be that no amateur skater should be allowed to perform with the professional skaters to secure the evidence and carefully to critic them to become professionals, but even if it did have this effect, they could no longer be amateurs.

I. S. U. Control. So far as the A. A. U. is concerned, they have no jurisdiction over the skating sports, but I think it is tooing situation. The I. S. U. having sole control over the skating sports. The proper course to take to clear up the skating situation in your territory would be to secure the evidence and present your report to the Amateur Skating Association of Canada, which Association at present is the governing body over the amateur skating sports of Canada until at such a time as your skating association should become affiliated with the International Skating Union through the releasing of your territory from the Amateur Skating Association of Canada.

I believe that Louis Rubenstein and James A. Taylor, officers of the Canadian Association, are men beyond reproach and feel that they will greatly aid you or other officials interested in clearing up the present difficulty in skating circles in Canada.

I have every respect for Frank White, who I know has done many great things for the promotion of skating events in Provinces, and I believe Mr. White can tell you honestly through his acquaintance with me and my connections, that I have played the game on the level and if there are any charges of commercialism to be placed at my door, I at least think it only fair that I should be allowed to explain so that I may have the opportunity of admitting or denying them.

I have also great respect for Dan J. Corr, R. D. Patterson, H. J. Sheehan, Frank McCafferty, Chas. A. Owens, Martin R. Dolan, Hugh H. Lellan, R. S. Ritchie, F. W. Keenan, W. K. Haley, Dr. H. Barton, H. Mont Jones, and other members of the Executive Committee who promoted the International Championships Meet, and believe them all to be real men with rich sporting blood, who do things for the love of the sport and as I have mentioned in your city at the banquet and different receptions tendered to your guests, we need men of their calibre to keep the skating sport clean. I am at a loss now to understand why all this should happen in your skating circles with such a number of good fellows and hard and untiring workers as you are now experiencing in skating matters in your Maritime Province Skating Association, and this letter is only written to you with the understanding that it may result in the present skating difficulty being straightened out and also to prove to your entire satisfaction that as president of the I. S. U. I have never placed a wager on a skating race in my life, even when I knew how races were going to turn out and could have made a lot of money by taking advantage of my experience. But I wanted to go on record that I never have to stoop so low as to take advantage of my fellow skating officials or use any unfair tactics that would in any way gain for me something that I am not justly entitled to. Life is too short to chisel such tactics at my stage of life after serving over thirty-five years of my life in almost every branch of sport and as an official for over twenty-five years and I think it is tooing late for me to make any changes at this time, for I like the honor and the glory of keeping my name from being diminished in your Province.

I am writing these paragraphs to you in good spirits and hope that you will receive them the same way and will be pleased to have you give me your reply, and I offer my undivided attention in serving the skating sports and hope to see the trouble now existing in the Maritime Province Skating Association settled and a reorganization effected so that you will continue in the good work that has already been accomplished in your Province.

POLAR AIRSHIP READY JULY 1

New York, March 10.—The 680-foot dirigible ZRI which is to carry American naval officers and crews over the North and South Poles, according to Rear Admiral William A. Moffett, chief of the bureau of aeronautics, is more than three-fourths built and will be ready for service on July 1, it was learned at Lakehurst, N. J., where the dirigible is now being constructed.

The engines are now being tested by the Packard Company in Detroit. Its 2,000,000 cubic feet of helium will be carried in 18 gas bags.

The dirigible trip over the North and South poles is perfectly feasible and is bound to be made in the near future, according to Vilhjalmur Stefansson, the explorer and author of "The Friendly Arctic" and other books on the far north.

It was the certainty that such trips were to be made and were to continue that caused Mr. Stefansson to retire from his life work of exploring and pioneering in the Arctic. The remaining work of writing in the detail on the blank spaces of the map of the world will be accomplished by photography from dirigibles and the exploration is gone, according to Mr. Stefansson. Scientists will continue to make intensive surveys of little-known localities. But discoveries in the few remaining unexplored regions are all to be accomplished incidentally as a by-product of air travel, according to Mr. Stefansson.

The explorer, who is a Canadian and who, two years ago, sent a party to Wrangell Island in the Arctic north of Siberia to occupy it as a British air base, discussed its strategic value today. With future development of flying, Mr. Stefansson asserted that Wrangell would become a key point of air strategy in the Arctic. On the question of transpolar air commerce Mr. Stefansson said:

"In crossing the Atlantic the dirigible or any flying craft has to compete with ocean liners, but in crossing the polar area there is no competition with any form of transport except for the possible development of the submarine which has been suggested by various writers, including Simon Lake and myself."

"If you look on a globe you will see that the shortest route between Great Britain and Japan lies across the north polar area. The difference in distance between that route and the shortest railway and steamer route by the region of the midnight sun before your first sunset. You will not leave the continent until you approach Japan, so that even at the speed of the dirigible or any flying craft, it is no greater than that of the 1-34 there, today."

will be only one night's darkness in the whole journey, and by careful manoeuvring you would probably avoid even that."

Comdr. R. Weyerbacher, who is in charge of the construction of the dirigible at Lakehurst, said today that part of the gasoline system had already been installed and that the tests of the engines so far had been highly satisfactory.

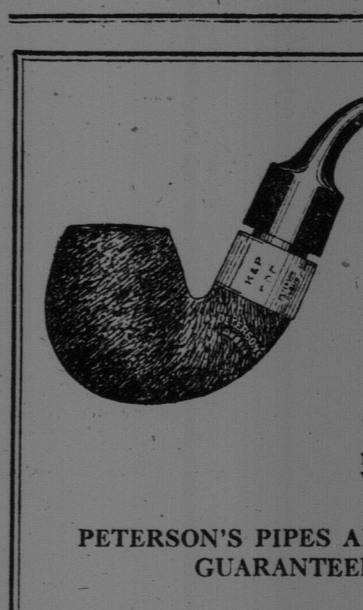

Sir Thomas G. Esmonde's Fine Home in the County Wexford, Ireland, Burned

Historic Home, Where St. John People Have Been Guests, Put to the Torch on Sunday.

A Canadian Press Cable today from Dublin reports that the historic residence of Sir Thomas H. G. Esmonde, at Gorey, county Wexford, Ireland, was burned to the ground yesterday. Clorin Castle, near Delvin, county West Meath, a magnificent Norman structure, formerly the residence of the Greville-Nugent family, was burned last night.

The loss of the magnificent home of Sir Thomas Gratton Esmonde will be keenly regretted by many St. John friends. Sir Thomas has been a frequent visitor here since his first visit some 88 years ago. Last fall he was a guest of Hon. R. J. Ritchie at a delightful dinner gathering at Bond's. Since his return home Sir Thomas had the great misfortune to lose his wife, Lady Esmonde succumbing to illness in the home which is now destroyed.

It was called Ballynastagh and was situated at Gorey, County Wexford. The estate has been in the family some 1500 years and the house dated back some three centuries. Mr. and Mrs. T. N. Vincent and Miss Vincent and Hon. Mr. Ritchie have been delighted visitors there at various times, and all today deeply regretted receipt of the news of the Wexford senator's great loss.

Hon. R. J. Ritchie was shocked and grieved this morning when he learned that the magnificent home of Sir Thomas Gratton Esmonde had been destroyed. While enroute to Rome last year he visited Sir Thomas and was a guest of his for some days. He said it was one of the most beautiful estates in Ireland and the home could compare favorably with many of the famous chateaux in France. Ritchie had been in the house, which was a regular castle, of stone construction of the artistic architecture, and it tastefully furnished and surrounded by some 700 acres of land. A charming and picturesque lake was almost at the door. There were twenty rooms in the home, in addition to a small but beautiful chapel, where priests came to celebrate Mass. The interior of the chapel was very pretty and the altar a masterpiece of art.

Upon entering the grounds the drive passed the lake and over to the right stood a large tower, from which a panorama was unfolded to the eye. Upon entering the house there was a large hall, to the left of which was Sir Thomas' private room. Passing through folding doors the hall proper was disclosed and at the end of it was an immense wide stairway. To the left of this was a very large dining room and to the right was an equally large drawing room. Adjoining the dining room was a large library containing hundreds of volumes from the pens of many of the famous writers. On the second floor were situated the chapel and the bedrooms, while in the rear of the house were the quarters of the large number of servants.

Throughout the house were more than 400 magnificent pictures, some of them original masterpieces while others were copies of some of the great masters. The fixtures throughout were beautiful and everything was arranged so artistically that the house was a veritable palace.

Old Furniture. While writing at one of the tables one day Hon. Mr. Ritchie happened to look down and saw Cromwell's name on a plate and inscribed alongside was "two years ago." This furniture was secured in 1640. This family heirloom was handed down from generation to generation. While looking at this antique his attention was called to the chair on which he was sitting. It was a chair used by the famous Sir Henry Gratton in the Irish Parliament.

AFTER 22 YEARS

New Brunswick's Reply to Advertisement of 1901 Delivered a Few Days Ago.

Another possible world's record was established the other day when a letter reached the E. A. Strout Farm Agency at 150 Nassau street, New York, in reply to an advertisement which appeared in a newspaper twenty-two years ago. The letter was written in Central Millstream, N. B., and had been forwarded by the P. O. Department from Kent's Hill, Me., to which it had been originally addressed. A key number on the envelope traced the letter back to an advertisement which last appeared in the newspapers of the Strout Farm Agency was in the little village of Kent's Hill, four miles from the nearest railroad station. The total business for the year 1901 was twenty sales. The main office was moved to 150 Nassau street, New York, nineteen years ago.

PRESBYTERIAN CHURCH IN PERITH IS BURNED

Perth, Ont., March 12.—St. Andrew's Presbyterian church here was destroyed by fire yesterday. The church was built in 1892 and rebuilt in 1898. A new organ installed at a cost of \$10,000 last year, is a total loss.
