An Act to remove doubts touching the Act incorporating The Burlington Bay Dock and Ship-building Company.

THEREAS doubts have arisen as to the powers and rights of The Preamble. Burlington Bay Dock and Ship-building Company, by reason of the failure of the persons therein mentioned and incorporated, to cause Directors to be elected and other proceedings to be had at the periods mentioned or intended in the Act incorporating the said Company; For the removal of such doubts be it declared and enacted, &c.,

That the Act of the Parliament of this Province, passed in the Session Act 10 and 11 held in the tenth and eleventh years of Her Majesty's Reign, and inti- Vic., cap. 84, tuled, "An Act to incorporate certain persons under the name of The declared to be in force. " 'Burlington Bay Dock and Ship-building Company," is and shall be held to be in full force, notwithstanding any such failure as aforesaid; except the tenth Section thereof, which is hereby repealed.

Exception.

II.
