THE GOVERNMENT has issued in the form of a Blue-book the report of His Majesty's Commission appointed to inquire into the military preparations and other matters connected with the South African war. The Blue-book is a bulky volume of 316 pages, and is divided into four sections. The first section deals with the military preparations for the war. Section 2 applies to the supply of men. Section 3 is a general section dealing with the supply of men, equipment and transport by sea and land, and section 4 to question of War-office organization.

PRELUCE TO THE REPORT. The Commissioners, in the course of a lengthy preface to their report, criticize the terms of reference. THE SUPPLY OF MEN.
