## PROVINCIAL LUNATIC ASYLUM.

### Report of the Medical Superintendent.

On the 31st October 1872, the date of last Report, there were two hundred and forty three patients on the record—one hundred and twenty six males, and one hundred and seventeen females.

During the year there have been admitted ninety one—fifty males, and forty one females.

The total number under treatment has been three hundred and thirty four—one hundred and seventy six males, and one hundred and fifty eight females.

The result of treatment is, forty three have been discharged recovered—twenty males, and twenty three females; two much improved—one male and one female; eight improved—five males and three females; one female unimproved; thirty six have died—twenty two males, and fourteen females; and there remain in the Institution two hundred and forty three—one hundred and twenty eight males, and one hundred and fifteen females.

The cause of death in sixteen was exhaustion from various forms of chronic insanity; and in six, consumption; in five, old age; in three, epilepsy; in two, apoplexy; and in one each, paralysis, erysipelas, typhoid fever, and softening of the brain.

Seventeen of those who died were buried by their friends, seven by the Rev. Mr. Dunphy, six by the Rev. Dr. Scovil, three by the Rev. Mr. Hickson, and one each by the Rev. Messrs. Burgess, Michaux, and Donahoe.

Of the two hundred and forty three remaining, sixty one are improved—thirty two males, and twenty nine females; and one hundred and eighty two unimproved—ninety six males, and eighty six females.

Of the whole number under treatment during the year, there were from Saint John one hundred and forty; Charlotte, thirty five; York, thirty three; Westmorland, twenty three; King's and Northumberland, twenty two each; Gloucester, eleven; Albert, ten; Kent and Carleton, eight each; Queen's, seven; Sunbury and Restigouche, each three; Victoria, two; Nova Scotia, five; Prince Edward Island, two.

The monthly average during the year has been two hundred and forty three. The greatest number at any one time, 22nd August, two hundred and forty nine, and the smallest number at any one time, 6th March, two hundred and thirty eight.

Sixty one patients have been admitted under the Act of Assembly 53 Vic. Chapter 25; forty one on Warrants of County Treasurers; and twenty one cash payments on account of the Provincial Receiver General.

The Warrants on County Treasurers have been transferred to R. W. Crookshank, Esquire, for collection, and the money will be paid to the Bank of New Brunswick to the credit of the Provincial Receiver General.\*

\* The money—four hundred and twenty dollars—has since been paid.

In this year the admissions have been ten less than the last, shewing the continued favorable operation of the Act of Assembly imposing an entrance fee of twenty dollars, and also of the Commissioners' Order,\* leaving some cases to the decision of the Medical Superintendent to admit or not at his discretion. The number at the end of this year, however, is the same as that of last year. The Institution is still too full. The only proper relief for which, is to furnish more accommodation. Last year I published the Resolutions passed by the American Association of Medical Superintendents of Institutions for the Insane, giving their expression of the evil effects of over-crowding, which I hope may not be overlooked, and that they will have their due influence in the proper quarter.

\* ORDER.—“It is Ordered, in consequence of the crowded state of the Lunatic Asylum, that, until further notice, the Medical Superintendent be authorized to exercise his judgment in reference to receiving additional patients. All Magistrates and others are therefore notified that, except in the case of lunatics clearly dangerous and violent, it would be advisable before issuing Royal Gazette, 26th June, 1872.

Last year I referred to the subject of "Expense," and I shewed conclusively from statistics drawn from various sources that this Institution is one of the least expensive known, while the result of treatment compares favourably with that of any country where provision is made for *all* the insane, as is done here.

Messrs. E. T. Kennedy & Co. have completed the work of putting in the new Cooking apparatus, new fittings in the wash room, and an additional section of heating apparatus in the south wing.

It is proposed to add the remaining section of the heating apparatus, embracing the eastern front of the building, in the course of the next year, and when that is done the whole will be completed and the establishment made safe and very comfortable. So long as stoves are continued in use we will be liable to accidents from fire. Recently a patient\* was very seriously burnt by setting fire to her clothing from the door of the stove. Fortunately, this is the first accident of the kind that has occurred, though the liability to them at any time has been to me a constant source of uneasiness.

A drying room, to dry clothes by steam heat, is required, and also a mangle for the laundry, and the laundry to be fitted up with shelves and tables, to enable the work of that department to be done with greater facility than it can be now.

The fences, to which I have frequently referred as being in a dilapidated condition, remain unimproved, and, consequently, in a worse state from another year's wear.

The barns require general repairs on the outside, and to be covered with paint or wash.

The farm and garden have been very productive the last season, richly rewarding all the labour expended on them.

The Reverend Dr. Scovil continued his gratuitous services as Chaplain till near the end of the year, when he left for England, where he is to remain till May next. Before leaving he arranged with the Reverend Mr. Dowling to perform his duties in his absence.

The Messrs. J. & A. M'Millan, of Prince William Street, have kindly furnished gratuitously a lot of excellent reading matter for the patients, and a visitor contributed for the same purpose a handsome volume, "Golden Hours."

The proprietors of the following Newspapers have our hearty thanks for continuing gratuitously to forward their papers for the use of the Institution:—The "Evening Express," Halifax; the "Saint Croix Courier," Saint Stephen; the "Religious Intelligencer," Saint John; the "Christian Visitor," Saint John; the "Patriot," Prince Edward Island; the "Argus," Prince Edward Island; the "Union Advocate," Newcastle; the "Head Quarters," Fredericton; the "Christian Work," London; the "Carleton Monthly," Carleton; the "Meteor," Alabama Insane Hospital, Tuscaloosa.

In addition to these, there is furnished at the expense of the Institution, Illustrated papers, English and American, and some of the Magazines.

In the year that has now closed, nothing of an extraordinary character has occurred worthy of note to interrupt the usual course of the affairs of such an Institution. The work has been done in the usual way, and on the whole
