The Provincial Grand Secretary, Brother N. C. Gowan, then read his report as follows:—

To the Right Worshipful the Provincial Grand Orange Lodge of Western Canada:

In obedience to the practice that requires your Grand Secretary to give to the Grand Lodge information of the state of the Order, and recommend for the consideration of the Grand Lodge such measures as he may judge necessary or expedient, I have to communicate that since the last meeting of the Grand Lodge, not anything has occurred to disturb the harmony that existed at the time of my last Report. My relations with all parties under your jurisdiction have been distinguished by friendly and brotherly intercourse. I am happy to inform you, that during the year there have been opened six new Lodges, each of which appears to contain the elements requisite for good, healthy, useful branches of our Order. The form of Return introduced last year has been highly serviceable in securing accurate and detailed information, and has enabled me nearly to complete the directory which I began some four or five years since. I trust, however, that Brethren will see that

the Annual return for the Grand Secretary from Primary Lodges is filled up in open Lodge immediately after the election of officers at the December meeting, and then forwarded directly to the office of the Grand Secretary. Returns that I ought to have received one year ago last December, I did not receive until December, 1862. I must again remind the Grand Lodge that there are several Warrants bearing the same number on their face scattered through the country. I trust that the Provincial Grand Lodge will memorialize the Most Worshipful Grand Lodge to remedy this evil. I have obtained a press and "letter copying book," in which will be found recorded full copies of important answers to questions on the jurisprudence of the Order. In the "General Record of Correspondence" will be found an epitome of four hundred and sixty letters, which I deemed of sufficient merit to make an entry of and to answer. I trust that the committee on Correspondence will find the answers to these letters satisfactory. I am gratified to find, that there has not come to this Grand Lodge a single protest against the decision given on any one point that has been submitted for my official action. I have sent to the County Masters "Forms of Returns," with printed headings, from Primary Lodges to their District or Township Lodge; from the District Lodge to the County Lodge, and from the County Lodge to the Provincial Lodge. Those from the Primary Lodges should be made out the day after the December meeting, and sent to the District Masters. The returns from the District or Township Lodge, should be filled on the second Wednesday in January, and sent to the County Master, the returns from the County Lodge to the Provincial Lodge should be made out on the first Wednesday in February, and forwarded immediately to the Provincial Grand Secretary. All fines, suspensions, or expulsions, should be taken from the Primary to the District, thence to the County Lodge for confirmation, (and in case of appeal, should be accompanied by the papers,) to be brought forward by the County Master, otherwise they should not be entertained by the Grand Lodge. In order to avoid mistakes and to secure prompt replies, I am anxious that every member of the Order who corresponds with me, should state his past

office address, Township, District, County, and the office (if any) he holds in the Order. I sent the circular notifying of this meeting to all the County Masters, and to as many of the District and Primary Lodge Masters as I knew the address of; on each of these circulars I had to pay one cent postage, but this is an immense saving over the large bills that we used to pay Printers for advertising the meetings of the Grand Lodge in their newspapers. I regret to say, that after all my former efforts to induce Lodges to send their dues directly to the Grand Treasurer, they still continue to send dues through a variety of sources to that officer, I must therefore again urge that the Treasurers of Primary Lodges do send the dues of their Lodge directly to the Provincial Grand Treasurer, who should, immediately on their arrival, send a receipt for them to each Primary Lodge Treasurer. I beg leave to recommend that a judicious Committee be appointed for the purpose of collecting and compiling the decisions given on the Jurisprudence of the Institution, in order that the same may be published for the information and guidance of the brotherhood. I am also of opinion that a specific form of regalia should be adopted for each of the Degrees, so that each regalia should be indicative of the number of Degrees a Brother has received, and also of the office (if any) he holds in the Order.

Talso wish the Grand Lodge to decide, whether the fact of a Brother filling the office of Master, disqualifies him from speaking and voting as a member of his Lodge. I also think it would be well to pass a resolution declaring that Orange Funeral Processions should not be granted (except in rare cases) to certificate members. I take the liberty of recommending the Grand Lodge to appoint Grand Committeemen, in the proportion of one for every ten members of a Primary Lodge; each Committeeman to be recommended by the vote of his Lodge, and to pay one dollar annually, towards the Provincial Grand Lodge Funds, upon the payment of which, he should have the right to vote in the Provincial Grand Lodge, and upon the payment of a like sum to his County and District Lodge, to have also the privilege of voting therein. This plan would secure the wisdom of many aged and intelligent members to assist us in our chief official

meetings, besides materially augmenting the revenue of the various Lodges, and so enabling them to be regularly represented at all meetings of the Order. It would also, largely increase the number in attendance upon the Grand Lodge, and would thereby add increased intelligence to, and greatly vivify the annual gatherings of the Provincial Lodge, and indeed, I may add also, of the County and District Lodges of the Order. In view of the many defects in the arrangement and rules of the present Constitution, I am of opinion that it would be well for this Provincial Lodge to request the Most Worshipful Grand Lodge to appoint at its next meeting a large and judicious committee, for the purpose of revising and improving in arrangement the Constitution of the Order. Many of the local defects in the working of the Order, which I pointed out in my last report, still exist, and I shall continue to call attention to them until every Primary Lodge is properly working in its own District and County. The subject of Provincial Lodges, and a restoration of the Order to the Constitution that existed prior to 1859, will doubtless again engage your attention. I gave notice at the last meeting of the Most Worshipful Grand Lodge, that I should at its next session move that Masters of Primary Lodges should be allowed to vote in the Most Worshipful Grand Lodge, for I cannot see why we should have in Orangeism taxation without representation. It appears to me most singular and most unjust too, that the Provincial Lodge which does not pay one cent to keep up the Supreme Grand Lodge, should have the right of sending every one of its Officers there to vote away money which they never contributed; that the County Lodge which pays no dues for the support of the Supreme Grand Lodge, is allowed to send its Master there, while the Primary Lodge that pays two dollars annually, is denied the right of sending its Master; so, likewise, the District Master, who by Constitution is only required to meet his Lodge once a year, is given a vote in the law-making body of the Order; while the Master of the Primary Lodge, who by the Constitution is required to meet his Lodge monthly, and thereby, to do twelve times the duty of a District Master, is denied the privilege of speaking or voting in the Most Worshipful Grand Lodge. The

daily history of the Order convinces me more and more of the importance of a return to "the old paths and the good way" of former years. There is a constant and increasing demand for changes in the constitutional features of the Order; probably there never was a period in the history of Orangeism, when so large an amount of dissatisfaction existed in the Order as at present, and nearly all owing to the strong opposition felt to cutting up the Order into Local Lodges. In a voluntary association, harmony can be maintained and lasting prosperity insured, only by a cheerful and free concurrence in all its requirements, and this can reasonably be expected only, where participation in enacting those requirements has been freely enjoyed. But Primary Lodges, though more numerous than Provincial, County, or District Lodges, and though the only ones that pay dues, are, strange to say, denied any participation in the measures of the Most Worshipful the Grand Lodge. Thus making representation in that body not only numerically weak, but also partial. Besides the views and wants of the Primary Lodges not being represented in the Most Worshipful Grand Lodge, can only be partially known to that body. And certainly, in those days when the distant parts of the earth are brought together, as if belonging to the same locality-when the inhabitant of the antipodes are brought almost within speaking distance, by the appliance of science and art, it is not in accordance with the tone of the day, nor the spirit of the age, that Orangeism should separate its forces and divide its members, keeping them apart.

I regret to find that there is a class of minds among our membership, who do not understand our Order; who are in fact dead weights on the institution. These are they who are Orangemen in name only, and whose only care is to keep good upon the books to prevent the disgrace of their expulsion: but who take no real interest in the Order. They appear never to have studied its origin, principles, objects and advantages, and consequently, they do not understand its machinery, the extent and the result of its operations; they do not understand and practice the morality of its teachings—the scope and tendency of its laws and governments, and the beauty, aim, and

wisdom of its mysteries. They do not closely notice its practical operation and bearing, both upon those within its pale and upon those without its fold. They do not contemplate it in the Lodge-room, in the family circle, in the city, in the church, in the election contest, in the House of Parliament, by the side of the sick, at the grave of the dead, in the house of the fatherless and the widow. They do not examine it as a secret society, as a moral institution, as a loyal order, as a benevolent association. Were this done, they would not fail to discover in Orangeism as they advance from degree to degree, and from mystery to mystery, new beauties and perfections as they proceed; and in a short time would be satisfied that the Order is a subject of vastly greater moment than they at first glance imagined. And their increased and just appreciation of its worth, and of its peculiar and admirable adaptability to its proper mission, would cause them to be more punctual in their attendance upon the various meetings and duties of the Order. Though I furnish the Grand Lodge with a short epitome of my correspondence, which contains the chief official decisions given during the year, yet there have been many decisions made on constitutional points, which, though not deemed of sufficient importance to claim the attention of the Grand Lodge, either in their consideration or rehearsal, but which have cost me much research and no inconsiderable amount of labor. This, however, has been fully compensated for, by the knowledge that many points of difference have been amicably settled, and many appeals prevented. I trust that the Grand Lodge will consult how public opinion can best be elicited, and public attention called to the alarming increase and still continued prospect of addition to Roman power in this country. I also hope that some means may be found by which we can thank and uphold the firm and consistent opponents of Romanistic intoler-Many of our public men, ance in the Parliament of our country. and some even of our own Brotherhood, in the House of Assembly, are too compromising in their policy. I am convinced that it is a mistaken course for Orangemen, as for other warriors, to be ever on the defensive. There are indeed times when right must be defended, but there are also, times when right should be propagated. The best plan to banish Romanism from the land, is to spread Orangeism through the land; the surest way to kill rebelism, is to spread loyalty over the land. A continual posture of defence, such as we have generally taken both in Parliament and out of it, is an acknowledgement of weakness. True, some men tell us to keep quiet for fear of giving offence, and thereby doing more harm than good. Absurd argument, must we fold our arms and sit in inglorious inertia, because the enemies of religion and loyalty are liable to take offence if we move, or because we are in danger of not always acting in the wisest and most perfect manner. Shame upon the thought. Let Orangemen be up and doing. A bold manly independent front (especially by our public men,) will accomplish wonders for the Order. I detest what some men call expediencyism. Expediencyites are always ready to

"Bend the pregnant hinges of the knee, That thrift may follow fawning."

Orangemen should be known in modern days as they were known in olden times, for honest inflexibility. The past has already thanked our noble fathers and founders for the great principles of freedom, patriotism and piety, with which they inaugurated the Order. Let us prove ourselves worthy sons of noble sires, and the Order will continue to receive the sympathy of the intelligent, the respectable, the freedom loving and the pious in the land. We have much yet to do for our country—public opinion must be called more fully into exercise upon the assumptions of Romanism—it must be concentrated or it will not be felt. Much responsibility undoubtedly rests upon the Order of which you are the wise and zealous managers. Orangeism, spread as it is throughout the Provinces, gives us power to act in unison and harmony, and consequently, with efficiency. Pointing you, therefore, to the enemy now holding the field, I say in the language of the great here of Waterloo, "up Guards and at them."

### SERMON.

"And it shall be for a token upon thine hand, and for frontlets between thine eyes."—Exopys xiii. 16.

It is altogether impossible for us to advance the great cause we have in hand, and for which our Protestant Association was first called into existance, if there is want of unity-union is strength, disunion, weakness-and so truly are our adversaries aware of this, that we find them by every means in their power endeavouring to sow the seeds of discord; yea, and by craft and subtilty assuming characters which are contrary to their own feelings, if they may thereby the more effectually overturn that which they feel to be an hinderance to the spread of their own unholy principles. Hence, necessity is laid upon us to be a united body, men of one purpose and object, who have solemnly in the presence of God and those who were to love their associates, sworn to bear true allegiance to our Queen and lawful successors, so long as they are true to their solemn coronation oaths, to uphold and maintain the Protestant Faith; who have also faithfully promised and sworn to resist all attempts to weaken British influence in these noble Provinces. Brethren, we need be upon our watch, lest we be surprized, and when too late find that to our own neglect may be traced evils which may

weigh heavily on those who may come after us. Now, this unity of one far st action will never be carried out, indeed it cannot be, if there is any forward o dissimulation, any double dealing. St. Paul's exhortation is most worthy of being given heed to-"Lie not one to another." Every less waste one of you my Orange Brethren have a double duty to observe in this respect. You are citizens among your fellows, and should strive to maintain a character of probity and truth, but you are especially bound to do so as Christian Orangemen, because any departure therefrom tends to bring disgrace on the cause which with the life you profess to honor. This truth keeping refers not only to what you say, but also to what you do; and the more you really consider your very first obligation, the one on which you were initiated into our glorious Institution, the more will you see the necessity of being true men. Your solemn vow and oath have bound you to sobriety, temperance and honesty; and I say an Orangeman who is a drunkard, or a swearer, or a liar, or dishonest, is a perjured person, guilty of endeavoring by his own example to injure his brother, by tempting to the committal of the same sins, when the very sign on his hand, or the frontlet between his eyes, should put him in mind of his promise, "I will be faithful and true to every Brother Orangeman in all just actions, neither wronging him, nor knowing him to be wronged or injured, without giving him due notice thereof, and preventing it if in my power." Every step you have taken since your first initiation, has brought with it fresh remembrances to stir up your minds to consider whereunto you are called. The lessons you had to learn may have been easy and pleasant, or they may have partaken of a directly opposite character, comparable almost to the fiery ordeal of the burning furnace, still they were lessons, teaching you plainly the great duty of obedience to those set over you as your elders, or the equal duty of concealing the foibles of your Brethren while you labor diligently, prayerfully and faithfully for their reformation, remembering the words of St. Paul,---"Brethren, if any be overtaken with a fault, ye that are spiritual restore such an one in the spirit of love, considering thyself lest thou also be tempted." Not only may we learn from the exhortations of the great Apostle, but from the example of

He is then our guiding star, the morning star, leading the traveller safely across this otherwise trackless waste, to a fairer land where the days of privations and watchings, and cares, shall be over for ever and for ever. As Israel of old was led safely under the guidance and direction of the "Great I Am," so shall we also be guided, for

"By his unerring spirit led,
We shall not in the desert stray;
We shall not full direction need,
Nor miss our providential way."

The vows of the Holy One rests upon all of us—the responsibilities of baptismal engagements are such as we can never by any mortal power be absolved from-were we not prepared or rather pledged under the sign, the seal or emblem of the covenant of grace, even the Sacrament of Baptism to be true to our God, and true to our Brethren also. Ought not the various tokens on our hands be as remembrances, putting us in mind of death, of judgment, and of that eternity into which we may each of us so soon enter, for verily there is but a step between us and death, and death's narrow stream is the only dividing line between time and eternity. God knows the difficulties we have to encounter in our homeward journeyings-the various temptations which assail us-the hinderances which are set in our pathway by adversaries, and hence his loving mercy has provided grace to help in every time of need, grace and strength sufficient to meet every emergency; a glorious and sure direction in his own blessed Word, which is a light to our feet and a lantern to our path if we ask the enlightening influence of His Holy Spirit. But do all of you ask for that influence? I know for the most part you glory in your privilege of having God's word in your possession, and that none dare hinder your reading it, but then is it not, alas, too truly manifested by the lives of many Orangemen, as it is by the lives of many professed Christians, that the Word of God has little lodgment in the heart; that the great lesson of repentance for sin is received as a theory but not acted on; that faith, and hope, and charity, exert no

actual influence on their daily conduct, while sin, that deadly evil, first introduced into the world by Eve, who yielded to the beguiling of the serpent, spreads its pollution through every part, and those who should be patterns of piety and true loyalty, are in too many instances the direct contrary, and are found day by day adding sin to sin, drunkenness to thirst, perjury to profanity, thus making our glorious institution as much as in them lie, as far as they possibly can do it, a bye-word and reproach. Thank God, all are not so, there are faithful ones among the faithless; as in the days of Elijah, so now there are doubtless more than seven thousand among us who have not betrayed their trust-who, as they think of the various lessons they received in the different Degrees to which they have been advanced, call to their minds the words of the text, "And it shall be for a token upon thine hand, and for frontlets between thine eyes," and govern themselves accordingly; who really feel and act under the conviction that Orangeism is a reality. To such in God's house at this time, the preacher would address the words of exhortation and encouragement.

Brethren, be true to your vows, and you shall ever find in the Great I Am, and Lord Jesus Christ, a present helper. He will guide you continually, yea, and feed your souls with that spiritual manna of which that laid up in the golden cup in the ark of Gopherwood was only a type, while the sprinkled blood of the Lamb shall preserve your soul from the destroying angel, when he shall pass over the dwelling of the wicked and cut them off from the face of the earth. In the meanwhile, be diligent in daily duties, let the emblems of the mysteries communicated to you, my companions, be as tokens upon your hands, to put you in mind "that you are bound to give alms to the poor and weary pilgrim travelling from afar, to succour the needy, to feed the hungry, to clothe the naked, and bind up the wounds of the afflicted;" that we are to be lovers of peace, but at the same time are bound by the most solemn obligation to war against the enemies of innocence, destitute widows, helpless orphans, and the Protestant faith; and he who acts contrary thereto, no

The Committee on the Royal Scarlet then handed in their report as follows:---

To the Right Worshipful the Grand Lodge of Western Canada:

Your Committee to whom was referred the consideration of the working of the Royal Scarlet order, beg leave to report that they recommend this R. W. G. L. to bring this subject under the notice of the Supreme Grand Lodge, and request them to remodel this Scarlet dispensation, so as to render it more efficient.

Your Committee see no fault with the Ritual or ceremony, but are of opinion a short code of rules for the guidance and government of Chapters should be issued, regulating how and when officers should be elected, the application of the funds, &c.

Your Committee find it has been the custom to embody the Scarlet Degree in Orange certificates and call attention to this irregularity, being of opinion that a Scarlet certificate can only issue from the Chapter, and should be separate and distinct from all other certificates.

Your Committee find that in some instances the officer holding dispensations claims the right of moving this Chapter from place to place without the consent of the Companions, and desire to record their opinion against this practice as subversive of good order, and to state that in their belief the Chapter, like any other Lodge, must be regulated in its internal arrangements by the will of the majority of its members, subject of course to any rules or order that may be issued for its government.

Special Committee on complaint made by Bro. D'Arcy Boulton, Past Deputy Provincial Grand Master of Western Canada, on behalf of Bro. Purvis, of the Township of Elmvale, in the County of North Simcoe, against Lodge 164, Scarborough, East York:

Your Committee having heard the evidence of Brother Boulton and Brother W. M. Button, feel it incumbent on them to give a synopsis of the ease, in order that this Right Worshipful Grand Lodge may be in a position to deal with the case on its merits.

Some six years ago the members of the above named Lodge purchased a piece of land to build a Lodge thereon, and did build a brick building 22 x 40—two stories high. On the completion of the Building, the Master, Deputy and Treasurer of said Lodge, to whom the Deed of Trust was made, found themselves unable to pay the balance of the debt on said building to the Contractor, and had recourse to borrow money by order of the Lodge to pay off said debt.

On making application for the money to several parties, they found that money could not be obtained on the Trust Deed held by them, and were under the necessity of giving a confession of judgment each for himself as collateral security, together with a Mortgage on the Hall, in order to obtain the money.

The borrowed money was not paid, and about two years ago the Sheriff levied only on one of the three Trustees that was worth anything, (H. Purvis), and sold him out for the sum of fifty pounds.

The Sheriff has now seized on all the property of H. Purvis for the balance of the debt, and will be sold out without any effort being made by the members of the Lodge to assist in paying the debt, or even giving up the Trust Deed to him.

Your Committee beg most respectfully to recommend that this Right Worshipful Grand Lodge deposit with the Right Worshipful G. M., Bro. Medcalfe, a sum not exceeding fifty dollars, to employ Messrs. Blake, Solicitors in Chancery, in Toronto, to get legal advice, in order that the said Hall may be foreclosed, or otherwise to pay the present debt on said Hall, (said fifty dollars to be paid back out of the proceeds of the sale.)

And further recommend that Bro. Boulton and Bro. Wm. M. Button be delegated to wait upon Messrs. Blake to give all the information in the case.

Your Committee would also recommend that the County Master of South Simcoe call a County Meeting at an early day, and have the members of Lodge 164 summoned before it, in order that they may be dealt with as in the judgment said County Lodge may seem meet.

## REPORT OF THE ANNUAL ADDRESS COMMITTEE.

Your Committee, appointed to draft an address to the Brethren of our Noble Order under the jurisdiction of the Right Worshipful Provincial Grand Lodge of Western Canada, setting forth "the prospects and objects of the Order and calling upon the Brethren to promote, by all means within their power, the interests of our Institution," beg leave to Report . That though there is a large majority of the membership under your jurisdiction that would prefer a modus operandi of the Institution, to what your Committee consider the "old path and the good way," yet we have reason upon the whole in reviewing the position of the Institution to "thank God" for the past, and to "take courage" for the future. The blood of the martyred dead which was poured forth at Derry, Aughrim and the Boyne, has not been in vain. The Empire of which it is our boast and our glory to be subjects, was, by the efforts and services of our noble sires, reserved from the thraldom of a Faction who teach that disloyalty to a Protestant Sovereign is not a crime, and the murder of a heretic is not a sin. These facts cannot be controverted. They are written as with a sunbeam in the history of the British Empire, and glare forth in the canons of Romanism. In those days Protestants did their duty. They were true to their God, their Country and their Sovereign. They opposed rebellion by loyalty; thunderous institutions by defensive ones. We are proud to say of the men who thus acted, they were our Fathers. May we ever prove worthy sons of these illustrious sires. In that day the friends of Orangeism were "few and far between;" but behold what a noble army is now marshalled under the banner of " No Surrender" to Popery. These objects your Committee trusts will not be lost sight of by any one member of our noble institution. We are a great Protestant and loyal Brotherhood-one in principle and in aim-let us then be one in action, and let the man who would break that oneness, that should characterize Orange action, be a

"Fixed figure for the hand of scorn To point its slow unmoving finger at."

And is it not advisable and necessary for every Protestant, but especially every Orangeman, to forget mere names and parties, either religious or political, and seek by all fair and constitutional means, to save our own fair Canada from falling prostrate before the capacious maw of Romanism.

- 2. The Seniority of members entitled to preside, is to be decided by the following scale of precedence:

- The M. W. the Past Grand Masters (taking rank from the date of their appointment.)
- 3. The Grand Master, or Grand Officer presiding, is the sole judge of order, (subject to an appeal to the Grand Lodge). He may address the meeting at any time he may deem it necessary, but whenever he does so, he must be standing and uncovered.
- 4. The Grand Secretary and Grand Treasurer, together with their Deputies and Assistants, shall have tables allotted to them, convenient to the Grand Master.
- 5. The M. W. the Grand Master, all M. W. Past Grand Masters, all present Deputy and Deputy Grand Chaplains, and all Grand Officers of the M. W. the Grand Lodge, shall be entitled to seats on the platform, to the right and left of the Chair.

- 8. On all subsequent days, the same order shall be observed as on the second day, except as regards the election of Officers.
- 9. Members admitted while the Lodge is open, shall first present their cards of office in the prescribed form, to the Grand Tyler, for delivering to the Grand Director of Ceremonies, and upon entering the Lodge Room, shall take their seats as noiselessly and with as little interruption as possible.
- 10. While the Grand Lodge is in Session, dignity and order are to be observed by all members, they are not to go across the house or remove from their places without urgent necessity; they are not to speak with other members so as to annoy any other member who may be at the time addressing the Chair, or to otherwise disturb the deliberations of the meeting.
- 11. When any member desires to address the Grand Lodge, he shall rise in his place uncovered, and address himself to the Grand Master, or to the officer presiding, and should two or more members rise at the same time, the Grand Officer presiding shall decide which shall first address the meeting.
- 12. No member is to speak more than once upon any subject under consideration, except to explain some part of his speech which may be misunderstood, and even then only briefly; but in no case to introduce new matter. No member except the mover of a motion is permitted the right of reply, except by special motion.

- 13. When any member is called to order by another member, he is immediately to take his seat till the point of order is explained, after which he is to resume his address.
- 14. When a member has occasion to allude to another member, he is not to do so by name, but by the dignity or name of the office which he holds, as "The Most Worshipful," or "The Right Worshipful," or "The County Master of ——," or "The District Master of ——," or "The Worshipful Master of ——," &c., &c., as the case may be.
- 15. No member shall speak beside the question in debate, nor longer than fifteen minutes except by special motion.
- 16. No motion is to be entertained unless in writing, and when once put, is not to be withdrawn without leave of the Lodge. When the "Yeas" and "Nays" are called for, they are not to be taken down unless demanded by five members, and when so demanded, the Grand Secretary shall call each name separately when the member shall rise, and his "Yea" or "Nay" audibly given, shall be recorded in a separate column.
- 17. It is a breach of order for one member of the Grand Lodge to attribute improper motives to another member, and when replying to the speech of a preceding speaker, the Brother addressing the Chair shall apply his answer to the matter without wrong to the person.
- 18. There can be no amendment to a nomination for appointment to office, which is always to be but in the order proposed; but to substantive motions of matter, amendments may be offered, which take precedence to the original, but no amendment can be received, except to amend, to postpone, to refer, or to adjourn—the last being always in order.
