CONSTITUTION

OF THE

Congregational Anion of Ontario and Quebec.

1. That the name of this Association be, "The Congregational Union of Ontario and Quebec."

II. That it shall consist of Congregational or Independent Churches, and of Ministers of the same Church Order, who are either in the pastoral office or (being members of Congregational Churches) are engaged in evangelistic or educational service, approved and received at a general meeting.

III. That this Union is founded on a full recognition of the distinctive principle of Congregational Churches, namely, the Scriptural right of every separate Church to maintain perfect independence in its government and administration, and, therefore, that the Union shall not assume legislative or administrative authority, or in any case become a court of appeal.

IV. That the following are the objects contemplated in its formation:—1. To promote evangelical religion in connection with the Congregational denomination. 2. To cultivate brotherly affection and co-operation in every thing relating to the interests of the associated Churches. 3. To establish fraternal correspondence with similar bodies elsewhere. 4. To address an annual or occasional letter to the associated Churches, accompanied with such information with a property of the constant of the configuration relative to the Congregational Churches throughout the British American Provinces. 6. To hold consultation on questions of interest connected with the cause of Christ in general.

V. To promote the accomplishment of these objects, and the general interests of the Union, an annual meeting of its members shall be held, each of the associated Churches being represented by two lay delegates; the meeting to be held at such time and place as may be appointed at each annual meeting.

VI. That the officers of the Union be a Chairman, Secretary-Treasurer, Statistical Secretary, Minute Secretary and Committee, all to be chosen annually from its members, who shall execute the instructions of the Union, and prepare a docket of business for the annual meeting.

VII. That alterations may be made in this constitution by any annual meeting, provided that notice of such alteration has been given at the meeting next preceding.

STANDING RULES.

1. All ministerial candidates belonging to Congregational or Independent Churches, for admission to this Union, shall make their application in writing, and shall furnish therewith certificates of good moral standing in the body from which they come, and a full and clear statement of their views on Christian doctrine and Church polity. In the case of candidates who present satisfactory letters of dismissal from a recognized sister Union, such certificates and statements may be dispensed with. Candidates for admission from other denominations shall be required, in addition to the abovementioned certificates and statements, to produce certificates of having passed through a course of literary and theological training, equivalent to that provided by our colleges. Failing this, they shall be required to undergo an examination in the several departments which constitute the theological course of study in the Congregational College of B. N. A. This examination shall be conducted by a Committee of Examiners, consisting of members of this Union, who shall be appointed annually for this special purpose. The said board shall appoint the course of reading, and the mode of conducting the said examination, subject always to the approval of this Union, and shall report the results of the same to the membership Commit-All applications shall be reported to the Union, and shall be, with their accompanying documents, referred to the Committee on Membership (or a special committee) for full inquiry. Candidates, upon whose application the Membership Committee has favourably reported and recommended, shall be eligible for immediate admission into the Union, provided always that a unanimous vote be required for such admission. In other cases, with the consent of the Union, candidates shall stand proposed for membership until the next annual meeting of the Union (with the privilege of honorary membership), at which, after a favourable report from the Membership Committee, they shall be eligible for admission.

2. The Union shall meet annually on the Wednesday after the first Sabbath in June, at 7.30, p.m., when the annual Sermon shall be preached, by appointment of the previous Annual Meeting.

3. The Union shall then be organized under the presidency of the retiring Chairman, or, failing him, the pastor in the place of meeting, by the election of Minute Secretaries and Reporters, the calling of the Roll, and the appointment of Standing Committees on Business, Membership, Examination, Nominations, and Finance, on nomination by the Committee of the Union.

4. On Thursday morning, after the devotional exercises, the retiring Chairman shall deliver an address, and the new Chairman shall be elected, after nomination by the Committee of the Union, or by any member of the Union.

5. After the election of a new Chairman, the Committee of the

Union shall present their annual report.

6. The meetings shall be daily opened and closed with prayer;

the morning devotional exercises to extend to an hour.

7. No motion shall be discussed unless seconded; no member shall speak twice to the same motion, without permission from the chair; and every motion shall be presented in writing by the mover, if required by the chair.

8. The roll shall be called, and the minutes of the preceding day read at the opening of each day's session, and the minutes of the last day at the close of the session.

9. The Church in whose locality the annual meeting shall be held shall be requested to celebrate the Lord's Supper in connection with

such meeting. 10. On the Monday evening during the sittings of the Union, a

public meeting of the Union shall be held.

11. Application shall be made by the Statistical Secretary, one month at least before the annual meeting, for statistics of the several Churches, and a brief narrative of the state of religion among them, that he may prepare a condensed narrative of the whole, for

the annual meeting, and for publication, if so ordered.

12. A collection for the funds of the Union shall be made annually in each Church, on or near the Lord's day prior to the meeting. From this source, in addition to the other expenses of the Union, the travelling fares, by the cheapest route, of the ministerial members of the Union, and of one delegate from each Church contributing for the year, shall be paid in full, if possible, and of both delegates as soon as the funds suffice; on the understanding that such payment shall not be made until after the final adjournment, except with the leave of the Union.

13. The delegates from the Union to corresponding bodies, who may fail to fulfil their appointments by personal attendance, shall address those bodies by letter, communicating in substance such information and sentiments as they would furnish if present at their

annual convocations.

Charles Pedley, deceased, and made a touching reference to that circumstance

THE REPORT OF THE COMMITTEE OF THE CON-GREGATIONAL UNION OF ONTARIO AND QUE-BEC AT ITS NINETEENTH ANNUAL MEETING.

Beloved Brethren,-Through the loving kindness of our God, we are brought together, according to adjournment, in this our nineteenth annual assembly, for the seventh time meeting in this commercial metropolis. The large experience of brotherly love and hospitality with which the Union has been received by Zion Church has rendered Montreal to our Churches, what topographically she is not, the social centre. This unifying local bond has been greatly strengthened by the presence and personal influence of the revered Principal of our College, whose 35 years' Pastorate of Zion Church, followed by the presidency of the School of the Prophets, renders him now more than ever, the father and presiding spirit in our Sisterhood of Churches. May his yerrs of efficient service for the body-be much extended in this most important sphere of usefulness!

The personnel of the Union as represented by its ministry, has undergone some changes in the year that has elapsed since our last happy assembly in Guelph. One beloved brother, the Rev. Charles Pedley, of Coldsprings, has been removed to his Though we have been thus de-Heavenly rest and reward. prived of the anticipated privilege of hearing his voice as preacher of the annual sermon, nevertheless "he being dead yet speaketh." May this vacancy and its hallowed associations prove more stimulating to our faith, and love and zeal than his presence and utterances could have been. Within the year another devoted minister of Christ, long connected with this body, though at the time of his decease labouring in another portion of the vineyard, the Rev. Thomas Lightbody, has likewise entered into the joy of his Lord. Death has also entered the family of another brother, the Rev. J. Salmon's wife having been removed last March. With such instances of mortality in our ministerial fellowship, it becomes us to lay to heart the Master's words-"I must work while it is day; the night cometh when no man can work."

During the year three removals from pastoral charge have occurred, viz.: Rev. A. McGregor, who has retired from the bounds of this Union, in order to enter the pastorate at Yarmouth, N.S., Rev. James Howell, who has left his charge at Granby, and accepted an agency for the Montréal Tract Society, and Rev. Mr. Rae, who has ceased to be the pastor of the

The following settlements have taken place, viz.: Rev. J. A. R. Dickson, as pastor of the Northern Church, Toronto, and Rev. S. N. Jackson, over Zion Church, Toronto; Rev. James Hay, after twelve years' absence in Africa, Australia, and New Zealand, having returned to Canada, has accepted a call to Brockville; Rev. W. H. Heu de Bourck, after a period of withdrawal and association with the Canada Presbyterian Church, has accepted the pastorate of the Congregational Church at Stratford; Rev. J. M. Smith has returned from the Western States, and entered upon pastoral labours at Amherstburg; Rev. R. W. Wallace, B.A., has been ordained pastor of the Church at London; Rev. J. H. Perkins has entered the ministry at Franklin; Rev. J. Shipperley, at Abbotsford; and Mr. D. McGregor has become assistant of the pastors of Zion Church, Montreal.

The new Chapel Deed prepared by instruction of this Union and presented at last annual meeting has been withheld from publication, awaiting the Act of Incorporation of the "Canada Congregational Missionary Society," required, therein, for which application to the Ontario Legislature was made, a few minutes too late for introduction at the late session. duplicate copies of the old deed have been issued.

The hope expressed in last year's Report respecting a more general agreement of religious bodies in the observance of a day of Thanksgiving was attained by the concurrence of the principal Protestant denominations in the appointment of Thursday, Nov. 16th, for that purpose, which was accordingly well observed. It is highly desirable that in the absence of action in this matter, on the part of the Governor-General, or the Lieutenant-Governors, a similar arrangement for concert in such observance as last year be secured, by interchange of communications between the several Christian denominations. We earnestly desire that the special day of Thanksgiving appointed by His Excellency the Governor-General on occasion of the merciful recovery of H.R.H. the Prince of Wales, so very generally kept by all classes of the community, may serve the purpose of a precedent for similar Government appointments of an annual day of Thanksgiving.

Your committee would recommend that a special committee be appointed to prepare an Address of Congratulation to be presented by this Union to Her Gracious Majesty the Queen, on the happy experience of the tender mercy of our God vouchsafed to Her Majesty and the whole nation, in the remarkable answer to prayer for the recovery of H.R.H. the Prince of Wales, when all human means seemed unavailing.

The Ladies of Zion Church, Montreal, have assumed the responsibility for continuing the Labrador Mission, not as their exclusive charge, but in hope of enlisting the co-operation of churches and individuals throughout the Dominion in this ne-

cessary labour of love.

Other extensive and inviting fields in the west are open to us, and there never was more urgent need of large-hearted liberality and self-sacrificing devotion on the part of Zion's sons and daughters. May the present Assembly receive such a baptism from above of "the spirit of power and of love, and of a sound mind," as shall render us more willing and able than ever to attempt great things for God, under the inspiring expectation of great things from Him.

Rev. F.H. Marling, on behalf of the Nomination Committee, reported the names of speakers for the various public meetings,

which report was received and adopted.

Applications for membership were read from the Rev. W. M. Peacock, of Athol, Ontario, and Rev. J. M. Smith, of Amherstburg, Ontario (late of Iowa, U.S.) On motion they were

referred to the Membership Committee. Similar applications from the churches at Forest and Embro, Ontario, were likewise

referred to the Membership Committee.

Invitations were read from the Young Men's Association of Zion Church, to a festival on Friday evening; also from the Mechanics' Institute and Montreal Y.M.C.A., to the use of their reading rooms and libraries during the sittings of the Union.

Rev. W. F. Clarke requested to be excused from being the convener of the Business Committee, owing to the necessity of his attendance as Home Secretary on the meetings of the Gen. Miss. Com., whereupon he was released, and Rev. J. A. R.

Dickson appointed.

After prayer by Rev. J. Hay, the Union adjourned until

2.30 p.m.

At one o'clock on Thursday, and again on Friday; the Union was invited to an elegant luncheon in the Lecture Hall, which was adorned with flowers and mottoes. Rev. C. Chapman, M.A., presided, and several brief, impromptu addresses were delivered.

THURSDAY AFTERNOON.

The Union met at 2:30, p. m., and after prayer by the Rev. E. J. Sherill, proceeded to business.

The minutes of the previous sessions were read and confirmed.

The Rev. James Hay, and Rev. J. M. Smith, were received

as honorary members.

An application was read from Rev. James Hay, of Brock-ville, for admission to the Union, which, on motion, was referred

to the Membership Committee.

Communications were read from Rev. H. D. Kitchel, D. D., delegate from the National Congregational Council, lately held at Oberlin; also from Rev. R. D. Osgood, from the Association of Congregational Churches of Maine, U. S., expressing regret at their inability to be present at the Union, and sending greetings from our sister churches in the U. S.

Delegates from the Union to corresponding bodies were

called upon to report.

The Rev. F. H. Marling responded on behalf of the delegation to the National Council at Oberlin, Ohio, which had been represented by himself and the Rev. W. F. Clarke.

From other responses made, it appeared that none of the Associations in the United States, to which delegates had been

appointed had been visited, but in most instances communications had been sent to them, conveying the salutations of the Union.

On motion, Rev. Thomas Gales was received as an honorary member.

The Union then adjourned until Friday, at 9 o'clock, a. m.

FRIDAY, JUNE 7th, 9 A. M.

The Rev. James Hay conducted devotional exercises, which lasted one hour.

At 10 a.m., the Union resumed business. The minutes of previous meeting were read and confirmed.

The Business Committee presented a report, concerning the order of business which was adopted.

An application for membership was made by Revd. James Shipperly, which, on motion, was duly referred to Membership

Committee.

The Membership Committee reported, recommending that the application of the Rev. W. M. Peacock, James Hay and James Shipperly be granted; likewise the application of the Forest Church.

The report was received and laid on the table for future consideration.

The Rev. J. M. Smith asked leave to withdraw his application for membership, and Rev. W. S. Rae applied, in like manner to be dismissed from the Union. Both requests were, on motion, referred to the Membership Committee.

A communication from the Canada Presbyterian Assembly, in reference to a Day of Thanksgiving, was received and referred

to the Business Committee to consider and report on.

The claims of the CANADIAN INDEPENDENT were presented by Rev. F. H. Marling, who stated that, notwithstanding a fair increase of subscribers during the year, the subscriptions were so irregularly paid, that a considerable indebtedness had been accruing for some years, and it was necessary for the proprietors to be assisted by others who felt the necessity for a denominational organ, in order to ensure its continuance.

The Rev. Mr. White, of Belfast, Ireland, addressed the Union, whereupon it was resolved, that this Union receives with much pleasure the greetings of its Irish brethren, and reciprocates most heartily their expressions of good will.

The Business Committee reported in reference to the communication from the Canadian Presbyterian Assembly, with regard to the Day of Thanksgiving, recommending concurrence in their proposal, whereupon it was moved by Rev. J. Wood, seconded by Rev. W. F. Clarke, and resolved, that the report of Business Committee be received and amended as follows:—"That we concur in the observance of November 14th, the day named by the Assembly for this year, and respectfully suggest that hereafter, the various denominations in the Dominion observe the same day, as is observed in the United States, so that there may be uniformity all over the continent."

A communication was read from the Secretary of the Temperance League of Quebec, inviting the Union to attend a Public Temperance Meeting, in Great St. James' Street. Weslevan

Church in this city, on Tuesday next.

The Rev. R. McAlpine Thornton, and the Rev. Mr. White, of Belfast, were invited to sit as honorary members.

On motion, the order of business as previously adopted, was

amended as follows :-

That from 3:30 to 4 p. m. be given to the CANADIAN INDE-PENDENT, and that the essay from Mr. Elgar, be listened to and discussed from 4 to 5.

The Union then adjourned.

The Union re-assembled at 2:30 p. m.

At ten the Union came to order for business. The Business Committee rendered a report, presenting a docket of business for the day, which on motion was adopted.

The minutes of the two previous sessions were read and confirmed.

The Union then made way for the adjourned meeting of the Congregational College.

The Union resumed at 12 o'clock.

A Special Committee, consisting of the Revs. Dr. Cornish, E. Ebbs and John Wood, was appointed to draft an Address of Congratulation to Her Most Gracious Majesty the Queen on the recovery of His Royal Highness the Prince of Wales.

The Membership Committee then reported that the Rev. W. S. Rae, lately of Danville, Que., was a member of the Congregational Union of Ontario and Quebec, but being no longer doctrinally in accord with this body, they recommend that his connection with this Union do now cease.

The adoption of this report having been moved and seconded, it was moved in amendment by the Rev. F. H. Marling, seconded by Rev. R. Lewis, that the Rev. W. S. Rae having desired to withdraw from the Union, his name be erased accordingly, but that, as this desire was expressed while charges against him were under investigation, no letter of dismissal can be granted him.

It was moved in further amendment, by Rev. C. Chapman,

M.A., seconded by Rev. J. A. R. Dickson:

That this Union having ascertained with regret that serious doctrinal differences have arisen between the Rev. W. S. Rae and the Congregational Church at Danville, which have issued in his separation from that church, and in most calamitous results to that church, it is deemed right that his connection with the Union should cease and that it does hereby cease.

A still further amendment was moved by Rev. W. F. Clarke,

seconded by Dr. C. W. Cowles:

That the report of the Membership Committee be received, but not concurred in, and that the Rev. W. S. Rae be expelled

from this Union.

A lengthened and earnest discussion arose upon these motions, in the course of which it appeared that the demand for action arose from moral as well as doctrinal considerations. As the result, Messrs. Marling and Chapman withdrew their amendments, and Mr. Clarke's amendment was carried almost unani-

mously

The Membership Committee further reported, recommending that the Rev. J. M. Smith be allowed to withdraw his application for membership in this body.

Moved by Rev. J. Brown, seconded by Rev. H. J. Powis:

That the report be accepted and adopted.

Moved, in amendment, by Rev. W. F. Clarke, seconded by Dr. Cowles:

That this application be laid over for one year.

The amendment was carried unanimously.

The Union was then asked to excuse some of the brethren who were necessitated to absent themselves for Sabbath duties. The Rev. Messrs. Purkis, Duff, Parker, Sanderson, Rogers, McKillican, and Mr. Stockwell, were excused accordingly.

SATURDAY AFTERNOON.

After singing, and prayer by Mr. J. Wickson, the Secretary presented applications for dismission from Rev. Ludwick Kribs, of Minnesota, and Rev. Alexander McGregor, of Yamouth, Nova Scotia, which on motion were referred to the Membership Committee.

A telegram was received from the Primitive Methodist Conference, in Session at London, Ont., presenting the salutations of that body to the Union, which on motion was referred to the

Business Committee.

A letter from Rev. W. I. Budington, D.D., of Brooklyn, N. Y., relating to the Resolutions passed by the National Council at Oberlin, in regard to the Washington Treaty, and expressing his firm belief in the solution of national difficulties by Christian arbitration, was read and, on motion, referred to the Business Committee.

Mr. Thos. Elgar, of Toronto, then read an Essay on "The Christian Training of the Young," which was followed by a dis-

cussion of this important topic.

The Business Committee presented a docket of business for Monday, which was adopted.

On motion, it was unanimously resolved:-

That the thanks of this Union be presented to the Rev. Professor George Cornish, L.L.D., for his suggestive and practical address, and that he be requested to place it at the disposal of the Editor of the Canadian independent for publication.

The ex-Chairman, in acknowledging this expression of thanks, took occasion to explain some passages in the address which had

been misapprehended.

The Union then adjourned until 9 a.m., Monday morning.

MONDAY, JUNE 12, 9 a.m.

The usual hour of prayer having been observed, the Union came to order for business.

On motion the programme adopted on Saturday was suspended, that the delegates from the Wesleyan Methodist Conference might be received and heard. Whereupon the Revs. Dr. Green and John Gemley addressed the Union, expressing the warm regard and fraternal feeling toward our denomination which exist in the Wesleyan body.

It was moved by Rev. W. F. Clarke, seconded by Rev. J. A. R. Dickson:

That the Union has received with much pleasure the fraternal salutations of the Wesleyan Methodist Conference now in session in this city, so heartily and eloquently conveyed by its honoured delegates, the Rev. Anson Green, D.D., and the Rev. John Gemley; and while reciprocating to the full their kind utterances, would express the earnest desire that these pleasant interchanges may be continued from year to year.

This resolution was carried by a unanimous rising vote.

On motion, the Rev. S. P. Barker, of Lamont, Michigan, was welcomed as an Honorary Member of the Union.

The topic brought before the Union in the Essay read on Saturday by Mr. Elgar, was again discussed for some time, and, on motion, a resolution of thanks to Mr. Elgar for his kindness in responding to Mr. H. J. Clarke's request that he would fill his place and present the Essay on "The Christian Training of the Young," was unanimously carried.

Rev. James Howell addressed the Union in behalf of the

Montreal Tract Society.

Rev. W. F. Clarke presented the claims of the Widows' and

Orphans' Fund in a brief address.

A letter was read from Rev. Albert Bowers, of Macon, Missouri, delegate to the Union from the General Association of Missouri, expressing regret at his inability to be present, and presenting the salutations and good wishes of the body on whose behalf he wrote.

The Committee appointed to revise and publish the Trust Deed reported that they had not been able to complete their work, in consequence of the passage of the Act of Incorporation of the Missionary Society having been delayed. The Committee was re-appointed, with the same powers, and one change of name. It consists of Revs. F. H. Marling, Convener, W. F. Clarke, and S. N. Jackson, Messrs. H. J. Clark and J. Turner.

A motion was introduced by Rev. J. I. Hindley, to the effect that this Union do express its sympathy with the Church at Danville in its late and present difficulties, which was duly referred to the Business Committee.

Rev. J. McKillican briefly addressed the Union in reference

to his work as the Agent of the S. S. Union.

The Finance Committee presented the following report in regard to Union receipts and expenses, which, on motion, was received and adopted.

That this Union reiterates the expression of its deep conviction as to the well-known and wide spread evils resulting from the drinking usages of society, and would respectfully request all the pastors of our Churches to preach on this subject on or before the second Sunday in December.

That this Union recommend the Churches to take up an annual collection in aid of the Widows' and Orphans' Fund. Also, having heard with much gratification that the Widows' and Orphans' Fund Society have resolved to establish a Pastors' Retiring Fund as a branch of its operations, would commend it to the liberality of the Churches.

That the Secretary be requested to convey the thanks of this body to the several Railway and Steamboat Companies that have given facilities to ministers and delegates for travelling at reduced rates to and from this meeting.

That we again commend to the confidence and prayerful cooperation of the Churches the French-Canadian Missionary Society, and the Canada and Ontario S. S. Unions, and would urge a continuance of the aid heretofore granted to these Societies.

That the thanks of this Union be tendered to the proprietors of the Witness, Gazette, Herald, and Daily News, for gratuitous supplies of their journals to members of this body during the sessions of this Union.

That we gladly give expression to our sincere and grateful thanks to the Rev. Dr. Wilkes, and Rev. Chas. Chapman, M.A., pastors of Zion Church; also to the Rev. Jno. Fraser, and the members of their respective congregations, and the Y. M. Association of Zion Church, for their abounding hospitality, and the many kind attentions rendered to the members of this Union during the present meeting.

That in future meetings of this Union, in order to secure a full attendance of ministers and delegates at all its sittings, and thereby facilitate an intelligent and prompt despatch of business, the various Committees meet for the preparation of their respective business from 9 to 10 a.m.; and that the Union meet at 10 a.m., and spend 30 minutes in devotional exercises, and that a full attendance of members be enjoined; that from 10.30 to 1 p.m. be occupied with routine business, so that the afternoon session may be devoted to the consideration of topics relating to the spiritual interests and prosperity of our Churches, with a view of calling out a large attendance of the friends and public of the city in which such meeting may be held. And in order to carry out this plan the General Committee of the Missionary Society be requested to meet the day preceding the regular meeting of the Union.

These resolutions, on motion, were unanimously adopted, with the exception of the last, which was referred to the Union Committee, with power to adopt its recommendations, and make such arrangements for the next Union meeting as they may see fit; also to take steps for such changes in the standing rules

as may be found requisite.

It was further resolved, on motion :-

That 200 copies of the Minutes of the Union be printed, 150 of them to be done up in a triple form; that the table of Statistics be printed in book form if possible, as more convenient for preservation, and that it be also given in for publication to the editor of the CANADIAN INDEPENDENT; that the Chairman, Secretary and Minute Secretary be a Committee to prepare and publish the minutes.

Powis presented the grateful acknowledgments of the Union for Montreal hospitalities; and the Union adjourned, after devotional services, to meet in Brankford, on Wednesday, June 4th, 1873.

At Abbotsford, the Rev. J. Shipperley has commenced labouring amid some discouragements, especially denominational rivalry; but prospects are brightening. Good, but frail Father Wheeler, at Al-BION, reports tersely:—"Very dry, and very cold. Want showers and sunshine."—Rev. M. S. Gray, of Alton, has shown indomitable energy in leading on his people at a new station in Erin to erect a handsome brick church, at a cost of \$1,645, exclusive of the land, only \$30 dollars of a debt remaining on it. At the same time the spiritual church seems not to have been neglected, as thirteen precious souls have been added to the membership. has been looked upon by some as akind of forlorn hope, but the new pastor has had the pleasure of seeing the clouds lift one by one. The ground has been improved; the congregation is growing; the Sabbath school nearly doubled; people exceedingly liberal; and many have found the Saviour. "The prospect is that we shall grow." May God grant it !---After a patient struggle for many long years, the Bowmanville church rejoices in having attained its majority. pastor writes:—"At a meeting of the friends on Thursday evening, 16th May, it was resolved to make no application for a missionary grant this year."—The Brantford church shows in figures the usual steady progress, but sends no "Notes."—Our beloved brother, the Rev. James Hay, is welcomed by the brotherhood in Ontario to devote the results of his world-wide experience to the field in Brockville. May he be strengthened, and permitted to see this comparatively small church expand into noble dimensions! He believes the Lord has sent him thither to do something for Him. Brome is under the ministration of Rev. H. J. Colwell, who resides at Waterloo, sixteen miles distant. He believes it would be a thriving church under a resident pastor; but he himself labours there at a great disadvantage.——Rev. E. J. Robinson reports the "day as dark and cloudy," at Burford; nothing bright but the addition of two members.——Church-Hill is "making progress slowly;" the want is felt here, as everywhere, of "able and willing workers for Christ." --- Colpoy's Bay, chapel burnt down, and no pastor; still living, however, and able to give an account of itself.—Rev. C. P. Watson writes most hopefully of the cause in Cowansville, especially the Sabbath school. He has lately opened two new stations with most encouraging prospects; one at Stanbridge Village, twelve miles from his house, and the other at the rapidly growing Village of Brigham.—The pastor at DOUGLAS has been much encouraged by "good congregations," a thriving Sabbath School, a "vigorous temperance movement," "weekly offering system a success," and a prospect of increase. A good part of the debt on the church building has been removed during the year. - Eaton points us to its statistics, of which, by God's grace, it

is not ashamed. - Fergus has plenty of work and a few good workers. - Forest feels deeply the loss of his excellent deacon, John Livingston; and his pastor is stricken down by the death of his beloved partner and fellow-labourer. Still he is sustained. It is a good complaint that the church is too small to accommodate the audience; seats are necessary in the aisles. ——The Southwold, or FROME church, as it is now called, is becoming fruitful in the way of furnishing labourers for the Lord's harvest-field. They are evidently attached to their pastor, to whose comfort they are continually ministering. Thus he is made thankful, hopeful, and zeal-The "weekly offering" is also successful ous for their welfare. -GARAFRAXA FIRST has lost a number by deaths and removals, but the Lord is filling their places. The people's kindness towards the pastor effectually repels the first risings of discouragement.—Rev. R. Brown, pastor of GARAFRAXA NORTH, sees little to encourage him there, looking manward. His courage must be inspired from a higher source. — The plodding pastor of George-Town writes:—"Upon the whole, we have had a year of prosperity, though not equal to our desires."—Rev. J. Howell parts from the Grandy church, with the best wishes for their prosperity under the temporary charge of our young brother Nighswander, though he regrets that the church could not all have gone along with him in his aggressive movements. —Guelph rejoices at the extinction of the debt on its "holy and beautiful house" of worship, but is not without its share of difficulties and discouragements, especially owing to removals.——Hamilton church has just closed the "most prosperous year of its present pastorate of fourteen years." "En-" "church-meeting attended by two-thirds tire charch harmony; of its resident members!" "Sabbath attendance greatly augmented;" "a number more about to join the church;" "the young men's Sabbath morning meeting, the young people's meeting conducted by the pastor, the ladies' working society, and the Sabbath school, are all making encouraging progress. Last Sabbath, all the scholars on the roll were present, and the difference between the number present, and the number on the roll for the year, was very small indeed."—Rev. W. M. Peacock writes of Indian Lands: -"A year opening with clouds, but closing with sunshine. The church has passed through the furnace of affliction, but through the mercy and love of God, she has been sustained and purified." He feels that his work is largely a work for the future—of sowing to be reaped in another generation.—The pastor of Scotland says "there is no church in NORWICHVILLE."—KINGSTON most successful in grappling with its debt; it is "all subscribed, and two-thirds of it paid. "-Rev. J. Brown's first year at LANARK VILLAGE has been one of great comfort to himself: "people punctual in their payments of salary—quarterly in advance," though the amount is felt to be insufficient. "Sabbath school very interesting;" "a sewing society organized."—The Markham pastor needs and deserves encouragement. Had some little difference of opinion in selecting a site for a parsonage; conversions few; valuable members removing, &c .- MARTINTOWN and ROXBOROUGH still vacant. They need a pastor badly.—Meaford also without a pastor, though supplied by a student in the summer. "The meetings at all the stations more numerously attended than for

many preceding years." --- At the MONTREAL EASTERN church. "there is a marked gain." During the year the church has been organized distinct from Zion church, and has had the property handed over entirely to it. --- MONTREAL ZION prospering under its new joint pastorate. Still at its mission work in the city; has opened another station and is about to erect a new mission church. The pastor of Oro, Rugby, and Vespra feels that his field grows faster than his strength, though not faster than his desires. A new parsonage is about to be erected at Oro. In Vespra, another of the very common disputes about the possession of a Union church has been over-ruled by the building of a new church, in which the congregations are excellent.—In the OTTAWA church more has been done this year to reduce the "church site" debt than during the previous five years. "Bible class and Sabbath school steadily sustained. Temperance Union kept up. Children's monthly Sabbath service well attended." A new organ (cabinet) has been purchased and paid for. But a gloom is cast over all this prosperity by the resignation of the pastor, to take effect on the 30th June !--- OWEN Sound has been blessed with a gracious revival, in which our brother Robinson's church has shared to some extent, resulting in an addition of twelve to their number. "The work," he says, "is the Lord's, and to the blessed Master be the praise!"—The pastor of the Paris church writes thus:—"Have been happy, peaceful, no wave of trouble has crossed the church through grace; prayermeetings well sustained. Our financial year ended better than ever known here by our oldest deacon." Our good brother at PINE GROVE speaks of good attendance on the regular means of grace; the Sabbath school very prosperous, &c., but mourns that there is but little "spiritual progress." "We WANT A REVIVAL!" he says. He has commenced a third Sabbath service at Kleinberg, with encouraging results .- The QUEBEC church has had "a quiet year, yet there is good doing, and our congregations are better than they ever were."-There have been peace, unity and prosperity at Scotland. A season of refreshing last winter brought sixteen to the fold; "thirty more asked for prayer, and hopes are entertained that many of the enquirers will be brought to decision ere long." The church has been enlarged and refitted. - Speedside has enjoyed the services of a resident pastor, after having been served for some years from without. - The pastor of STANSTEAD feels sadly about the work there:—"There is nothing to encourage." His chief work is with the church at Derby, Vt., which he does not report, as it is in the United States.—Stouffville is growing both spiritually and financially. There are two out-stations, at both of which there is a probability of churches being organized within the coming year. The friends made no application for missionary aid for next year, and are free! --- STRATFORD has changed pastors during the year, Rev. E. C. W. McColl, M. A., having resigned, and the Rev. W. H. Heu de Bourck having taken the post. The latter writes encouragingly of the Sabbath services, the atten-This return writes encouragingly of the people; "but," he says, "the bright spot in our experience is the Wednesday evening service."—At This return with the ris a good attendance, mostly of young people, "but no apparent impressions made."—An interesting feature of the TORONTO BOND STREET church has been the "reception of

more than usual Congregational emigrants." "An effort to organize the members of the church more thoroughly for Christian work thas had a fair measure of success."——The Northern church of that city has been equally prosperous. "God has blessed his word to many." The church Sabbath school is too small. The mission schools and prayer-meetings are all encouraging. --- Old Zion (Toronto) thrives under its new pastorate. The members are very active, especially with respect to the church building, which they have repaired and beautified at a considerable expense." Note this: -"The young men sustain a prayer meeting every Sunday morning, which has been the means of leading several to Christ !"-- The WARWICK church embraces three stations, and is under the same pastoral care as that of Forest, already referred to. Our brother Salmon must have his hands and head full, as well as his heart. This church has mourned, and yet rejoiced, in the death of a mother in Israel, who has given to our churches three beloved ministers-the brethren Hay. The debt on one of the churches in this field has been entirely liquidated during the year, and considerably reduced on the other two. The pastor has also enjoyed an encouraging measure of spiritual prosperity.—Rev. H. J. Colwell's church at Waterloo has suffered from an opposition of an unpleasant nature, but amid unfaithfulness in some, there are faithful ones, who "endure hardness, as good soldiers." They are obliged to use school-houses yet for public worship, but hope soon to have buildings of their own. They feel the need of more sympathy from their sister churches. Brother Colwell is pastor also of Brome, already referred to .- At WATERVILLE, Rev. G. Purkis feels the need of patient waiting, and the want of encouragement, on the part of the friends of the cause, to young persons whom the spirit is leading. But he is not without hope that all hindrances will be removed .-Rev. S. T. Gibbs, of Whitey, has been deeply involved in a work material, as well as spiritual during the year. The church has shown great energy and liberality in repairing the church, and in the erection of the parsonage. May our good brother live to see this long drooping interest revive, and occupy the place among our churches to which its age entitles it!

SUMMARY OF STATISTICS OF CONGREGATIONAL CHUR-CHES OF ONTARIO AND QUEBEC, FOR YEAR ENDING MAY 6, 1872.

Out of 83 or 84 churches of our order in these Provinces, returns have been received from only 60, so that one-fourth of our churches and some of these among our best ones-are unrepresented in this Summary. From the 60 whose statistics are given, a number are incomplete, the returns being made from memory, or without reference to church records. I have refrained copying, from the statistics of former years (when I have had no reports), such items as church-buildings, parsonages, &c., &c., as even these may change year by year; besides, it is better, in a summary, to give a limited number correctly, than a larger number incorrectly. Considering that a dozen or more of the churches, whose statistics were included last year, are omitted this year for want of returns, it will not be surprising if the aggregates given in this year's table are less than those of last year; and, for this reason, I had almost concluded to give no sums total, as these might be used to our disadvantage. It is to be hoped, however, that no one will make use of them to represent the strength of the body as a whole or its entire increase or decrease year by year. It will be observed in the Table that the column under "Attendance at all Stations" has been omitted entirely this year, as there is evidently a diversity of opinion among those making the returns, as to the meaning of the heading; some understanding it as implying the average attendance at all the stations, and others, the entire number of adherents or occasional hear-ers. The question will be put next year in a more distinct form.

At this date, 15 of the churches are without pastoral care, and a few others have only temporary supplies. There are 119 preaching stations reported from 60 churches, with 8,712 average attendance of hearers. The total membership of these churches is reported at 4,036; of which 447 were added during the year, 262 by profession, and 185 by letter. There have been removed by death, 44; by letter, 93; by excision or dropping off, 45; making total of removals, 182. So that the net gain in 60*churches has been 265. There have been returned 298 baptisms, of which 263 were infants, and the other 35 adult baptisms. No doubt many churches, whose members are engaged in Union S. Schools, have made no mention of this fact. Only 49 churches, or a little more than onehalf, give S. School statistics: in these, there are 563 teachers, and 2,223 scholars. The 60 churches reporting own 66 churchbuildings, of which 26 are stone or brick, and 40 wood; these have accommodation for 18,505 hearers, or nearly 10,000 more than the average attendance. Of these churches, 6 are reported as uninsured, and 3 as unregistered; while a large proportion send no returns on this point, leaving us to infer that many more still are neglecting a proper care of what has cost them no little struggle to The total increase in the value of the chapels and parsonages, so far as reported, is \$25,650; this, of course, takes no account of the indebtedness of many of the churches for their improvements, which it would be only fair to reckon. Sixty churches hold in possession property estimated at \$286,090, or more than a

quarter of million of dollars. The returns are so incomplete respecting the details of the annual contributions, that we can give only, with any degree of fairness, the sum-total of the contributions of 58 churches, amounting to \$63,701.20; or at the rate of nearly \$17 for every church member. These churches have raised within \$2,000 of the amount raised by 66 churches the year before; and the aggregate increase in the contributions of those 58 churches over their contributions of last year has been \$1,369,74, notwithstanding a special case of decrease in one of these churches, amounting to upwards of \$6,000.

Although, therefore, the very large deficiency in the returns this year makes this Summary worse than useless as indicating the strength of the Congregational body in these Provinces, either in numbers or in wealth; and although the sums-total will admit of no comparison with those of other years, yet-the details of the individual churches give cause for encouragement and gratitude, revealing a steady progress year by year in all that is good and useful. It is earnestly to be hoped that more carefulness will be used next year in making up the returns, and in sending them in at the proper

time.
