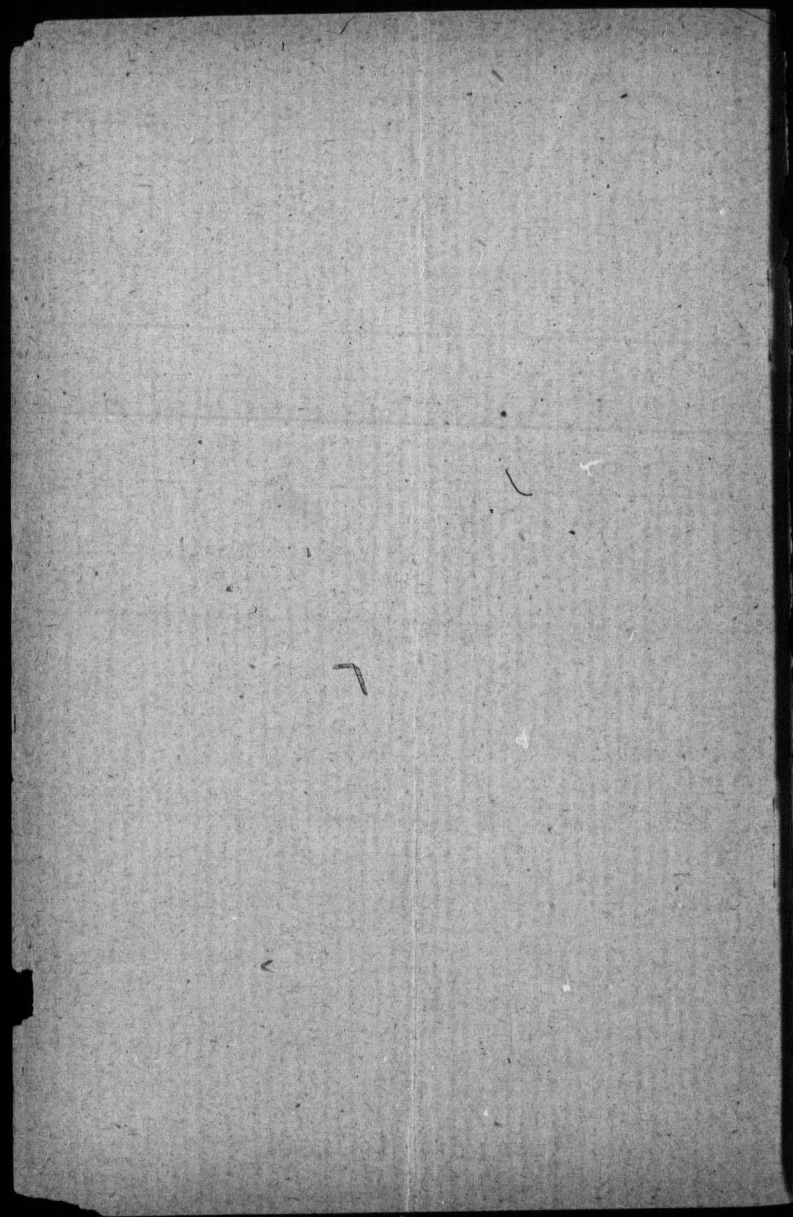

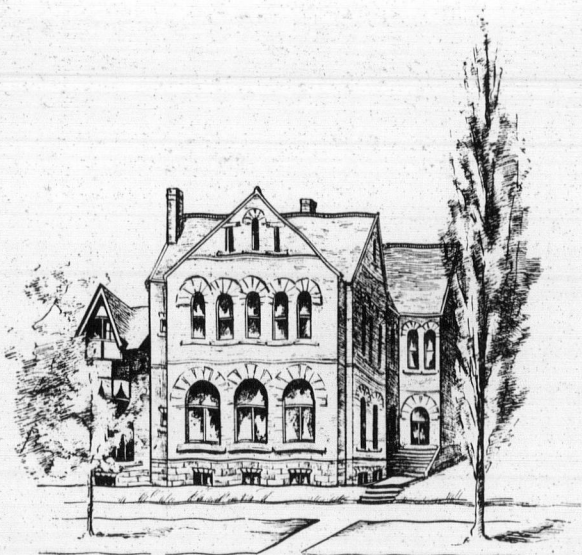

ANNUAL ANNOUNCEMENT  
OF THE  
WOMAN'S MEDICAL COLLEGE  
TORONTO.



The ninth session of the Faculty will be opened on Thursday, October 1st, 1891, by an Introductory Lecture at 3 p.m. The regular lectures will begin on October 2nd at 9 p.m., and will be continued for six months.

The Faculty take great pleasure in calling attention to the successful completion of its new college building, which was opened last session. A cut of this building will be found elsewhere. It is one of the most complete buildings of its kind in America. Among other rooms it contains a large Lecture Hall, fitted with special students' chairs, movable blackboards, chart frames, and accommodating over fifty students; the Microscopical Laboratory, on the 1st floor, is modelled after the well-known Biological Department of Toronto University, and each student is provided with the requisite space and appliances for the best work in Microscopy. On the same floor is the large Chemical Laboratory, fully equipped, and with accommodation for 37 students. Adjoining the Microscopy room is a commodious waiting-room, set apart entirely for the use of the students, and provided with books and journals; connected with this room is a students' lavatory.

The building formerly occupied as a College has been remodelled and now forms the dissecting-room, being entirely separated from the main building and thus conducing to the health and comfort of the students.

Recognizing the great importance of the clinical study of Diseases of Women and Children to women students, the Faculty have still further amplified the course of instruction on these subjects by the addition of special practical classes in Gynæcology and Diseases of Children.

The Faculty also take great pleasure in announcing that, with a view of giving the students increased facilities for obtaining a practical knowledge of Obstetrics, an Extern Maternity Department is about to be established. By this means it is hoped that the students will receive such advantages as have never heretofore been placed at their disposal in Canada.

The course in Pathology and Microscopy has been arranged in conformity with the recent advanced requirements of the Medical Council of Ontario.

Forestalling the new Regulations of the College of Physicians and Surgeons, the Faculty have deemed it wise to afford its students the benefits of a course of Lectures in Practical Pharmacy which, will be delivered by Dr. Smith.

One Summer Session being now compulsory upon every student in Medicine proceeding to a degree in Ontario, the Faculty have arranged for a thoroughly practical course, full particulars of which will be found on a succeeding page.

That the students of the College still make good use of the advantages placed at their disposal will be readily seen by reference to the record of their successes at the various examinations of 1891. (See pages 36, 37.)

Students of the Woman's Medical College may proceed to their degree before the Universities of Trinity College, Toronto, or Victoria. Intending students should determine, early in the session, to which degree they will proceed, so that they may be enabled to conform with the special regulations of the various Universities.

To encourage women to enter the Foreign Mission Field in connection with the various religious bodies, the Faculty admit such students to lectures for two-thirds of the regular fees, with the exception of those for registration and examination; but each applicant for this reduction must furnish a certificate from the Foreign Mission Society under whose auspices she is, and also give a personal engagement to prosecute medical work abroad.

The Faculty of Knox College have cordially agreed to provide a special course of lectures in Theology to any Presbyterian students preparing for the mission field, and the Faculty of McMaster Hall



will, it is expected, afford the same advantages to students of the Baptist mission.

It is open to women who do not contemplate pursuing the study of medicine with a view to professional practice to attend one or more of the courses of lectures, on payment of special fees.

The Parliament Street and the College and Carlton Street cars of the Toronto Street Railway pass every five minutes within a few yards of the Woman's Medical College.

The cost of living depends largely upon the tastes of the students. Board may be obtained at from \$3.00 to \$5.00 per week. Intending students may apply to the Secretary for a list of boarding houses.

### Hints for Intending Students in Medicine.

1. The License to Practise in the Province of Ontario can be obtained **ONLY** by passing the prescribed examinations of the College of Physicians and Surgeons of Ontario (page 30). N.B.—University degrees do not confer the license to practise in Ontario.

2. A Degree in Medicine can be obtained **ONLY** by passing the prescribed examinations of either the University of Trinity College (page 19), or Toronto University (page 23), or Victoria University.

3. The Lecture Tickets of the Woman's Medical College are accepted by all the above mentioned examining bodies.

4. Students may be matriculated before the College of Physicians and Surgeons, or any one of the Universities, by passing the matriculation examination of the College as laid down on page 14, or by passing the Art Matriculation Examination of any one of the Universities, and paying the stated fees.

5. After July 1st, 1892, every candidate, except she be a graduate in Arts, must present the official certificate of having passed the Pass University Departmental Art Matriculation, with the pre-

scribed Science course added and compulsory (viz., the Science course in Chemistry and Physics prescribed in the Junior Leaving Examination of the Education Department).

6. To attend lectures at the Woman's Medical College, no matriculation examination is required.

## PRACTICAL COURSES.

### Anatomy.

Anatomy is taught in the most practical manner possible, and its relation to Medicine and Surgery fully considered. The lectures are illustrated by the fresh subject, moist and dry preparations, sections, models and plates, and drawings on the blackboard.

The department of *Practical Anatomy* is under the direct control and personal supervision of the Lecturer on Anatomy, assisted by his staff of Demonstrators.

The methods of teaching are similar to those of the best European schools, and students are thoroughly grounded in this branch.

Every student must be examined *at least* three times in each part dissected, and no certificate is given unless the examinations are satisfactory.

Special demonstrations on the Brain, Thorax, Abdomen, Bones, etc., are frequently given.

The dissecting-room is open from 8 a.m. to 6 p.m. daily.

The Demonstrator will be present from 10 to 12 a.m. at least four days in the week, and one of the Assistant-Demonstrators will be present at other times.

## Normal and Pathological Histology.

*Lecturer,* . . . . . GEORGE ACHESON.

*Assistant-Demonstrators,* . . . . . S. P. BOYLE, E. J. IRVINE.

The course in Pathology will comprise—

1. Twenty-five lecture demonstrations on Elementary Pathology to students of the 3rd year.
2. Twenty-five lecture demonstrations in advanced Pathology to students of the 4th year.
3. Weekly demonstrations of at least two hours length in Pathological Microscopy to students of both years.

Gross specimens will be presented as frequently as possible.

Each student will be provided at the commencement of the session with a microscope, and a number of slides, cover glasses, staining reagents, etc., and assigned a table and locker—for all of which she will be held strictly responsible. There will be a laboratory fee of \$5.00, which will be returned at the end of the session, less a deduction for breakages, etc., payable to the Secretary.

## Histology.

The course in Histology will consist of Weekly Demonstrations of two hours each. Students will be fully instructed in the technique of Microscopy, and in the preparation and mounting of specimens. Each student will be expected to possess by the end of the session a cabinet of at least fifty specimens of her own preparations, which will be of great use in practice.

As in Pathology, each student will be provided with a microscope, etc., for which she must deposit at the beginning of the session a laboratory fee of \$5.00, which will be returned at the end of the session, less a deduction for any breakages, etc., payable to the Secretary.

Any student desiring at the end of the session to purchase her microscope may do so at cost price. Each student may thus obtain a microscope at a much more reasonable rate than is possible elsewhere.

### Practical Chemistry.

*Lecturer,* . . . . . A. R. PYNE.

The course includes two or more hours laboratory work, once a week, throughout the session.

The students are instructed individually in chemical manipulations, blow-pipe analysis, and qualitative determination of the salts, acids, etc., they will require to use in practice.

Each student will be provided at the beginning of the session with a set of reagents, sandbath, blow-pipe, drawer and locker, Bunsen burner, etc.

There will be a laboratory fee of \$3.00, payable to the Secretary, which will be returned at the end of the session, less a deduction for breakages, etc.

### Maternity Department.

*Lecturer,* . . . . . A. T. CARSON.

*Associate-Lecturer,* . . . . . H. T. Machell.

This department will be under the direct supervision of the Lecturers in Obstetrics, aided by their Assistant Accoucheurs.

Students who have attended one course of Lectures in Midwifery will be furnished with cases in rotation, which they will be required to report and attend till convalescence.

Every facility will be afforded for acquiring a practical knowledge of the various obstetric manipulations.

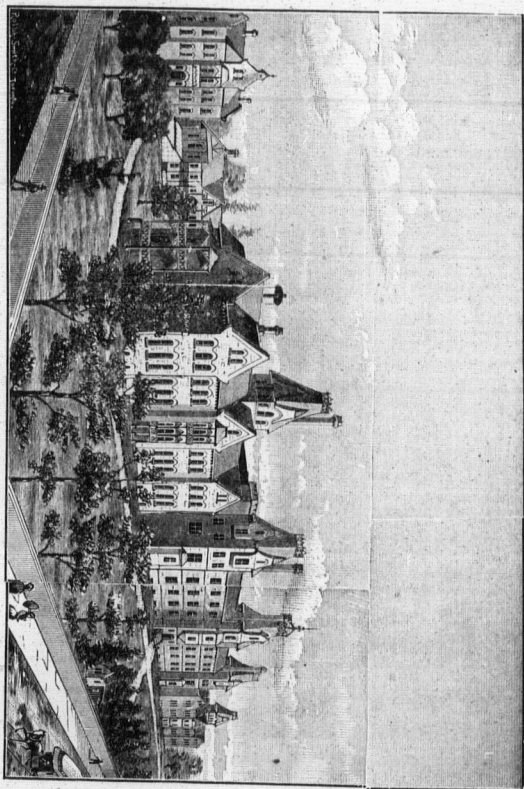
The fee for this department will be extra.

### Ophthalmology, Otology, Etc.

*Lecturer and Instructor,* . . . D. J. GIBB WISHART.

A dark room has been especially fitted up in the new building, and ophthalmoscopes, mirrors, etc., are provided, so that each student will receive a thorough course of instruction in the accurate handling of these instruments, and in the observation of the normal appearances of the eye, ear, throat, and nose.

## HOSPITALS.

Women preparing to undertake the arduous duties connected with missionary work will in Toronto find special inducements in the study of disease. The city being in a central position and connected by so many lines of railway and steamboats, its hospitals often receive foreigners suffering from diseases indigenous to their respective countries, thus affording to students a wide field for the study of rare and peculiar forms of disease.

### The Toronto General Hospital.

This hospital, situated directly opposite the Woman's Medical College, includes the *Mercer Hospital for diseases of the Eye and Ear* and the *Burnside Lying-in Hospital*. It contains 350 beds and is the largest and best conducted hospital in the Province. During last year 2,637 in-patients were admitted, and several thousands of out-patients received their treatment in the out-door department. Particular arrangements have been made for the benefit of the students of the Woman's Medical College. Special seats in the operating theatre, with a separate entrance, are set apart for their use. Practical instructions at the bedside will be given in the hospital wards by Dr. Nevitt and Dr. Macdonald. These classes are exclusively for students of the Woman's Medical College. A limited number of Clinical Clerkships may be obtained by students of the final year on application to the above-named gentlemen. Every opportunity will be afforded for the most careful study of disease in all its forms. *Post mortems*, to which women alone will be admitted, are held, of which due notice is given. The regular Clinical Lectures given daily in the large theatre by the various professors are open to the women students.

The out-patient Clinics take place daily at 1.30 o'clock.

Dr. Jas. F. W. Ross will give a weekly Clinic in Gynæcology to the final students, at which every opportunity will be given for personal examination of the patients.

### The Victoria Hospital for Sick Children.

This large and commodious hospital, with 160 beds, is situated on College St., in direct street-car communication with the College.

This is the only hospital wholly devoted to diseases of children in Canada, and with its most approved modern appliances, and the excellent Intern, Extern, and Dispensing Departments, affords unrivalled advantages to the students of the Woman's Medical College.

The Clinics in Diseases of Children will be delivered by Dr. Thistle, in this hospital, twice a week. The students may also attend the Clinics of Drs. Nevitt, Macallum, and Covernton.

Students desiring Clinical Clerkships are requested to apply to Dr Thistle.

### The Toronto Dispensary.

The City Dispensary is situated on Simcoe St., and has one of the largest and most varied Extern Clinics in the Province. Dr. Ross will give Clinical instruction in Gynaecology in the Dispensary on Tuesdays and Fridays to students of the Woman's College. Dr. G. B. Smith gives excellent opportunities to the students for minor operations and case diagnosis.

### Other Charities.

The students of the Woman's Medical College will have opportunity from time to time of attending Clinics on interesting cases in the Home for Incurables, the House of Providence, the Infants' Home, Girls' Home, etc.

### College Examinations.

1. College examinations may be held at the end of each session by the Lecturers.

2. No candidate will be considered as having passed any College examination who has not obtained at least 50 per cent. of the aggregate number of marks allotted to such examination. Nor will a candidate be considered as having passed in any individual subject who has not obtained at least one-third of the marks allotted to such subject.

3. To obtain Honors in any College examination, or any single subject of such examination, 75 per cent. of the aggregate marks

allotted to such examination or single subject will be required to entitle the candidate to the standing of First-Class Honors, and 66 per cent. to that of Second-Class Honors.

4. In determining the relative standing of the candidates presenting themselves at the several College examinations, the comparative value of the subjects will be estimated according to the following schedule :

### Diplomas.

Diplomas will be awarded at the close of the final examination to successful candidates.

The candidates for Diplomas must furnish satisfactory proof

1. Of having attended a full course of Lectures in the Primary and Final branches of the Woman's Medical College, Toronto.

2. Of having spent four entire years in the study of Medicine at some recognized University, College, or School, the last of which must be attended at this School.

3. Of having passed the Faculty Examination at the end of their fourth year.

1. A prize in Books or Instruments, awarded for the best examination, written or oral, in the Final branches.

2. A prize in Books or Instruments, awarded for the best examination, written or oral, in Primary branches.

3. A prize in Books or Instruments, for the best sessional examination in Therapeutics.

Candidates must in all cases give satisfactory evidence of regular attendance at Lectures during the session.

To obtain any of the aforementioned prizes candidates must pass the prescribed examination with First-Class Honors.

A Special Prize will be awarded to the student passing the best examination in Anatomy in the first and second years respectively. The examination will be both written and practical. In order to compete for these prizes, students must take the regular examination for the year in all subjects. The prizes will not be awarded unless First-Class Honors are taken in Anatomy, and the standing in the other subjects must be to the satisfaction of the Faculty.

### Fees.

The total Collegiate fees for all students taking a full course of four years at this College will be \$360.00. This sum to be paid in four annual instalments of \$90.00. The above sum of \$360.00 includes en-registratation, tuition for four Winter and one Summer Sessions,

examination fees and fee for Diploma. If the student elect to attend the two other Summer Sessions of the course, she may do so without further payment.

The fees to be paid by students taking special courses, or students entering from other Colleges, will in all cases be a matter of special arrangement by the Faculty.

## SUMMER SESSION, 1892.

The Summer Session of the Woman's College will commence on Monday, April 9th, and continue for ten weeks.

It will be open to any women Medical Student on payment of the regular fees.

In making arrangements for the Summer Session, the Faculty have endeavored to relieve the Final Students of some of their regular fourth year winter's work, and at the same time to give a course essentially practical in its nature. The course will consist of Lectures and Practical Instruction in the College, and Clinical Instruction in the General Hospital, the Hospital for Sick Children, Toronto Dispensary, etc.

A special feature of the course will be the attention devoted to the Departments of Gynecology and Diseases of Children. Clinics in each subject will be held twice weekly, at which students will receive practical instruction in the examination of patients, etc.

The Lectures in Medical and Surgical Anatomy and Sanitary Science may not be repeated in the Winter Session, and the tickets for these lectures will be over and above the fee for the general course.

The fee for the course will be \$30.00, for Anatomy \$10.00, and for Sanitary Science \$5.00, all payable on or before the 2nd of May.\*

The following Courses will be given in the College:

DR. A. R. TYNE—Practical Examination of Urine, Chemical and Microscopical, to include the recognition of pus, bile, haematin crystals, blood, etc.

DR. POWELL—Practical Surgery, including operations on the cadaver, bandaging, and the use of surgical instruments.

DR. AUGUSTA GULLEN—Dietetics, Nursing, and the Management of the Sick-room.

DR. G. ACHESON—Physical Diagnosis.

DR. B. E. MCKENZIE—Medical, Surgical, and Topographical Anatomy, including demonstrations with cross sections and prepared dissections.

DR. T. S. COVERNTON—Sanitary Science.

DR. WISHART—Practical instruction in the dark room in the use of the Ophthalmoscope, Laryngoscope, and Rhinoscope (a set of instruments is provided for each member of the class).

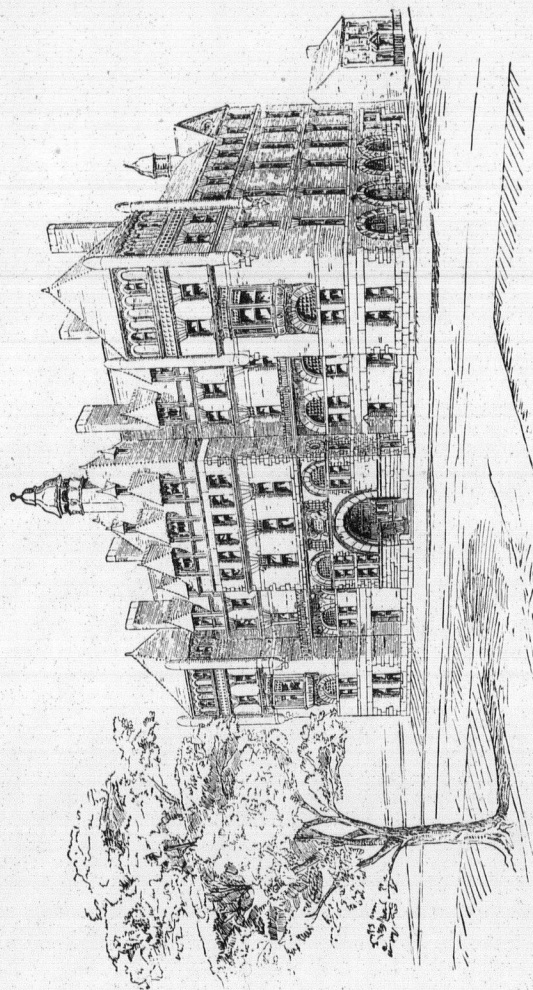

(b) By having passed the Matriculation Examination accepted by the College of Physicians and Surgeons of Ontario or Quebec, or the Primary Examination of the Law Society of Upppr Canada.

The subjects of the Medical Matriculation Examination are :

7. One of the following divisions, to be selected by the candidate :
  - (a) Scripture History; and St. Matthew's Gospel, chaps. i.-x. incl., in Greek.
  - (b) Xenophon's *Anabasis*, Book I.
  - (c) French, Voltaire's *Charles XII.*, Books VI.-VIII.
  - (d) German, Schiller's *Thirty Years' War*, Book I.
  - (e) Natural Philosophy, including Mechanics, Hydrostatics, and Pneumatics. (Balfour Stewart's *Lessons in Elementary Physics* is recommended.)

The candidate for Degrees in Medicine or Surgery must be of the full age of twenty-one years.

She must furnish certificates of having attended *four Winter Sessions* at some Medical College recognized by the University, except she be a graduate in Arts or Science, when attendance at three Winter Sessions will be accepted.

Before admission to the Primary Examination in Medicine, she must have attended in some recognized Medical College two courses of Lectures of six months each on

and one course of three months on each of the following subjects :

Medical Pathology, including Practical Pathology,  
Principles and Practice of Surgery,  
Midwifery and Diseases of Women and Children,

and two courses of three months each on

Medical Jurisprudence,

and one course of three months on

Sanitary Science.

She must have attended for at least *eighteen* months the practice of some General Hospital, and, during two sessions, Clinical Lectures on Medicine and Surgery.

She must have attended for at least six months the practice of a Lying-in Hospital, or give satisfactory evidence of having otherwise enjoyed equivalent advantages of gaining obstetrical knowledge, with a certificate of attendance upon at least six cases of labor.

She must have passed two University Examinations, called the Primary and the Final Examinations in Medicine.

Before admission to the Primary Examination, she must produce a certificate that she has passed the First Year Examination in some recognized Medical College.

#### PRIMARY EXAMINATION IN MEDICINE.

This Examination may be passed at the end of the Second Year. The subjects are : Anatomy, Physiology, including Histology, Chemical Physics, and General Chemistry, Practical Chemistry, Botany, Materia Medica and Therapeutics, and Toxicology.

The Primary Examinations of other recognized Universities, and that of the College of Physicians for Ontario, Quebec, or Manitoba, will be accepted in lieu of the University Primary Examination, provided that the candidate shall in all cases pay the full fee for the Degree ; but if any of the subjects of the Primary Examination do not form part of the Examination allowed, the candidate shall be required to take such subjects together with her Final Examination.

Graduates in Honors in Physical and Natural Science of at least Second-Class standing of any recognized University shall not be required to take such subjects of the Primary Examination, as they have already passed in their University Honor Examination.

#### FINAL EXAMINATION IN MEDICINE.

This Examination shall take place at the end of the Fourth Year. The subjects are : Theory and Practice of Medicine, Medical Pathology, Principles and Practice of Surgery, Clinical Medicine, Clinical Surgery, Midwifery and Diseases of Women and Children, Medical Jurisprudence, Sanitary Science.

In order that a candidate may pass in either of these Examinations she must obtain thirty-three per cent. of the marks assigned to each paper, and fifty per cent. of the total marks of the Examination. Candidates who satisfy the Examiners will be arranged in three classes in order of merit, the standard for the first and second class respectively being seventy and sixty per cent. of the total marks of the Examination.

Candidates who do not pass in at least three of the subjects of Examination in the Examinations of the Faculty of Medicine, obtaining thirty-three per cent. of the marks of each paper, and fifty per cent. of the total marks of these subjects, shall be deemed to have failed altogether in the Examination. Candidates who pass in three subjects at least, obtaining the requisite single and total marks, as above, may be allowed to take the remaining subjects at the next following and subsequent Examinations, provided that a candidate shall not be given credit for any portion of the Examination unless she shall have obtained at least thirty-three per cent. of the marks of each paper, and at least fifty per cent. of the total marks of such part of the Examination.

Candidates in the First-Class of the Final or the Primary Examination in Medicine shall be awarded Certificates of Honor, provided they obtain at least seventy-five per cent. of the marks of the Examination.

The Primary and Final Examinations may be taken together at the end of the Fourth Year.

The Registrar will see medical students in his office at Trinity College on Saturdays from 11 to 1.30, and on other week days from 12 to 1.30.

## MEDALS IN MEDICINE.

A Gold and a Silver Medal are annually awarded to the candidates who are first and second respectively in the Final Examination, and two Silver medals to the candidates who are first and second in the Primary Examination for the Degree of M.D., C.M., provided that a Medal shall not be awarded to any candidate who obtains less than seventy-five per cent. of the total marks of her examination.

All candidates for the Final Medals must have taken the Primary Examination in the University, and if they have not already done so they may take it at the same time as the Final Examination.

The fee for the Degree of M.B., or M.D., C.M., shall be paid by the candidate as follows: \$10 before presenting herself for the Final Examination, and \$14 before presenting herself for the Final Examination. Candidates rejected at either Examination shall be entitled to have the fee returned to them, less \$5. Candidates conditioned may present themselves subsequently for examination without payment of any further fee.

Certifi

Degree, from any Dominion or British University, or (2) have already matriculated in the Faculty of Arts or of Law in this University, or (3) have passed an examination entitling them to be registered as matriculants in the College of Physicians and Surgeons of Ontario.

Before presenting themselves for examination, candidates must produce satisfactory certificates of good conduct, and of having completed the sixteenth year of their age.

The Ordinary Annual Matriculation Examination (both Pass and Honors) will commence in the beginning of July.

Supplemental Matriculation Examinations will be held in the latter part of September, at which new candidates may offer themselves.

The Matriculation Fee of Five Dollars must be paid to the Registrar at least three weeks before the date of commencement of Examination. The fee for registration of exemption from the Matriculation Examination is Five Dollars.

Candidates may delay presenting themselves for the Matriculation Examination until any time before the Final Examination; but no candidate will be allowed to compete for relative standing, prizes, or scholarships, until she has passed the Matriculation Examination.

Candidates are recommended to take the Junior Matriculation Examination in Arts, or the Second Class Non-Professional Examination, with Latin option compulsory, as required by the College of Physicians and Surgeons of Ontario.

No fee will be charged for transferring from the Faculty of Arts to that of Medicine.

First Year standing will be allowed to those who present certificates of being matriculants in the College of Physicians and Surgeons of Ontario. The fee for such admission is \$5.

### Regulations Relating to Undergraduates.

Undergraduates are required to attend Lectures, and receive practical instruction during each of the four years at one or other of the Schools of Medicine recognized for this purpose by the University. The certificates of attendance upon Lectures must mention the precise number of Lectures given in each course, and must certify the attendance of the candidates at two-thirds of these at least. The Certificates of Practical Instruction must certify that the candidate

has diligently pursued the studies in question for the whole of the time required, and these must be signed by the teachers in the immediate charge of the laboratories where the instruction was obtained.

Each undergraduate at the end of each year of her course must present herself at the annual Examination of that particular year, except in the case of those who elect to take a Primary and Final Examination; and those so electing will not be allowed to compete for Honors or Scholarships.

Candidates may, under special circumstances, be allowed to present themselves at the Examination for M.B., or at any of the Intermediate Examinations, without having passed the preceding Examination or Examinations in the University.

Undergraduates below the standing of the Fourth Year, who have been rejected, or prevented from attending the Annual Examinations by sickness, domestic affliction, or other cause beyond their control, may present themselves for examination at the September Supplemental Examination. Candidates of any year, who have passed a creditable examination in the majority of the subjects required, may present themselves at the Supplemental Examinations next ensuing in the subjects in which they failed, and upon passing at such Examinations shall be allowed their year. Candidates who failed to attend at the Annual Examinations must prove to the satisfaction of the Vice-Chancellor, before presenting themselves in September, the existence and sufficiency of the alleged cause of absence. Candidates who were rejected must pay a fee of ten dollars, and those who did not attend a fee of five dollars, before offering themselves for the Supplementary Examinations.

Graduates in Arts of the University may enter at the Second Examination, but will be required to take such subjects of the First Examination as they have not taken in their Arts Course, though in these subjects they shall not be required to take an Honor standing.

Undergraduates who elect to take the Primary and Final Examinations may take the Primary at the end of the second or third year, and the Final at the end of the fourth year of their course. Graduates in Arts who elect to take the Primary and Final Examinations may take the Primary at the end of the second year, and the Final at the end of the third year of their course.

No candidate will be allowed to pass any of the Examinations who has not obtained at least one-half of the marks allotted to such Examination. Nor will a candidate be considered as having passed in any individual subject who has not obtained at least one-third of the marks allotted to such subject.

The fee for each Examination is five dollars, payable when the candidate notifies the Registrar of her intention to present herself.

Notice will be given annually, in January, of the days on which the Examinations for the year will commence. Every undergraduate who proposes to present herself at an examination must send in to the Registrar a statement (according to a printed form which will be furnished) of the course she is taking, whether Pass or Honor, of the Lectures she has attended, and one of the practical instruction she has received, with the names of the teachers, and such other particulars as the printed form may indicate, together with the original certificates referred to in this statement.

Certificates required for the different Examinations :

#### First Examination—

(1) Of having attended Lectures in the following subjects :

Anatomy (100 lectures), Physiology and \*Inorganic Chemistry (60 lectures each), \*Natural Philosophy (20 lectures), \*Biology (including Botany and Zoology) (30 lectures), Materia Medica (40 lectures).

(2) Of the foregoing Lectures marked \* at least one-third must be of the nature of practical lessons involving laboratory practice on the part of the student, and this must be attested to on the same or a separate certificate.

(3) Of practical instruction in ~~Anatomy~~ during six months.

#### Second Examination—

(1) Of having attended Lectures on the following subjects :

Courses of 100 Lectures each in Anatomy, Physiology, Materia Medica, and Therapeutics.

Organic Chemistry (40 Lectures).

(2) Practical instruction in Anatomy (second course of six months), Histology (three months), and Chemistry applied to Medicine (three months).

(3) Of having dissected the parts of the Human Body once.

#### Third Examination—

(1) Of having attended lectures on the following subjects :

Courses of 100 Lectures each in Practice of Medicine, Surgery, and Obstetrics. Also courses of 50 Lectures each in Clinical Surgery and Clinical Medicine, Medical Jurisprudence, and Therapeutics.



- (2) Of having dissected the parts of the Human Body a second time.
- (3) Of practical instruction in Pathological Histology during at least three months.

#### Fourth Examination—

- (1) Of having attended courses of 50 Lectures each on Practice of Medicine and Medical Pathology, Clinical Medicine and Clinical Surgery, and Forensic Medicine; of 25 Lectures each on Surgery and Surgical Pathology, Obstetrics and Gynecology, and Hygiene; of 12 Lectures on Medical Psychology.
- (2) Of having attended at least 6 Clinics in a public Lunatic Asylum.
- (3) Of having conducted at least 6 labors. } Certificates received from any
- (4) Of Proficiency in Vaccination. } registered Practitioner.
- (5) Of attendance for eighteen months in the Wards of a Public Hospital having not less than 100 beds.
- (6) Of attendance for six months on the Out-practice of a Hospital, Dispensary, or registered Practitioner.
- (7) Of attending 12 Autopsies.
- (8) Of being skilled in compounding and dispensing drugs, having been engaged for a period of at least three months in such work, and shall set forth that the candidate has been engaged for a period of at least three months in such work.

(This certificate may be from a registered Practitioner, the Apothecary of a Public Hospital or of a Public Dispensary, or from a Member of the Pharmaceutical Societies of Ontario or Quebec.)

### Primary and Final Examinations.

The Certificates required for the Primary Examination are the same as those required for First and Second Examinations. For the Final Examinations, the same as those required for the Third and Fourth Examinations.

### Annual Examinations.

Candidates taking Honors will be entitled to First Class Honors if they obtain seventy-five per cent.; to Second Class Honors if they obtain sixty per cent. of the aggregate marks.

Extra papers on all Pass subjects will be set for Honor candidates.

Undergraduates who have taken the First and Second Examinations may transfer to the Primary and Final Course, the First and Second Examinations being considered equivalent to the Primary.

The Committee shall have power to allow any applicant desirous of presenting herself for any of the Examinations in the Faculty of



Medicine (except the Final Examination) any Examination which she may have passed in any other University or School of Medicine, upon production of proper certificates showing her standing in such University or School of Medicine.

### Subjects of the Different Examinations.

#### FIRST EXAMINATION.

Elements of Anatomy, Human Physiology, Inorganic Chemistry, Natural Philosophy, Electricity, Heat and Light, Biology (including Botany and Zoology).

#### SECOND EXAMINATION.

Chemistry applied to Medicine, Elements of Organic Chemistry, Anatomy, Physiology, Materia Medica, Normal Histology.

#### THIRD EXAMINATION.

Practice of Medicine, Surgery and Surgical Anatomy, General Pathology (including Morbid Anatomy and the mode of conducting Autopsies), Obstetrics and Diseases of Women and Children, Clinical Examinations in Medicine and Surgery, Therapeutics.

#### FOURTH EXAMINATION.

Practice of Medicine, Surgery, Obstetrics and Diseases of Women and Children, General and Special Pathology, Forensic Medicine, Hygiene, Medical Psychology, Clinical Examinations in Medicine and Surgery.

#### PRIMARY EXAMINATION.

Anatomy, Physiology, Materia Medica, Chemistry (Inorganic, Organic, and Chemistry applied to Medicine), Biology, Normal Histology.

#### FINAL EXAMINATION.

Practice of Medicine, Clinical Medicine, Surgery and Surgical Anatomy, Clinical Surgery, Obstetrics and Diseases of Women and Children, Therapeutics, Medical Therapeutics, Pathological Histology, Hygiene, Medical Psychology.

In Anatomy, Normal Histology, General Pathology, and Chemistry, Examinations of a specially practical character will be given in addition to the written Examinations. In the practical Examination in Anatomy the Cadaver will be used.

### Medals, Prizes, and Certificates of Honor.

A Gold Medal and three Silver Medals are offered annually for competition among those students of the Medical Faculty who have succeeded in obtaining the Degree of M.B., with First Class Honors, and will be awarded according to the percentage of marks in the aggregate results of the Second, Third, and Fourth Examinations.

## COLLEGE OF PHYSICIANS AND SURGEONS OF ONTARIO.

### Regulations for 1891-92.

#### SECTION I.

#### MATRICULATION.

1. Every one desirous of being registered as a Matriculated Medical Student in the Register of this College, except as hereinafter provided, must present to the Registrar the official certificate of having passed the Second Class Non-Professional Examination—as prescribed for Form II. of the High School course of study—embracing the following subjects :

2. Graduates in Arts, or students having Matriculated in Arts in any University in Her Majesty's dominions, are not required to pass this Examination, but may register their names with the Registrar of the College upon giving satisfactory evidence of their identity and certificate of qualifications, and upon paying the fee of twenty dollars.

3. Every medical student after Matriculating shall be registered in the manner prescribed by the Council, and this will be held to be the preliminary to her medical studies, which will not be considered to begin until after the date of such registration.

4. *On and after the 1st day of July, 1892, any desirous of becoming registered as a medical student in the Register of this College must present to the Registrar of the College the official certificate of having passed the Pass University Departmental Art Matriculation with the prescribed Science course added and compulsory, viz., the Science course in Chemistry and Physics prescribed in the Junior Leaving Examination of the Education Department.*

#### SECTION II.

#### MEDICAL CURRICULUM.

1. Every student must spend a period of four years in actual professional studies, except as hereinafter provided; and the prescribed period of studies shall include four Winter Sessions of six months each, and one Summer Session of ten weeks, compulsory, attended AFTER being registered as a medical student in the Register of the College of Physicians and Surgeons of Ontario. *For students entering after July 1st, 1892, the course will be five years.*

2. Graduates in Arts of any College or University recognized by the Council will only be required to pass three years after graduating in attendance upon Medical Lectures before being admitted to their Final Examination. No tickets for Lectures will henceforth be accepted by the Council unless it is endorsed thereon that the pupil had attended said Lectures regularly.

3. Applications for every Professional Examination must be made to the Registrar of the College of Physicians and Surgeons of Ontario by the first Tuesday in April. No application will be received unless accompanied by the necessary tickets and certificates, and by the Treasurer's receipt showing that the fees have been paid.

4. Each "Six Months' Course" shall consist of not less than One Hundred Lectures, and each "Three Months' Course" of not less than Fifty Lectures.

5. Every student must attend the undermentioned courses of Lectures in a University, College, or School of Medicine approved of by the Council, viz.:

Anatomy.

 Physiology (including Histology).  
 Theoretical Chemistry.  
 Materia Medica and Therapeutics.  
 Principles and Practice of Medicine.  
 Principles and Practice of Surgery.  
 Midwifery and Diseases of Women and Children.

 Clinical Surgery.

Medical Jurisprudence.

One course of not less than three months each upon

Practical Chemistry (including Toxicology),

One course of Fifty Lecture-Demonstrations on

Medical and Surgical and Topographical Anatomy.

One course of not less than Twenty-five Demonstrations upon

Physiological Histology.

One course of not less than Twenty-five Demonstrations upon

Pathological Histology.

One course of not less than Twenty Lectures upon

Sanitary Science.

6. Every candidate will be required to prove that she has carefully dissected the whole adult Human Body.

7. Every student before being admitted to the Final Examination hereinafter mentioned must have spent a period of six months in compounding medicines.

8. She must have attended the practice of a General Hospital for twenty-four months.

9. She must have attended six cases of Midwifery.

10. She must, before being registered as a Member of the College of Physicians and Surgeons of Ontario, have passed all the Examinations hereinafter prescribed; and she must have attained the full age of twenty-one years.

11. Graduates in Arts who have attended one course of Lectures on Botany and Practical Chemistry, and two courses on Theoretical Chemistry, and who already have passed an Examination on these subjects in any of the recognized Colleges, will not be required to undergo a second Examination on the same, provided they produce tickets for the course of Lectures stated, and a Certificate of having passed an Examination on these subjects.

12. Graduates in Medicine from recognized Colleges outside the Dominion of Canada, who desire to qualify themselves for registration, must pass the Matriculation Examination recognized by the Council; and must attend thereafter one or more full Winter Courses of Lectures in one of the Ontario Medical Schools, so as to complete fully the Curriculum required by the Council, and shall pass before the Examiners appointed by the Council all the Examinations hereinafter prescribed.

#### SECTION III.

#### EXAMINATIONS.

1. The Professional Examinations are divided into two parts: a "Primary" and a "Final."

2. The Primary Examination shall be undergone after the second Winter Session, and the Final after the fourth Winter Session.

3. The following branches shall be embraced in the Primary Examination:

- a.* Descriptive Anatomy.
- b.* Physiology and Histology.
- c.* Chemistry (Theoretical and Practical) and Toxicology.
- d.* Materia Medica and Pharmacy.

4. Each candidate for the Primary Examination will be required to present, with her Lecture Tickets, a Certificate of having undergone an Examination at the school she has attended at the close of her first Winter Session on the Primary Branches. (Such Examination shall not, however, in any way affect the Primary Examination



of the Council.) Also a Certificate of ability to make and mount Microscopic Specimens. Each candidate for Final Examination must present a Certificate of attendance at six *Post Mortem* Examinations, and a Certificate of ability to draw up a Report of a *Post Mortem* Examination; also a Certificate of having reported satisfactorily on Six Cases of Clinical Medicine and Six Cases of Clinical Surgery.

5. The following branches shall be embraced in the Final Examination :

- a. Medical and Surgical Anatomy.
- b. Principles and Practice of Medicine and Therapeutics.
- c. General Pathology.
- d. Surgery, other than Operative.
- e. Surgery, Operative.
- f. Midwifery (other than Operative), Puerperal and Infantile Diseases.
- g. Midwifery, Operative.
- h. Medical Jurisprudence and Sanitary Science.

6. The Primary Examination shall be "Written" and "Oral." The Final Examination shall be "Written" and "Oral" and Clinical in Medicine and Surgery.

7. Any Candidate who passes creditably in three or more branches, but fails in the others, shall receive credit for the subjects so passed, and be compelled to pass in the other branches *only* at a subsequent Examination.

8. The next Professional Examination will be held in Toronto and Kingston simultaneously, commencing on the second Tuesday in April, 1892.

N.B.—There will be no examination held in September, 1892.

#### SECTION IV.

#### FEES.

1. The following scale of fees has been established by the Council of the College of Physicians and Surgeons of Ontario :

a. Registration of Matriculation.....	\$20 00
b. Primary Examination.....	20 00
c. Final Examination, including Registration.....	30 00

These fees are to be paid to the Treasurer of the College before Examination.

## Fees after 1st July, 1889 :

a. Registration of Matriculation.....	20 00
b. Primary Examination.....	30 00
c. Final Examination, including Registration .....	50 00

This is not to affect any student who is registered as a Matriculant prior to 1st July, 1889.

2. All fees must be paid in lawful money of Canada to the Treasurer of the College.

3. No candidate will be admitted to any Examination until the fee for such Examination is paid in full.

4. Candidates who have failed in any Professional Examination shall pay a fee of Ten Dollars for each subsequent Examination.

*N.B.—The changes in the above Regulations recently enacted by the College Physicians and Surgeons will not come into force till July 1st, 1892, and are therefore not inserted this year.*

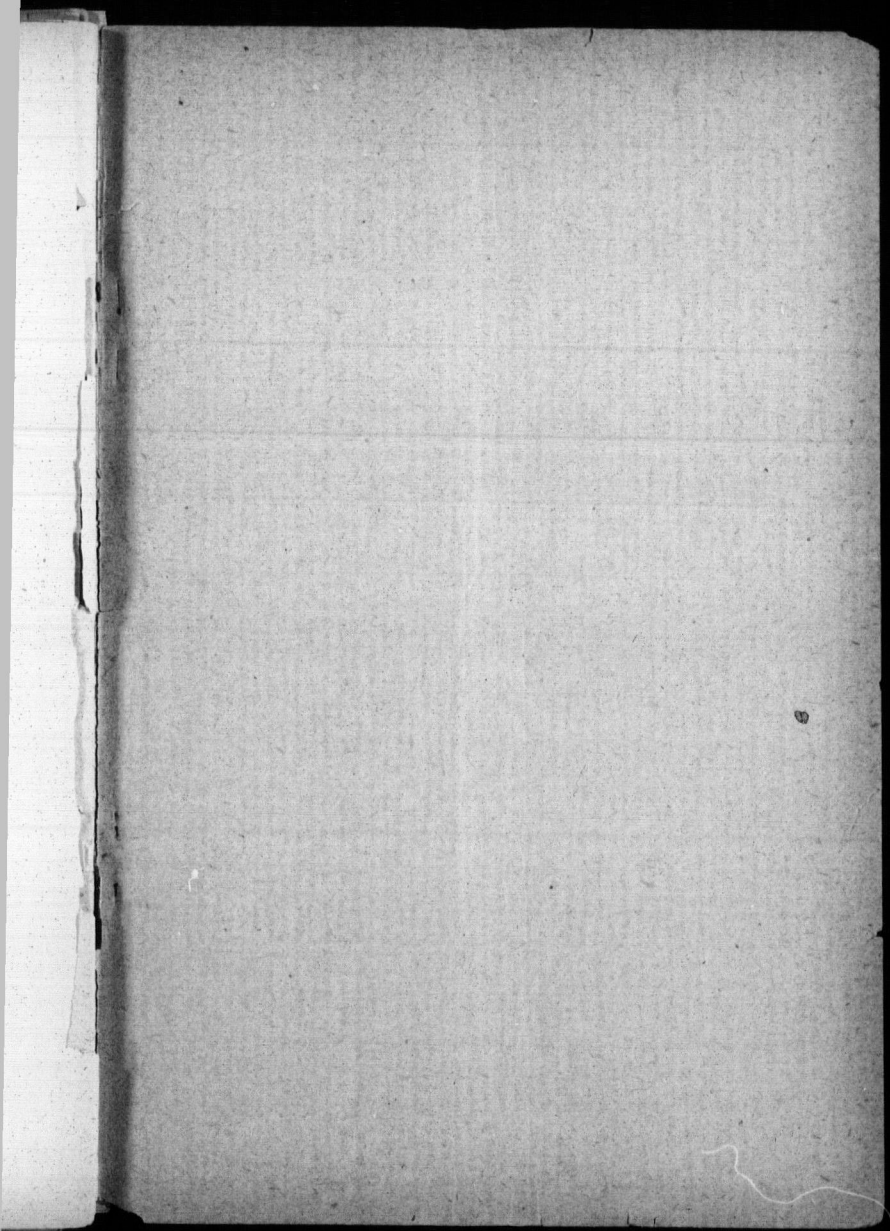

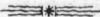

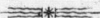
