WHEREAS the remedy provided by the Act respecting the action Preamble. of seduction and the support of illegitimate children, chapter 77 of the Consolidated Statutes for Upper Canada, has proved insufficient in many cases of great hardship in which relief ought to be granted, by 5 reason of the neglect of the persons mentioned therein as being entitled to bring such action, or of their decease, or of their being absent from the Province, or being under other disability:
