## General Officers and Conveners of Committees

## International Council of Women

BERDEEN, COUNTESS OF, Ishbel Maria Marjoribanks; was born March 14th, 1857. By parentage on both sides she comes of a notable and vigorous ancestry; on her father's side, that of the well known Border family of Marjoribanks of Berwickshire, Scotland, and the de Latours of France; and on her mother's side, that of the Swintons, of ancient Scottish lineage, and the Hoggs, who through intermarriage with the O'Neills, trace descent from that Clan of Irish Mediaeval fame.

Much of Lady Aberdeen's childhood was spent in the Scottish Highlands, her father having acquired the beautiful Estate of Guisachan, Strathglass. Of this region one of the old-fashioned guide books truly declares that—"the traveller here finds an assemblage of rock, wood and water, on a scale so extended and magnificent that the far-famed scenery of the Trossachs and Loch Katrine sinks into insignificance beside it."

To the dwellers in these romantic glens there was for years no more welcome sight than that of this young girl, who on her beautiful Arab pony could traverse the steepest and most rugged of mountain paths, and who soon became at home in every cottage in the locality; while the large attendance at her Sunday School gave early proof of the power to attract and interest children. During all this period also she was brought into acquaintance with a constant succession of guests at the Manor House, many of them being prominent in the world of politics and public life. Amongst these was the late Mr. Gladstone; and between him and the young

girl a friendship was then formed which continued with ever increasing strength during the remainder of the great statesman's life.

Ishbel Marjoribanks was married in 1877 to the seventh Earl of Aberdeen. After a trip to Egypt, the young couple took up their abode in Lord Aberdeen's country home, situated in the agricultural part of the East of Scotland. The family estates are extensive, and being divided into numerous holdings, the population thereon must be fully six thousand.

Amongst these, and especially amongst the young, Lady Aberdeen's activity and resourcefulness soon found beneficial scope, the first organization founded by her being the "Onward and Upward Association" which brought "mistress and maid" into a fuller and mutually helpful relation. This society continues to thrive.

The first public and official position with which Lady Aberdeen was connected, was that of the Representative of the Sovereign (Lord High Commissioner) at the General Assembly of the Church of Scotland, to which Lord Aberdeen was appointed in 1881, and which he filled on four or five successive occasions. During his official residence in Edinburgh, the Lord High Commissioner occupies the ancient Palace of Holyrood; and here Lady Aberdeen showed those gifts of the hostess, and the capacity for organization, which have since so often and so successfully been called forth.

In 1886, Lord Aberdeen was appointed Viceroy of Ireland. The duration of Lord and Lady Aberdeen's official stay in Ireland at that time was only about six months, but the period was eventful and

historic, and the leave-taking scene at their departure was one of almost unexampled enthusiasm, regret, and good will.

During this brief sojourn in Ireland, Lady Aberdeen founded and organized the Irish Industries Association, which has continued its beneficent work continuously during the subsequent twentythree years, and has brought practical advantage to countless Irish homes.

At the end of 1886, Lord and Lady Aberdeen started on a tour round the world, visiting India and Australia, and returning home through the United States.

Soon after this, Lady Aberdeen became, first Chairman, and afterwards President, of the Women's Liberal Federation of England. The Chairmanship of this extremely vigorous organization of able and active women (the membership amounting to about 80,000) implied a test and task, the successful fulfilment of which is perhaps as significant as anything that has been accomplished by the subject of this sketch.

The Presidency of the Scottish Women's Liberal Federation was likewise occupied by Lady Aberdeen, who also edited the Monthly Magazine of that Association. (Her successor in this particular position and work is her daughter, Lady Pentland, whom many Canadians remember as Lady Marjorie Gordon).

In 1890 and again in 1891, Lord and Lady Aberdeen had made private visits to Canada, travelling on both occasions as far as Victoria, B.C., and back; and it was during the second visit that Lord Aberdeen purchased the Coldstream Estate, which has become well known as a pioneer fruit growing enterprise, on a large scale, in that district. At that time also Lady Aberdeen, during a visit to Chicago, made full preparations for the holding of the Irish Village at the World's Fair in 1903, which was so successful in promoting Irish Home Industries.

In that year, 1893, Lord and Lady Aberdeen returned to Canada officially, Lord Aberdeen having been appointed Governer-General, which position he occupied until the latter part of 1898.

Space will not permit of any detailed reference to the leading features of Lady Aberdeen's work during the five years of her official life in that country, but the organization of the National Council of Women, and the formation of the Victorian Order of Nurses, must at least be mentioned; also the "Aberdeen Association" for providing literature to settlers in outlying parts, this having been initiated by Her Excellency during her first visit, as the result of observation when travelling in Manitoba and the North-West.

In 1899, Lady Aberdeen presided over the proceedings of the International Council of Women, held that year in London, and at the Berlin Congress in 1905 she was again unanimously elected President of the International Council of Women.

In 1906, Lady Aberdeen returned once more to Ireland in an

official capacity, Lord Aberdeen having been again appointed Viceroy, which position he at present occupies.

Among the many activities with which Lady Aberdeen has since then been associated, the most prominent is that of the Women's National Health Association of Ireland, of which she has been the President and leader from its commencement in 1907. This society has now 170 branches, and the success attending the movement in its various phases has been remarkable.

Its operations include, a vigorous and wide-spread crusade against tuberculosis; the establishment of a Pasteurised milk depot, and various other means to reduce infant mortality; the placing of trained district nurses in numerous localities; and many other kindred arrangements.

The monthly magazine, Sláinte (Health), is edited by Lady Aberdeen, who is also, and has been for many years editor of the monthly organ of the Scottish Mothers' Union, a religious and social organization in Scotland.



HIERTA-RETZIUS, HON. MRS. ANNA (Stockholm, Sweden). Daughter of statesman who introduced important reforms in favor of women during his parliamentary career. She founded evening schools for female servants, and introduced first penny savings bank in Stockholm. Started first exchange for sale of ladies' work. With others founded first school for co-education in Sweden. In 1873, with her sister, organized first society for Women's Rights, and was for many years president. In 1897 published an extensive report "The Workshops of Children in Sweden," and in 1900 another illustrated work, "Series of Models from Swedish Workshops of Children." Has been President of Swedish National Council of Women for ten years, and was at Berlin Congress in 1904. Elected 2nd Vice-President of International Council of Women, and has taken part in the Congresses of London and Berlin and in the Executive in Paris and Geneva.

STRITT, FRAU MARIE, born in Segesvar, Hungary, 1855. First Vice-President of the International Council of Women, and President of the National Council of Women of Germany; has worked for the women's movement in Germany since 1891. Founder of the first Legal Aid Society in Dresden. Took an active part in the campaign against the new civil code. Became member of Executive of the German National Council, 1896; Acting President, 1899; and was elected President in 1900. Since then, Frau Stritt has represented the National Council of Women of Germany at all the Council meetings and meetings of Executive of the International Council of Women in London, Paris, The Hague, Copenhagen, Dresden, Berlin, Geneva and Toronto. At the Berlin meeting, 1904, she was elected 1st Vice-President of the German Council of Women and was the President of the International Congress. Editor of the official paper of the National Council of Women of Germany.

SEWALL, MRS. MAY WRIGHT (United States). In 1875 she aided in founding the Woman's Club of Indianapolis. Since then she has organized over fifty women's clubs in various parts of United States. One of the founders and 1st Vice-President of the General Federation of Women's Clubs. Chairman of the Executive Committee of the National Woman Suffrage Association for seven years. Represented women of United States in series of congresses held under auspices of French Government during Paris Exposition, 1900. President of the National Council of Women of the United States from 1891 to 1895, and from 1897 to 1899. In 1896, as Vice-President of the International Council held in London, England. President of the same body from 1899 to 1904, when she presided over the Third Quinquennial of the International Council, held in Berlin. In 1904, elected Honorary President

of International Council, and Chairman of the Committee on Peace and Arbitration of the Council. Honorary President of the National Council of Women of the United States.

SANFORD, MRS. W. E., widow of the late Hon. W. E. Sanford, of the Senate of Canada; Treasurer of the International Council of Women; a Vice-President of the Canadian National Council, and President of the Hamilton Local Council. In her extensive travels Mrs. Sanford has had unusual opportunities of studying questions relating to the welfare of women. Besides many private benefactions, she maintains "Elsinore," a rest home for needy convalescent women and children, situated at Hamilton Beach.

OGILVIE GORDON, MRS. MARIA M., D.Sc., Ph.D., F.L.S., F.R.P.S., eldest daughter of the late Rev. Alex. Ogilvie, M.A.,

L.L.D., Aberdeen. Married, 1895, Dr. John Gordon, Aberdeen; educated at Ladies' College, Edinburgh (Dux Medallist and Travelling Scholar); Gold Medallist in Zoology and Comparative Anatomy under Sir E. Ray Lankester, University College, London, 1889-90; graduated D.Sc., 1893, London University, studied Geology and Palaeontology, Munich University, 1891-95, and was awarded the Ph.D. degree with the highest honours in 1900 when the degree was for the first time conferred by that University on women; was elected Fellow of the Linnean Society of London in 1906 when that Society for the first time admitted women Fellows, and a Fellow of the Royal Physical Society on the first admission of women Fellows in 1909. Is a Vice-President of the National Council of Women of Great Britain and Ireland; a Vice-President of the Scottish Association for Promotion of Women's Public Work, and Hon. Corresponding Secretary to the International Council of Women, 1904-1909.

SWIFT, MARY WOOD, President of the National Council of Women of the United States. Representative from California for the Daughters of the American Revolution, and the National Council at Washington. She is the widow of John F. Swift, for many years American Ambassador to Japan. A woman of brilliant personality, with a marked talent for organization. She has taken a leading part in club and society life in San Francisco.

AVERY, MRS. RACHEL FOSTER, has been for thirty-one years engaged in work for woman suffrage; was Secretary of Committee of Arrangements for National Council of Women at Washington, D.C., in 1888; was the first Corresponding Secretary of the International Council of Women from 1888 to 1893; from 1891 to 1894 Corresponding Secretary of the National Council of Women of the United States.

HOLLISTER, MRS. LILLIAN M., Secretary of the National Council of Women of the United States, born in Milford, Michigan. After her marriage, removed to Detroit, where she became prominent in the work of the Woman's Christian Temperance Union, was elected president of the society, and is connected with leading international movements among women. Mrs. Hollister was elected Great Commander of the Great Hive of the Lady Maccabees of Michigan in 1893, and Supreme Commander in 1896.

BARRETT, MRS. KATE WALLER, born at Clifton, Virginia, widow of Rev. Dean Barrett; took course in nursing at Florence Nightingale Training School, London, afterwards taking degree of Doctor of Medicine in Georgia State College; present Vice-President of National Council of Women of United States; delegate to recent Conference for the Care of Delinquent Children; has devoted her efforts to professional education for women, and better laws for the protection of young girls.

MILLER, MRS. FLO. JAMISON. Prominently identified with the work of the Woman's Relief Corps in Illinois; an energetic worker for woman's rights; has served as State Chairman of the Republican Women of Illinois; has been State Delegate to National Conference of Charities and Corrections and National Prison Congress. Represented the Woman's Relief Corps in the National Council and acted as Corresponding Secretary of the American Council. Is the editor and publisher of a newspaper in the interests of her work and is the present Vice-President for Illinois of the National American Women's Press Association.

Grannis, Mrs. Elizabeth B. President National Christian League for Preservation of Social Purity, New York; editor and proprietor for 23 years of a successful religious newspaper; actively connected with National Woman's Christian Temperance Union from its beginning; interested in kindergarten work, missionary labors, peace and arbitration, child protection and in providing homes for homeless children; a strong exponent of woman's political enfranchisement.

STEINEM, MRS. PAULINE. President Local Council of Women, Toledo, Ohio; Chairman Education Committee of National Council of Women. Delegate to Executive Meeting International Council, Geneva, Switzerland, 1908. President Ohio Woman Suffrage Association and Chairman Education Committee National American Woman Suffrage Association.

AMERICAN, MISS SADIE. Secretary of Congress of Jewish Women, World's Fair, Chicago, 1893. Was instrumental in the formation of the Union of Jewish Women Workers, England; member of the Executive Committee of the Council of Women of the United States since 1895; President of Consumers' League of New York State, 1901-1906; founder Vacation Schools, Chicago, 1896; one of the founders Army and Navy League of Illinois during the Spanish-American War, 1898; one of the founders of the Playground Association of America; delegate and speaker at the International Congress on Tuberculosis, Washington, 1908.

HER EXCELLENCY COUNTESS GREY, wife of the Governor-General of Canada; Honorary President of the National Council of Women of Canada. Lady Grey will give a few words of welcome at the opening of the Congress.

EDGAR, LADY. President of the National Council of Women of Canada; occupies a prominent position among Canadian women. She has been at different times President and Vice-President of the Women's Canadian Historical Society, and Vice-President of the United Empire Loyalist Society. Her husband, the late Hon. Sir James David Edgar, K.C.M.G., P.C., was for years Speaker of the House of Commons. Lady Edgar's first publication, "Ten Years of Upper Canada in War and Peace," won the praise of no less a critic than the late Mr. Glad-

stone. "The Life of General Brock" followed, and has been very favourably received.

DRUMMOND, LADY, wife of Sir George Drummond of Montreal; first life patron of National Council of Women of Canada; Past President of Montreal Local Council, of which she is also a patron. Founded Home for Incurables, Montreal, 1894; has taken a leading part in the charity organizations of Montreal. Lady Drummond has been for years a moving spirit in all that has been done for art and literature in Eastern Canada.


GIBSON, MRS. J. M., wife of His Honour the Lieutenant-Governor of Ontario; is one of the Honorary Vice-Presidents of the National Council of Women of Canada; and was for many years President of the Local Council of Women in Hamilton.



LADY TAYLOR

TAYLOR, LADY, born in Hamilton, Ontario; married Thomas Wardlaw Taylor, afterwards Chief Justice of Manitoba. Lady Taylor was for ten years First Directress of the Children's Home in Winnipeg, organized the Aberdeen Society, and was President until 1899. Was connected with the Local Council of Women at Winnipeg from its inception, and was President 1896-1899. In the autumn of that year succeeded Lady Aberdeen as President of the National Council of Women of Canada, and held office until 1902.

DERICK, MISS CARRIE M., Assistant Professor of Botany, McGill University, Montreal, eldest daughter of the late F. U. Derick, Esq., a descendant of United Empire Loyalists. Graduated from McGill University. Studied and carried on research work at the Marine Biological Laboratory; at the Royal College of Science, London, Eng.; and at the University of Bonn, Germany. Miss Derick is a Vice-President of the National Council of Women of Canada; Chairman of the Montreal Local Council.



DAY, MRS. ROBERT SCOTT, has been actively engaged in public work since 1889 when she was instrumental in organizing the first benevolent society in Kimberley, South Africa. Coming to Canada, she was appointed first Vice-President of Women's Local Council of Victoria; afterwards Vice-President for British Columbia; originator and organizer of the first Alexandra Club in Victoria.

Last year Mrs. Edwards published for the Council a valuable compilation of the laws, Provincial and Dominion, that chiefly affect women and children. Is an active member of the Women's Christian Temperance Union. Convener of the section on "Laws" in the Congress.

Thomson, Mrs. Robert, St. John, New Brunswick; Vice-President of the National Council of Women of Canada, was President of this Council from 1903-1907. Has always taken a deep interest in philanthropic work; and has held many important offices in connection with the same in St. John. A member of the Committee of Arrangements.

HARRIET A.; formerly Vice-President for Ontario of National Council; for years President of London Local Council; three years a member of the London School Board; is largely identified with the playgrounds and other interests of London. Author of "On Trek in the Transvaal." Mrs. Boomer is a member of the editorial staff of "The Farmer's Advocate."

SHORTT, MRS. ADAM, second daughter of Sylvester Smith, born at Winona, Ontario. Was the first regularly matriculated woman student to enter on a course in Queen's University, Kingston. Has been active in various educational and philanthropic work; President of the Ladies' Musical Club, of Kingston; and a member of the Executive of the Women's National Council.

RITCHIE, MISSELIZA, Ph. D., Halifax, Nova Scotia. Convener of the Section "Professions for Women" in the Congress; Convener of the Standing Committee on Education, National Council: Vice-President of the Halifax Local Council; Graduate of Dalhousie University, Halifax; Fellow of Cornell University, U.S.A.; Associate Professor of Philosophy, Wellesley College, 1890-97; daughter of the late Hon. John W. Ritchie. Miss Ritchie has devoted much time to the critical and historical study of Art, and has frequently lectured on the subject.

Pappenheim, Fraulein Bertha, Frankfurt-on-the-Main; born in Vienna. Is engaged in the care of the poor and of orphans, in connection with the town of Frankfurt. Author of translation of the "Vindication of the Rights of Women," by Mary Wollstonecraft; "The Condition of the Jewish People in Galicia," and "The Rights of Women," a play.

HAGEMANN, FRAULEIN E.; was born in Hanover; educated in England. She took an active part in the political movement of women in London. Is a member of the "Somerville," the first woman's club in London; was for some years its Chairman of Committees. On her return to Germany took part in the movement for the higher education of women; founded in Wiesbaden, where she now resides, a branch of the International Abolitionist Federation, of which she is the President.


GRAFIN SELMA VON DER GROBEN

When the latter lady, a few months after, was elected President of the Deutsch Evangelischen Frauenbund, Gräfin Selma Gröben took her place as leader of the Ortsgruppe, Hanover.

TIBURTIUS, DR. FRANZISKA; was born on the Island of Rügen in the Baltic. She studied medicine in Zürich, Switzerland, because, at that time, the German universities were not open to women. Dr. Tiburtius and Dr. Emilie Lehmus from South Germany were the first women to practice medicine in Germany, and for thirty-one years the former had an extensive practice in Berlin, which she resigned to younger hands two years ago. Since then her life has been spent in travel.




