MORNING MAY 22—Early this morning another terrible fatal disaster was added to the list which has already made 1889 a memorable year in the history of the Dominion as it was just broken over the St. Lawrence at Pointe aux Trembles when the Allan steamship Polyne-sian, Captain Hugh Wyllie, and the Donaldson liner Crystal, Captain John Tyler, crashed into each other.
