A Wolfville Boy's Experience.

INTERESTING ACCOUNT CAPTURED BY CONDOR BY KARLSRUHE.

(Written for the "Hantspost" Review) by Mr. H. M. Dexter, Wolfville, N. S.)
The S. S. "Condor" on which I was employed as purser at the time of her capture, Oct. 11th, by the German cruiser, "Karlsruhe," was owned by Grace Bros. & Co., of London, and was bound for the east and west coast of South America. We left New York Sept. 17th, called at Philadelphia for three hundred tons of dynamite, and at Fernandina, Fla., for lumber to complete our loading. The four thousand tons of general cargo taken on board at New York included a large quantity of lubricating and kerosene oil, that proved very valuable to the German cruiser as we could mix the two and make a very fine fuel. The "Karlsruhe," commanded by Captain Kohler, was very speedy, making twenty-eight knots an hour on coal fuel and thirty on oil.

We were off the coast of Brazil, very near the equator, bound southward, on Oct. 11th, when another merchant vessel flying the English flag came into view, steaming in the opposite direction. Thinking that there might be a possibility of a German cruiser lurking in that vicinity, Capt. Purdy of the "Condor" ordered a signal sent, reading, "Have you seen any sign of war?" After some time had elapsed, the vessel was not distinguished by our signals. "Come closer," when we had closed to within about one mile of our supposed sister ship, there appeared but in frequent small doses, at the first indication of trouble, this treatment loosens the cough and affords relief and comfort. CANDLING OF EGGS

A SIMPLE PROCESS

W. A. Brown, B.S.A., Gives Some Timely and Valuable Suggestions

As regards quality, an egg is one of the most difficult of food products to grade. Fortunately, an egg is semi-transparent when held before the light and permits, if carefully rotated, of even minor defects being seen. Many appliances for commercial and private use have been invented for the detection of bad eggs, but it is now possible for anyone with little practice to tell at a glance the main points between good and bad eggs.

In order to teach the proper methods of examination, there was prepared under the direction of the five stock commissioner, a pamphlet by Mr. W. A. Brown, B.S.A., chief of the poultry division.

It is not necessary, says Mr. Brown, to use an extremely powerful light. An ordinary kerosene lamp, a gas jet, or a 15 candle power incandescent bulb are the sources of light most generally used in commercial work.

From time to time various appliances have been invented to facilitate the candling of eggs in quantities. These have proven serviceable for the simple detection of bad eggs but have not been found satisfactory for the purpose of fine grading.

It is necessary therefore in commercial work as well as in private practice for each and every egg to be passed separately and with a quick turning movement before the light.

The large wholesale produce houses which handle quantities of eggs are handled in a remarkable way. They pick up regularly from two to three eggs in each hand and dip rapidly under the season candle from 25 to 30 thirty dozen cases per day.

The size of the air cell, the opacity of the albumen, the color and mobility of the yolk and the general transparency of the whole egg are the factors most generally recognized as determining the quality.

The contents of an egg, just laid completely fill the shell, but as cooling takes place, contraction occurs and an air space about the size of a five cent piece is formed. The yolk is only slightly perceptible and should be really in the albumen when the egg is turned around.

A stale or shrunken egg may be detected by the size of the air cell. The shell is porous and evaporation takes place whenever the egg is exposed to a temperature above freezing point. Even in the low temperatures of a storage house a small amount of evaporation occurs. The higher the temperature and the more porous the shell, the more rapid is the evaporation.

A bad egg or an egg which has been incubated may be readily detected from the fact that the clear, transparent part has become dark and opaque. Many other forms and degrees of decomposition occur, but these are those most commonly seen.

Many simple devices and appliances have been devised for the candling of eggs. Probably the simplest method is to place the egg between the thumb and first finger and hold it between the eye and the light.

Perhaps the most serviceable of homemade appliances may be constructed from an ordinary tin biscuit box which can be used in conjunction with a kerosene lamp or an electric bulb. The polished tin surface reflects the light and increases greatly the efficiency of the apparatus. A hole one and one-eighth inches in diameter should be cut in one side of the box, three and a half inches from the bottom. To obtain the best results this hole should be faced with thick paper or felt.

It is possible for anyone with a little practice to tell at a glance the main points of difference between good and bad eggs.

The specifications called for the best quality of seasoned Douglas fir, to be treated with 12 pounds of creosote per cubic foot, under specified temperature and pressure conditions. If the Douglas fir ties prove satisfactory for railway construction in India it is probable that other large orders for similar supplies from British Columbia will follow, and the growing industry of the province will be given a decided impetus from India.

Fence Building.

When most farmers prepare to build fences they set green posts and then when they begin to rot off at the top of the ground after four or five years they grumble and fret a great deal about the trials and tribulations of fencing. As a matter of fact if the posts are neatly piled in the dry and allowed to thoroughly season, and then are treated by charring the end which is to be placed in the ground, and the top, which should be slanting, is painted with red lead and linseed oil, they will last fifty or sixty years.

Here is the method for charring: Build a heap of logs ten or twelve feet long, set it on fire, and when burning briskly, lay upon the fire the ends of as many posts as will accommodate crosswise. Turn them over a time or two, and when a slight coal has formed upon the surface, throw them into a pile and set on others. You can treat four or five hundred a day, and if practised by every farmer when building fences, it would save enough in a few years to build good roads in every community.

We prefer to paint the entire post with red lead and linseed oil; it is a little more expensive at first, but pays us bigger dividends than anything we know of.

One word about your fencing wire. We are willing to pay a fair price for it, but the dealer must guarantee its rust proof qualities.

In many cases it is more practical to dip posts in creosote than to char them. The creosote treatment is simple and prevents rotting.

Editorial Brevities.

That expression 'playing the game' is frequently employed in a wrong sense. Men speak of playing a game for money, failing to see that in that expression there is a contradiction in terms that is essentially absurd. One cannot play a game for money—it is impossible. Primarily a game is played for pleasure, whether it be cricket, football, the sports of the field or river or whist or nations or some such like substitute employed by good people who want to play cards but are afraid to handle the real article. But when a number of persons assemble together and agree to pay each other for playing the best game, then whatever the pastime may be, it ceases to be a game. It is a contest for a prize or for money. The game itself is only a means to an end—that end is the prize or the money. A man paid to play cricket or football or hockey is no longer playing a game—he is earning a living. He is in the same class with the shopkeeper who would be insulted if it were said of him by his customers that he was playing the game. Everyone who engages in a game with the hope of a possible reward if they can outwit their opponents—that person is merely exploiting his or her skill and thus earning, for the time being, a living.

We are glad to note that some attention is again being paid to the matter of municipal assessment. At the recent meeting of the County Council the subject came up and although no action was taken it is a hopeful sign that the matter is being considered. Some years ago THE ACADIAN discussed this question, which has always been a vexed one, at length. The system employed throughout the municipality and in the incorporated towns is antiquated. Very often the people who are least able to pay the taxes are obliged to pay more than their share. Anything in the line of reform should be gladly welcomed.

Tuesday was the day for filing nominations for the approaching civic election. C. S. Fitch was the only candidate nominated for Mayor and he is thus elected by acclamation. For the three vacant seats in the Council the following were put in nomination: Messrs. A. M. Whiston, J. E. Hales, F. J. Porter and A. V. Rand. Their cards appear in our columns this week.

It is said that the race course on Lulu Island, Vancouver, built at a cost of nearly \$120,000 will be turned into a dairy farm next year. This is to be done away with, the officials of the Minoru Park having been indicted under the criminal code of Canada.

The Greek minister to England, in addressing a meeting in London, said: 'We are not only in sympathy with but are absolutely devoted to the cause of England, in this great world crisis, because we are convinced that her cause is just and good for the world.'

What Canada Will Pay.

In his budget speech at the coming session, Hon. H. T. White will deal with the extraordinary military and naval expenditure. On his estimate will be based the extra revenue to be raised and he will state methods to be employed for this purpose.

It is evident that all new taxation will be based on an extraordinary expenditure of two hundred million dollars, which is expected to cover the war expenditure from Aug. 1, 1914 to Jan. 1, 1916. This is made up of the \$50,000,000 voted last August, an additional \$50,000,000 needed to meet the outlay to April of this year and \$100,000,000 to be voted for the expenditure from April to January, 1916.

In providing for additional revenue there must be taken into consideration the fixed charge on the two hundred millions, a sinking fund to wipe out the war debt at the expiration of the time over which its payment is distributed and a pension fund for the families of killed or disabled soldiers, and for disabled soldiers themselves. About 4 1/2 per cent. in the price we will have to pay for the money, which will leave the fixed charge at about \$9,000,000 annually. No doubt the war debt will be spread over fifty years. If this is the time decided upon, there will be required for sinking fund about \$5,500,000 per annum, to wipe out this debt on the expiration of this period.

What the pension fund will require is conjecture as yet. No more land grants will be made, so that all rewards or pensions will be a direct tax on the treasury. Some estimate that for a number of years there will be an annual charge on the treasury of ten million dollars for this purpose. We will have at least 150,000 men in the field, if the war lasts another year, and allowing one in five to be killed or disabled, it would mean 30,000 to be provided for, or for their dependents. The cabinet has carefully considered the whole pension question, and will at the coming session place before Parliament its proposals.

Municipal Council.

(Continued from last week.)

Various reports in re Lunatics which had been tabled during the session were brought up; lists of patients at Mt. Hope and at Colchester county and Annapolis county Asylums were read with statements of amounts paid or owing for their support and of extent to which the Municipality might expect to be recouped by the families of the patients. The matter was finally referred to the Committee on Lunatics with instructions to report fully at April Term.

Report of L. K. Patterson appointed to re-survey road in Aylesford (Ormsby to Pierce Road.) read, and on motion. Resolved that no change be made in this road but that it be established as laid out by Commissioner H. J. Nelly in 1913.

Read Petition of residents of Kings-ton and vicinity asking that action in regard to a proposed new road near Kings-ton Station be indefinitely postponed. On motion of Coun. Bowly the prayer of the petition was granted.

Bill of Fred S. Fisher, \$78, for services in securing legislation to validate the appointment of David Bar-teaux, as arbitrator in the matter of damages for lands taken for Right of Way of North Mountain Railway, was ordered paid.

Resolved, that the Clerk advertise for tenders for insurance on public buildings.

Resolved, that all fuel for public buildings be purchased by tender and contract.

Read letter from Dr. Hattie in re Tuberculosis Sanatoria, suggesting a meeting of delegates from incorporated towns and municipalities in Hants, Kings, Annapolis and Digby counties.

On motion of Coun. Nichols the Warden and the County Health Officer were appointed to represent this Municipality at such a meeting.

Read letter from F. Giffins, Esq., Gen. Manager of D. A. Ry., drawing attention to the fact that the law granting right of way to the North Mountain branch specified areas to be given for station grounds and also for terminal at Weston, the latter not to exceed ten acres. The whole ten acres was required for ways and other accessories of a terminal and two and a quarter acres additional had been used for station purposes at Weston. He asked the Council to consider that this should be included in the land grant.

Resolved that the Council do not accede to this request.

Read petition that lands at Sand Creek be disposed of by auction or by tender. Prayer granted; the necessary legislation to be procured.

Committee on Tenders reported recommending Collectors as per tenders received. The report was adopted and collectors appointed.

Resolved that a Committee be appointed to examine public documents not in the custody of this Council and have the same indexed and deposited in the Clerk's Office.

The usual grant of \$25 to Farmers' Association was made.

The presentation amounting to \$28,800, was read. The receipts from the towns for joint services were estimated at \$3000, necessitating for ordinary services, including payment to Patriotic Fund, \$1750; an assessment of \$2500. The payment for railway land damages, which, under the law, must be kept in a separate account, will require for principal, \$2600, being 10 per cent. of amount (\$26,000) borrowed, and interest for one year at 5 per cent, \$1300, or \$3,900, making in all, \$59,700. The rate of assessment will be 52 cents on \$100.

Resolved that the salary of Municipal Clerk be \$750. Carried.

Resolved, that Finance Committee meet hereafter on first Monday in June and in September, and consider accounts that may be in hands of Clerk at those times. Carried. Council adjourned.

Oath of Office Requires Law to Be Enforced.

TO THE EDITOR OF THE ACADIAN: DEAR SIR:—I desire to call the attention of the various candidates now seeking the support of the ratepayers to the fact that, under the Nova Scotia Temperance Act, they have practically to take a specific oath swearing to enforce that particular Act.

The oath of office, so far as the Canada Temperance Act was concerned, was only general and councillors, after their election, might think that their duty was discharged by appointing officers to enforce the law. With the N. S. T. Act it is different.

The oath of office recites among other things, 'I will faithfully perform the duties of which I hold office, to the best of my ability. So help me God.' And the law of 1913 proceeds to outline one of such duties as follows:

7. It shall be the duty of the Council and of every member of the Council and of the Police Commission, the Police and Temperance Committee and of every police officer and inspector in every municipality, town or city to enforce the provisions of this Act and to take such proceedings as may be necessary for the punishment of any offenders thereunder.

See 7 Chap. 46 Acts 1913. There is no getting away from it gentlemen. Are you prepared to take the oath? Yours truly,

By signing the petition, which is being circulated, asking for the reinstatement of Mr. E. M. Beckwith as Justice of the Peace and Stipendiary Magistrate, the men of Kings county have an opportunity they should welcome and use for, at least, two reasons:

1. The signatures will be an expression of their attitude towards the grave injustice which has been done Mr. Beckwith. After many years of faithful service one of the most respected citizens and most efficient officers in the county, has been dismissed without an investigation of the charges against him. The present is a time when much is being said at home in public affairs. 2. In the dismissal of Mr. Beckwith a foul blow has been struck at the principle of the administration of justice—perhaps the most vital point in national life. The machinery for enforcement of law has been crippled, and, in consequence, lawlessness abounds. The responsibility for such conditions, is, indeed, heavy. By placing their names on the petition form, electors shift the responsibility to those who have the power to remedy the injustice. Let it be signed by every lover of justice throughout the county. A Sermonette on Etiquette.

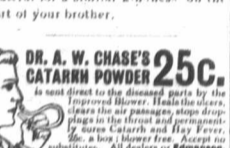

'I have learned,' Birt wrote, 'that you have misjudged your wife, just as

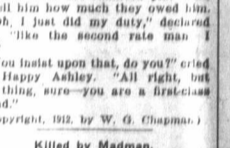

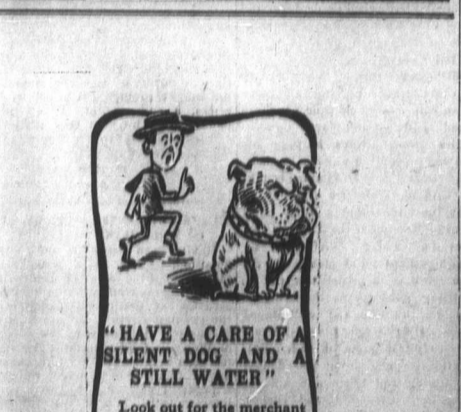
