## The Local Legislature.

(Condensed from Official Report.)

FREDERICTON, April 2.—In the hour

of this afternoon, Mr. Pitts quoted from

articles in the Telegraph and Herald

newspapers, which he said had vilified

him for the part he had taken in the

Quinn matter. He said that he had

him by reading the following declaration,

which had been placed in his hands:

I, William H. Quinn, of the City of Fred-

ericton, in the County of York,

Merchant, solemnly declare that:

## Editorial Notes.

The budget debate is still going on in the Dominion Parliament, and it looks as if it may continue for some time yet.

Ottawa advises that the New Brunswick members are opposed to the granting of \$750,000 to the Government to build a company running a fast line of steamships from an English port to Halifax in the winter and Quebec in the summer.

It is stated that the government intend pressing the ratification of the French treaty made by Sir Charles Tupper, and against the wishes of prominent prohibitionists as well as the Canadian grain growers who object to the admission of French light wines at a reduced rate of duty as provided in the treaty made by Sir Chas. Tupper.

## An Investigation Force.

The commission formed of members of the house of assembly to investigate the charges made by Mr. Pitts, M. P. for York, that an officer under the appointment of the government had been promised for a sum of money paid towards election expenses, turns out as expected, a force similar to that Leary investigation of several years ago. As in that case Mr. Blair is trying himself before a committee originally by himself, and with a chairman (Kilham) pliable enough at the bidding of Mr. Blair to rule out all questions not directly implicating Mr. Blair, evidently fearing that the alleged promise of sale of an office in return for a sum of money might be proved against some one equally interested with himself in the return of government supporters at the general election.

The committee was composed of five members, Messrs Tweedie, Kilham, Pitts, Silverthigh and Powell, with Mr. Kilham as chairman, and their effort seems to be to prevent getting at the truth of the matter and to declare Mr. Blair innocent of such barter, preventing the evidence showing that the dirty work was done by other members of the house in the interest of Mr. Blair. Application was made that the general election of the office be allowed counsel but Mr. Blair protested against it and it was not allowed, and on a motion being made to that effect it was ruled out by the casting vote of the chairman.

And under these circumstances, the finding of the committee is a foregone conclusion. Mr. Blair will be fully exonerated although the money was used for the purposes mentioned and the office without simply because, so it is stated, that another party paid a larger amount than Mr. Quinn had offered for his son. A subsequent committee for government majority will accept the majority report of the committee and the pure (O), honest (B), straightforward (O), character of the Attorney General and the government paraded and glorified before the electors of the country. But the people believe there is a great deal of truth in the charges, and that the Attorney General and his government are guilty of even far more dishonest practices than those enumerated by members of the opposition, and they know such to be the fact by the history of several years past, and in this case they judge that the charges brought against them at the recent investigation the Attorney General would not have been so anxious to confine the limit of the investigation within stated lines as to win a verdict of not proven.

The investigation was a farce from its very inception and has been but an expense to the country without bringing out the truth at the bottom of the matter.

Several committees reported and the reports were on motion received and adopted. A standing property committee was appointed to provide furniture and any other things necessary. Committee consisted of Messrs. Thomas, Clarke, D. Morrison, J. D. Creighton. Some other business matters came up after which the meeting adjourned until Monday evening next, April 16th.

## Hinds.

Another correspondent writes us as follows:

New Mills, April 9, 1894.

Mr. J. T. Windsor, New Mills, is receiving a large order to his capacious retail store for a wholesale business.

The weather still continues extremely cold.

Preparations are being made to start the single mill on the shore as soon as the navigation is open.

It is said that the price of shingles does not rise a few will not run, such as are situated some distance from a station.

The expense of hauling will not warrant the proprietors to run them.

Much sympathy is felt in Resuney for Mr. J. A. Gillis and family, who had their dwelling house burned.

A large number of portable shingle mills which were in operation in the woods during the winter are nearly closed, on account of the low price of shingles in the American market.

Very few have been shipped. They are held up in great quantities with the expectation of better prices.

At no period in the history of Restigouche has so much hay been imported as this year.

It is said that the price of hay is very low and has been imported.

The crop was very limited last season on account of the excessive drought.

## Public Meeting.

At a Public Meeting held in the Temperance Hall at the Village, Harcourt, on Tuesday, the 3rd of April, Councilor P. Hennessey was elected Chairman and A. G. Williston Secretary.

The following resolutions were passed by an unanimous standing vote.

Whereas, Black Brook is an important collecting and shipping point for the Eastern half of the County and is now at a great disadvantage for want of railway facilities.

Therefore Resolved: That this public meeting memorialize the Dominion Government to grant a subsidy for extending the Canada Eastern Railway to Black Brook, a distance of five miles.

Further Resolved: That a committee of three be appointed to prepare a petition to be forwarded to the representatives of this County in the House of Commons to be presented to the Government praying for the necessary subsidy.

Resolved: That this meeting strongly urge Mr. Adams to personally press upon the Government the importance of this Railway extension to the large export trade of the Eastern half of the County.

That a copy of these resolutions be forwarded to our representatives in the Local Legislature with the request that they secure whatever local legislation is necessary to promote the extension of the Canada Eastern Railway to Black Brook, and the business of the Parish of Harcourt would be largely benefited by the said extension.

The large hall was filled to the doors with rate payers from all sections of the Parish. Addresses were delivered by Messrs Watters, Winslow, and Watt of Chatham, Robt. Leggie of Black Brook, and Councilor Collins of Harcourt.

## Travelling and Coach Hire.

The public accounts show that Mr. Chas. Laybells got \$800 in travelling expenses as a member of the executive and \$24 for attending meeting of executive as a member of the executive, or a total of \$824 in 1893.

Mr. Connell got \$834 for travelling expenses as a member of the executive, or \$834 in 1893.

Mr. Mitchell's provincial secretary received \$250 in travelling expenses as a member of the executive, or \$250 in 1893.

Mr. Blair's travelling expenses as attorney general were \$360, and for visiting the Maritime asylum he got \$48, a total of \$408.

Mr. Emerson, as chief commissioner was paid \$900 in travelling expenses, and \$48 for visiting the Maritime asylum, a total of \$948.

Mr. A. S. White, as solicitor general, got \$350 for travelling expenses. He too went to the asylum and got \$48, or a total of \$398.

The coach hire bills of the members of the executive are likewise not negligible. Under the heading of executive government is charged \$252.80.

Mr. John A. Edwards also got \$78.50 for coaching the provincial officers about.

The following amounts were paid to Mr. John A. Edwards for coaching the several members of the executive.

Mr. Mitchell, \$68.00  
Mr. Tweedie, \$32.50  
Mr. Emerson, \$50.00  
Mr. Blair, \$36.00  
Mr. White, \$25.00  
Mr. Connell, \$5.00

These figures, it is to be kept in mind are only for the coaching done by Mr. J. A. Edwards.

Mr. Edwards also got \$30 for driving Prince Napoleon about town.

Take Mr. Mitchell's bill for coaching, \$68.50. It will make 274 coaching trips in the year, or a trip from the Queen to the train for nearly every office day in the year.

Mr. Mitchell is not in Fredericton all the year, but his bill shows the greater part of this \$68.50 gone! Surely Mr. Edwards does not coach the province with the expenses, when he is called to take Mr. Mitchell from his office to his private boarding house in a coach.

Sub-section 15 and 16 of section 5 were struck out with understanding that they may be dealt with again when the question of poll tax is settled. Progress was reported with leave to sit again.

Tweedie committed bill to revise, continue and amend Northwest Boom Company. Wells chairman. Agreed to with amendments.

Powell introduced bill amending law relating to Justices of Civil Court. Phinney committed bill to revise and continue act incorporating western railway company. Bill chairman, agreed to with amendments.
