An Act to amend *An Act to facilitate the performance of the duties of Justices of the Peace, out of Sessions, with respect to persons charged with Indictable Offences.*

WHEREAS it is expedient to amend an Act of the Legislature of Canada, passed in the Session thereof, held in the fourteenth and fifteenth years of Her Majesty's Reign, intituled, *An Act to facilitate the performance of the duties of 5 Justices of the Peace, out of Sessions, with respect to persons charged with Indictable Offences*: Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

I. It shall be lawful for the Sheriff to pay the expenses attending the arrest of any prisoner who may be held to bail for any indictable offence, on the production to him of an Order as in the form A. to this Act annexed, from the Justice or Justices before whom the accused party has been so held to bail, showing the amount ascertained by him or them to be payable to such Constable in that behalf.

ascertained that the sum which ought to be paid to C. D., Constable of the District of for arresting the said A. B., amounts to the sum of ; these are therefore to order you, as such Sheriff for the said District of , to pay unto the said C. D., the said sum of , according to the form of the statute in Such case made and provided, for which payment this Order shall be your sufficient voucher and authority.
