CHURCH SOCIETY MEETING.

The regular quarterly meeting of the society was held in the board room, on Wednesday, August 10th; present, Von. Archdencon of Toronto in the chair, the Rev Drs. Beaven, Shortt, O'Meaca, McNab, and Read, Provest Whittaker, Revs H J Grasett, S. Givins, F. L. Osler, J. G. Gelles, A. J. Broughall, H. C. Cooper, G. S. J. Hill, T. P. Hodge, H. Holland, J. H. McCollum, H. Brent, and J. W. Gamble, F. Farncomb, E. G. O'Brien, R. B. Denison, Esqs.

Prayers were read by the chairman. The minutes of the previous meeting were then real, amended, and confirmed in accordance with the following resolution :

Moved by the Rev. Dr Beaven, seconded by J. W. Gamble, Esq., and

Resolved—That the minutes be confirmed, subject to this alteration, that the old order of procedure in the names of the vice-presidents be adhered to

A report from Rural Dean Palmer on the Elora globe was read, when it was moved

by J. W. GAMBLE, E.q., seconded by E. G. O'BRIEN, Esq.,

Resolved-That in the matter of the Elora parsonage the recommendation of the Rev A. Palmer, advising the sale of the present pursonage and site, and the election of a new one on the land given by Mr. Reynolds, be carried out, provided the legal objections can be removed so far as relates to the saie of the Gilkinson gift.

The Rev. Dr. Macnab submitted a proposition for the settlement of the Darlington Endowment Trust, whereupon it was moved by Rev. H. C. Cooper, seconded by

Rev. H. Holland, and

Resolved - That the proposition now made by Dr. Macnab, together with the legal opinion accompanying it be referred to the solicitor of the society, and that the solicitor of the society be requested to report upon the Darlington glebe question at

the next quarterly meeting of the society.

The following re-olution was adopted on the motion of the Rev. J. G. GEDDES, seconded by the Rev. Dr. BEAVEN, That whereas the synod of the diocese, at its last meeting, agreed to adopt a report of a committee on the subject of the best mode of raising the funds required by the mission board, and desired its secretaries to recommend to the church society the resolutions embodied in that report for its adoption and embodiment in a by-law, that this circumstance be recognised as a sufficient notice, and that the rule requiring previous notice be suspended, to allow of this proceeding.

The Rev Dr Beavan then moved, seconded by the Rev. J. G. Geddes, and it was Resolved - That the following be by laws of this society, for the raising of the

funds required by the mission board, and for the general purposes of the society.

I The Mission Board shall, at the November meeting in each year, make an estimate of the amount required to be raised by voluntary contributions in the ensuing year, both for the keeping up of existing Missions, and for the supply of additional Missionaries when they are required, and in accordance with the regulations of the board.

2 The Mission Board shall thereupon apportion to the several districts the

amounts which they may reasonably be expected to raise.

3 The Secretary of the Church Society shall communicate to the Chairman of each District Association the amount apportioned to be raised within the District, and shall request him to call a meeting of the District Board, taking special care that one or more laymen from every congregation thall be summoned to attend such meeting, according to the 18th article of the constitution; the business of which meeting shall be to apportion the sums to be raised in each parish or cure, in order to make up the whole amount; on a fair consideration of the apparent means of the laity of the church in each parish or cure, together with any special helps or drawbacks, which may exist in such parish or cure.

4. The Chairman of the District Board shall take care that this allotment be communicated to the elergyman and churchwardens of each parish or cure, and shall request them to use all diligence, in connection with their Parochial Association, to raise the allotted amount, by application to every professed member of the

church within the cure, or in any other equally effective manner.

A memorial having been presented from Mrs. Jacobs, widow of the the late Rev. Peter Jacobs, asking for the customary pension, it was moved by the Rev. H. Brent, seconded by Rev. S. Givins, and

Resolved-That the petition of the widow of the late Rev. Peter Jacobs for a

pension be granted, at the rate of \$200 per annum, the usual pension.

A renewed application of the widow of the late Rev. M. Harris, was referred to

the committee on widows and orphans' for their report thereon.

Grants were made to the following churches, to be paid in the order in which they stand, as soon as the funds of the society permit, and also subject to the conditions on which the grants are made, namely, to the church in Flamboro' \$50; to church in town of Clifton, \$50, when the building is enclosed; to church in Brock, \$50; to church in Adjala, \$50, when the church is enclosed; to church in Lakefield \$50 when the building is well advanced.

On the application of the Rev. J. D. Gibson two octave Prayer-books and Bibles, and Sunday school books to the amount of \$10, were granted for the use of his mission, and on the application of the Rev. W. E. Cooper books to the same amount

were granted for the Sunday School at Port Colborne.

The following gentlemen were elected incorporated members of the society:—Hon S. Smith, Isane Robinson, C. A. Miller, James Wallis, and Honry Rogers, Esqs., and Dr. Burnham, of Peterboro', and F. Farncomb, S. Wilmot, J. J. Robson, and R. T. Wilkinson, Esqs., of Newcastle.

The Synod of the Diocese of Toronto, assembled on Wednesday, the 8th June, in St James' Cathedral, at 10 o'clock; the prayers were said by the Rev. Dr. Beaven, the lessons read by the Rev. D. J. F. MacLeod, the ante-communion office by the Rev. A Palmer, the epistle and offertory sentences by the Rev. Dr. Shortt, the sermon was preached by the Rev. John Wilson, of Grafton, from St. Matthew, 28th chapter, 19th and 20th verses, after which the holy communion was administered to the officiating clergy by the Lord Bishop, and then by them to the clergy and lay delegates The synod adjourned to re-assemble in St. Georgo's Parochial School Room, at 2 o'clock, p.m.

At two o'clock the synod was opened, the clerical secretary reading the appointed prayer. His Lordship the Bishop delivered his address.

The Rev. Dr. Lett took exception to the minutes on the ground of their inaccuracy, upon which a question was raised as to Dr. Lett's right to a seat in the

REPORT ON SUNDAY SCHOOLS.

The committee appointed at the last synod to report annually on the condition and progress of Sunday schools throughout the diocese, beg respectfully to submit their first annual report.

ACTION OF BISHOPS AND SYNOD IN REGARD TO SUNDAY SCHOOLS.

The committee find that owing to various causes the synod as a body has not been able hitherto to devote as much attention to the subject of Sunday schools as could have been wished, nevertheless, it has not escaped the attention of the Bishop or of the synod, as will appear from the following extracts:

"In the minutes of a conference of the British North American Bishops, held at Quebec, in September, 1851, the committee find the following declaration of the

Bishops on this subject ":

"We desire to express our sense of the importance, in the existing state of the church, of Sunday Schools, especially in large towns, and we thankfully acknowledge the benefits which have resulted from the labours of pious teachers both to themselves and to their scholars under proper superintendence and direction. In every possible case the Sunday school should be under the personal direction of the minister of the parish or district; or otherwise the minister should appoint the teachers, choose the books and regulate the course of instruction, that there be no contradiction between the teaching of the school and the church. All Sunday scholars should be instructed in the church catechism and regularly taken to church.

"We would carefully guard against the assumption that instruction in the Sunday school, even by the minister of the parish, may be allowed to supersede the directions of the Rubrics and Canons on the duty of catechising in church, for we distinctly recognise and assume as well the great importance, as the sacred obligation of those directions."

In a report on lay co-operation laid before the synod in 1861, the following para-

graphs bearing on the subject occur:

"Every clergyman should endeavour through God's assistance, to raise up about him a goodly band of the faithful, pledged to each other, and more than pledged to their common Master, to do all they can to promote His kingdom upon earth. He might select from this band the superintendent of his Sunday school, to aid him in carrying out the faithful instruction of the lambs of Christ's flock, in providing tenchers and books for the Sunday schools, and to keep him acquainted with the individual cases in the school needing counsel, warnings and encouragement.

"A very important portion of every congregation consists of young men who have been confirmed but not yet settled in the world the care bestowed on this class, would scoure for the Sunday school an abundance of male teachers.

The commutee on "Parochial Statistical Reports," in its report laid before the Synod the same year, also recommend that a report embracing among other things information on Sunday schools be annually furnished to the clerical secretary of the Synod as follows:

8. The number of children on the Sunday school books and the average atten-

The state of the s

9. The number of teachers divided into males and females.

10. The number in attendance in the Bible class.

The Synod at its last session also bestored some attention to the subject, and passed the following resolutions for the appointment and guidance of this committee.

1st. That with a view to provide as far as possible for united action in the diocess

in promoting the greater efficiency in Sunday schools, a committee beformed for this purpose, whose duty it shall be to present a report annually to this Synod on the condition and progress of Sanday schools throughout the diocese, and to make such suggestions for their improvement as they shall judge expedient.

2nd. That the committee consider what steps can be taken to secure the publica-

tion of books suited for libraries and instruction in Sunday schools.

IMPORTANCE OF SUNDAY SCHOOLS.

Deeply impressed with the great value of Sunday schools and the immense practical benefits to be derived from them as a means of imparting sound scriptural knowledge to the young, the committee cannot too forcibly impress their sense of the duty incumbent on the clerical members of the Synod to give the utmost prominence to the work of Sunday schools in their several parishes or charges nurseries of the church, and as means under the influence of God's Holy Spirit of impressing lasting religious convictions on the mind, they have long since established their claims upon the active support and sympathy of the devoted minister and christian parent. The difficulty, nevertheless, of keeping up that active sympathy between the school itself and the congregation, has often been a matter of regret and disappointment to many of the clergy. The committee cannot therefore too strongly urge the importance of each minister endeavouring by a decided personal interest in the school, and by frequently bringing the subject before his congrega-tion, both individually and collectively, to ker an pothat interest in the work which is essential under God's blessing to its due success.

The committee feel the necessity of calling the aftention of the laity of every congregation of the diocese to this great work, as one in which they are especially called to take a part, and to promote it with their means, their sympathy and active co-operation; and of requesting their serious consideration of the high privilege and opportunity of cultivating the spirit of christian charity which the discharge of this

duty affords them

As an evidence of what has been done in this direction, the committee append to this report the printed cory of "a plea for Sunday schools," which was largely circulated in the parish of St. James', Toronto, during the latter part of 1801, and which they have reason to believe has been productive of much good. In addition to the benefits of the Sunday schools, the committee would further point to the advantages of Bible classes held during the week under the direction of the clergyman, and to which the congregation generally should be invited as tending to promote a knowledge of Scriptural truth, and to increase reflection upon serious things; such classes would prove particularly advantageous to Sunday-school teachers and young persons who have been confirmed and left the Sunday school, and are in danger of neglecting the continuance of religious improvement, and at the same time could not be wanting in deep interest to any christian mind,

FORM OF ANNUAL REPORT.

With a view to give effect to that part of the resolution of the Synod which relates to collecting statistics of the state and progress of the Sunday schools throughout the diocese, the committee would recommend that a printed form of blank report to be filed up and returned, be forwarded to each Rector, Incumbent and Missionary in the diocese, as follows:

SUNDAY SCHOOL LIBRARIES.

Of the importance and influence of good libraries in Sunday schools, the comnuttee cannot speak too highly or urgo their introduction too strongly; they at once are a means of interesting the children in the Sunday school, and of supplementing and lightening the labours of the paster and teacher, often proving a benefit to the parents and friends as well as to the children.

In regard to the selection of books for Sunday school libraries, the committee feel that very great benefit would arise from having selections carefully made, adapted with circumstances of our own country and published in the province; this object should be kept in view, yet they fear there are serious difficulties in the way of amediately accomplishing it, and therefore must at present be content with recommending the obtained libraries from the best available sources.

BOOKS OF INSTRUCTION.

The committee feel that suitable books of instruction are essential to the success of this important institution, and think that here something can be done to meet a want that those engaged in Sunday school teaching in this country feel, by preparing new books for the purpose, or by adapting to our use books published elsowhere. As a means of promoting a more thorough course of instruction as well as giving a more extensive range to the subject of Sunday school teaching, the committee propose the preparation of a schedule of biblical lessons and texts for use in Sunday schools similar to the one used by some of the clergy in Montreal, a copy of which is appended to this report.

LAY-SUPERINTENDENTS.

In regard to the management of Sunday schools, the committee are of opinion that each school should be in charge of a lay-superintendent, with a sufficient number of letated and pious teachers to help him. It is very desirable, when possible, that e clergyman should have a general and ever vigilant oversight of the school, but the det ils of management, the order and discipline of the schools, rest with the layaperintendent, who should be appointed by, and responsible to the clergyman; thus lay-agency would be worked, and lay-co-operation secured.

In conclusion, the committee would suggest in addition to the ordinary routine of the school, that the chargyman should set apart specific periods for entechetical instruction given by himself in the school, and at stated periods to preach a sermon specially addressed to the Sunday-school scholars.

REPORTS OF COMMITTEES.

Col. O'Brien presented the following report on the security of the Church Property, and gave notice of a motion to-morrow that it be adopted.

The committee appointed to report on measures adviseable for the better security

of church property, beg to report as follows :-

1st.--That the "Church Temporalities Act" having placed the church and church yard under the immediate care and controut of the parish, acting through its vestry, all repairs and expenses of, and attending on the same, necessarily devolves on said vestry.

2nd.—That whereas the parsonage house and globe lands, not being unoccupied wild land, is held as a joint interest, the parish being the landlord or proprietor, and the incumbent as tenant with a life interest, it is right and reasonable that the

ris should bear all expense of erection and material repairs: and that the incumished be responsible for all matters of repair necessary to keep the glebo charge and premises in decent order and repair, namely:—1st. As to the dwelling, site painting, papering, and all such other matters following on occupying the excess a dwelling, including repairs to roof, not involving renewal thereof; and to said the out-buildings, keeping them in like manner in decent repair. 3rd. As to gates at feaces, keeping them in efficient order and repair; renewing or repairing when it shere necessary, but not to include the expense of erection of new feaces to receive the parsonage premises; the standard of such efficient order and repair reast feace municipal rule or law of the place where such exists, or otherwise the relast; custom and rule of landlord and tenant.

in Should the incumbent, by wilful negligence, by any act of commission or sission, suffer the said buildings, gates or fences, to go out of repair, it shall be heduty of the churchwardens to point out such disapidations to the incumbent. plrequest him to find a remedy for the same: and the churchwardens may, after artisonable space, employ a suitable mechanic or mechanics to execute the necessur repairs, and the certified expense thereof they may deduct from any funds in a passing through their hands payable to the incumbent. But should the incumhat feel aggrieved by such contemplated action of the churchwardens, he may inceal to the Bishop, who shall (if he see fit) appoint a committee consisting of the Ross Dean, if resident within his deanery, and one or two, or more neighbouring degreen and laymen to be named by the bishop, or under his authority by the mbleacon, which committee, together with the archdeacon, if he is so directed by the bishop, or considers the matter of sufficient importance to require his personal interference, shall enquire into the same, reporting their decision to the bishop or urbdeacon, as the case may require, and such decision when approved by the bishop or archdencon shall be final.

4th.-Should any extensive improvements or repairs become necessary from lapse of time, or otherwise the visitation of God, such as new roofings, external paintings, REDEWAL or replacing of important matters necessary to the stability or safety of the buildings, or the erection of new fences to protect the parsonage premises; it shall bethe duty of the clergymen to lay a detailed statement of the same, with an approximate estimate of the expense, before the usual Easter Meeting of the vestry. bring previously given notice of his intention to do so, or before a vestry meeting especially convened for the purpose: and should the members of the vestry sanction the same, the churchwardens shall forthwith proceed to effect the necessary repairs, providing for the expense thereof from the funds of the church, by parochial subscriptions, or by any other mode determined by the vestry; provided that in no cue shall the prope ty of the parish be so encumbered by the debt or morigage, as blead to the probability of its being ultimately lost to the parish, nor shall the espense of such improvements or repairs be defrayed from any funds appropriated but pertaining to the support of the clergyman. But should the vestry decline to spection the necessary repairs and the expense thereof, or should the churchwardescribed to accomplish such required repairs when so sanctioned, the clergyman my then appeal to the bishop, who may appoint a disinterested committee, as appointed in the foregoing section (No. 3,) to inspect the premises and report upon the necessity of the proposed alterations or repairs; and as far as sanctioned by their aport, the bishop shall require the parish, through its churchwardens, to effect the une: and in case of non-compliance within the time specified by his Lordship, then the incumbent shall have authority to accomplish the same by means of money birrowed for the purpose, the amount of which should be a debt due by the parish; and which debt together with the interest on the same, shall be discharged within a imted time named by the bishop or committee aforesaid; and in default of payment being made at the time specified, the incumbent shall notify the same to the buttop, who shall then take such further action in the premises as he in his wisdom my see fit.

ith.—That whereas it is advisable that no proper precaution should be omitted for the preservation of the property of the church, all the buildings thereof should be insured, it shall be the duty of the churchwardens to keep such buildings con-

stantly insured in some respectable office, and in respect of the parsonage house and premises, in default of the churchwardens doing so, the incumbent may affect

such insurance, and make the expense thereof a charge on the parish.

6th.—That a book of record be kept in each church in which shall be entered a sufficient abstract of all titles and deeds by which the lands of the said church, whether site of church, burial ground, glebe, endowment, or whatsoever they may be, are held, showing their date, by whom given, situation, quantity of land, conditions of trust or gift, where and when registered, and any other information necessary to a full understanding of the same; also, if wild and unoccupied land, whether any or what provision is made for payment of taxes, when the taxes have been paid, and what arrears of taxes may from time to time accrue.

7th.—That whereas there is much valuable, though at the time unproductive property, held as endowments for various churches or parishes, and much loss has been incurred by the sale of such lands for taxes, it is necessary to define on whom the re-ponsibility of the payment of such taxes should rest, it is proper that in all cases where wild or waste lands are held, being unproductive, and the incumbent deriving no benefit from them, the expense of maint-ining such lands should be a charge on the parish or church for the benefit of which they are given, and in all cases where any benefit or emolument is derived from any such piece or parcel of land by the incumbent, or on his behalf, then the expense of taxation should be incurred by such incumbent as a part of the ordinary expense of his glebe or mission.

8th.—That in accordance with the foregoing, the Church Society, or other parties holding real estate or other property in trust for any particular church or parish, do send a statement of the same to the churchwardens of such church or parish to be recorded, and that from the time of such trustee or trustees so doing they shall be exonerated from any liability for non-payment of taxes accruing after that time.

9th.—That for the convenient safe keeping of such record book, as well as other documents, papers, or records, a sufficient strong box with lock and key scall be provided by the churchwardens, and kept in the vestry of said church, and shall be at all times, under such ordinary and convenient regulations as may be adopted by the vestry, open to the inspection and for the information of the parish, as well as

for any properly authorised officer of the church.

10th.—For the purpose of duly enforcing the foregoing regulations, it shall be the duty of the Rural Deans, each in his own Rural Deanery, acting under the authority of the ordinary or archdeacon, carefully to examine into the same from time to time as he may be required or have convenient opportunity; and to take such steps in case of neglect or failure as may be necessary therein according to the authority with which he is clothed; also, that the archdeacon, shall in his visitation examine into all such matters, either approving of the manner in which such rules and regulations have been carried out, or otherwise if not so done, and in any case of neglect or non-compliance to take such steps as may seem to him desirable in the premises; making an entry in the record book of each church, of such examination and the result thereof.

All which is repecfully submitted.

Mored by the Rev. Dr. Shortt, seconded by Dr. Rowan, that the practice of total abstinence from the use of intoxicating liquors as an article of ordinary diet, bespitality or luxury, is a practice to be commended in those who feel it their duty

to adopt it, especially as affording a good example to youth.

Dr. Bovell moved in umendment, seconded by the Rev. Mr. Ardagh, that in order to mark the extreme displeasure with which the church regards the soul-destroying vice of intemperance, it is desirable that a canon should be passed, sutherising the clergy to refuse to receive at Holy Communion any one who is known to be living a life of habitual intemperance.

The Rev. II. C. Coopen moved a second amendment, seconded by F. W. Cumberland, E.q., that this synod, though not pledging itself at present to any definite action in reference to the subject of Dr. Shortt's motion, would express its approval of all proper means adopted by the members of the church, individually and collectively, for the suppression of intemperance.—Carried.

Mr. Harman obtained leave to bring in his report on the registration of deeds,

and gave notice that he would move to-morrow for its adoption.

The committee named at the last synod to consider the subject of registration in matters connected with the church, beg leave to submit the following

REPORT.

Your committee feel that it must be evident that when the number of parishes or missions in this rapidly increasing diocese is considered, and the land and other property already appertaining, or likely to appertain to them, is contemplated, the

title deeds or other evidences of the same must be exceedingly numerous.

Your committee have, in the next place, considered the extremely insecure character of the present system of guardianship or holding of these title deeds or eridences of property, which are for the most part in the hands of churchwardens, a body of church officers perpetually changing, and who, for the reasons to which your committee will hercinafter revert, may not be deemed the right custodians of the same.

Your committee have further considered the subject of parochial registers of births, marriages, and deaths, containing, as they do, records of incalculable value in the proof of descent, as affecting the transmission of property, and the character of families. These registers, your committee believe, are generally kept at the private residences of the clergy, and their risk of destruction by fire or otherwise is at all times, to say the least, possible.

Your committee feel that there may be many other papers or instruments bearing indirectly, but still with importance, on parochial and church property, which it may not be desirable should remain in parochial keeping, such, for instance, as

important receipts or releases, given or procured in the adjustment of church detail incurred in the course of the erection and construction of the church or church buildings, sentences of consecration, abstracts of the boundaries of parishes u settled by consent, or otherwise, with many other matters of a statistical character and bearing.

Your committee will not encumber their report with many reasons which pless; themselves why a different and more efficient plan should be adopted for the guardianship of the many important documents to which they have above allucid they will content themselves with urging a few, which they deem are sufficiently man. fest to recommend themselves at once to the consideration of the synod. In the first place, with regard to real estate this may, in many instances, have come to ut church either directly from, or through the agency of local residents, who may te or become churchwardens, and thereby the custodians of their own deeds. In the second place, in the case of the documents referred to in clause four of this report such as releases and receipts which may be taken or procured for local residents to as members of building committees, or otherwise may have had large pecunun reckoning with the then authorities, and who subsequently becoming churchwardens, may have under their own control these very receipts and releases given by themselves.

Your committee would, therefore, recommend the institution at the earliest day of a system of registration, under the authority of the synod, to embrace the folion. ing heads, namely,

- 1.—All deeds, or other instruments connected with the property of the church a the way of real estate, viz.,
 - (a) Lots granted for the sites of churches. (b) Lots granted for the sites of parsonages. (c) Lots granted for sites of school-houses.

(d) Lots granted for purposes of endowment, whether in glebes or otherwise.

2.—Other property, (not real estate,) such as debentures, stocks, &c., convered to, or settled to the use of any church or school, for the benefit or endowness thereof.

3 —Debentures, bonds, or other securities for money issued by any church in the arrangement of its liabilities.

4.—All other documents of importance connected with the settlement of the debt of or upon any churches, parsonages, or school houses, which, for the reasons alon suggested, should not remain in parochial custody.

5.—Certificates of the day of the corner stone of any church, or its church build

ings appurtenant being laid.

6.—Sentences of the consecration of churches.

7.—Abstracts of the boundaries of parishes, or the sub-division thereof, as settled by mutual consent of the neighbouring clergy, or by commission for the Lord Bishop. in accordance with the provisions of the canon of synod in that behalf.

8.—The dates of appointment to any rectory or mission of the rector, incumbent

or assistant minister thereof.

9.—The names of the churchwardens appointed annually, at the Easter vestries

10 .- An alphabetical registration of births to be compiled from sheets containing copies or transcripts from the parochial registers, to be furnished annually by ever parish, the said sheets containing such transcripts or copies to be carefully filed and enrolled when entered.

11 .- A like registration of marriages.

A like registration of deaths.

In conclusion, your committee had proposed to themselves the introduction of s canon on this important subject at the present synod, but considering the magnitude of the different points to which they have referred, they are of opinion it may be more satisfactory to the synod that the matter should receive additional consider-They, therefore, respectfully submit that a committee be now appointed, v be styled the "Provisional Registration Committee," who shall at once enter up the duties of the collection of material for a complete registration of the different matters above enumerated, with a view to ensure the due protection of the property of the church, and all statistical matters entrusted to her sacred keeping, and h a safeguard against any careless or fraudulent dealing with the same, such provisional committee to report on the same at the next meeting of synod.

All which is respectfully submitted.

The Rev Dr. FULLER presented the report of the committee on the endowment of the see, and moved, seconded by the Rev. Mr. Cooper, that it be adopted .-

The committee on the endowment of the see beg leave to

That they made arrangements, in the month of October last, for a deputation to visit the parishes in the Niagara Rural Deanery, on behalf of the fund for the endo ement of the see; and several meetings were held with a good prospect of success, but owing to pressing parochial duty, the deputation were obliged to return to their parishes.

The result of the mode adopted on this occasion convinced the committee that it was not advisable to pursue this course any further; inasmuch, as the meetings, being held on consecutive evenings, it was impossible to follow up the impression

produced at the meetings, so as to secure the desired result

Being thus convinced that this was not the best course, they came to the conclusion, to recommend to the Lord Bispop to appoint an agent, who should be able to give his whole time to the duty, and his Lordship was pleased to appoint the Rev. Dr. Read, in December last, as such an agent

Since his appointment Dr. Read has visited the parishes of Stamford, Chippawa. Fort Eric, Welland, Drummondville, Cayuga, Walpole, in the Niagara Rural Deanery, Most of this duty he discharged whilst continuing to dison behalf of the fund.

charge his duty as Rector of Thorold.

Since the 1st of March last, he has been enabled to devote himself exclusively to this important duty; and has removed temporarily to this city, as a more convenient centre of operation. Since his arrival here he has held meetings on behalf of his

mission, in the parishes of St. James, St. George, and St. Stephen.

He has to report, as received in the Rural Deanery of Ningara, in promises, which he considers as perfectly good \$170.00; in notes of hand, bearing interest, \$663 00; in cash \$1346 00; making a total from that Rural Deanery \$2188 00: as received in Toronto, in promises considered by him perfectly good, \$1,395.00 in notes of hand bearing interest \$1405.00; in cash \$800.00, making a total for this city of \$3,600, being the contributions in part of the three above named parishes, and a total reported by Dr. Read, of \$5788 00.

This report is intended only to give the result of Dr. Read's work, so far as carried out, and not to show what is to be expected from any one of the places visited, as

in no case had the work been completed.

Moved by the Rev. Dr. Fuller, seconded by Mr. Gaviller, that this Synod views with alarm the late decision of the Judicial Committee of the Privy Council in the case of the Rev. Dr. Williams, and the Rev. H. B. Wilson, as tending (if not regarded with all the guards and limitations thrown around it by the court) to shake the faith of many members of our Holy Communion. That this Synod representing that form of the United Church of England and Ireland, planted by Gol's providence in this Diocese, avails itself of this opportunity to declare before the world its firm and undoubting conviction that the Church to which this Synod have the high privilege of belonging, maintains without reservation on equivocation the inspiration, and the Divine authority of the whole canonical Scriptures, as not only containing, but being the word of God, and that she further teaches in the words of our blessed Lord that the punishment of the cursed equally with the life of the righteous is everlasting.-

Carried. The Rev. Dr. O'Meara presented the following report of the Committee on assessment and Finance: -The Treasurer's accounts to the Synod stows a balance in hand of \$432 50, after the payment of all expenses up to the opening of the present session, independently of amounts handed in since the balance sheet was struck; the committee, therefore, in view of the highly gratifying state of our finances, recommend that the balance in hand, after the expenses of the present session shall have been defrayed, shall be handed over to the mission Board, and the assessment for the ensuing year be the same as that of the present financial period, all of which is respectfully submitted.

Moved by Mr. Hodgins, seconded by R. A. Harrison, Esq, that with a view to relieve the secretaries of much of the routine duties and detail connected with their office during the sittings of the synod, they be authorised to employ an assistant, whose duty it shall be to give special attention to the recording and printing of the daily minutes of proceedings.

That for the information of the members of the synod, a summary statement or synopsis of the whole of the unfinished business before the synod be prefixed to the daily printed notices of motion in the order in which it is proposed to take it up,

That with a view to ascertain what resolutions and canons have received the sanction of the synod, it be an instruction to the secretaries to employ a person to collate from the official minutes book, and append to the printed minutes for this year a copy of each canon or resolution which has been duly passed since 1858, with an index, and that a similar appendix and index for each succeeding year be prepared and inserted in future in the annual printed minutes proceedings of the synod.

That the compilation of the proposed list of canons and resolutions, when prepared, be submitted to the committee on the vestry manual, for its approval, before being printed in the appendix to the printed minutes of the synod.—Carried.
