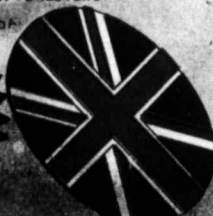

Independent Order of Foresters

BENEFITS.

In addition to the **Social** and **Paternal Privileges** which a Forester enjoys by virtue of his membership in this great Fraternal Order, he secures the following substantial Benefits.

For Himself, During His Lifetime.

A.—FURNISHED BY THE SUBORDINATE COURTS.

- 1.—Free Medical Attendance of the Court Physician, within whose jurisdiction the Brother is taken sick, except where the Court by By-Law has dispensed with such attendance.

B.—FURNISHED BY THE SUPREME COURT.

- 2.—A Sick Benefit of \$3.00 a week for the first two weeks and \$5.00 a week for the next ten weeks, and, as provided in the Constitutions and Laws of the Order, \$3.00 a week for additional twelve weeks.
- 3.—A Total and Permanent Disability Benefit of \$250, \$1,000, \$1,500, \$2,000 or \$2,500.

For His Beneficiaries, at His Death.

- 4.—A Funeral Benefit of \$50.
- 5.—A Mortuary Benefit of \$500, \$1,000, \$2,000, \$3,000, \$4,000 or \$5,000.

Old Age Benefit.

All members cease paying premiums when they attain the age of 70 years.

When Benefits Commence.

Members of the I.O.F. are under the protection of the Supreme Court and entitled to full benefits as soon as they have passed the Medical Board, (b) have paid their Initiation and other required Fees, and (c) are initiated into the Order. In most of the other societies, members are not entitled to full benefits until six months after initiation.

The Cost in the Order ranges from \$6.50 to \$12, according to amount of Assurance taken.

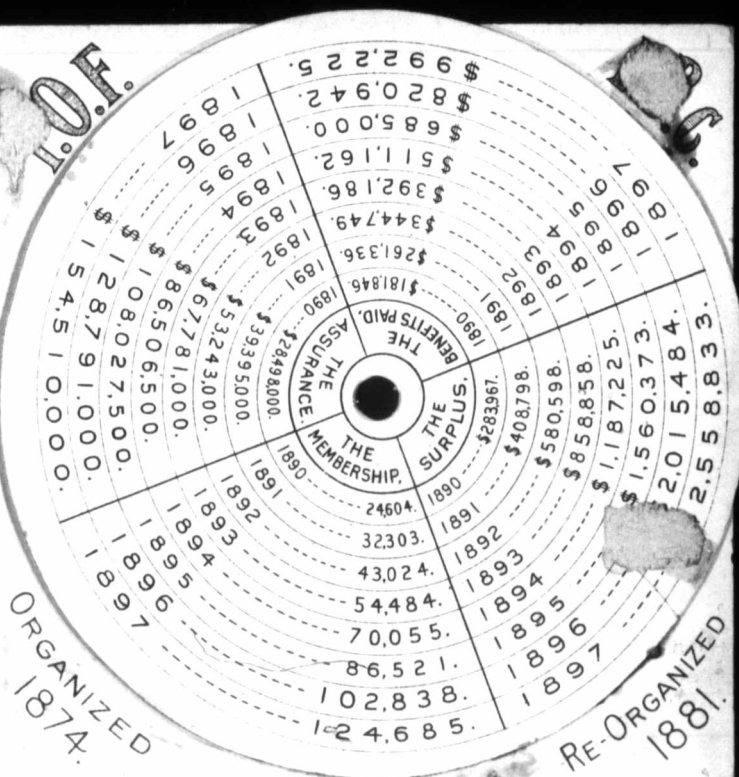
