MINISTER APPOINTS NEW INTERNATIONAL TRADE ADVISORY COMMITTEE AND NAMES CHAIRPERSONS FOR SECTORAL ADVISORY GROUPS

The Minister of Industry, Science and Technology and Minister for International Trade, the Honourable Michael H. Wilson, today announced members of the reconstituted International Trade Advisory Committee (ITAC) and the incoming Chairpersons for 15 Sectoral Advisory Groups on International Trade (SAGITs).

"I have asked committee members to work closely with Canada's trade negotiators on issues directly related to the Uruguay Round of Multilateral Trade Negotiations (MTN) and the negotiation of the North American Free Trade Agreement (NAFTA)," Mr. Wilson said. "I will also call on the ITAC and SAGITs to interact with the Government in implementing the Canada-U.S Free Trade Agreement and in examining issues affecting Canada's competitiveness, especially those issues directly related to international markets and marketing."

Mr. Wilson said by helping to guide Canada's trade policy, the advisory committee system will advance Canada's export objectives. But he added that trade policies alone will not guarantee Canada's future prosperity. "Better marketing and a commitment to competitiveness will be needed for long-term prosperity.

"Canadian companies are proving they can compete -- and win -- in some of the toughest export markets in the world. By adopting a positive outlook and taking advantage of new and expanding opportunities, we will continue as a force to be reckoned with in world markets. Some three million jobs across Canada depend on our exports. It is not hard to see why competitiveness is the key to our high standard of living today, as well as our prosperity tomorrow."

The 53-member ITAC provides for an ongoing two-way flow of information and advice between the Government and the private sector on international trade matters. The ITAC complements the 15 SAGITs, which provide in-depth sectoral expertise. Taken together, they cover the full spectrum of Canadian economic activities and comprise more than 200 prominent individuals from the business, labour, environmental, academic, consumer, research and cultural communities. Members serve on a voluntary basis without remuneration.

The chairperson of each SAGIT is also a member of the ITAC. The full list of SAGIT members for the coming two years will be announced in the near future.

The Minister earlier announced that Marshall A. "Mickey" Cohen, President and Chief Executive Officer of The Molson Companies Limited, has succeeded Senator Trevor Eyton as Chairman of ITAC. Senator Eyton, Chairman of Brascan Limited, served as ITAC Chairman for the past three years.

BACKGROUND INFORMATION

THE INTERNATIONAL TRADE ADVISORY COMMITTEE SYSTEM

I. MANDATE AND STRUCTURE

This permanent advisory committee system has been established to provide an ongoing, confidential, two-way flow of information and advice between the Government and the private sector on international trade matters. It is the main channel for communicating to the Government the views of the Canadian private sector.

The advisory committee system, which reports to the Minister for International Trade, ensures that the Government has the benefit of private sector views in its deliberations relating to trade policy and trade development issues that arise in Canada's international trade relationships, both bilateral and multilateral.

The advisory committee system has two components -- the International Trade Advisory Committee (ITAC), which has broad terms of reference on all international trade matters; and the 15 Sectoral Advisory Groups on International Trade (SAGITs), which ensure that sectoral views are fully considered in the advisory process.

On issues directly related to the Uruguay Round of Multilateral Trade Negotiations (MTN) and the negotiation of the North American Free Trade Agreement (NAFTA), both components of the advisory committee system work closely with the Canadian trade negotiators.

In addition to the above issues, the ITAC and SAGITs interact with the Government in the implementation of the Canada-U.S. Free Trade Agreement (FTA) and in the examination of issues that affect Canada's competitiveness, especially those directly related to international markets and marketing.

II. MEMBERSHIP - APPOINTMENT AND TENURE

Members of both the ITAC and SAGITs must be Canadian citizens and are appointed by the Minister for International Trade. Members serve for a period of two years, subject to suitable arrangements being made for sensible rotation and the need for continuity.

Members serve without remuneration and may be reappointed for one or more additional periods. However, at all times, members serve

at the discretion of the Minister for International Trade. The Minister may create additional sectoral advisory groups as required.

One of the unique characteristics of the advisory committee system is the openness with which members exchange information and advice with the Government. The nature of these exchanges is often of a confidential nature.

In this context, before they take their position on a committee, all members are required to sign a security declaration undertaking to respect the confidentiality of classified information provided to them by the Government.

The International Trade Advisory Committee (ITAC)

The membership of this committee is broadly representative and reflects regional, sectoral and demographic interests. ITAC members are selected from the business, labour, environmental, academic, consumer, research and cultural communities.

Sectoral Advisory Groups on International Trade (SAGITS)

The 15 SAGITs are as follows:

- 14. Transportation Equipment
- 15. Transportation Services

Members of the ITAC and SAGITs serve in their individual capacities, not as representatives of specfic entities or interest groups.
